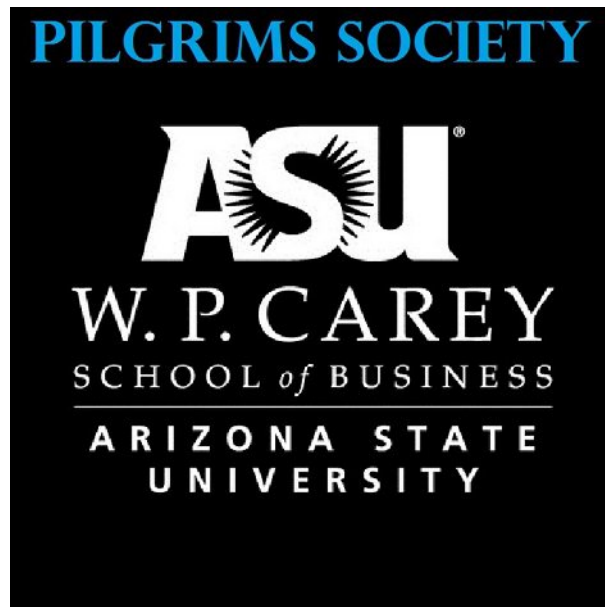

Not discussed---British UN Ambassadors to the UN since 1980 who are deceased; same with late US Secretaries of State; several others.

It's most likely that Henry Morgan Jr. was also a Pilgrims member and the Senator is a very warm prospect also. Senator McCain's [mother](#) was also an oil and gas industry heiress. Ducey also worked for consumer products colossus Procter & Gamble run by Pilgrims Society members. "Ducey's [honors](#) include the 2002 Spirit of Enterprise Award on behalf of Cold Stone Creamery by the Center for the Advancement of Small Business at the [W. P. Carey School of Business](#) at Arizona State University, and induction into the W.P. Carey School of Business Hall of Fame in 2004." We'll review William Polk Carey (Pilgrims Society, large scale New York real estate financier) in Silver Squelchers Nineteen. His company is worth over \$11 billion as of 2014. Mister Carey ([1930–2012](#)) had a direct connection to the Du Ponts (Pilgrims Society/Silver Users Association) as we will document with court acceptable evidence! 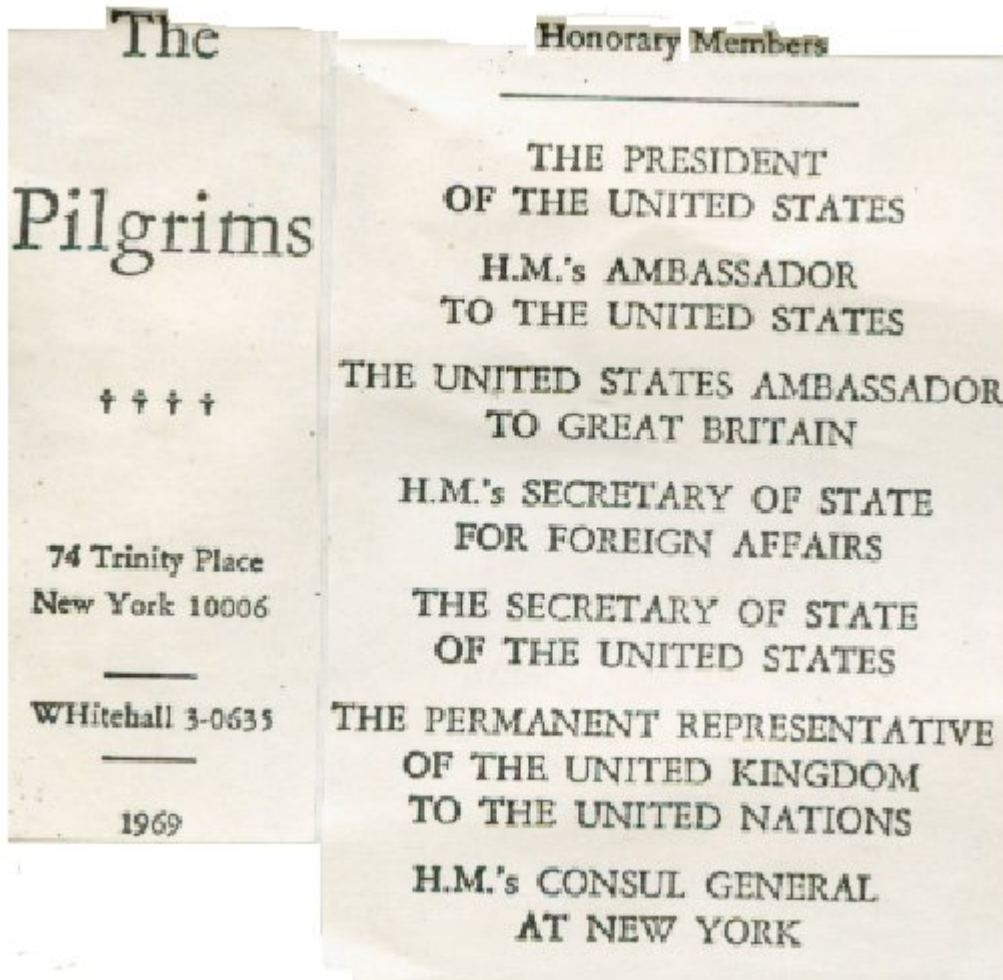
Sellout artist Ducey is an ex-officio [regent](#) of Arizona State University.

He remains on the scene today and is into “closely held companies.” McCallum’s results are for persons who couldn’t match his profile, leaving him in the category of potentially identifiable.

Please bear in mind that information as to confirmable members remains very limited; around 88% of members in London and New York are currently unidentifiable as to unquestionable documentation. Therefore, the influence this group has in various spheres is far greater than what these profiles suggest! The one exception is that we know that all Ambassadors to and from England are members, plus all British UN Ambassadors. American Ambassadors to the U.N. are chancier and many may end up at the level of the Council on Foreign Relations (CFR) and may not rise higher, with an occasional exception. This detail on U.S. Ambassadors to the U.N. is current as of this writing or till we find the Society has taken all these U.N. Ambassadors into its fold.

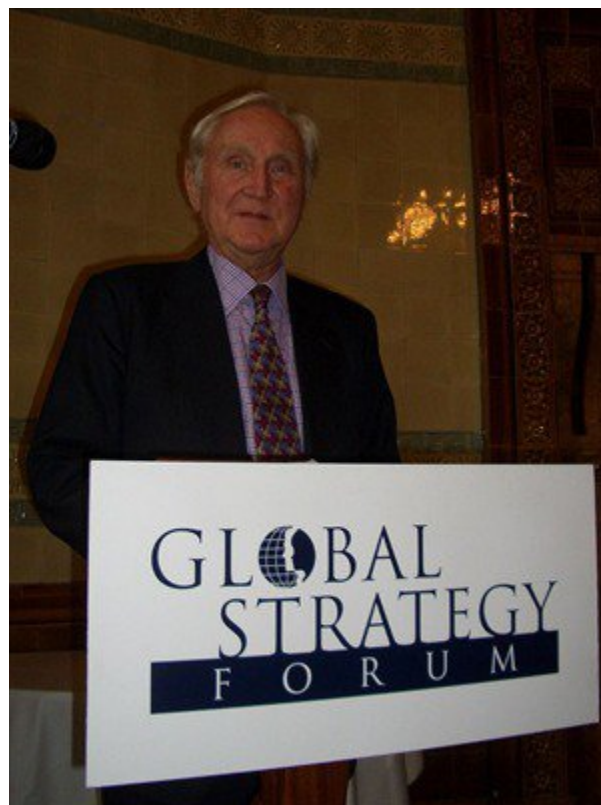

1) Sir Crispin [Tickell](#) (1930---: Pilgrims Society London as of undetermined, by 1987 at the earliest); 1969 Pilgrims roster shows that British U.N. Ambassadors are included), Knight Grand Cross of the Order of Saint Michael and Saint George; Knight Commander of

the Royal Victorian Order; fellow, Zoological Society of London, was British Ambassador to major silver producer Mexico (1981–1983) and British U.N. representative and Security Council member (1987–1990). Tickell, who could become a “ticklish” subject, was the president British official for Queen Elizabeth II’s official state visit to Mexico in 1983. Mexican presidents have made [four](#) visits to Buckingham Palace and the Royals, three visits to Mexico. This is the same woman whose image is on Canadian Silver Maple Leaf coins stamped \$5 Canadian---the Royals are apex silver price suppressors, and their financial network, The Pilgrims, runs most of the gold and silver price inhibition. He was Secretary of the Overseas Development Administration (now Department for International Development) (1984–1987).

Actually this was the same lecture, same date. I wanted to include this so you can see that members of The Pilgrims Society London sometimes have an annual meeting at the American Embassy in London---the very same plotters who want to rule over our country again as in colonial times, and the most influential Americans are in league with them as their junior partners!

Sir Crispin was President of the Royal Geographical [Society](#) from 1990 to 1993 and Warden of Green College, Oxford, between 1990 and 1997, where he appointed George Monbiot and Norman Myers as Visiting Fellows. Green College merged with Templeton College in 2008 to become Green Templeton College, located at what was previously Green College. He was President of the Marine Biological Association from 1990 to 2001.

The [MBA](#) of the UK was founded in 1884. Crown [Prince](#) Philip, Duke of Edinburgh, Pilgrims Society inner circle member, is Royal patron of the MBA. It's to be expected that the London Pilgrims would have a counterpart to Woods Hole Oceanographic Institution, controlled by the US Pilgrims; their interests include seizure of seabed mineral wealth---



From 1996 until August 2006 he was chancellor of the University of Kent when Sir Robert Worcester took over the position. We profile Worcester elsewhere in this series as he's a Pilgrims London official. Sir Crispin Tickell is currently director of the Policy Foresight Programme of the James Martin 21st Century School at the University of Oxford (formerly the Green College Centre for Environmental Policy and Understanding) and Chairman Emeritus of the Climate Institute, in Washington DC. He has many interests, including climate change, population issues, conservation of biodiversity and the early history of the Earth. The James Martin 21st Century School has [vaccines](#) as one of its interests---puncture all the small folks so they can croak sooner and get out of the elite's way!



As of October 2014, Sir Crispin Tickell was still [chairman](#) of the Climate Institute in Washington D.C. and is seen in this [video](#). He's [held](#) this post in 1990–1992 and 2012 to the present. I can't resist mentioning there's a Dr. Daniel [Wildcat](#) who's a Climate Institute trustee, apparently a Native American. It also bears notice that

three Mexicans from the national capitol are board members and a fourth is an honorary board member. I do wonder if there's a silver connection here, especially since Tickell is a former British Ambassador to Mexico.

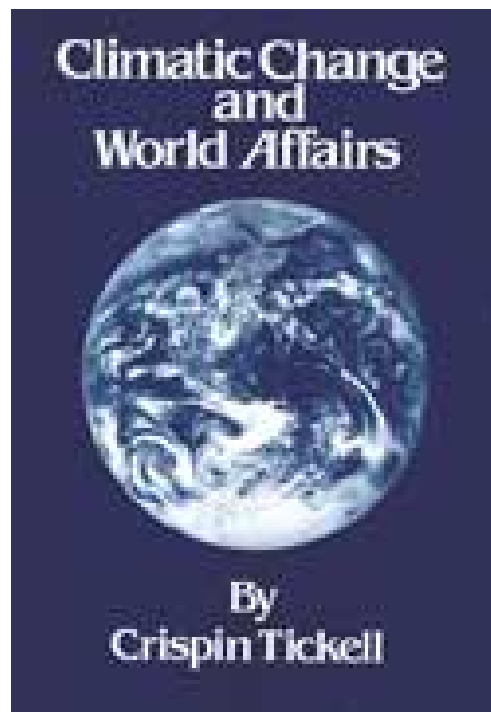

“Margaret Thatcher credits Tickell for persuading her to make a speech on global climate change to the Royal Society in September 1988 (though the speech was written by Thatcher and George Guise). He chaired John Major's Government Panel on Sustainable Development (1994–2000), and was a member of two government task forces under the Labour Party: one on Urban Regeneration, chaired by Sir Richard Rogers, now Lord Rogers (1998–99), and one on Potentially Hazardous Near–Earth Objects (2000).”

Margaret Thatcher was entertained by The Pilgrims London on January 29, 1981 and John Major on October 20, 1997 (“The Pilgrims of Great Britain,” short run book, 2002, pages 200 and

204). Are all speakers or guests at Pilgrims meetings also members? No, but they're all their subalterns. More---

"A man of strong environmental convictions, he has been described as influential in Britain, although his environmental message has not always travelled as easily abroad, particularly to the United States. His 1977 book **"Climatic Change and World Affairs"** argued that mandatory international pollution control would eventually be necessary. He is internationally respected as having a strong grasp of science policy issues. He has been the recipient, between 1990 and 2006, of 23 honorary doctorates."



"He is currently the president of the UK charity Tree Aid, which enables communities in Africa's drylands to fight poverty and become self-reliant, while improving the environment. He is also a patron of population concern charity [Population Matters](#), (formerly known as the **Optimum Population Trust**), and told Radio 4's Today

programme that the ideal population for Britain could be around 20 million. As a member of Lord Rogers' Urban Task Force, Tickell counseled against spreading cities saying that we need denser living, that young adults should not expect to leave home straight away, and that older relatives could live in “granny flats.”

Sophie [Churchill](#) chairs Tree Aid; apparently she’s a member of the famous Churchill family (Pilgrims Society). Sir Nicholas Soames (Pilgrims London 1980 is Winston’s grandson and a member of Parliament; his kid [brother](#) has 100,000 employees). [Lord](#) Carrington is a patron of Tree Aid; he’s among the most important mid-circle functionaries for the inner circle of The Society. [Founded](#) in 1987, Tickell appears to be ex of this group. Planting over 7 million trees is OK, but is this a cover for less wholesome activities?

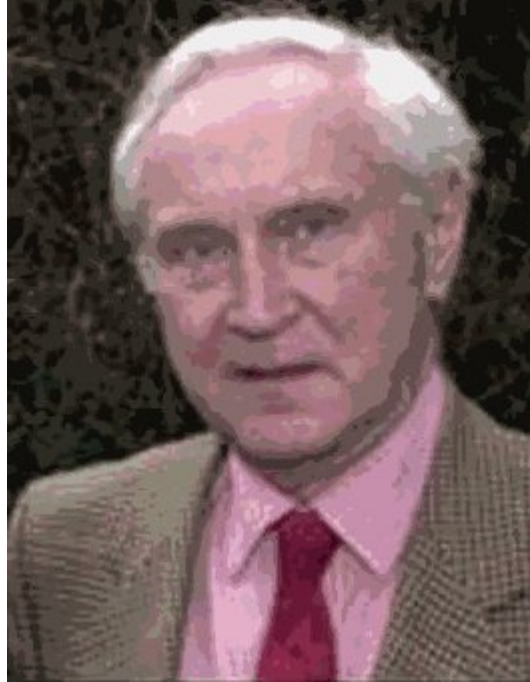

“In the past half century, Sir Crispin Tickell has alerted political leaders and the public of the potential threat posed by climate change and the need for international cooperation in responding. From his first assignment as a British diplomat in 1954 when he had responsibility for the British Antarctic Territory, he has developed an intense interest in climate related concerns. Although Sir Crispin comes from a family with a distinguished history in both science and literature, his formal training at University of Oxford was more in history and public policy. His great intellectual curiosity, however,

has driven him to develop a remarkable grasp both of climate science and of the potential challenges disruptive climate change could pose to humanity and to vital ecosystems. No one has exemplified the international nature of the climate challenge and the need to work across national boundaries more than Sir Crispin. He has been an advisor on climate change and global environmental issues to Prime Ministers of both major parties within the UK. He was the only non-US citizen to serve on a climate change task force of the US National Academy of Sciences on Policy Implications of Climate Change. Beginning in 1992 he served as a **founding member** of the China Council for International Cooperation and Development where he advised Chinese leaders on climate and related matters. He currently serves as Co-Chair of the India-EU High Level Dialogue on Climate Change.”





British Antarctica covers 666,000 square [miles](#)---more than the size of [Alaska](#) and [Oklahoma](#) combined---and is likely to contain untold mineral wealth! Furthermore, the same link states that Britain has filed a claim at the U.N. In 1965 he was appointed 2nd Secretary and later 1st Secretary to the UK Delegation to the European Community. In 1970 he was appointed 1st Secretary to the UK negotiating team for entry into the European Community. From 1973–1977 he held the post of Chef de Cabinet for Sir Christopher Soames (Vice-President of the Commission of the European Community) and from 1979–1984 was Assistant Under-Secretary of State (European Community) at the Foreign Office. From 1984–1985 Hannay held the position of Minister at the British Embassy in Washington and from 1985–1990 he held the post of Ambassador and Permanent Representative to the European Community. He

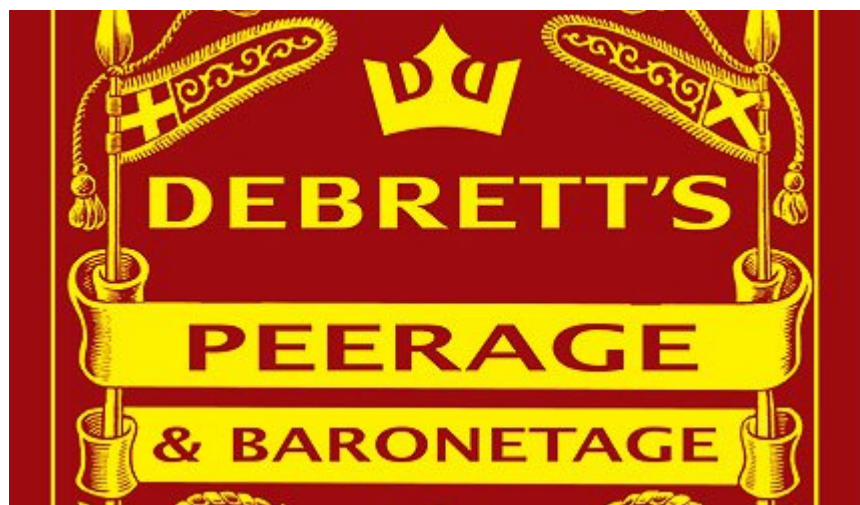

He's recognized as a [warmonger](#) concerning Iraq. He's an alumnus of the snobby Sherborne School and is [listed](#) on their "Fascinating and Famous Alumni" page. It also will be mentioned in other profiles with additional detail.

4) Sir Jeremy Quentin [Greenstock](#) (1943---; Pilgrims at least by 1998) Order of St. Michael and St. George; he was British Ambassador to the United Nations (1998–2003) and attended over 150 meetings of the Security [Council](#). From 1969 when he joined the Foreign Service till 1998 when he was posted to the U.N., Jeremy had diplomatic assignments in Washington, Paris, New York, Dubai and Saudi Arabia. He speaks [Arabic](#). Another specialty of his is on the [Balkans](#), Cyprus and Gibraltar. He headed a U.N. Security Council mission to West Africa in 2003 and in 2003 he was head of

the U.N. Security Council's Counter-Terrorism Committee. He has served as special British emissary on Iraq in 2003–2004.

Greenstock [was](#) a director (2004–2010) of the Ditchley Foundation, a sponsor of important transatlantic Pilgrims controlled conferences. From 2004 to 2010 he acted as a special advisor to British Petroleum (BP). He is chairman of Lambert Energy Advisory Limited and also chairs Gatehouse Advisory Partners. He is an advisor to International Rescue Committee UK division and to Forward Thinking, an NGO and is a director of De La Rue. Greenstock is chairman of the United Nations Association of the United Kingdom. The [International](#) Who's Who for 2004 (Europa Publications), page 648, is fairly unrevealing of Greenstock's connections.

“Lambert Energy Advisory Ltd (LEA) is one of London’s leading M&A and Strategic Advisory firms dedicated solely to advising the Global Energy sector. LEA was founded in 1999 and is headquartered in Mayfair, London. LEA also has senior representation in Kuala Lumpur, Moscow and Oslo. LEA gives strategic and M&A advice to a select group of the world’s leading NOC’s, IOC’s, Independents and Utilities on their strategic direction and subsequent M&A initiatives.”

There isn’t much [info](#) on this one but I notice a concern with oil in Iraq especially. Here he is on You Tube discussing [nuclear](#) weapons. Greenstock is currently chairman of the United Nations Association of the U.K.; he’s openly globalist, advocating the U.N. become a world government (which the British and their “Pilgrim Partners” in America intend to rule). At their [site](#) we read---

“Currently he is also Co-Chairman of the European Eminent Persons Group on the Middle East, a Member of Council at Chatham House, an Adviser to the International Rescue Committee (UK) and Special Adviser to the NGO Forward Thinking.”

I don't see a site for the European Eminent Persons Group on the Middle East, but it's mentioned [here](#) along with Greenstock. A list of its members is [here](#) and includes Sir Peter Sutherland (Pilgrims Society) whose playthings have included British Petroleum, Allied Irish Banks, Bilderberg Steering Committee, World Trade Organization, associate of David Rockefeller (Pilgrims) and more. They advocate for a separate Palestinian state with Israel receded to the 1967 borders. Not everyone like this idea; are there disputing factions inside The Pilgrims? Very likely, but never in such a way as to benefit the ordinary person. Greenstock is a council member at Chatham House (Royal Institute of International Affairs), England's equivalent to this tumor we have known as the Council on Foreign Relations---both direct Pilgrims subsidiaries as The Pilgrims constitute **"the first organization"** (Review of Reviews, May 1902, page 557).

His dealings with the International [Rescue](#) Committee (founded 1933) allow him to flag himself as a do-gooder, but what are the facts? He works for world government---not good. A 2008 [document](#) shows at that time the president of the IRC was making \$447,000 yearly and evidently these people are profiting from helping immigrants settle; and they need people to be continually displaced to facilitate this!



[Forward](#) Thinking NGO (non governmental organization) is another group focusing on the Middle East. Out of four trustees, two are members of the British House of Lords. Greenstock chairs Gatehouse Advisory [Partners](#) in London which “provides strategic advice to organizations on their changing international environment.”



Greenhouse runs this elite consultative bureau with fellow Pilgrims member Sir David Manning; his son Nick Greenstock is also there and he is “the primary [contact](#) for the Gatehouse expert network of over 500 contributors.” Connections of the Gatehouse management besides Greenstock and Manning (see their profiles in this series) include Royal Bank of Scotland; Nomura Securities; Financial Times; Fidelity European Values Investment Trust; Overseas Development Institute; Political Studies Association of the United Kingdom; Center for Strategic & International Studies; and the 500 plus unidentified persons they mention and their connections! One of the Gatehouse managers [has](#) a degree in “war studies” from King’s College in London; [another](#) one is “a member of the World Economic Forum's

Global Agenda Council on Global Institutional Governance.” Cool huh? Globalists through and through! Greenstock chairs the U.N. Association of the U.K. ---



Greenstock is a special [advisor](#) to [MTM](#) Capital Partners. They have an office in [Switzerland](#). It [invests](#) in “the efficient and safe use of resources and the reduction of environment-damaging emissions, is collaborating with the US Environmental Protection Agency to advance coal mine methane recovery and use projects in China. MTM, a subsidiary of alternative investment manager [Man](#) Group, has established the USD600m China Methane Recovery Fund, which provides direct investment to develop and implement turnkey coal mine and landfill methane recovery and use projects. MTM is working with Advanced Resources International, a US company selected by the EPA to undertake feasibility studies to evaluate potential coal mine methane capture and use projects in China.

Man, which traces its origins back to a brokerage founded in 1783, is today an alternative investment management business with some USD79.5bn in assets in funds for institutional and private investors and employs 1,800 people in 13 countries. Its subsidiary MTM Capital Partners Limited makes direct principal capital investments in sectors involved in the efficient and safe utilization of resources and the reduction of environment damaging emissions, notably the converging energy, resources, infrastructure and environmental sectors.”

Do not confuse Greenstock’s MTM with an unrelated MTM! The precious metals [dealer](#) MTM being in New City, New York, zip code 10956.



Man Group, in the billions range among [other](#) activities operates a hedge fund. During 2005 to 2013 Greenstock was a [director](#) of De La Rue, founded in [1821](#), it’s “a British security printing, papermaking and cash handling systems company. In 1855 it started printing postage stamps and in 1860 it began printing

banknotes. De La Rue sells high-security paper and printing technology for **over 150 national currencies.** Other such enterprises members of The Pilgrims have been involved with include Bowne & Company; American Bank Note Company; United States Bank Note Company; and Crane & Company, which supplies paper for Federal Reserve currency---see "[The](#) Paper Hangers," released in July 2006. De La Rue also manufacturers passports, vouchers, tax stamps, traveler's cheques, driver's licenses, bank checks and postage stamps. They print paper currency for the Bank of England (Pilgrims Society).



We [read](#)---

“De La Rue is a leading commercial banknote printer, security paper maker and provider of security products and software solutions and, as a trusted partner of governments, central banks and commercial organisations around the world, is at the forefront of the battle against the counterfeiter.

De La Rue, as the world’s largest commercial banknote printer, provides customers with a fully integrated range of sophisticated products and services which are available either individually or as a whole. This includes a leading design capability, production of innovative security components, manufacture of security paper and polymer substrates and sophisticated printing of banknotes, all contributing to trust in the integrity of currencies.

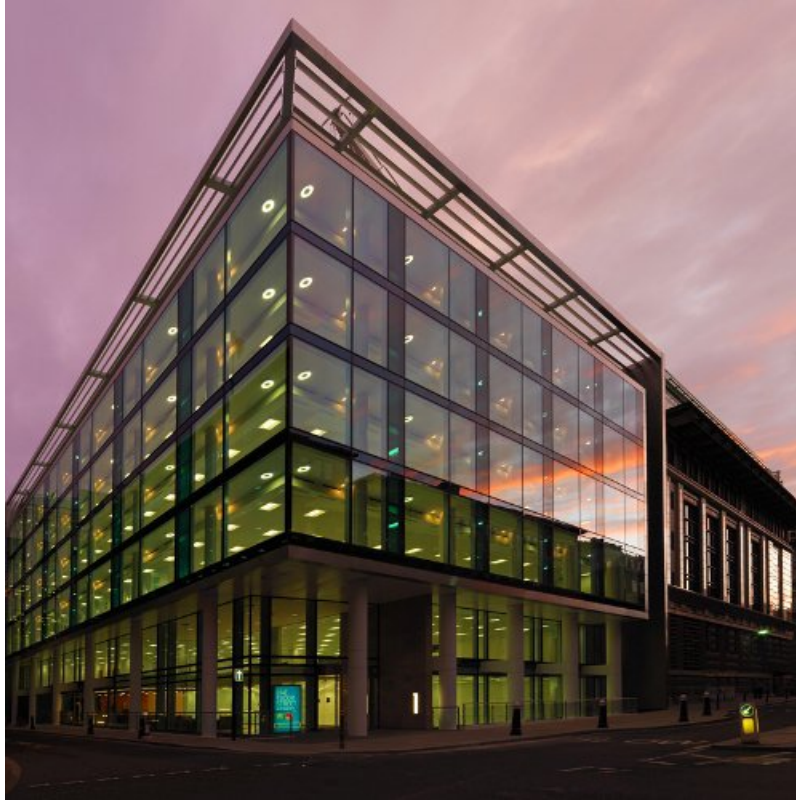
De La Rue is the world’s largest commercial passport manufacturer in an environment of increasing global concern over security at national boundaries and border control. De La Rue also produces a wide range of other security products, including tax stamps for governments who are seeking to combat illicit trade and collect excise duties. Other products include authentication labels, assuring purchasers of product validity, and government identity documents. In addition the Group manufactures high speed cash sorting and banknote inspection equipment.”

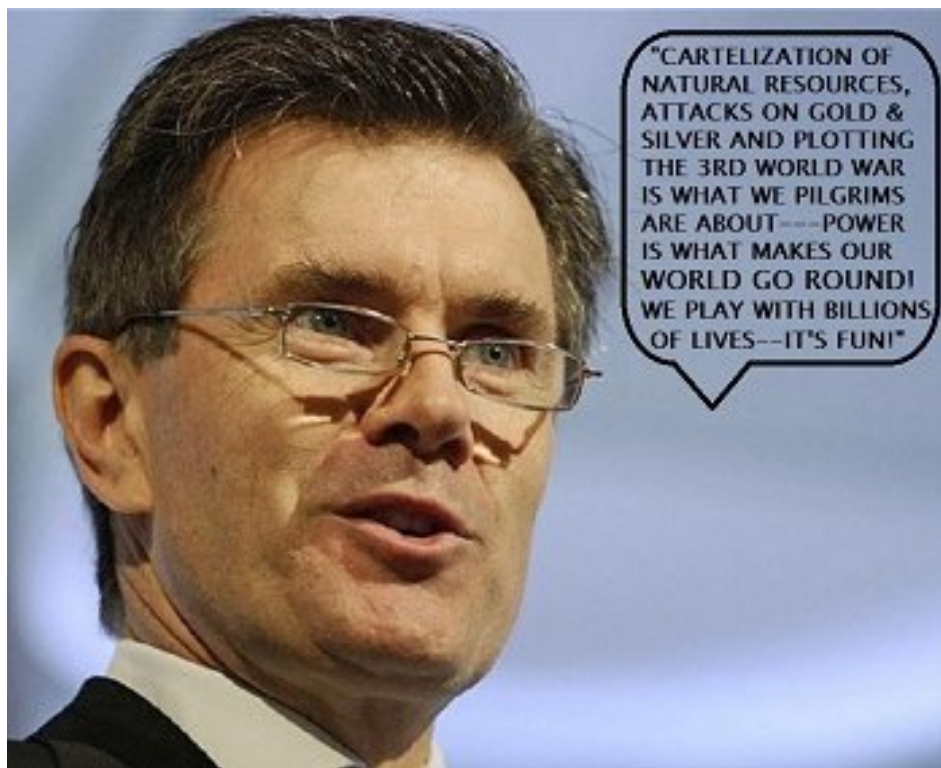
Greenstock is a former governor (2005–[2008](#)) of the London Business School, “one of the world’s [elite](#) business schools.” He [chaired](#) the European Union Political Committee in 1998. His profile seems almost brief compared to other members; this may be due to scarcity of public info on him. Many members over the years seem to not have been listed in any Who’s Who volume and barely even mentioned in any obscure newspaper accounts. Those are the members who are in the background having others pulling strings for them; or as outer circle members with lots of “homework” to do. Greenstock’s office in Gatehouse Advisory Partners is at 1 Tudor Street in London---



As to when Sir Jeremy Greenstock became a Pilgrims member; he'd have been a member by 1998 when he became British United Nations Ambassador. Sir John Thomson, who became British U.N. Ambassador in 1986, was in The Pilgrims London 1980 roster. These men therefore may be Pilgrims members before appointment in this top level diplomatic post.

5) Sir Robert John [Sawers](#) (1955---; Pilgrims at least as of 2007, when he became British Ambassador to the United Nations, a post he held into 2009) and after leaving the United Nations post, he headed the Secret Intelligence Service (MI6) till November 2014. He's a member of the Order of St. Michael and St. George, well

interlocked with The Pilgrims of Great Britain. “He is a descendant of the historic Stratford family. After retiring as Chief of the Secret Intelligence Service Sawers became Partner and Chairman of Macro Advisory Partners, who provide strategic advice and insights to investors and governments. He also became a Visiting Professor in the Department of War Studies at King’s College London. Already Knight Commander of the Order of St. Michael and St. George (KCMG), he was appointed Knight Grand Cross of the Order of St. Michael and St. George (GCMG) in the 2015 New Year Honours for services to national security.”



We additionally read---

“Sawers joined the Foreign and Commonwealth Office in 1977. In his early career, Sawers worked in Yemen and Syria on behalf of [MI6](#).

He became Political Officer in Damascus in 1982 and then returned to the Foreign & Commonwealth Office to take up the role of Desk Officer in the European Union Department in 1984 and Private Secretary to the Minister of State in 1986.”

“He was based in Pretoria and then Cape Town in South Africa from 1988 to 1991 during the first part of the transition from apartheid. He returned to the Foreign & Commonwealth Office yet again to take up the roles of Head of European Union Presidency Planning Unit in 1991. The period was dominated by war in Bosnia, crises in the Middle East, and the debate in Britain on the European Union.”

“From 1995 to 1998 he was in the United States and spent a year as an International Fellow at Harvard University and later at the British Embassy in Washington where he headed the Foreign and Defence Policy team.”



“From January 1999 to summer 2001 he was Foreign Affairs Adviser to Prime Minister Tony Blair ([Pilgrims](#)) dealing with all aspects of foreign and defence policy and working closely with international counterparts. The period included the Kosovo War. He also worked on the Northern Ireland peace process and the implementation of the Good Friday Agreement. He reviewed the Iraq sanctions policy

during this period and issued a document that included consideration of regime change.”

“He served two years in the Middle East as Ambassador to Egypt from 2001 to 2003, and for three months was the British Government's Special Representative in Baghdad assisting in the establishment of the Coalition Provisional Authority as the transitional government during the Occupation of Iraq.”

“In August 2003 Sawers was appointed Director General for Political Affairs at the Foreign and Commonwealth Office. In this post he advised the Foreign Secretary on political and security issues worldwide and negotiated on behalf of the Foreign Secretary with international partners in the [G8](#), EU and the UN. He was particularly closely involved in policy on Iran, Iraq and Afghanistan and the Balkans. Sawers headed the British team in the negotiations over Iran's nuclear program in 2006, utilizing his scientific background on nuclear matters. In 2007 he became British Permanent Representative to the United Nations. Sawers is a governor of the [Ditchley Foundation](#), which aims to promote international, especially Anglo–American, relations.”



Let's review Sawers background---“**sawing**” our way through his aspects. The [Stratford](#) family traces to the Norman conquest of England in 1066 by William the Conqueror---yet another connection back to this historic monarch, military figure, and owner of immense lands. We read---“Since their establishment the Stratfords have spawned numerous religious, cultural and political leaders, multiple Bishops, Arch-Bishops, Viscountcies, Baronies and an Earldom. Historic family seats have included Farmcote Manor and Stratford Park in Gloucester, Merevale Hall in Warwickshire, Baltinglass Castle, Belan House and Aldborough House in Ireland and Stratford House in London. They have links with numerous noble families. They were at their most powerful in the 14th and 18th centuries.”

Sir Robert John Sawers founded and is chairman of Macro Advisory Partners whose partners besides himself [include](#) people with background from J.P. Morgan & Company; Morgan Stanley & Company; British Petroleum; Oxford Analytica; White House Deputy Chief of Staff. Its Global Advisory Board [includes](#) Kofi Annan, who was United Nations Secretary General from 1997 to 2006 and who operates the (very questionable) Kofi Annan Foundation; the School of Advanced International Studies of Johns Hopkins University in Baltimore; Brookings Institution (India subsidiary---Brookings in D.C. is vehemently opposed to monetary silver); Shell Petroleum Group India; Paris France School of International Affairs; and Liaquat Ahamed, author of **"The Bankers Who Broke the World"** which won the 2010 Pulitzer Prize for History. This book is [meets](#)

expectations, as it makes no mention of The Pilgrims group! This author was with Fischer, Francis [Trees](#) & Watts, a little known but influential multi-sector investment concern in London and New York.



Macro Advisory [Partners](#) “provides corporate, investor, and sovereign advisory services. It offers political risk, risk management, government relations, strategic scenario planning, and frontier markets advisory services. The company also provides asset allocation, multilateral relations, financial regulation, diplomatic, geopolitical risk, and SWF investment advisory services. It caters to investors, **corporations, hedge and wealth funds, banks, foundations, and governments.** Macro Advisory Partners LLP is based in London.” British Broadcasting [News](#), November 1, 2009, reported “Little is known about Sir John's previous work at MI6. Sir John has top-level contacts, such as US Secretary of State Hillary Clinton. After his hands-on role in foreign affairs, he will now have to lead from the front in the struggle to stop global terrorism.” MAP won't be so forward as to state that it can tell a client when war will

break out here or there, but I figure they can and it's because a Pilgrims Society member runs this enterprise and that's the most "insider" you can get anywhere on the entire world map.

On July 5, 2009, The Daily [Mail](#) reported, "MI6 Chief Blows His Cover as Wife's Facebook Account Reveals Family Holidays" remarked---

"Sir John Sawers is due to take over as chief of the Secret Intelligence Service in November, putting him in charge of all Britain's spying operations abroad. But his wife's entries on the social networking site have exposed potentially compromising details about where they live and work, who their friends are and where they spend their holidays. Amazingly, she had put virtually no privacy protection on her account, making it visible to any of the site's 200 million users who choose to be in the open access London network regardless of where in the world they actually were. There are fears that the hugely embarrassing blunder may have compromised the safety of Sir John's family and friends. Lady Shelley Sawers' extraordinary lapse exposed the couple's friendships with senior diplomats. Immediately after The Mail on Sunday alerted the Foreign Office to the astonishing misjudgment, all trace of the material---which could potentially be useful to hostile foreign powers or terrorists, was removed from the Internet."

Aww gee, Shelley left out to mention his Pilgrims Society activities! Think how the SHTF on that! He's a governor of the British Ditchley [Foundation](#), which has correspondent foundations in Canada and America, with the American branch being the more important.

Ditchley is another festering pocket of Pilgrims Society activities! Other Pilgrims London members on the governing board of Ditchley Foundation England include Sir Robert Worcester (see him in this series of post 1980 members); Sir Crispin Tickell (former British U.N. Ambassador); Sir Nigel Sheinwald (former British Ambassador to America (see him in this series of post 1980 members); Lord Robertson (see him in this series); Sir David Manning (he's in this series); Sir Jeremy Greenstock (former Ambassador to the U.N.); Lord Carrington and others I can't presently ID. The American Ditchley [Foundation](#) has Pilgrims including Philip Lader and Sarwar Kashmeri; and several others who cannot presently be identified. This guy hardly looks like an inner circle member but a very important underling to them.

6) Sir Mark Lyall Grant (1956---; Pilgrims Society as of [undetermined](#); most likely by his appointment as British United Nations Ambassador) which term was 2009 to 2015 during which period he was president of the Security Council on four occasions. He's a member of the [Middle](#) Temple in London and joined the British Foreign Office in 1980. During 2003 to 2006 he was British high commissioner in Pakistan. Before that he was stationed in various places including South Africa and Paris. He's a Knight Commander of the Order of Saint Michael and Saint George and is a career diplomat. His wife, Lady Sheila Lyall Grant, is [active](#) in something called Women of the World, probably another globalist front. With available info at the last link, it seems to be focused on Syria. Grant is recently departed from his United Nations post. He'll likely be endowed with a spate of connections and placed on a series of company and nonprofit category organization boards, same as his forerunners in that high post. His info on page 540 of the Who's Who in the East for 2014 doesn't show who his parents were/are, nor his wife's maiden name.

7) [Matthew](#) Rycroft (1968---; Pilgrims Society as of very recently in 2015 at the latest) is the new British Ambassador to the United Nations as of April 2015 and is a Commander of the British Empire. He joined the British Foreign Office in 1989. After being stationed at Geneva, NATO headquarters and Paris, he was at the British Embassy in Washington from 1998 to 2002. In 2002 he became private secretary to Prime Minister Tony Blair (Pilgrims; great pals with President Bush II, Pilgrims). During 2005 to 2008 Rycroft was U.K. Ambassador to Bosnia–Herzegovina. During 1990–1991

Rycroft was in the Security Policy Department of the British Foreign & Commonwealth Office (FCO). In several years when his term at the U.N. is up, we may anticipate The Pilgrims in London will have all manner of strings to present him with for pulling---corporate and banking boards, and alleged nonprofit groups. On April 28, 2014, the British Council [announced](#) Rycroft's appointment as a trustee of their organization which states---

"The British Council creates international opportunities for the people of the UK and other countries, and builds trust between them worldwide. We call this work cultural relations. We work in over 100 countries, connecting millions of people with the United Kingdom through programmes and services in the [English](#) language, the arts, [education](#) and society. We believe these are the most effective means of engaging with others, and we have been doing this work since 1934. Our work in English aims to bring high quality language materials to every learner and [teacher](#) who wants them. In developing and post-conflict countries we teach English and train teachers through radio, web and TV broadcasts. We offer over three million UK examinations worldwide, helping people gain access to trusted qualifications to support their career and study prospects. Our work in education and society helps transform national education systems."

Apparently this is similar to the English Speaking Union in that they both have the objective of English as the world language in their hoped for World Government.

To cap off this discussion of British Ambassadors to the United Nations, a glance back to The Pilgrims 1957 roster gives more perspective---some names change, policy remains. Dixon, with obvious Dutch ancestry (Pierson) was the British diplomat at the UN, 1954–1960 and his son became a Pilgrims member and a member of Parliament. They're [linked](#) by marriage to the Churchills (Pilgrims). Next we notice members of the Dodge family, of the Phelps–Dodge polymetallic copper mining family, greatly enriched by Arizona mineral deposits. Marcellus is said to have inherited a \$60 million [fortune](#) in 1902, but that was only the publicly visible part. “Dodge was also the grandson and successor to Marcellus Hartley, his maternal grandfather, a famous merchant and financier of Manhattan. In 1907, Dodge became engaged and married to

Geraldine **Rockefeller**. Dodge became the chairman of **Remington Arms Company**, taking the place of his maternal grandfather.

Following the business tradition established by his grandfather at the time of the American Civil War, his company was the supplier of **sixty-nine percent of the arms, ammunition, and munitions being used by the federal government during the Second World War.**

Secret meetings about this were held on his country estate, He was a member of the board of trustees of Columbia University. General Dwight D. Eisenhower and he became close friends.” Finally we see a member in the old Dutch colonial Bayard line with vast land grants tracing back to the 17th century, married into the Dominicks (Wall Streeters and investment bankers). These centuries old land holdings eventually became of **scandalously enormous value**, but always out of public view. The Dominick investment banking operations also had input from [both](#) the Dodges and the Rockefellers. The Dodges additionally held [interests](#) in the National City Bank and the El Paso & Southwestern Railroad. Now I [discover](#) the Dodges and Bayards are linked by marriage.

8) William Jacobus Vanden Heuvel (1930---; Pilgrims Society as of---uncertain---probably at least by early to mid 1980s) was United States [Ambassador](#) to the United Nations offices in Geneva and New York (1977–1981). We include him as he fits in with these profiles. In 1962 he was assistant Attorney General and in 1965 he joined Stroock, Stroock & Lavan law firm. However, his first law firm membership was in 1952 with Donovan, Leisure, Newton & Irvine, an important Pilgrims Society firm. George Stanley Leisure was in The Pilgrims 1969 and 1974 lists; Peter K. Leisure appeared in 1980. He's son in law of the founder of Music Corporation of America founded in 1924 ([MCA](#))!

“One hundred and ten years ago, on the eve of his coronation, Edward VII had appendicitis. The coronation was postponed for six weeks. In those days, ocean travel was the only transportation link between Great Britain and its former colony. Many Americans were in London for the coronation—an event that they had never seen since Queen Victoria’s reign had lasted 64 years—so during this unplanned interval, they had lunches, and dinners, on the very eve of the Royal event, a hundred Englishmen and Americans who saw in the greater alliance of their two countries the possibilities of a better world, forged the structure of the Pilgrims Society, an organization to exist separately in London and New York with the mutual purpose of “promoting brotherhood among nations especially the United States and the British Empire.” In its illustrious history, Presidents, Prime Ministers and Reigning Sovereigns have praised the Pilgrims Society’s role as an advocate of the Special Relationship between Britain and America. At college, I was a participant in the debate between American universities and Oxford. We were given two topics to discuss. One was---Columbus Went Too Far. We chose the alternative which was---Resolved, **The World Would Be Better Off Had Not The Thirteen Colonies Broken Away From the British Empire**---an honest subject worthy of discussion.

The Pilgrims Society will certainly continue as a principal advocate of the Special Relationship.”

His remarks were made at the Union League Club of New York on May 1, 2012 (“Mayday,” an old revolutionary symbol from 1848!)

Here’s Vanden Heuvel with Happy Rockefeller, widow of Pilgrims Society member Nelson Rockefeller, the “almost” President---

At <http://www.hesterheitel.com/images/> we notice a January 2009 document showing William Vanden Heuvel with AIG Private Client Group. AIG at one time was named by Ted Butler as the leading silver [short](#) on the COMEX (torch passed along as of 2004) and a leader of silver leasing out of China. He’s a Cornell University graduate, where he became a member of The Telluride Association,

named for Telluride, Colorado. It's said the name comes from "to hell you ride," a reference to the steep mountain slopes surrounding much of that city. It's long been a significant mining area including gold and silver.

At <http://www.saintnicholassociety.org/> a Dutch related hereditary group with significant Pilgrims Society interlock, we find Vanden Heuvel speaking of Franklin Roosevelt in glowing terms (he stole gold and silver from Americans; imposed rent controls that bankrupted tens of thousands of small landlords; moved America closer towards Fascism-Socialism; and arranged to have Pearl Harbor on "off alert" status to get excuse to bring us into World War Two with our "Pilgrim Partners" in London.) The link also states that Vanden Heuvel is "long a prominent figure in New York City politics."

I'm not finding Vanden Heuvel in Who's Who; but page 1437 of the 2014 Who's Who in the East shows his radical, globalist daughter---

VANDEN HEUVEL, KATRINA, publishing executive, editor; b. NYC, Oct. 7, 1959; d. William Jacobus and Jean Babette (Stein) Vanden H.; m. Stephen F. Cohen, Dec. 4, 1988; 1 child, Nicola Anna. BA summa cum laude in Politics, Princeton U., 1982. Prodn. assoc. ABC Closeup Documentaries, 1982-83; asst. editor The Nation, NYC, 1984-89, editor-at-large, 1989-93, acting editor-in-chief, 1994-95, editor-in-chief, 1995—, and pub., gen. ptr., 2005—. 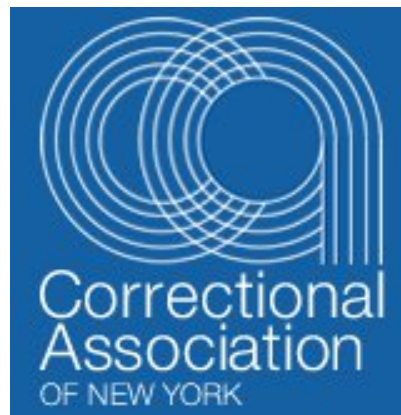

Left out of his info is his [attendance](#) at the Hill School in Pennsylvania, a college prep academy for [elitists](#) and typically overweighted with Episcopalians.



After Princeton University and the University of Texas he started with [Andrews](#) Kurth, a law firm founded in 1902 and still in business in energy, maritime affairs and offshore drilling, life sciences, construction, banking, health care, museums and more. This was/is a significant regional law firm. Notice that he was with it from 1957 into 1981, yet during 1975–1976 he was undersecretary of Commerce in D.C.; he was active with President Ford (Pilgrims) in 1976 and was campaign chairman in 1979–1980 for George Bush Senior (Pilgrims). During 1980 to 1981 Baker was active with both Reagan and Bush Senior and during 1981 (his last year with Andrews Kurth law firm) he became White House Chief of Staff until 1985 in the Reagan White House. Sometime in that period (IMO) Baker became a Pilgrims member, having been on the waiting list for several years. Also IMO The Pilgrims inner circle had its plans

One of Baker III's top three government posts was that of White House Chief of Staff (1992–1993) in the administration of Bush the First. Finally in 1993 Baker III returned to Houston and resumed law practice as senior partner at Baker & Botts. This law firm actually traces back to [1840](#) and today has around 725 attorneys. James Addison [Baker](#) (1821–1897) was the great, great grandfather of James Addison Baker III. It was this man who added his name to

what is today known as Baker & Botts. Walter B. Botts was a Confederate Army colonel from Virginia. The law firm is closely connected to Rice University in Houston, founded on the fortune left by slave owner William M. [Rice](#) (1816–1900) who was in cotton, land, railroads, lumber and other ventures. The reason Baker started with Andrews Kurth LLP was to avoid accusations of nepotism. Baker Botts has other [offices](#) in Austin; Dallas; Palo Alto California; Washington and New York. International locations include London; Brussels Belgium; Dubai; Kuwait City; Riyadh Saudi Arabia; Hong Kong; Beijing; Moscow and Rio De Janeiro Brazil. Its ties to the energy business are reflected in its home address of One Shell Plaza. 78 of the [Fortune](#) 100 corporations are clients of Baker Botts! It's therefore mainly a corporate law firm but is big in other areas.

Notice that in 1993 (see scan) when Baker exited the White House he became simultaneously a senior partner in Baker Botts but also a senior counselor to the Carlyle Group in D.C. and his info shows offices in D.C. and Houston. Baker made a triple grand slam in 1993 as also in that epic year in his activities he became honorary chairman of the James A. Baker III Institute of Public Policy at Rice

“[Founded](#) in 1993, the James A. Baker III Institute for Public Policy has established itself as one of the premier nonpartisan public

policy think tanks in the country. The institute ranks 9th among university-affiliated think tanks worldwide, 18th among U.S. think tanks and fourth among energy resource think tanks.”

Baker Institute also has a Center for Health and Biosciences. It definitely is a vaccine pushing [fanatic](#). Baker Institute has other divisions on Space Policy, Science and Technology, Energy, International Economics, Latin America, China Studies, Religion and Public Policy and more. 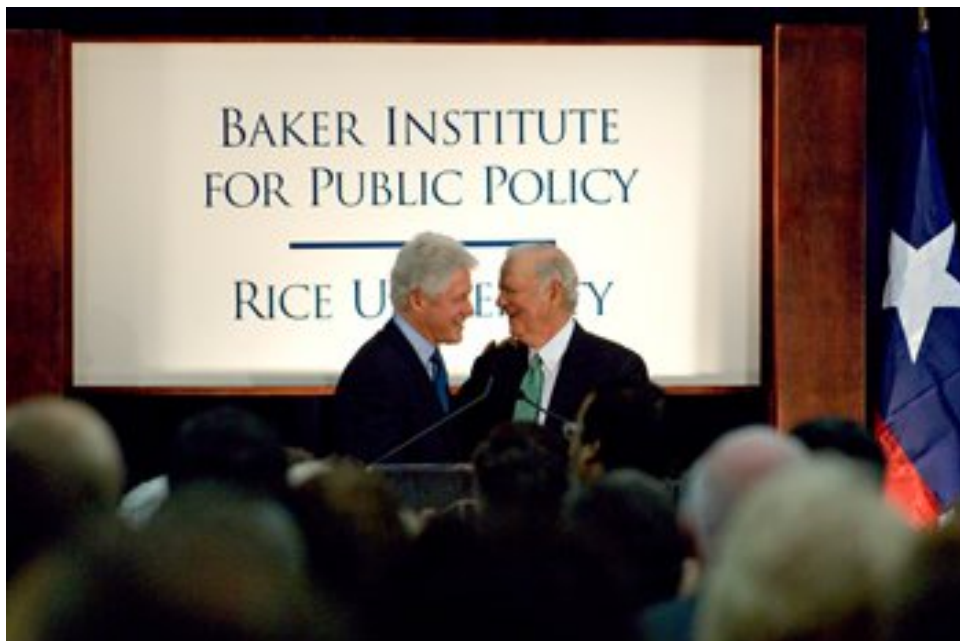

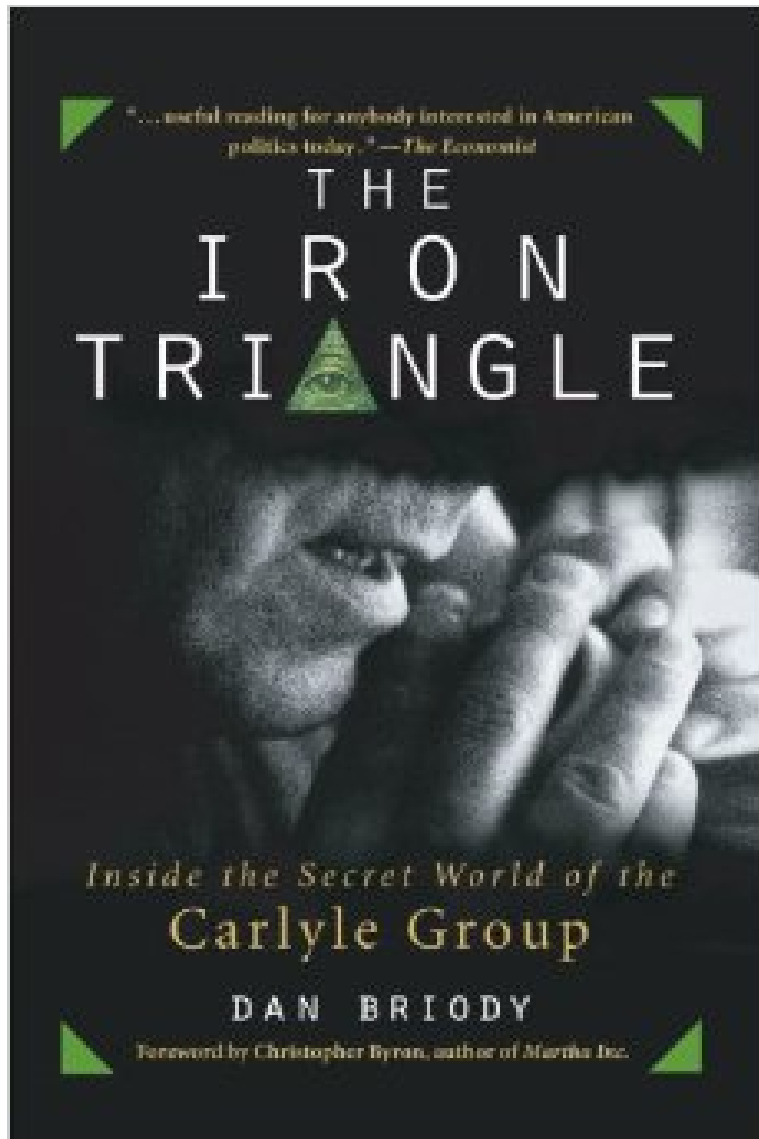
Baker became involved as top legal counsel with the Carlyle Group around six years after its founding in 1987. 2014 info [shows](#) that it

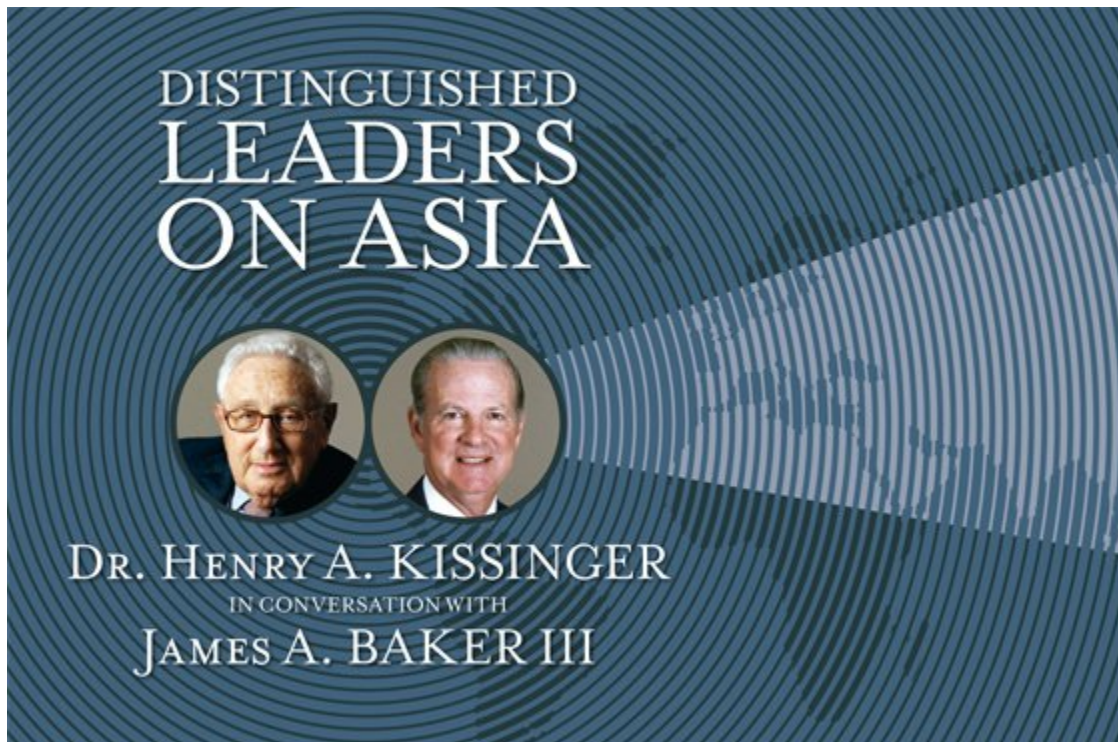
Surprise, surprise---Carlyle was [founded](#) with original capital from the fabled Mellon family---an inner circle Pilgrims Society dynasty. George Bush Senior and James Baker III are the two most famous government figures connected to Carlyle. Baker is just as much a globalist as Henry Kissinger. Both are Pilgrims Society members, with Kissinger having been there most of ten years earlier. It was lead adviser to a consortium of oil companies that wrapped up a \$3.5 billion finance package in February for one of the world's biggest energy projects, the Baku–Tbilisi–Ceyhan pipeline. Critical support for the pipeline came from two U.S. government-backed agencies, the Export Import Bank and the Overseas Private Investment Corporation. The pipeline, which will carry one million barrels of oil a day from the Caspian to the Mediterranean, faced fierce opposition from environmental groups. But Baker Botts and the oil companies prevailed. Baker Botts lawyers wrote all the

regulations governing the pipeline, overriding domestic laws, including the environmental policies of the nations of Azerbaijan, Georgia and Turkey. Baker Botts represents Exxon Mobil, ConocoPhillips and Occidental, all of which have major business interests in the Persian Gulf. Nor was it considered a conflict for Baker to be a partner in Carlyle. Baker has played a key role in six of the last seven presidential elections, including all four of the races in which a man named Bush has been a candidate.”



On October 17, 2003, silver stealer Dick Cheney was in [attendance](#) at the James Baker Institute for Public Policy at Rice University in Houston. Cheney, probably a Pilgrims Society member, was one of the top two bureaucrats in the Nixon era Cost of Living Council who capped domestic silver at \$1.61 the ounce! 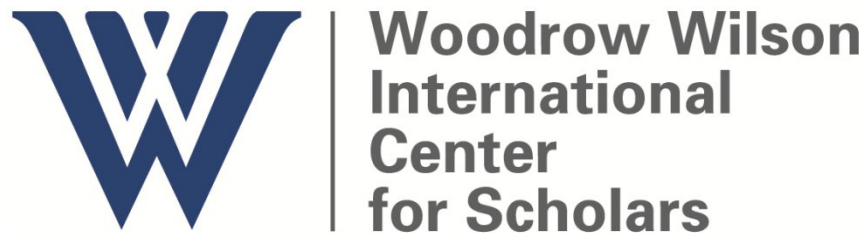

During 1996 to 2003, Baker was a director of Electronic Data Systems Corporation. EDS was founded in 1962 by eventual Texas billionaire H. Ross Perot Senior and merged into Hewlett Packard in 2009. Joseph Medill Patterson Albright is a possible relation of Archie Earl Albright Jr. (Pilgrims 1974, 1980 and other years) who was an important associate of the Drexel family (Pilgrims Society; the Firestone family (Pilgrims Society); the Loeb family (Pilgrims Society) and the Schiff family (Pilgrims Society)---1978-1979 Who's Who in America, page 33. Archie was a director of defense contracting giant Grumman Corporation, Michigan Gas Utilities and other companies.

J.M.P. [Albright](#) is "the scion of a media empire, the grandson and namesake of Joseph Medill Patterson, founder of the New York Daily News. His great-great grandfather, [Joseph Medill](#), owned the Chicago Tribune and had been elected mayor of Chicago. His aunt, Alicia Patterson, founded Newsday." J.M.P. Albright graduated from Williams College in Massachusetts, where he may have become a member of the Gargoyle Society ([founded](#) 1895). J.M.P. was a legislative assistant in 1971-1972 to Maine Senator Edmund Sixtus Muskie, who was Secretary of State (1980-1981). Madeleine Korbel Albright was in Muskie's organization also, 1975-1978. Muskie voted [for](#) the Coinage Act of 1965, removing most silver from our money system! Maine is a silversmith friendly state meaning--- hostile about silver miners getting fair prices! J.M.P. left Madeleine for another woman after they had three children, and a divorce was registered in 1982. How much wealth did Madeleine wrest away from J.M.P.? In his genealogical [tree](#) appear several members of the Chicago McCormick family (real estate, International Harvester

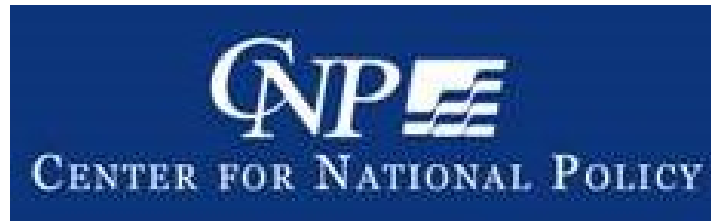


From 1982 to 1993 Albright was with the Foreign Service School at Georgetown University. A look at its current Board of Visitors shows men from Barclays, Lazard Brothers, Bank America and so forth--- more of the same globalists.

Then from 1985 to 1993 Albright was president of the Center for [National](#) Policy at 1250 I Street Northwest in D.C. This is another globalist rat nest! Maurice Templesman, owner of Lazare Kaplan Diamonds, is there and is a CFR member with other connections such as Woods Hole Oceanographic Institution; his interest there is undoubtedly motivated by recovery of diamonds on the sea floor that have washed out of river deltas. Another director is [linked](#) to Citigroup and Sabin Vaccine Institute (giant poisonous mosquito bites in reverse!) Others represent the Episcopal Diocese of Connecticut, Bretton Woods Committee; Hunter Biden, son of the corrupt Vice President Biden is there; Hunter was appointed by President Bush II to Amtrak! These people appear no higher than CFR level, except possibly Templesman.



In 1984 Albright became a national rabble rouser for the Mondale–Ferraro White House bid. Mondale was a CFR member and Ferraro was Hillary Clinton before Hillary herself showed up! On the rebound from that sickening fiasco, Albright became vice–chair of the National Democratic [Institute](#) for International Affairs, (though they call themselves nonpartisan) which is another way of saying the national Democrat Party leadership want to drag America into a world government (same as the Republicans). Having done a good job there, Albright was elevated to be head of this parasitical group (founded 1983), after her “service” as U.S. representative to the United Nations (1993–1997) and finally Secretary of State (1997 to 2001), and would have been admitted into The Pilgrims by 1997 at the latest due to the “honorary” membership for the Secretary of State. Not that Albright's term as representative to the U.N. isn't noteworthy, it's just that her term as Secretary of State is more so! One of our top financiers, George Soros, who I completely anticipate would be on an updated Pilgrims roster except the Secret Society is the last major globalist group to refuse to release rosters, made a "run" at the currency of the country of Malaysia, causing millions to suffer financial dislocation there. The Chicago [Tribune](#), July 29, 1997, stated---

"The prime minister and his minions denounced U.S. human rights policies, blamed American financier George Soros for recent currency problems in Thailand and Malaysia and repeatedly implied that the U.S. is an unreliable ally. On Monday Albright fired back. She defended U.S. policies, praised Soros and belittled Mahatier. The next day he repeated an allegation, widely reported in the Malaysian press, that Soros, the Hungarian-born billionaire currency trader, has conspired to drive down the value of Thailand's and Malaysia's currencies as punishment for ASEAN's decision to admit

Burma. Soros concedes that he opposes the admission of Burma's repressive military regime into ASEAN, but he denies exacting revenge through the financial markets.

Thailand's currency has dropped precipitously in the last month, forcing Thailand to follow the Philippines in seeking an emergency loan from the International Monetary Fund. Malaysia's currency has also dropped recently, but by a smaller margin. Malaysia's foreign minister, Abdullah Badawi, intensified the attacks against the U.S. on Monday at a ministerial meeting where he alleged that ASEAN countries are "bedeviled" by the "unholy actions" of currency traders. U.S. Undersecretary of State Stuart Eizenstat delivered what aides said was an impromptu rebuttal. "Blaming these events on speculators is not supported by the evidence," he said."

Naturally our high officials protected one of our top financiers--- lying and covering up for his evil deeds! The New York [Times](#), July 29, 1997, "Malaysia's Conspiracy Theory Draws Criticism From Albright" showed bias at the start. Any time something is labeled a conspiracy theory, the implication is that merely by use of this epithet, all facts to the contrary are supposed to be immediately dissolved. That is an enormously damaging social dogma which regrettably has become stylish and fashionable to parrot. If you discount all allegations of collusive wrongdoing, especially by powerful people, this is supposed to automatically show you are sophisticated, of top intelligence, and part of the "in" crowd.

Speaking for the nine-member association, Mr. Abdullah said: "It is indeed troubling that the Asean economies continue to be bedeviled by currency fluctuations caused by hostile elements bent on such unholy actions," which he called "villainous acts of sabotage" and **"the height of international criminality."** Manila went to the International Monetary Fund for a stabilization loan 10 days ago, while Bangkok, its currency still slipping, finally announced today that it would seek similar help. Asean links Brunei, Myanmar, Indonesia, Malaysia, the Philippines, Singapore, Thailand, Vietnam and Laos. Given that 450 million people are represented and that Asean is now America's fourth-largest trading partner, its economies are crucial to the United States. Washington **"cannot remain indifferent to weird allegations that a respected American citizen is carrying out some financial conspiracy,"** a senior American official said. "This kind of stuff gets picked up around the world, and we had to answer it."

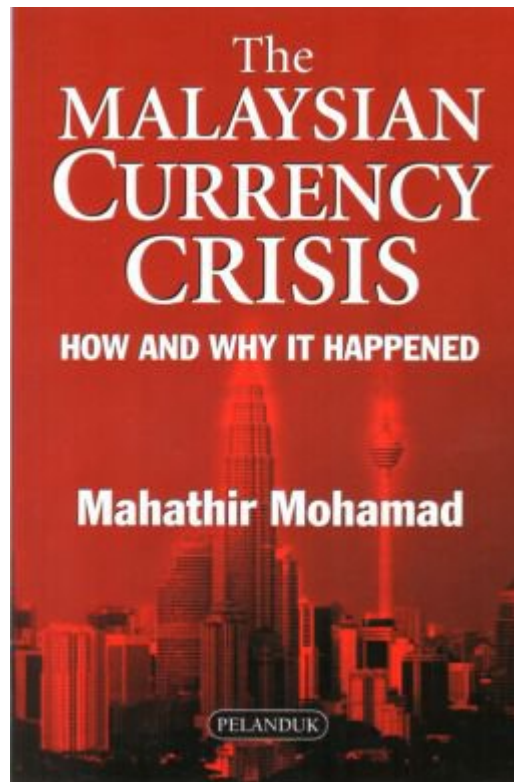

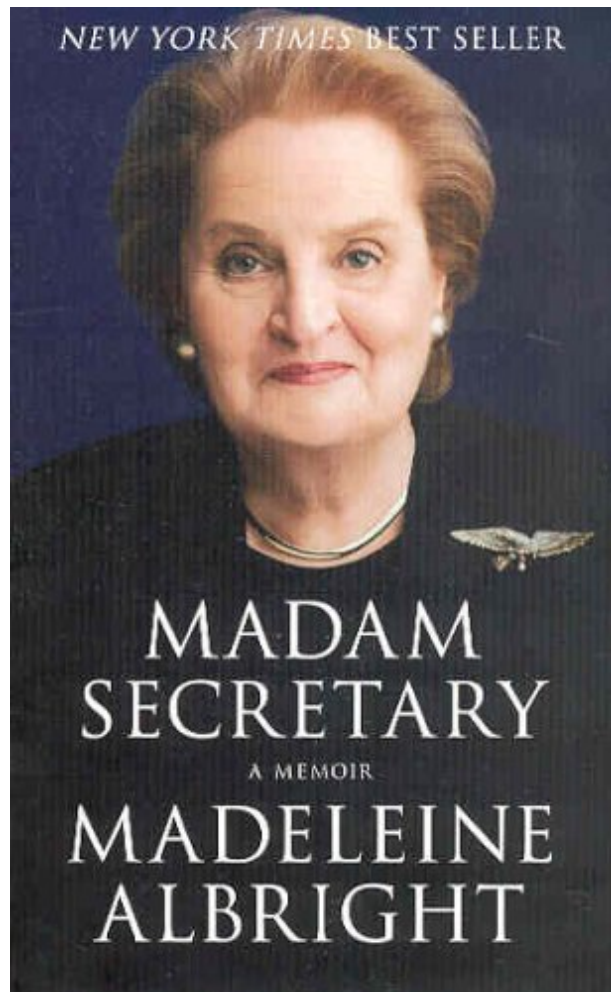


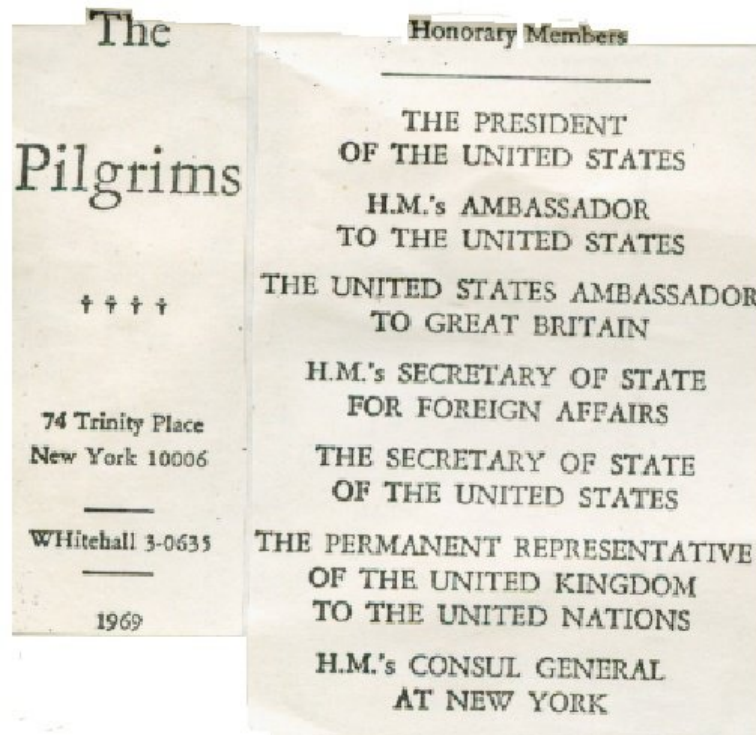

Albright is an emeritus [director](#) of the Council on Foreign Relations of which Soros and son Jonathan are [members](#). Jonathan is a senior fellow at the [Roosevelt](#) Institute of which Pilgrims members William J. Vanden Heuvel and Mrs. Franklin D. Roosevelt Jr. are [directors](#). Thomas Leffingwell Pulling (Citigroup and Pilgrims executive committee as of 1998) is there, as is a member of the Morgenthau

family, of FDR's Treasury Secretary who stole gold and silver from the public, March 1933 through February 1937.

[Reuters](#) on March 8, 2011, released news that Soros and Albright were investing \$250 million in APR Energy--- “Based in Jacksonville, Florida, APR has existing or new power service contracts in Ecuador, Peru, Argentina, Botswana, Burkina Faso, Costa Rica and Haiti, among others. The company primarily supplies government utilities in developing nations with interim solutions from six months to three years while the utilities look to install lasting power solutions. APR is also targeting mining, oil and gas industries for future business.”

Albright and Soros are connected to the [Rothschilds](#) in a \$350 million venture called [Helios](#) Towers Africa (cell phone towers). Albright very likely got north of \$20 million from her first marriage but through the consulting firm she set up after leaving the State Department, Albright Stonebridge Group has attracted much more investment funds, (\$379 million during 2006–2007). ASG says the world is “increasingly [interconnected](#)” (globalism). Founded in 2009, naturally it's in the District of Columbia---



“The Albright Stonebridge Group is a global strategy and business advisory firm led by former U.S. Secretary of State in the Clinton administration Madeleine Albright, former National Security Advisor Samuel Berger, and former Commerce Secretary and Kellogg Company CEO Carlos Gutierrez. The firm is headquartered in Washington, D.C., with offices or staff in Beijing, Shanghai, São Paulo, New Delhi, Madrid, Berlin, Sydney, Thailand, and Moscow. The Albright Group LLC and Stonebridge International, each founded in 2001, merged in 2009. Albright Stonebridge Group has worked in **more than 100 countries** on six continents. The company advises multinational firms, financial institutions, and non-profit organizations on corporate strategy, market-entry and regulatory approaches, government relations, investment assistance, and dispute resolution. Many executives at the firm served in senior government roles including, at the White House; Departments of State, Treasury and Commerce; Office of the U.S. Trade Representative; in the U.S. Congress; as Ambassadors from and to the United States; and at the World Bank Group. Albright Stonebridge Group is affiliated with Albright Capital Management, an emerging markets investment firm founded in 2005. Albright Stonebridge Group is a significant shareholder of Albright Capital Management.”

Albright is associated with the William Davidson Institute at the University of Michigan School of Business. The [Institute](#) sponsors “Global Impact Summer Internships,” everything Albright is into is

marinated in globalism. World trade, travel, tourism, diplomacy--- all those can be had outside a globalist notion of the nations surrendering their separate identities!



During 1968–1976 Albright was a director of the Beauvoir School in D.C., an **Episcopalian** [school](#) for children through the third grade. It's part of the larger National Cathedral School, founded in 1900 by a member of the Satterlee family, whose daughter married into the Rhineland family. Both families are Pilgrims Society represented---the Rhinelanders as huge New York State landowners from Dutch colonial times and the Satterlees, one of whom became son in law of J.P. Morgan Senior. From 1978–1983 Albright chaired Beauvoir School. For around 20 years Albright was a trustee of the Black Student [Fund](#), concerned with the D.C. area. Inasmuch as she covered for Soros harming the finances of millions of people in several southeast Asian nations, why would she have any bona fide concern for Black students? I suggest another sham activity. She spent around ten years total being a trustee of Williams College (founded 1793) and later Wellesley College (founded 1870).



In 1975–1976 she was on the executive committee of D.C. Citizens for Better Public Education. What was that about---increasing globalist bias in classrooms? During 1982–1984 Albright was a director of Washington [Urban](#) League which is more elitists misleading the [small](#) folks. Chatham House Federation is an English [school](#) for [children](#) of globalists over in the [U.K.](#) It may be directly related to Chatham House, site of the Royal Institute for International Affairs, England's counterpart to our CFR. Albright received the John Heinz [Award](#) in 2001, named for the food processing family who made billions in that industry, and landed a

member in the U.S. Senate, Senator John Heinz from Pennsylvania. Howard Heinz and Henry J. Heinz II were both members of The Pilgrims Society, with Heinz II on the Bilderberg Steering Committee. The Senator died in an aviation accident in 1991, and his widow later married John Kerry; their combined net worth stands north of \$1 billion, mostly from her inheritance from the food processing and agribusiness colossus. Also in 2001 Albright received the award for distinguished service to education from the National [Association](#) of Elementary School Principals. In 2012 Obama tossed the Presidential Medal of Freedom at Albright. She was one of the 50 U.S. political figures who in 2010 earned the most income. There's this pattern here and in England of Pilgrims members after leaving high government posts, setting up consultancies and raking in big money. **You have to figure that while Secretary of State Albright did the right favors for the right people**, who afterwards showered her consultancy with business, and/or directed business her way!





What does Albright get for being a member of the American Political Science [Association](#)? More business for the Albright Stonebridge Group?



The APSA is composed largely of university professors influencing students for globalism. Founded in 1903, by 1907–1908 its president was [Viscount](#) Bryce (Pilgrims Society) who arrived as British Ambassador to America (1907–1913) and in 1913–1914

Pilgrims member John Bassett [Moore](#) was APSA president and became the first American to take a seat on the World Court. You can't expect Albright to be in anything that isn't rotten to the core. As of 2014 she identifies herself as a director of the [Atlantic Council](#) of the U.S., an obvious Pilgrims Society front wanting America to become a political subdivision of the United Kingdom!



This warmongering group's motto is
"Working together to secure the future."

Founded in D.C. in [1961](#), the Atlantic Council bills itself as "an international affairs think tank." We also read, "The Atlantic Council creates **a meeting place for heads of state, military leaders, and international leaders from both sides of the Atlantic.**" Dean Acheson (Pilgrims Society) and a chief architect of the North Atlantic Treaty Organization, was the driving force [behind](#) the Atlantic Council. Since then a procession of identifiable members of The Pilgrims have been president of the Atlantic Council---General Lauris Norstad; Federal Reserve figure Randolph Burgess; Union Carbide (Silver Users Association) exec Kenneth Rush; and newspaper heir Henry Catto. This 2010 presentation, "The Insidious

Role of the Atlantic Council” is quite good however; no mention of The Pilgrims.

Having come from Prague, Czechoslovakia, Albright is a member of the American Association for the Advancement of Slavic Studies (Eastern European studies) founded in [1961](#); another group for globalist scholars. She may as well have come from neighboring Hungary as she’s become a philosophical Elizabeth Bathory (1560–1614), the Hungarian countess who [massacred](#) 600 + young women to bathe in their blood. This is not a harsh assessment, as this woman is a committed warmonger!

11) Colin Luther Powell ([1937](#)---; Pilgrims Society as of undetermined; at the latest by January 20, 2001, when he became Secretary of State, a post he held until January 26, 2005) was chairman of the Joint Chiefs of Staff from October 1, 1989 to September 30, 1993. He was national security adviser to the President, November 23, 1987 to January 20, 1989. He was a career Army officer who became a Colonel in 1976 and General by 1979. He holds military related decorations from South Vietnam; Albania; honorary Knight Commander, Order of the Bath (England); France; Canada; and Bulgaria. He holds 17 United States military decorations. In 1995, Colin Powell was awarded the [Enron Prize](#) for Distinguished Public Service by the James Baker Institute of Public Policy at Rice University. Not only did Enron go bankrupt and ruin regiments of innocent investors, its disgraced chairman, Kenneth

Lay, died in [summer](#) 2006 and unjustly, that was cited as a reason for his malfeasance convictions to be vacated as to criminality! He was also a Trilateral Commission member; his disgrace was no impairment for the TC to proceed with its own disgraces. The 2005 Who's Who in America, page 3729 shows this on Powell---

Powell entered an Army career and during 1983 to 1986 he was a military assistant to the Secretary of Defense, who was Caspar Weinberger (an Episcopalian by the way who was once an official for the state of California). Caspar was a Pilgrims Society member who was also a silver stealer and a silver squelcher as during his watch the former silver stockpile for defense was raided for 24,435,000 ounces for price suppression. Powell led the forces that repulsed Iraq's invasion of Kuwait in 1991. In 2008 Powell announced his [endorsement](#) of Obama.

Kissinger, a top agent of the Rockefeller faction in The Pilgrims Society's inner circle, found Powell acceptable. As of October 1977

The Pilgrims first Black member was admitted (Clifton Wharton a New York State educational official); since then a few others such as Colin Powell and Condoleezza Rice have followed ("The Pilgrims of the United States," short run book, 2003, page 29). Powell also joined Kleiner Perkins Caufield & Byers, a Silicon Valley venture capital firm, as a "strategic limited partner." Most recently he joined the board of directors at Steve Case's new company, Revolution Health, a health-related portal site and social network that provides online tools to help people better manage their health.”

Giuliani is a neocon police state globalist one worlder who received an honorary [knighthood](#) in 2002 from the British Crown. Italians rarely ascend high in Pilgrims Society controlled power structures due to the centuries old enmity between English royalty and the Pope. Founded in 1972, [KPCB](#) is “one of Silicon Valley’s top venture

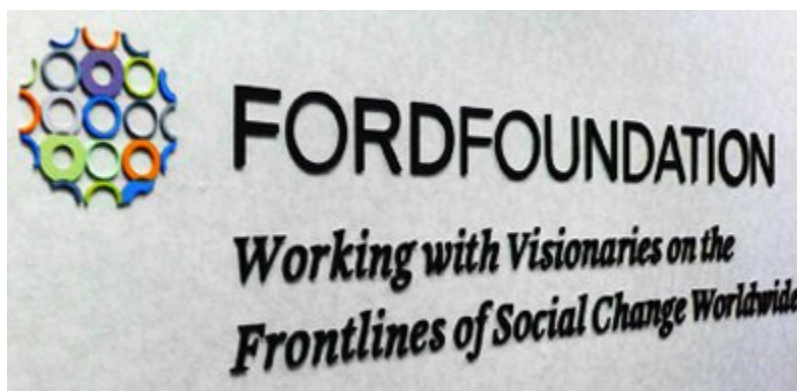

Rice is closely connected to the earlier Secretary of State, Madeleine Albright, because she attended a [school](#) in Denver named after Albright's father, Josef Korbel, the Korbel School of International [Studies](#) at the University of Denver. He was a diplomat for the former government of Czechoslovakia. Rice first worked at the State Department in 1977 and was an intern researcher at RAND Corporation in Santa Monica California. RAND, which we describe elsewhere, is among the top several think-tanks working to globalize us **and destroy our basic freedoms.** In 1980 to 1981 she

was living on Ford Foundation (Pilgrims Society) money while at Stanford University. During 1981 to 1993 Rice was in the political science department of the Stanford University faculty. George P. Shultz, one of the most important members of The Pilgrims who is outside the inner circle, was at the Hoover Institution on War, Revolution and Peace at Stanford and he chose Rice as someone The Society could entrust some key positions with. Shultz was at that time on the board of directors of Chevron (formerly Standard Oil Company of California) and he recommended her for a seat on the Chevron board, which later transpired. She helped in negotiations between Chevron and some former Soviet satellite countries. Chevron named the 129,000 ton supertanker SS Condoleezza Rice after her. Standard Pilgrims Society practice is to name big ships after members, such as U.S. Steel and the Roger Blough, a huge iron ore hauler on the Great Lakes after a member.

In 1991 The Pilgrims inner circle placed Rice on the board of Transamerica Corporation and in 1993 on the Hewlett-Packard board. During 1993 to 1999 Rice was provost of Stanford University California. After leaving State, Rice returned to Stanford as a professor and member of the Hoover Institution on War, Revolution and Peace of Stanford, a warmongering think tank always having Pilgrims Society members associated with it. In 2004 Congress misguidedly created the Millennium Challenge Corporation, a conduit for funneling foreign aid funds drained from taxpayers and clandestinely redirecting the funds so that Pilgrims Society members

with overseas operations can soak it up. Rice chaired the MCC during her time at State Department. The Hoover Institution began in 1919 as a library [founded](#) by Herbert Clark Hoover. Hoover was a mining engineer based in London who struck economic gold deposits in Western Australia. His name was in The Pilgrims London 1914 and 1924. They arranged for him to be President during 1929 to 1933 during which time he refused to call an international silver conference to address the severe problems caused by the low price of silver, intentionally caused by his British pals dumping silver out of India starting in 1927 as described in "The Silver [Stealers](#)." 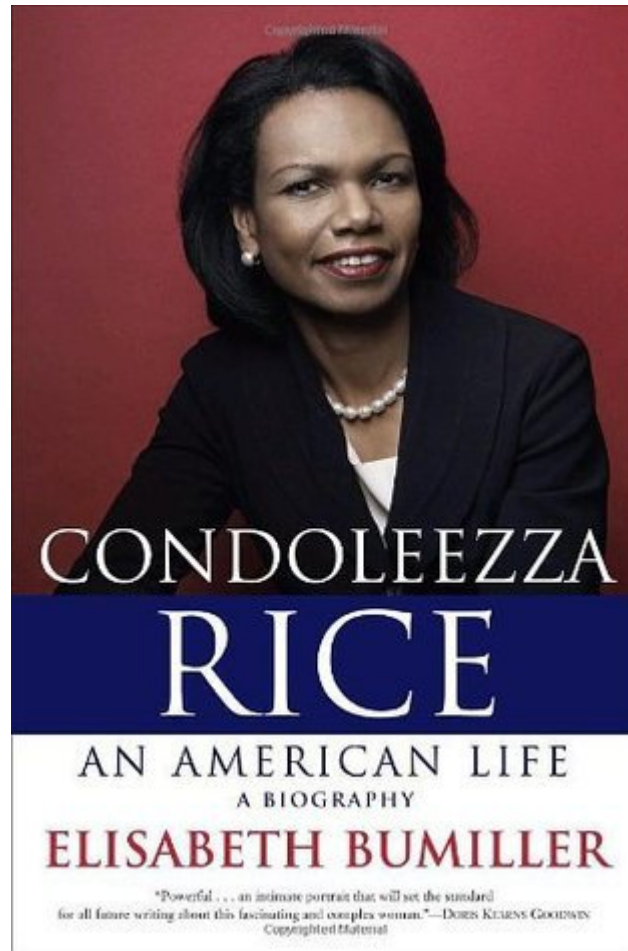

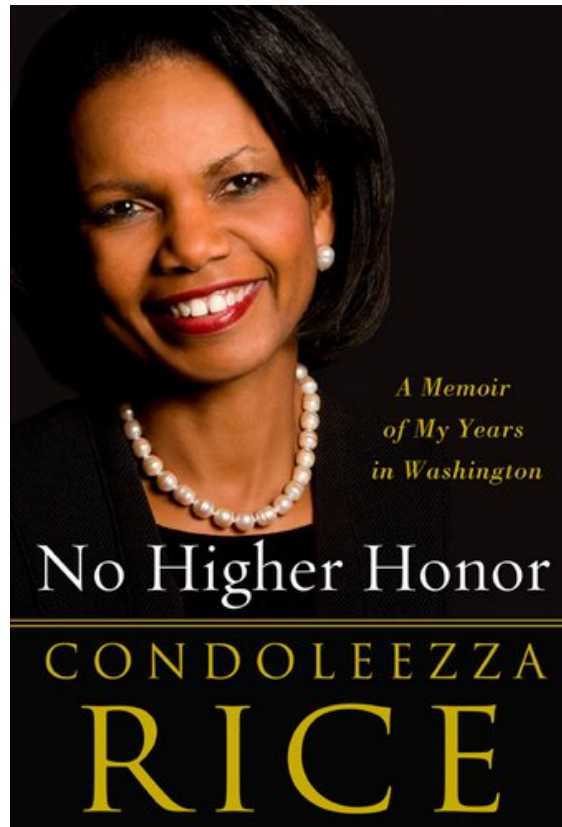

In 2013, Rice was appointed to the College Football Playoff Committee (CFPC), formerly the Bowl Championship Series (BCS). still another Pilgrims Society subsidiary operation. McCaffery is also ex-of Morgan Stanley, and Makena has other connections such as Wells Fargo (Pilgrims Society).

The Bush Institute has a “Global Health” project and it [does](#) push vaccines. The Bush Institute is part of the Bush Presidential [Center](#) at Southern Methodist University in Dallas. A Bush Center trustee is Ray L. [Hunt](#) of Hunt Consolidated (oil and gas). He’s younger half brother to Nelson and Herbert Hunt who The Pilgrims Society shot down in flames in 1980 for trying to remonetize silver. Schwab had a [75 room](#) mansion in Manhattan and a 44 room estate in Pennsylvania and he provided the steel for the great Trans-Siberian Railroad. He was a director of other companies including Empire Trust Company; Metropolitan Life; Tonopah Extension Mining (gold and silver); Federated Metals Corporation; Chicago Pneumatic Tool; United Zinc Smelting; Loew's Corporation and the silver price suppressing Chase National Bank (Who's Who in America, 1930-1931, page 1965) ---

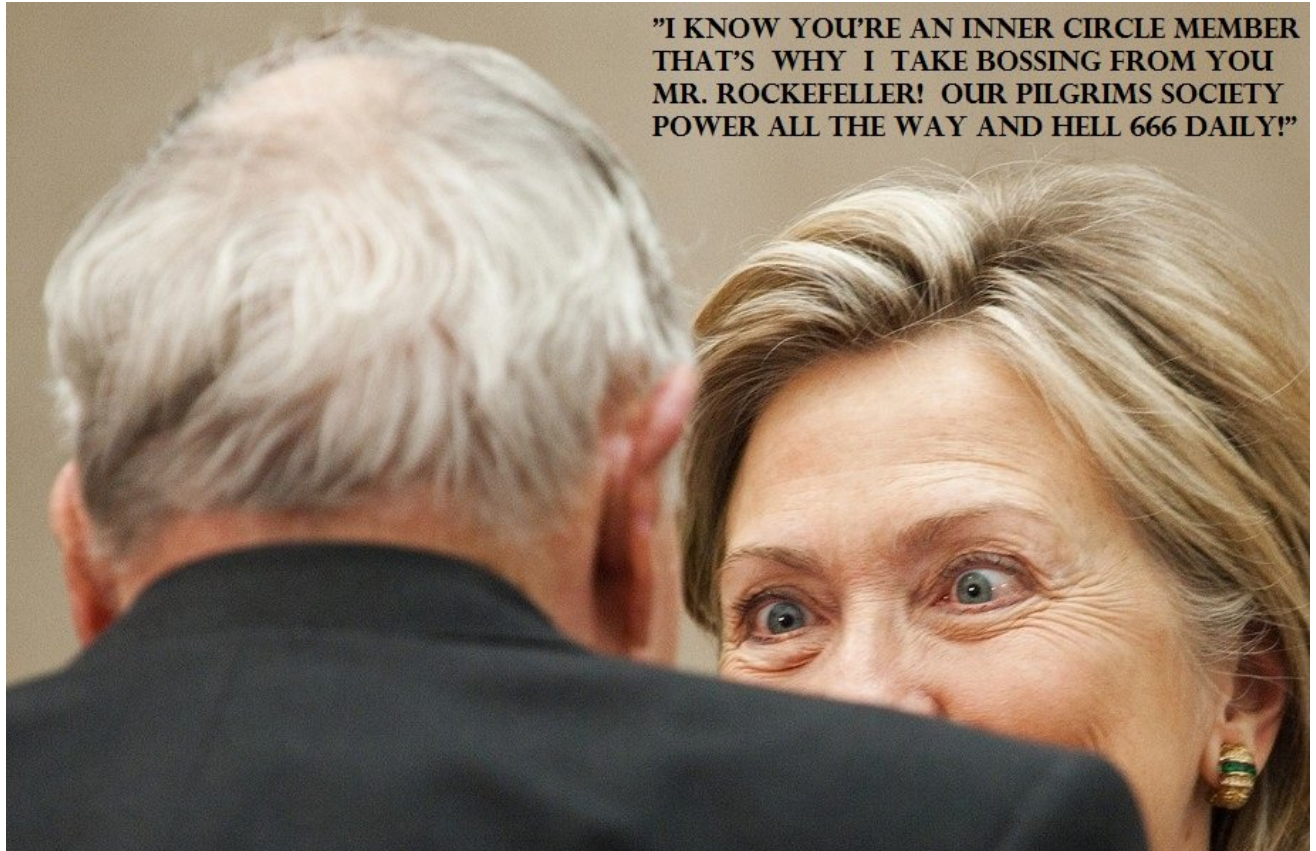

14) John Forbes Kerry (1943---; Pilgrims Society as of unknown; definitely as of February 1, 2013, when he became Secretary of State; most likely years before) is of course better known as a

member of the Skull & Bones Society of Yale, having become a member while a relatively young man in college. The point being that The Pilgrims is easily the senior organization, and that reins of power are seldom turned over to men in their late teens or early twenties. Bones is a conduit, The Pilgrims stand “atop the pyramid.”

In 2012 Forbes estimated Kerry's net worth at just a touch under [\\$200](#) million. There's a consistent pattern of Forbes intentionally lowballing fortunes of Pilgrims Society members so; I suggest it's considerably north of that amount. "His extended maternal family enjoyed great [wealth](#) as members of the Forbes and Dudley-Winthrop families."

"His maternal [ancestors](#) were of Scottish and English descent, and his maternal grandfather James Grant Forbes II was a member of the [Forbes family](#), while his maternal grandmother Margaret Tyndal Winthrop was a member of the [Dudley-Winthrop family](#). Margaret's paternal grandfather [Robert Charles Winthrop](#) served as the 22nd Speaker of the U.S. House of Representatives. Robert's father was Governor [Thomas Lindall Winthrop](#). Thomas' father John Still

Winthrop was a great–great–grandson of Massachusetts Bay Colony Governor [John Winthrop](#) and great–grandson of Governor [Thomas Dudley](#). Through his mother, John is a first cousin once removed of French politician Brice Lalonde.”

The Forbes family representation in The Pilgrims Society is split into two groups---the older group and the newer, represented by the famous magazine publishing family who we’ll review later. The Dudleys are a very old family tracing to important persons in medieval England. William Dudley of this old English dynasty currently heads the gold stealing Federal Reserve Bank of New York and is almost certainly a Pilgrims Society member. Robert Charles Winthrop was Speaker of the House of Representatives, 1847–1849 and a member of the House, 1840–1850. He was a member of the sickening Whig Party, which wanted a central bank. The Whigs are described in a November 2006 [presentation](#) on one of our few good Presidents, John Tyler (1841–1845), who courageously blocked another central bank.

Navigating to http://en.wikipedia.org/wiki/Thomas_L._Winthrop we find---

“Thomas L. Winthrop (March 6, 1760 — February 22, 1841) was a Massachusetts politician who served as the 13th Lieutenant Governor of Massachusetts from 1826 to 1833. He was elected a Fellow of the American Academy of Arts and Sciences in 1813. He was a member of the [Dudley-Winthrop family](#), a line that originates with [Thomas Dudley](#)—founder of Massachusetts and Winthrop's

great-great-grandfather— and which, among other politicians, includes [John Kerry](#), Winthrop's great-great-great-grandson. Winthrop was born in New London, Connecticut and died in Boston. In 1785 he married Elizabeth Bowdoin Temple, daughter of Sir John Temple, the first British envoy to the United States.”

[Bowdoin](#) College in Maine, founded in 1794 and today with a \$1.2 billion endowment, is named after the same family represented by Elizabeth Bowdoin Temple.

John Kerry's [wife](#), Teresa [Heinz](#) Kerry has honorary degrees from Carnegie-Mellon and Drexel Universities---both key Pilgrims Society educational entities. She's received eleven other honorary degrees, including from the University of the [Witwatersrand](#) in South Africa. She's the widow of Pennsylvania Senator John Heinz III who died in 1991 in an aviation accident. His father headed Heinz Foods and was on several other important boards, including Mellon Bank and the Bilderberg steering committee. Heinz II and his father were both Pilgrims Society members; the Senator may have been a member in any case, you may be certain he was representing The Society's cruel objectives for America. Senator Heinz was previously a legislative assistant to Pennsylvania Senator Hugh Scott, who voted [for](#) the Coinage Act of 1965, deleting most silver from our money system. Hugh Scott, known to have attended Bilderberg, hasn't been mentioned as a Pilgrims member due to Bilderberg researchers being largely unaware of this more important group's existence---Scott was in the 1980 roster. Hugh Scott's great grandmother was the [niece](#) of President Zachary Taylor, and Scott

was born on an estate in Fredericksburg Virginia which was once owned by George Washington. Zachary Taylor (President 1849–1850) died of an infection while in office. He considered that President Jackson’s abolishment of the second United States Bank in 1836 was a “[mistake](#).”

Teresa Heinz and John Kerry married in 1995. Her net worth is considered to be up to \$1.2 [billion](#), most likely a gross underestimate. Has or will John Kerry taken any actions since early 2013 as Secretary of State which will cause an increase in the net worth of their marriage? Streator's mother, Ella Stout Streater, was in the 1960-1961 Who's Who in America, pages 2807-2808. She was interestingly a member of the Dutch Reformed Church, suggesting possible ancestry in large Dutch colonial land grants. In 1947 Ella became a member of the Board of Higher Education of New York City. Afterwards she held several administrative positions in Queen's College and Hunter

College. She received an award from Winthrop College in 1948, named after the old-line Winthrop family, prominent to this moment in The Pilgrims organization. In 1945 she became a trustee of Bowne House Historical Society and headed the Flushing New York Council of Women's Organizations. John Bowne married the niece of Colonial Governor of Massachusetts, John Winthrop, circa 1647. The [Bowne](#) family "traces their ancestry back to **William the Conqueror's time and were connected to many titled and powerful families.**" Bowne & Company, a major printing company, was headed by Edmund Allport Stanley Jr. (Pilgrims) from 1956 to beyond 1990 (Who's Who, 1994, page 3280). Robert Bowne founded Bowne & Company, financial printers, and he was a founding director in [1784](#) of the Bank of New York and started the Erie Canal. Ella Streater was a member of the American Association of University Women, co-founded in [1881](#) by Marion Talbot who became Dean of Women (1895–1925) of the Rockefeller controlled University of Chicago.

Streater's father [in law](#), W. John Kenney, was with the Securities Exchange Commission (1936–1938); assistant Secretary of the Navy (1945–1946); Undersecretary of the Navy (1947–1949) and a top administrator of the Marshall [Plan](#) for European Recovery (1950–1952). This allegedly gave today's equivalent of \$120 billion to war torn Europe for reconstruction. In reality it was another Pilgrims Society foreign aid gouge on the taxpayers. It was named after General George Catlett Marshall (1880–1959) who was Secretary of

State (1947–1949) and Secretary of Defense (1950–1951). He was Army Chief of Staff (1939–1945). Page 195 of “The Pilgrims of Great Britain” (2002, short run book) shows that our then Secretary of State was in London at a Pilgrims meeting---

W. John Kenney wasn't a Pilgrims member. There might be a relation to another known member, F. Donald Kenney, who was an investment banker. Ella Stout, his mother, may have been a relation of [Andrew](#) Varick Stout Jr. (Pilgrims 1969 and other years; James M. Stout was also 1969) who was a New York Stock Exchange governor and chaired Dominick & Dominick, with which Avery Rockefeller Jr. (Pilgrims Society second generation) was associated. A.V. Stout was also a Bayard relation, of a very old-line Dutch colonial family who were large scale landowners. With many Pilgrims members, there's no telling what's in their background; yet in some cases, it appears ordinary. Edward James [Streator](#) III is an investment banker. Elinor

Streator, his second child, married an exec with the Bank of New York, whose father held [steel](#) mill interests. His third child I am not finding anything about; her middle name raises the eyebrow however as to possible significance.

Having entered into a foreign service career in 1956 with the State Department, he was with the ICA, International Cooperation [Administration](#) into 1958. Amazingly, this globalist bureaucracy dissolved in 1961; usually they persist like barnacles. After spending 4 years in Ethiopia (northeast Africa) he was with the African division of State in 1962–1963. Between those two posts he was [with](#) the U.S. embassy in Togo, West Africa. Streator was assistant to Secretary of State Dean Rusk during 1964–1966; [Rusk](#) was first a Rhodes Scholar and later a Pilgrims Society member; he later headed the Rockefeller Foundation. In 1966–1968 Streator was in the warmongering division of State Department and in 1968–1975 he was involved with the State Department's NATO (North Atlantic Treaty Organization) desk. Finally in 1975 to 1977 he was made an Ambassador to NATO. For part of that time he was associated with U.S. Ambassadors (Pilgrims Society members) in London during 1975 to 1984. Those Ambassadors were [Elliott](#) Richardson (held 4 Presidential cabinet positions); [Anne](#) Armstrong; Kingman [Brewster](#) Jr. (president of Yale University, 1963–1977); John J. [Louis](#) Jr. (heir to Johnson Wax fortune and heavy holder of Combined Communications Corporation) and Charles H. [Price](#) II. After the ambassadorial post, these Pilgrims members were placed

on such boards as American Express; Boise Cascade; Halliburton; General Motors; Texaco; British Airways; Hanson PLC; American Bancorporation; Price Candy Company; Linwood Securities; Sprint Telecommunications; New York Times Company; and United States Industries. Price II [married](#) into the Swanson frozen food fortune.

During 1984 to 1987 Streator was U.S. [Ambassador](#) to the Paris based OECD, Organization for Economic Cooperation & Development, founded in 1961, of which 34 countries, mostly European, but including Canada and the U.S., are members.



Streator says he was a director of South [Bank](#) during 1991 to 1999. This isn't a bank, but "the **South Bank** is an entertainment, commercial and urban parkland district of Central London, England, next to the River Thames opposite the far east of the City of Westminster and all of City of London. It forms a narrow, unequal strip of riverside land within the London Borough of Lambeth and the London Borough of Southwark where it joins Bankside which is usually considered a part. As with most Central London districts its edges evolve and are informally defined however its central area has no rival names. It has the Southbank Centre, Sea Life London Aquarium, the London Dungeon and the London Film Museum,

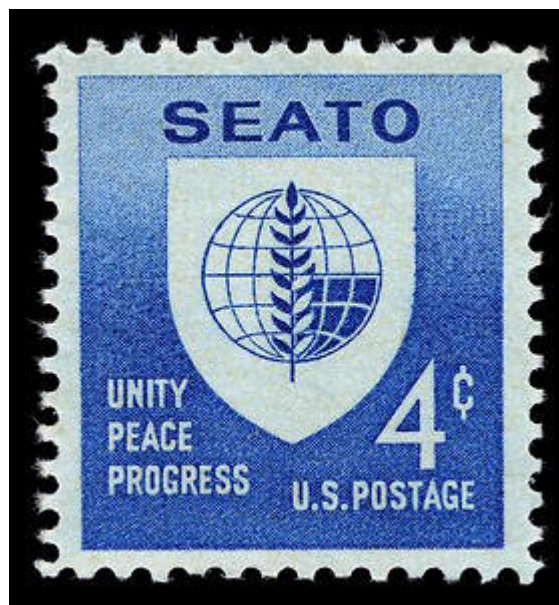
Jubilee Gardens and the London Eye among its long list of attractions.”



In 1996 Streator became chairman of another front for bringing America back under British control called the New Atlantic Initiative. It was based in the American Enterprise [Institute](#) in D.C., making it a front within a front or a box within a box! Somewhat strangely, the Jerusalem [Center](#) for Public Affairs has a page on the New Atlantic Initiative. It identifies George Shultz and Henry Kissinger, both former Secretaries of State, as patrons, and also highly likely member Margaret Thatcher, ex British Prime Minister, who was hosted by The Pilgrims London on January 29, 1981 (“The Pilgrims of Great Britain” short run book, 2002, page 200).



Streator attended a meeting of SEATO in 1965. The South East Asia Treaty Organization (1954 to 1977) was an attempt at merging several [countries](#) in that area, frightening them into an alliance over the threat of Red China---



Also in 1965 Streater attended an Inter-American [Conference](#) in Rio de Janeiro, Brazil, with the same intentions in this hemisphere as SEATO had elsewhere. The conference was under the auspices of the Organization of American States, an ongoing attempt to merge the governments south of the United States border. Founded in 1948, the [OAS](#) has 35 member governments and includes virtually the entire Western hemisphere. It actually traces back to 1889 and in 1910 the Pan American Union Building in Washington D.C. was constructed. Laying the cornerstone was Pilgrims Society [member](#) Andrew Carnegie of the giant Carnegie Steel empire, and it was Carnegie who first conceived the North American Union plan---



Here's Carnegie on page 8 of The Pilgrims 1914 leaked roster, located deep in the recesses of the New York Public Library. Other incredibly subversive operators appear with Carnegie. Calhoun was grandson of John C. Calhoun, vice president of the U.S. (1825-1829) under British collaborator John Quincy Adams, who had plenty of

help in stealing the 1825 election from the winner of the popular vote, General Andrew Jackson. Charles F. Adams, from the same Adams genealogical tree, was in The Pilgrims 1969 roster and headed Raytheon, large defense contractor. Carolan was a General Electric [official](#). The 1914–1915 Who's Who, page 351, shows Butterworth's office at 40 Wall Street.

Founded in 1958, the IISS [describes](#) itself as **"the world's leading authority on political-military conflict."**

Naturally being so involved in high level United Kingdom and world affairs, Streater in 1988 became a governor of The Ditchley Foundation, which stages elite conferences on the challenges of re-integrating America into a revived British Empire.

Consistent with past patterns repetitively noticed of The Pilgrims Society controlling the much more publicly visible, mass membership English Speaking Union, Streater was a governor of this group during 1988 to 1994. The ESU London branch was founded in 1918 and the New York branch in 1920 by Sir Evelyn [Wrench](#) (ever worried whether “Pat” meant Patricia or Pat? Regrets for the tasteless joke). Wrench went out into left field just a touch by marrying his first cousin. Wrench of course was a member of The Pilgrims and founded the Royal [Overseas](#) League in 1910. “Wrench served from 1942 to 1944 as American relations officer to the Government of [India](#), a post especially created for him by the Viceroy of India.” How much silver stealing was Wrench involved with in British India? He was also an official of the Royal Commonwealth Society. “I have devoted the whole of my life to working for the Empire” said Wrench on the front page of the July 25, 1941, issue of The [Examiner](#), a Tasmania based newspaper that reported on his being kidnapped.

Sir Laming Worthington-[Evans](#), Baronet, Knight Grand Cross of the Order of the British Empire and Member of Parliament, was British Secretary of State for War (1921-1922) and a member of the British delegation to the 1922 International Economic Conference in Genoa who remarked, "If the Arab population realized that the peaceful control of Mesopotamia (Iraq) ultimately depends on **our intention of bombing women and children**, I'm very doubtful if we shall gain that acquiescence of the fathers and husbands of Mesopotamia to which the Secretary of State for the Colonies (Winston Churchill) looks forward." How many of the small folks over there did this **Pilgrims Society member** play a role in **"LAMING?"** He was British Postmaster General (1923-1924) and again British Secretary of State for War (1924-1929). The Montreal Gazette, June 16, 1923, page 2,

showed that Brigadier [General](#) Cecil Wray was very close to the Royal family naturally, being one of their hit-men! Debevoise & Plimpton, one of the top ten Pilgrims Society connected law firms in New York---has a partner named [Cecil](#) Wray. Coincidence? Not with what's been established about this unbelievable group! He's a prospective member, but we await that rock being turned over, and it's a very big one! He graduated from Vanderbilt University and is a CFR member so; that adds to the prospects! The goal of the English Speaking Union is naturally to have English as the world language and is active globally in this activity---

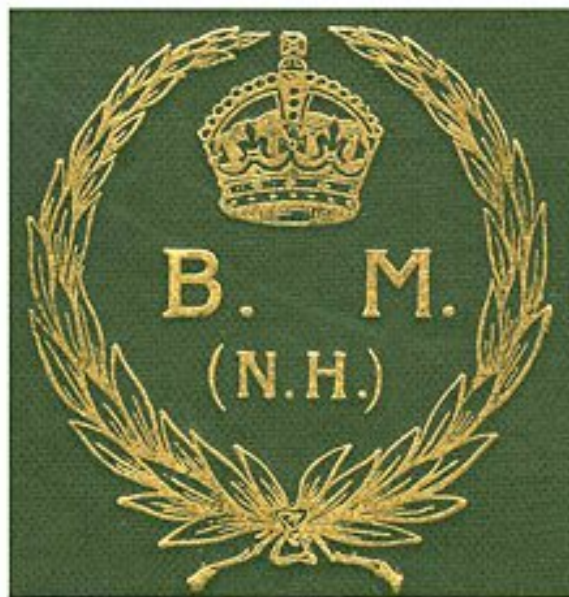


Also during 1988 to 1994 Streater was chairman of the American Chamber of Commerce in the United Kingdom. The near countless ways these members of The Pilgrims have worked since their

founding, to bind America and England together, illustrates their drive for eventual political unity of the two nations (“EMPIRES”) and in 1902 they admitted it would take 200 years to do this, but at that time couldn’t have foreseen the Internet and its potential for a vehicle to lay bare their secrets and plans. During 1987 to 1999 Streator was a director of the British-American [Arts](#) Association at 30 Rutland Gate in the Knightsbridge district of London. As of 2005 Streator was a director of the International Foundation accepting donators for the support of the British Museum of Natural History, [founded](#) in 1881---





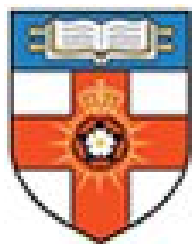


During 1991 to 1995 Streator was a member of the development committee (fundraising) of the [National](#) Gallery in London on Trafalgar Square---

During 1989 to 2001 Streator was a member of the council of the Oxford University Institute for American Studies, which most likely is about the ongoing insinuation of subversive Rhodes Scholars, trained at Oxford, into the American political scene, working to drag us under United Nations (“British”) control. This is closely similar to the Rothermere American Institute at Oxford, here we [notice](#) Streator was a founding member, along with other confirmed members of The Pilgrims including Caspar Weinberger (as Defense Secretary dumped 24,435,000 ounces silver for price suppression from the former strategic silver stockpile); Lord Weidenfeld (profiled elsewhere in this series); George P. Shultz (precious metals suppressor as Treasury Secretary and Secretary of State); Raymond

Seitz and Philip Lader (profiled in #13 in U.S. Ambassadors to England); also ex U.S. Ambassadors to England Walter Annenberg (billionaire) and Anne Armstrong (major South Texas landowner); Sir Anthony Acland (former U.K. Ambassador to U.S.); Sir Ronald Grierson of the Warburg (“warthog”) interests; Mrs. Rupert Hambro (wife of a member); **Viscount Astor, who all by himself absolutely takes the cake;** and others. Senator J. William Fulbright of Arkansas, a Rhodes Scholar (but not a Pilgrim) was there; he gave rise to the Fulbright Scholarships, similar to the Rhodes Scholars, another group unfavorable to our Constitution! In fact, the next item we see in Streater’s scan is that from 1995 to 2001 he was an adviser to the Fulbright Commission!

In 2004 Streator became a trustee of the Northcote Parkinson Fund, whose name changed in 2007 to The [Train](#) Foundation, run by Pilgrims member John Train (in the 1980 New York roster). Train is a highly absorbing study in himself; he isn't covered in the closing series as its limited to those who became members after the 1980 list. As of 2012, Streator and Train were still trustees, as was another member, Ann Brownell Sloane, whose father was a Pilgrims member and United States Attorney General. Train's father was a New York City district attorney. [Train](#) had a cousin from Rhode Island, Democrat Senator Claiborne Pell, inheritor of several sizeable fortunes (including Lorillard tobacco) ---he voted [for](#) the Coinage Act of 1965, removing most silver from our coinage, to help his greedy silversmithing pals in Rhode Island, but more so to help his

Pilgrims pals at the Federal Reserve! In “Money Masters of Our Time” (2003) Train does [not](#) mention The Pilgrims!



Streator received the Presidential Meritorious Service Award in 1986 from [President](#) Reagan (Pilgrims Society), presumably for “Pilgrimizing them for the [Gipper](#).” The Royal Society of the Arts and the Knickerbocker Club we describe elsewhere in this series and the other clubs. The Mill Reef Club in Antigua in the Leeward Islands of the West Indies has had many Pilgrims members over the years; many are involved in transglobal oceanic shipping and maritime affairs. White’s Club in London was [founded](#) in 1693 and is “the oldest and most exclusive gentleman's club in London.”



The Garrick Club in London of which Streater is a member, was [founded](#) in 1831 by The [Duke](#) of Sussex, brother of the King of England. It has 1,300 [members](#)---





Streator was in the U.S. Naval Reserves (1952–1956). Naturally, he is Episcopalian! His address in France (he's French fluent) is Chateau de Saint Aignan in La Romieu France where he resides in "a magnificently restored country [house](#) a few miles outside town."



The Royal Society of Arts [called](#) Streator **"a global big thinker."**

This [link](#) shows he was consul general in New York as of February 3, 1989. The International Who's Who for 2004, page 817 [shows](#) that Jewkes was consul general at Cleveland in 1979 to 1982 and during 1985 to 1988 had the more interesting post of high commissioner of British Antarctica. After exiting the post of consul general in New York in 1992, he became a director until 1994 of The Hogg Group PLC and of Slough Estates, 1992 to 2002. Slough Estates, founded in 1921, was renamed Segro Limited. This [URL](#) shows Jewkes is a former director of Segro Public Company Limited and Beaconsfield Management Company Limited. Segro is "the largest [industrial](#) property company in Europe and is the owner of The Slough Trading Estate – the largest trading estate under single ownership in

Europe.” Converting pounds sterling to dollars using May 2015 rates, in 2014 Segro had net [income](#) of \$1,074,000,000.



HRG started in [1845](#) in London as an insurance company. Today operating in 120 countries with 12,000 employees it's a specialist in “corporate travel” and “specializing in travel, expense and data management underpinned by proprietary technology. [HRG](#) is the only publicly listed company of its kind.”



During 1996 to 2002 he was on the executive committee of the Walpole Committee and during 1996 to 2001 he was a member of the council of the University of Buckingham.

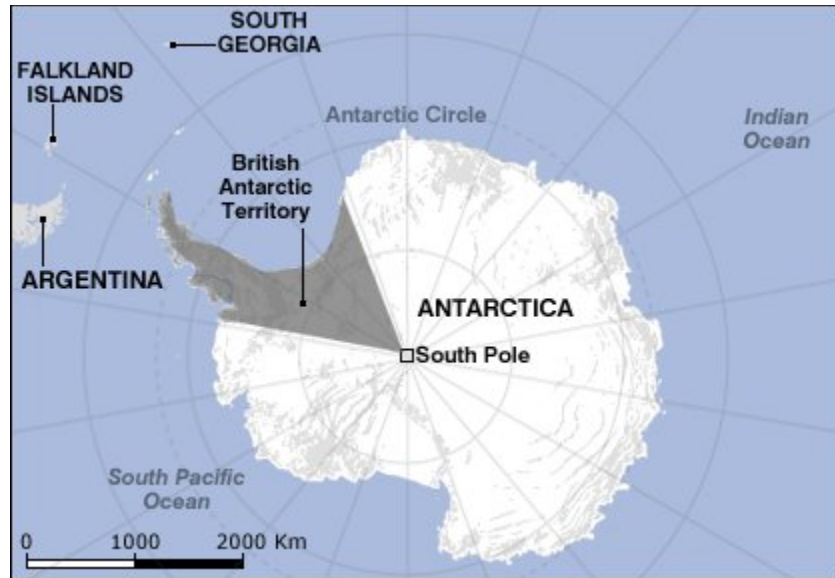

During 1996 to 1999 Jewkes was a member of the Marshall Aid Memorial Commission. This [link](#) to “Major Companies of Europe 1993–1994” shows that as of then, Jewkes was still a director of Slough Estates. The map of British Antarctica is misleading in two ways. First, it doesn’t show an additional 386,000 square miles of offshore territory claimed by Great Britain under the Law of the Sea [Convention](#) and secondly, it doesn’t show Australian Antarctica (Australia like Canada is definitely dominated by London interests).

New Zealand, another satellite government of England, [controls](#) 174,000 square miles of Antarctica. Aggregating this with the 2,276,651 square miles [controlled](#) by Australia and the 660,000 [controlled](#) by England, this gives The Pilgrims Society London branch control of whatever mineral resources exist on 3,110,651 square miles, plus the additional undersea 386,000 square miles

seized by England (plus corresponding sea areas claimed by Australia and New Zealand) in the most virgin mineral exploration areas on earth in addition to the deep open seas with depths of 15,000 to 36,000 feet!

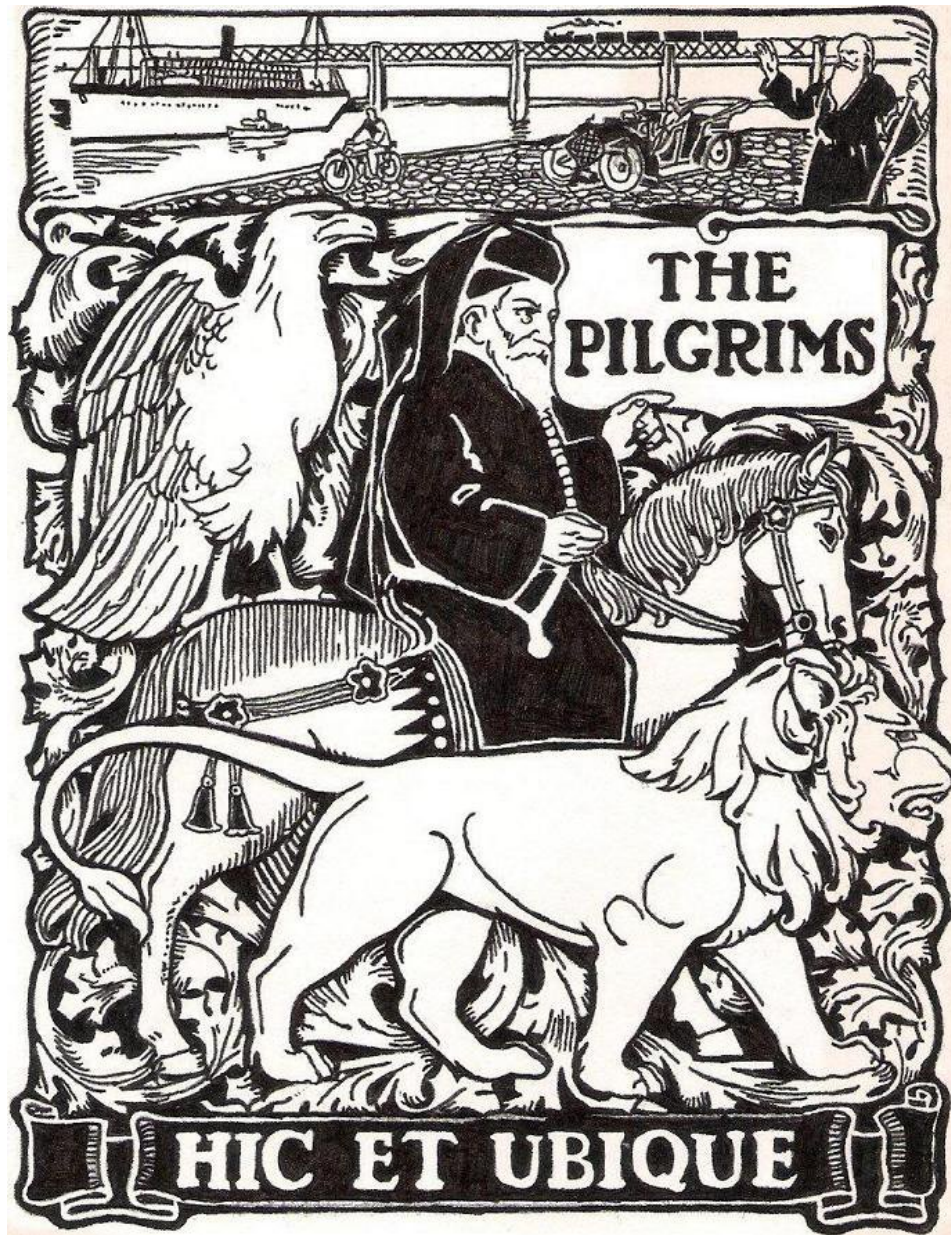
Harold Medina was a highly placed Federal judge in the Southern District of Manhattan for most of 30 years---the same district where silver price fixing lawsuits go nowhere (anywhere else would be the same!) "[Medina](#) presided over the year-long Investment Bankers Case in 1951-1952, an antitrust case against 17 of the most prominent Wall Street investment banking firms, known as the Wall Street Seventeen. **He ruled in favor of the investment banks."**

That figures---he was a member of the same Secret Society as his Wall Street pals, so naturally he'd rule in their favor. Medina wasn't in the 1949 roster. Either he was on the waiting list for Pilgrims membership, or he was intentionally doing as expected when the President appointed him and the Senate confirmed him. The Meeks of J. Walter Thompson Company, long the world's biggest advertising agency, had their fingers in other pies. S.W. Meek was a director of Time; governor of Yale University; director of National Bank & Trust of Connecticut; trustee Presbyterian Hospital and Empire Savings Bank of New York (1966-1967 Who's Who in America, page 1438) and a director of Pilgrims fronts including the English Speaking Union and the Atlantic Council. Paul Mellon was an inner circle Pilgrims member who may have inherited more wealth than anyone else in history, according to biographer William Hoffman. That matter is always debatable.

The 1974 roster shows these same names minus Guy Edwyn Meek. By 1980 Medina was also gone. The 1949 and 1957 rosters show Robert Pickens Meiklejohn. The 1940 roster shows William A. Meiklejohn and David Meiklejohn. The 1933 list shows William A. Meikleham---most likely a misprint. David was the father of Robert P. Meiklejohn, of whom the 1960-1961 Who's Who in America, page 1973, shows was a General Dynamics official.
