The Vaccine Conspiracy Originates Within The Pilgrims Society!

1) Barry MacTaggart (1931---; Pilgrims Society as of [undetermined](#)) was chairman of the **intensely demonized Pharma giant**, Pfizer, succeeding Edmund T. Pratt Jr. in that position. Pratt, Pilgrims 1980, was also a Chase Manhattan Bank director. I haven't

determined which years these men headed Pfizer (later), but Pratt had the post circa late 1970s into at least the early 1980s, followed by MacTaggart. Now I [find](#) in **"Globalization and Health"** (2006, page 89) that as of July 9, 1982, as chairman of Pfizer, MacTaggart had an editorial published in the New York Times in which he spoke of a "global strategy." Most likely by then MacTaggart was in The Pilgrims Society. However, there's a contradiction, because as we'll see later, the Pfizer site says that Pratt was chairman of Pfizer from 1972 to 1992. It could be a typo took place to make 1992 read 1982 in the book, because their site is more likely to have the years right. No; resolving the matter is that Pratt was overall chairman and MacTaggart chaired the international operations. MacTaggart, a native Australian, retired to Vero Beach, Florida, as Pilgrims Society members frequently do or have winter homes there. Here's a limited view of his house---

“The Barry MacTaggarts found Vero Beach via a wildly circuitous route. Both were born and raised in Australia, lived in Hong Kong, Japan and Greenwich, Connecticut, before they settled in Vero Beach. Barry left Australia when he was transferred to Hong Kong by Pfizer Pharmaceuticals.”

[This](#) item signed by actor Fred MacMurray was once in MacTaggart's possession. That's the nearest I've come to finding an image of him. Pfizer annual reports from the early to mid-1990s should have his mug shot! Here's his info from the 1994 Who's Who in America, page 2180. Note the discrepancy between the years he was claimed to be chairman of Pfizer and the years that Edmund T. Pratt Jr. is claimed to have acted as Pfizer chairman. Possibly MacTaggart was chairman of Pfizer International, the foreign operating subsidiary; in fact, that's exactly how his bio reads below, so that would have had him directly under Pratt in the company---

This [site](#) shows MacTaggart was born in 1934, not 1931---take your pick. He was a director of Synergy Incorporated. There's a company by this name in the printing industry, but they say they [started](#) in 1996 and his info was dated 1994. This one, Synergy International, is more like the company he'd have been a board member of, and has been around for [36](#) years. They have multiple business activities including major scale architectural projects, energy integrated buildings, resorts, renewable power, urban electric wind turbines, modular building systems, electric vehicles, wind and solar power and more.



I noticed his mother's maiden name and wondered if it's part of the Baron Bruno Schroder (Pilgrims London, banking dynasty, multi-billionaire) and assume not based on the obscure Australian town in which he was born---does the reader care to investigate?

Notice the two flagrant typos in MacTaggart's listing---“Riomar Day Yatch Club,” which should read “Riomar Bay [Yacht](#) Club,” also at Vero Beach, Florida. Home prices in the resort community range to \$4.5 [million](#) but then, I didn't look far.

The New York [Times](#), April 2, 1995 reported---

“Susan Margaret MacTaggart, the daughter of Mr. and Mrs. Barry MacTaggart of Vero Beach, Fla., was married yesterday to Kurt Werner **Saraceno**, the son of Mr. and Mrs. Dominic Saraceno of Newton, Mass. The Rev. Jeffrey Walker performed the ceremony at

Christ **Episcopal** Church in Greenwich, Conn. Mrs. Saraceno, 31, graduated cum laude from Fairfield University. Until recently she was an international marketing manager for Pfizer International, the pharmaceutical company, in New York. Her father, now retired, was the **chairman and president of Pfizer from 1981 to 1991**. Mr. Saraceno, 36, graduated from Colby College. He is the president of the Saracen Companies, a real estate development group, and of Venture Quest Inc., a venture finance company, both in Newton. His father is the owner of Kurt Saracen Associates, a real estate development company in Newton.”

Saracen, what a funny name for a Pilgrims Society son in law! The Saracens were a particular Muslim group, whose name is sometimes equated with the “Moors” (“Moorish”) who [controlled](#) parts of Christian Spain in the 7th and 8th [centuries](#). They were the subject of the 1961 classic movie “[El Cid](#)” with Charlton Heston, as a Spanish hero driving the invaders out of Spain. Montgomery Scott on “Star Trek” calls an alien, “you bloodthirsty [Saracen](#)!” This [link](#) states that Kurt Saraceno was a resident of Greenwich, Connecticut when he married this Pilgrims Society members daughter. A news item from 2010 reported that a con man [scammed](#) the Saraceno family for \$2.1 million in a real estate swindle. There’s a Dominic [Saraceno](#) in Buffalo, New York, practicing criminal law, probably the son of the man mentioned as a resident of Newton, Massachusetts.

[Saracen](#) Properties of Waltham, Massachusetts, suburb of Boston, evidently achieved representation in The Pilgrims Society via

member Barry MacTaggart being the father in law of Kurt W. Saracen, son of Dominic Saracen. Commercial and office buildings owned by this organization [contain](#) 1,967,120 leasable square feet. Which suggests that a \$2.1 million scam operation hardly made a dent in their picture. Saracen [Australia](#) in Perth and Melbourne (the same people) has an immense operation running past several billion dollars in office buildings, luxury homes, supermarkets and other developments.



There is also a Saracen Estates in Islamabad, Pakistan, in my opinion, the same people---



I've not found info as to how much Barry MacTaggart received in compensation from Pfizer during his career, including stock options however, it can be expected to run into quite a few millions. 235 East 42nd Street, New York, is Pfizer HQ, from which site the American public, hoodwinked and beguiled by doctors, is pillaged,


plundered, sacked, and sent to an earlier grave than had they relied on nutrients instead of toxic “medications”---

Pfizer and its British counterpart, the Glaxo Smith Kline colossus (Pilgrims Society London) were sued in [France](#) over vaccine injuries to children. Sally [Susman](#), executive vice president for corporate affairs of Pfizer, is the daughter of Pilgrims Society member Louis Susman, profiled in Silver Squelchers [#13](#) and is a director of WPP London, the world's largest advertising agency, headed by Pilgrims Society member Philip Lader, profiled in the same presentation as Susman. Both Lader and Susman are former Ambassadors to England, which apparently they do regard as their one true country!

2013 figures for Pfizer [show](#) revenues of \$51.6 billion on which it had an incredible net income of \$22 billion; assets of \$172 billion; and 78,000 employees.

Edmund Taylor Pratt Jr. (1927–2002, seen below, Pilgrims Society 1980 roster) was [president](#) of Pfizer (1971–1972) and CEO (1972–1991) and chairman (1972–1992). Pratt began his career at IBM in [1949](#) under Pilgrims Society member Thomas J. Watson Senior---

Founded in 1919 with lots of input from Pilgrims Society member Charles Dawes, Chicago utility kingpin who screwed Germany with the Dawes Plan, the ICC is completely globalist. Current chairman of the ICC is Harold [McGraw](#) III of the McGraw-Hill fortune, United Technologies and Philips 66. If we get an updated Pilgrims roster, my expectation is 100% to find McGraw listed---



“Pratt joined the Kennedy Administration as assistant secretary of the Army for [Financial](#) Management.”

By the 1980–1981 volume, page 2677, Pratt was also a director of General Motors, the New York Chamber of Commerce and Industry, a trustee of Duke University and chairman of the Emergency Committee for American Trade; and an overseer of the Wharton School of Commerce & Finance. He was a director of silver antagonist Chase Manhattan Bank, among the megabanks flexing to defeat the Hunt–Arab silver play of 1979–1980. Notice he was a director of the National Association of Manufacturers, which has potentially (unconfirmed) acted as a backup for the Silver Users Association, as all manufacturers want to minimize their raw material costs, and silver is the special whipping boy, as it is historic money while other commodities like lumber and cotton are not! What a hoot, Pratt’s home was on Astors Lane, named after an inner circle Pilgrims Society dynasty still very much on the scene. [Prices](#) on Astors Lane are in the millions. Apparently there’s an Edmund T. Pratt [Homeowners](#) Association. I have never encountered any positive detail regarding any homeowners associations--- everything is 100% negative. Pratt donated \$35 million to Duke

University, probably from years of huge paydays and stock options from Pfizer. Pratt also donated \$12 [million](#) in 1988 to Long Island University. Since his father was employed by the Army Corps of Engineers, he seems to not be of the same Pratt family that was a large [faction](#) in the old Standard Oil Company and would represent many times the wealth he accumulated. As of the 1974 New York Pilgrims roster, Frederick W. Pratt Jr., a confirmed Standard Oil inheritor, was a member. It's possible they were cousins, and in some cases, major inheritors took government, military or corporation jobs they had no need for based on income. I haven't seen any news story on Edmund Pratt stating his line tracing to Standard Oil however; it's inconclusive. He was a Duke University trustee, 1977 to 1988.

Pope's ancestor was in on the bicycle craze-boom of the 1890s and was into other consumer industries ("Peddling Bicycles to America---The Rise of an Industry," 2010, page [218](#)). His family came to America in [1634](#). They were involved with manufacture of motors ("Mechanical Engineering—A Century of Progress," 1980, page deleted from [view](#)). These engines and motors were "large internal [combustion](#) engines for industrial uses, such as engines that burn natural gas to run large generators for hospitals " and "for about a half century, Waukesha was an independent supplier of gasoline engines, diesel engines, multifuel engines (gasoline/kerosene/ethanol), and LNG/propane engines to many truck, tractor, heavy equipment, automobile, boat, ship, and

engine-generator manufacturers.” Preston of J.P. Morgan & Company was co-ringleader with Pilgrims Society members Paul Volcker, chairman of the Federal Reserve Board, and COMEX governor William Simon (Pilgrims Society), an anti-gold Treasury Secretary, in destroying the Hunt/Arab silver play in January 1980, as detailed in the 18,187 word [#10](#) Silver Squelchers. Prince was among the biggest Chicago fortune inheritors ever. He was also profiled in [#10](#).

I regard Pfizer as among the most dangerous of Pilgrims Society controlled corporations.

I had a beloved dog seriously injured by one Rimadyl, manufactured by Pfizer, which to all appearances burned an excruciating ulcer into his stomach. It was supposed to help him with a walking problem. Two veterinarians both failed to diagnose what his situation consisted of. They both said “hips,” and I paid one of them \$1200 for some liquid glucosamine injections, which neither helped nor harmed him. One day as he was on his side I pushed on his rump to move him and he cried out. I additionally had heard a completely bewildering sound coming from the same area as he was standing in the yard---a sound like a bundle of oak twigs snapping! I shaved a rectangular area over his lower spine, down to the bare skin, and applied roll-on DMSO. After 20 minutes, I helped him up, and he walked around the yard like a champ. Before the DMSO, he’d worsened to the point he couldn’t walk ten feet without collapsing from pain. The dog had a

case of spinal gout crystals, and the DMSO being a solvent, dissolved those needle-like crystals which were causing his pain (to satirize one of their effete words used to awe the small folks, “etiology”) and once dissolved, the pain abated. He continued to have gut pain every time he lay down over a 17 day period till he passed away at age 14. This Pilgrims Society owned corporation, Pfizer, added great misery to my dog’s last days, and had these veterinarians, prostituted to the pharmaceutical cartels, had the right education, and integrity, they’d have told me to try DMSO (it cost \$11.95!) DMSO is all over greyhound race tracks and boxers use it to heal faster from soreness---and one of these veterinarians insisted there was “nothing topical that could help him.” Many pet owners complained about this vile “medication,” Rimadyl, and filed [lawsuits](#) against Pfizer, because among other things, veterinarians weren’t telling pet owners what consequences could befall animals via use of their “medications” (poisons). Another dog was I believe harmed by another Pfizer Animal Health “medication,” prednisone. The other dog came to me as a lost dog and in time I discovered that when he was young he was hit by a barrage of veterinary vaccines, which destroyed his immune system as it related to fighting skin infections. The vets would always prescribe Cephalexin which did break the infection, however, it would always be followed by a round of prednisone.

We were never once told that prednisone with repeated usage is hard on the kidneys. The last time the dog was administered

Cephalexin, it finally [manifested](#) a side effect---the dog was nearly crippled. Another round of prednisone was prescribed “to overcome the undesirable effect of the Cephalexin.” It did overcome the side effect, but it also sent the dog into kidney failure, and another pet fatality caused by Big Pharma and its sickening prostitute veterinarians. [Pfizer](#) is among the manufacturers of Cephalexin. Sanitation, avoidance of poisons, toxins and physical dangers, relief from weather extremes, natural treatments against parasites (neem oil) and specialized nutrients, and avoidance of cheap, adulterated pet foods, are most of what pets need to prosper. Veterinary “medications” are unsafe. This is no advocacy of operations without anesthesia, but know this tends to be fatal to some breeds.

Another Pfizer animal “health” drug called ProHeart6, is documented to have induced fatalities in healthy dogs. I spent several hundred hours reading New York Times news accounts on the subject of dogs (this was in 1992) and the most profound thing I noticed during the period 1851 to World War One (1920-ish) was that the lifespan of domestic dogs averaged longer by several years, than after the arrival of organized veterinary “medicine” and its bastardized, bought off connections to **boundlessly conspiratorial pharmaceutical interests like Pfizer.** Veterinary “medications” are terribly [chancy](#). Dogs and cats get attacked far more by vaccines than people, and there are severe consequences. But what a racket! Prescribe a drug for something, then another drug to get rid of side effects of the first drug! Eventually the lifespan is shortened but the

vets and the drug companies prosper on this wretchedness they intentionally inflict.

Do NOT vaccinate your pets, besides if you are being coerced over a rabies shot. This site is instructive <http://www.stoptheshots.com/> If you can't avoid these, I suggest you read about use of reduced L-glutathione, calcium D-glucarate, selenium, colostrum, cilantro and another good botanical, blueberries or Aronia berries, administered a half hour before shots, and again another half hour afterwards, may help neutralize these injected threats to pet health. They are also applicable to neutralize your children's coerced injections!

The Pilgrims Society is poisoning the public with fluoride, chlorine, chemicals in plastics, mosquito spraying programs, vaccines, pharmaceuticals and many other modalities including genetically modified foods. This causes health problems and their hospital cartels clean up, lifespans are shortened in keeping with its depopulation goals. Robin Chandler Duke, a Pilgrims official whose husband, a major old-line inheritor of multiple fortunes, has long been active in population reduction advocacy [activities](#).

Current chairman of the Pfizer empire of megaprofits based on dealing misery is Britisher Ian [Read](#), who I regard as highly prospective for membership in The Pilgrims, as Pfizer is too large and too strategic to not have a Pilgrims member at its sinister, health crippling helm. His reported compensation for 2013 is \$18,947,737 and he's also a director of Kimberly Clark Corporation

(John Robbins **Kimberly**, Pilgrims 1969 roster!) Bloomberg [Business](#) reported Reed's 2014 compensation as \$23, 283,048. We read---

"He serves as a Director of The Partnership for New York City, Inc. He serves as a Director at Pharmaceutical Research and Manufacturers of America. Mr. Read is Pfizer's representative on the International Section Executive Committee of PHARMA and former chair of the Europe Committee. He has served as a Director of both the Brazilian Anglo American Pharmaceutical Association (CIFAB) and the Brazilian Association of the Pharmaceutical Industry (ABIFARMA). Mr. Read served as chairman of PHARMA's Latin America Regional Committee (LARC) and vice chairman of the Intellectual Property Coordination Committee (IPCC) section of IFPMA. He holds a BSc. degree in Chemical Engineering from London University Imperial College in 1974. He earned the Chartered Accountants Certification from the Institute of Chartered Accountants of England and Wales in 1978."

Read has a resort home in Bonita Springs, Florida, probably valued at megamillions, while [ten](#) percent of the residents are below the poverty line. His 2011 compensation reached [\\$25](#) million. Another fat Pilgrims Society (awaiting confirmation) bully boy tick filling up his body's blood sack at public expense---

His 1994 Who’s Who in America listing, page 2514, shows he was a member of the Lotos Club (described elsewhere) and made no

mention of The Pilgrims. Either he wasn't a member at that time or like the majority of members, was "undercover" about it. I find some [references](#) about a Hilda [Frost](#) having been with Merrill Lynch at 4 World Financial Center and silver thief Morgan Stanley, two of the more important Pilgrims Society affiliated investment banks. [Robert](#) C. Neis joined his father's enterprise, E.T. Browne Drug Company. R.C. apparently resides in the upscale community on Shelter Island, New York where megamillion residences are common. His sister Nancy is a probate and bankruptcy attorney in East [Providence](#), Rhode Island. Does she have a few Franklin half dollars or did they get converted into Rhode Island silversmith craftworks?

Bloomberg says [this](#) about Neis---

"Arnold H. Neis served as President Of Scott Chemical Co Inc., Paterson, New Jersey from 1960 to 1964. Mr. Neis served as Vice President-marketing of Odell Inc., New York, N.Y. from 1964 to 1971. In 1968, he became President Of Thayer Knomark Co, New York, N.Y. Mr. Neis serves as a Chairman of E.T. Browne Drug Co., Inc. From 1970 to 1971, he served as Director of Odell Inc., Knomark Of Canada And Esquire Ab Sweden (related Companies), New York. He received BS Degree from Columbia University In 1959 and also received MBA Degree from New York University in 1967."

There's a Scott [Chemical](#) Company in Ironton, Ohio, but apparently no current business by that name in Paterson, New Jersey. Maybe they moved. It deals in polishing and cleaning compounds. There's

an [Odell](#) Incorporated in Richmond, Virginia (architectural design) and an [Odell](#) Brewing Company in Fort Collins, Colorado. There's an [O' Dell](#) Equipment Company in Louisville, Kentucky, dealing in commercial laundry equipment. There's an [O' Dell](#) Corporation dealing in mops and brooms. His reference could be to any of these but probably not to the janitorial one. Thayer-[Knemark](#) owned Esquire Shoe Polish and was the number one such item in America for several generations.

I haven't delved to see if any of the previous companies Neis was involved with became part of Browne Drug. Browne Drug has an account manager named Susan [Crook](#). No, this isn't the usual drug

company you think about but is actually more of a cosmetics industry operating with the “Palmer” trademark for skin care items and hairdressing preparations <https://www.palmers.com/> Their consumer products are [featured](#) by Wal-Mart, K-Mart, Walgreen’s, Rite-Aid (drug store chain), Target Stores, CVS Pharmacy and other mass merchandising chains. The size of this business is not public information as it’s privately [held](#), but is likely to be considerable and that includes its export operations; notice E.T. Browne International in his scan. Smaller drug store chains and even some liquor [stores](#) stock their items. They have numerous products and brands, just a small sampling you may wish to henceforth boycott considering whose pockets your funds are going into---

This private company headed by Pilgrims member Arnold Neis, for which sales and income figures are truly in the dark, is a corporate [member](#) of the World Cocoa Foundation and we read---

“Founded in 2000, the World Cocoa Foundation (WCF) is an international membership organization representing **more than 100 member companies** across the cocoa value chain. We are committed to creating a sustainable cocoa economy by putting farmers first-- promoting agricultural & environmental stewardship, and strengthening development in cocoa-growing communities. WCF operates at the local and **global level**, bridging the needs of cocoa farmers and their families with the needs of the cocoa industry and the environment. Drawing on the strength of our members, and our partner network, we combine unique industry experience, expertise and influence to deliver the necessary social, agricultural and economic advances to promote a healthy, sustainable cocoa economy that benefits everyone from producer to consumer. WCF works through public-private partnerships that bring together

The Global Shea Alliance mission is to design, develop, and deliver strategies that drive a competitive and sustainable shea industry worldwide, improving the livelihoods of rural African women and their communities. Through the strength of our members, the Global Shea Alliance is committed to promoting sustainable shea production by empowering women through training sessions, establishing shea kernel quality standards and the promotion of shea butter as a high quality ingredient.”

Shea “butter” is an edible fat from an African tree nut [used](#) in cosmetics and confection. Global Shea Alliance---more one-worldism under the guise of harmless agricultural and commercial activities.

Next in his scan Neis says he's on the board of overseers of St. Luke's Roosevelt Hospital Center. There was a merger that created that hospital. Actually it's all [known](#) today as Mount Sinai Luke's and Mount Sinai Roosevelt with combined total of 1,028 beds. St. Luke's Hospital traced to 1858 and Roosevelt Hospital to 1871, founded by Franklin Roosevelt's father. Pilgrims Society members by the dozen have been trustees of these hospitals since 1903 when The Pilgrims Society New York went into operation---a catastrophe for our civilization. Neis is a fellow of the Royal Society of Chemists (actually, the Royal Society of Chemistry) which traces to [1841](#) and today has around 51,000 members---

The RSC of which Arnold Hayward Neis is a member certainly has to do with the chemical industry---with merchants of death as in warmongering; with chemical additives to water supplies and foods; and much of the chemical industry must have the precious metal---silver---to function as a catalyst in at least hundreds of processes. I'd say yes, the Royal Society of Chemistry favors suppressed silver prices---and no use of silver as investment or as money---anywhere! Their collaboration with traditional explosives manufacturers and pharmaceutical giants confirms them as a globalist group.



He's a member of the Royal Geographical Society in London, [founded](#) in 1830 with today over 16,500 members. Info [shows](#) Sir Crispin Tickell (Pilgrims London) in management of the RGS; we profiled [him](#) earlier. Lord Selborne is also in RGS management and he's prospective as a Pilgrim. My opinion about the RGS is that among other things, it's funded many explorations or expeditions allegedly just for mapmaking, but a deeper purpose is questing for valuable minerals which its Pilgrims Society sponsors can go in and exploit, often giving the uneducated natives little or nothing!



Neis holds membership in the American Institute of Chemists ([founded](#) 1923). Its directors [show](#) someone associated with Hercules Incorporated, a corporation of significant size affiliated with the Du Ponts (biggest USA silver users) and The Pilgrims Society. A 1952 document from the American Chemical Society, heavily interlocked with the AIC, [shows](#) Charles Higgins chairman of Hercules and he surfaced in the leaked Pilgrims 1957 roster---

Stanley High? I haven't found anything on him---anywhere, including obits. Those are the members who worry me most.

When patents are developed, they rake in the megabillions. His scan shows he's a member of the AAAS, which is often understood to indicate the American Academy of Arts and Sciences (globalist). However in this instance, confirmation is [found](#) that it's the American Association for the Advancement of [Science](#) that's the particular group he holds membership in. Management of this important group is largely faculty from many large [universities](#), either with Pilgrims Society members as trustees or regents, or their CFR subsidiary members as

trustees. It's recognized as "the world's largest general scientific society." It was founded in [1848](#) at Philadelphia and today has around 130,000 members. Again---any patents developed will bring more wealth into concentration inside The Pilgrims Society!



HQ is at 1200 New York Avenue NW in DC---



Neis is in the American Chemical Society, mentioned already in connection with the American Institute of Chemists. The ACS has 158,000 [members](#) including researchers and patent developers and this group is just another Silver Users Association in disguise. Its president for 1976 was Glenn T. Seaborg, Pilgrims Society, former Atomic Energy Commission chairman who squirreled away 65 million silver ounces that has [never](#) been accounted for---

It remains an obvious British influence front and is well interlocked with the superior Pilgrims Society. Note in his scan he says he's a director of the St. George's Society. At right is Mark C. Piggott, Order of the British Empire and a very highly likely member of The Pilgrims. [Forbes](#) Magazine alleges his family is worth \$7.7 billion through their ownership of Paccar, (Pacific Car & Foundry) founded in 1905 to manufacture railway and logging equipment, it produced Sherman tanks during World War II. 


Neis is a member of the Explorers Club, discussed in several other members' profiles; he received a [medal](#) they award in 1997. It would be revealing to know what mineral wealth has been brought into the fold of the Money Power via the expeditions it has sponsored! Next you notice he's a member of the Chemists Club at #3 West 51st Street NYC. Among its founders in [1898](#) were Charles Squibb (Big Pharma) and William Schieffelin (Pilgrims Society family intermarried with the larger Vanderbilts). The Chemists Club has a Winthrop-Sears Award. The Winthrop in that [title](#) is of the Winthrop family of colonial Massachusetts prominence who later became Pilgrims Society members connected to the founding of the Federal Reserve System! That last link notes the Chemists Club members are involved in "pharmaceuticals, metals, biotech, chemical industry management, attorneys" in other words, Big Pharma, silver use as a chemical catalyst and silver price suppression, and biological control over the Crown's "colonies" here! The attorneys are presumably

there to assist in such sordid matters as evasion of financial responsibility in cases of **groundwater pollution** and such. Why do they use what appears to be a dragon in their symbology? Neis states in his scan he's a director of the Soldiers, Sailors & Airmen's Club. At their [site](#) you see their full name is Soldiers, Sailors, Marines, Coast Guard & Airmen's Club. I immediately notice Ivan Obolensky is chairman, CEO and executive committee member of this club. Obolensky, old Russian nobility and an investment banker, has a staggering profile which we'll review in Silver Squelchers Thirty Two. Jacqueline Astor Drexel, another director of

this club, is married to John Rozet Drexel IV, who was on The Pilgrims New York executive committee as of 1998 and still there as of recent info. As this club is headed by Obolensky, we'll examine it in more depth in his upcoming profile---this is a very important club in controlling USA military forces! There are **SIX Generals** in management under Pilgrims member Obolensky!

We've encountered other members previously who were members of the Church [Club](#) of New York---now we discover Neis is the club's president.

Like many Pilgrims, especially the dominant Episcopalian faction, Arnold Hayward Neis is a member of the (Protestant) OSJ, Order of Saint John of Jerusalem, headed by the British Sovereign. We've discussed the OSJ in detail in the profile of John Rozet Drexel IV.

The Hotchkiss Library in Sharon, Connecticut, in a 2014 [document](#), mentioned (page 4) "Hilda Frost and Arnold Neis are hosting Francine Prose at their lovely estate of West Woods Road #1 in Sharon. Francine is the author of seventeen works of fiction. Her latest book was reviewed on the front page of the New York Times book review."

The property at that [site](#) apparently sold for \$1,245,000 in March 2015.

Wait---there's more! The same page at the same pdf Hotchkiss Library link also states---

"Carole Bailey and John French will entertain Simon Winchester at their gracious home in Great Elm. The author's most recent book is "The Men Who United the States---America's Explorers, Inventors, Eccentrics, Mavericks and the Creation of One Nation." He has written many other books including the "Professor and the Madman," the "Man Who Loved China," and "A Crack in the Edge of the World" and "Krakatoa," all of which were New York Times best sellers and appeared on numerous best and notables lists. In 2006 Mr. Winchester was made an officer of the **Order of the British Empire (O.B.E.) by Her Majesty the Queen.**"

This is the exact same John French III we [profiled](#) in Silver Squelchers Eighteen, pages 55 to 73! Since I didn't have this info when I researched French's profile in #18, I just discovered he's a vice president of a homeowners association ("HOA") called the Great Elm [Community](#) in Sharon, Connecticut. French's Who's Who profile shows this not! He resides at number 2 Great Elm Drive.

New York. Southampton is especially pricey and I'm surprised we haven't found Neis to be a member of the ultra-shady Bathing Corporation of Southampton, an exclusive, expensive private beach club of which a fair number of members of The Pilgrims have belonged to across the decades.

Arnold Hayward Neis has a residence at 898 Park Avenue where \$4.5 [million](#) is a typical price---898 Corporation is part of Douglas Elliman Real Estate, named after a member of The Pilgrims.

"Douglas [Elliman](#) is **the largest residential real estate brokerage in the New York metropolitan area and the fourth largest real estate company in the United States.** The company has more than 70 offices and 4,000 real estate agents."

Page 2073 also showed Henry Malcolm Lovett, probably the same family. H.M. was a director of oil and gas giant Tenneco; Southwestern Drug Corporation; and a law partner in Baker & Botts, Houston, of which Pilgrims Society member James Addison Baker III is the most influential partner.

Edward R. Lovett's [father](#), Robert Fillmore Lovett Jr., was "a retired investment counselor, he worked at Scudder Stevens & Clark in Cincinnati before becoming a cofounder and principal of Hanson

Investment Management Co., in San Rafael, Cal. He was a past president of the Harvard Club of Cincinnati and an ardent naturalist who had looked forward to devoting his energies to **environmental causes** during his retirement. He leaves his wife, Sara (Newcomb), who was injured in the accident, three sons, Robert '87, Andrew '89, and Edward, and three sisters, Emily Mannion, Edith Bogardus, and Linda Crawford.”

E.R. Lovett was an investor in San Francisco in 1994–1997 in we know not what; the San Francisco newspaper might be revealing. His info shows he’s a member of the Explorers [Club](#) in New York, founded in 1905. Prince Philip, Duke of Edinburgh, Pilgrims Society, is an honorary [member](#)---



Members of the Explorers Club have been involved in many firsts. I suspect it has something to do, one way or another, with exploitation of mineral deposits in remote areas. With this, we want to examine the “[Cardamom](#)” Project that Lovett runs. Recall that his

father expressed an interest in environmentalism. Again, there's the likely prospect that this has to do with mineralogical and other resource exploitation and land grabs, rather than wanting to maintain a great natural area in pristine condition. This suspicion must prevail due to the activities Pilgrims Society members have been involved with for more than a century---coal mining, oil and gas, copper, lead, zinc, gold and silver, bauxite and mining of many other minerals---uranium, manganese, iron ore and others.

Cardamom was [founded](#) in 2000. [Cardamom](#) is the name of a spice native to India, Pakistan, Nepal and Bhutan. It's the world's third costliest spice after saffron and vanilla. That again suggests profit motive. The spice has some medicinal aspects. In Lovett's case, Cardamom refers more to the Cardamom [Mountains](#) of Cambodia, which extend slightly into Thailand---more like big hills than mountains. The area is heavily forested, has abundant water---and mineral---resources and covers 190 miles long by 43 miles. This [source](#) says the area is five million acres.

“Due to a [lack](#) of comprehensive geological surveys the size of exploitable mineral resources in Cambodia is not clear, but the Ministry of Industry, Mines and Energy (MIME) has stated that copper, gold, iron ore, zinc, lead, tin, bauxite, sapphire, ruby, kaolin and limestone are amongst the most prevalent resources. Many of the resources have hardly been touched. The mining sector in Cambodia is still largely undeveloped. There are also a large number of artisanal miners running small operations recovering

gold and gemstones, often on a seasonal or part-time basis. To date there has been no industrial scale extraction of precious minerals.”

In “[Secret](#) Titanium Mine Threatens Cambodia’s Most Untouched Forest” we read---

“The mining consortium, United Khmer Group, has been drawing up plans to build a massive titanium mine in a Cambodian protected forest for three years, the development did not become public knowledge until rural villagers came face-to-face with bulldozers and trucks building access roads.”

The proposed mine might cover 50,000 acres. “If the titanium mine is successfully approved, China is planning three to four more mines covering 100,000 hectares (247,000 acres) in the Cardamom Mountains.” The URL for the board of directors of UKG Ltd shows nothing---[no names](#)!

“Between Vietnam and Thailand is Cambodia, a poor country with a basket of **largely untapped resources that include gold**. Within the past decade the surge of interest in the country’s mining prospects has been met with positive response from the Royal Government. For Cambodia, the mining sector may be a key to economic growth, meanwhile for investors, there may be attractive possibilities.”

Pilgrims Society member Edward Richardson Lovett---what is his interest with the Cardamom Project? Does he want to keep the vast natural area in untouched condition? Or does he want to have the region “locked up” against development---until he and his Pilgrims Society associates can step in and cartelize the area? If interests not aligned with The Pilgrims have commercial pursuits, are they short selling targets? Are Cambodian officials having their palms crossed with paper “money?”

At National Outdoor Leadership [School](#) we see---

“In the summer and fall of 1993, Ed Lovett took himself on a post-college trip through Asia, stopping off in the Himalaya for a few weeks to participate in a NOLS expedition. Another part of his journey took him to Cambodia—and of all the places Lovett visited, it was this war-torn nation for which he developed the deepest affinity. “It was everything—the history, the architecture, the city of Phnom Penh...but most of all it was the people,” he recalls. “I was struck by the serene, positive attitude they maintain after all they’d been through.” Lovett knew he’d someday return to Cambodia, and in April of 2000 he found his reason. He read an article in the New

York Times describing the predicament of the Cardamom Mountains. This range in southwestern Cambodia was a retreat for Khmer Rouge guerillas after their fall from power and remained untouched by developers afraid of the Khmer Rouge and their land mines. Now this unmanaged wilderness, with its incredible variety of wildlife, is being threatened by poaching, logging and other incursions.”

“As a global citizen, I found it unacceptable, even farcical, that this ecological tragedy could happen on the heels of Cambodia’s human tragedy,” says Lovett. “That conviction produced a vision: that preservation of Cambodia’s natural heritage had potential to be a big source of national renewal.”

“This is the mission of Lovett’s founding non-profit organization, the Cardamom Project. “We are working as conservationists to preserve this amazing wilderness,” explains Lovett. “At the same time, we want this to involve Cambodians, and to be deeply rooted in their experience. The Cardamoms have such a unique role in history that the story of wildlife and the story of the Cambodian people are tightly linked.” Lovett describes the Cardamom Project as “in transition from startup to phase two.” He and his advisory board are working closely with Fauna and Flora International, a British group currently undertaking a wildlife survey in the Cardamoms.”

“We’ve had two special events to spread awareness and begin fundraising for on-the-ground contributions to the conservation

effort,” Lovett reports. “And I’ve spent a lot of time forging contacts in Cambodian communities, both there and in the U.S. We want to do environmental education campaigns and create imaginative programs to help shift Cambodians’ attitudes toward nature.” The project is evolving as his relationships with Cambodians evolve: “They’re into it, they get it. **Most of them don’t know this treasure is there**—when they hear something about Siamese crocodiles, they’re amazed, happy and grateful.”

Was that a slip on Lovett’s part? That there’s treasure there? And he intended his remark to be interpreted at face value, but there’s this other meaning instead?

We must mention there was another [Lovett](#) on the scene---Robert Abercrombie Lovett (1895–1986) who was known to have become a member of Skull & Bones but not The Pilgrims, but only so far as available lists show. R.A. Lovett was Secretary of Defense (1951–1953) after holding multiple other high Federal posts and was a partner (1926–1940) in Brown Brothers, Harriman & Company at 59 Wall Street. He exited that to enter Federal “service,” and then returned in 1953 to BBH & Company. He was a director of Union Pacific Railroad of the Harriman family; and a director of CBS; North American Rockwell Corporation; Royal Globe Insurance; Freeport Sulphur Company; North American Aviation and Carnegie Institution of Washington. Since S & B and The Pilgrims both originated from British influence, and they have a membership overlap, they connect the same circles. Individual Bonesmen may sometimes appear more

important than certain Pilgrims members and in fact, this can occur. The general rule however, entails no such conclusion.

About Roger Appleton Burnham, his father, we [find](#) another [link](#) referring to the “Stedman/Steadman/Steedman Families of the New World.” It’s unclear if this other name is connected to something tracing to the 1950s, the [Steadman](#) group of mutual funds. “Of the New World” suggests centuries old genealogy and his [mother](#) Phyllis is also in this group. The Connecticut Quarterly, [volume](#) 2, 1896, page 399 mentions an Appleton Burnham in the year 1630 in Connecticut.

A December 2012 obituary from the Boston Globe on his wife, Frances M. Burnham, surprises in two ways; one, that she also was a member of The Pilgrims and therefore, among the relatively few female members and two, the fact that this was [mentioned](#) at all, even though almost no one would attach any special meaning to it---

“She enjoyed judging the breed in England and Wales. Her kennel name "Tarryon" was famous throughout the Cavalier world. Frannie was an Overseer of Plimouth Plantation for 25 years and a Council member of New England Historic and Genealogical Society. She was a Vestry Member of St. Stephens Church in Cohasset, MA, and a board member of the New England Farm & Garden Association. She was a life member of the Society of Mayflower Descendants, Colonial Society of Massachusetts, and a member of: The Pilgrims, National Society of Colonial Dames of Massachusetts, the Cohasset Discussion Club, and the Lansdowne Club of London, England. Frannie also served for many years on the Club Life Committee of

the Somerset Club of Boston and was active in the Junior League of Boston and London and the Children's Museum Aide. She was a member of the Cohasset Golf Club and Yacht Club. Frannie graduated from Northeastern University and received a Masters from Antioch University. She graduated from the Radcliffe Publishing Program. She served with her husband of 49 years in the US Peace Corps in Ethiopia and was Education Director at the Boston Respiratory Disease Association for several years.”

So absorbed are these Pilgrims Society members in merging the United States back into a revitalized British Empire, or Commonwealth of Nations, that they promote English specific dog breeds, this one having to do with a historical English monarch. I find nothing specific about the Sterling Institute in Boston; possibly connected to a university or college there. During 1977 to 1991 David Burnham was involved in “organizational development consulting” from Boston to London and Singapore and Sydney Australia. Afterwards he was with something similar called Interaction Associates. Without checking online newspaper archives we know little about these firms but I feel some surprises would be found if we had time to follow all the incredible ramifications of these Pilgrims members. Now we’ll look at the Burnham Rosen Group he’s been running for over twenty years. A question first, however. Is he related to the former Drexel Burnham Lambert investment bank which at one time was the leading COMEX silver short? I can’t show a solid connection so far however, I’d

expect to find it in the event of a newspaper/magazine archive search which is currently unfunded as to time.



“[Burnham](#) Rosen Group is dedicated to developing and supporting world-class leadership within organizations around the world. To that end, we offer the finest research-based leadership development products and consulting services.” His daughter Amery is there with several others specializing in one of the dismal “sciences” (psychology). Of himself he says---

“David Burnham is a partner at Burnham Rosen Group that specializes in strategic business planning, organizational change, and leadership development from its US and UK offices. Burnham Rosen is distinguished from its competitors by its "collaborative approach to business planning and its use of research and empirical data.”

“David, together with his former business partner and Harvard professor the late David C. McClelland, pioneered the field of competency assessment and development through the use of the behavioral event interview in the 1970’s. Their work in competency assessment was initially conducted for a host of organizations including: The U.S. State Department; the United States Navy; the Dept. of Commerce: Office of Minority Business Enterprise; the

Manpower Career and Development Administration, City of New York. Later as competency assessment and development became a validated and better known set of tools and concepts, David Burnham, then President and CEO of McBer and Company (now Hay-McBer, the leading behavioral science research firm of the 1970's), extended the research and the methodology to American industry. The best known output of that period is the McKinsey award winning Harvard Business Review article by McClelland and Burnham, Power Is The Great Motivator, republished in Jan-Feb 2003 as an HBR classic. That article reported on the competencies of successful American managers and created a wide spread surge of interest and experimentation in the field of competency assessment and development.”

“David has also continued to pursue his interest in leadership and leadership development. In the late 1980's the competencies, which he and David McClelland had identified in the mid-1970's as those distinguishing successful leaders from average leaders, were no longer predicting superior business performance. Accordingly, in 1992, he initiated a five year study in eight countries (Europe, Asia, the Americas), thirteen industries. He followed leaders delivering first quartile business performance and high employee morale in their industries and compared them to those delivering average performance.”

“This research has led to the development of Burnham Rosen's workshop to develop the competencies his research identified, Inter Active Leadership™; it also underlies Burnham Rosen Group's executive coaching practice. The workshop, developed in 1999, is now being widely offered including: **Fidelity Investments**, BBDO, **Lloyds, Pfizer**, Accenture, Mitre Corp., **Morgan Stanley, State Street**,

Boston Financial, Convergent Technologies, Parexel, Sun Life, **Harvard University**, GNER (UK), **Atomic Weapons Establishment (UK)**, and the **British Cabinet Office** to name just a few. David Burnham was also President and CEO of publicly-traded Intermedia Systems Corp. Intermedia (a producer of hardware and software for multi-media entertainment and educational presentations, owner of sound studios, an earning company and a film producer) was bankrupt when Burnham was hired to turn this Cambridge, MA-based firm around. Within one year the firm had regained both revenue growth and profitability.”

May I ask is there anyone out there who might have had a promising career except Burnham or his pals insisted that their mental blueprint wasn't right? Do they disqualify people who don't want the powers of the United Nations increased?



M.H. C. is involved with this HSCUS group and its site content has enabled identification of several members of The Pilgrims; it's almost always the last thing mentioned in a profile! They have a

long list of these genealogical, hereditary, military, colonial and so forth groups according to their year of founding. You arrive at 1903 and they do [NOT](#) list The Pilgrims Society, despite it being the premier genealogical power organization!



You ask, what's the basis for having an architectural interior designer in The Pilgrims? So intent is this group on reconnecting America to England that their members are immersed in every aspect of British culture, so that even their interior design often mirrors that of England and therefore constantly reminds them of their goal of subordinating these United States to the United Kingdom. Also there have been a fair number of members who inherited wealth from both parents' lineages, and chose to master an occupation in which they could earn a robust income, which they didn't need to start with. His [mother](#) was a member of the Huguenot Society of America, described elsewhere, but we will state here that it's a hereditary group of French Protestants who fled Catholic France and most of them became extremely prosperous. The financial picture combined with opposition to the Papacy, had the Huguenots ripe for interlock with The Pilgrims, which is just what transpired. Sylvia "Cookus" was also a member of "Colonial Daughters of the 17th Century, Florida Society, Dames of the Court

of Honor and the Dutch Settlers Society of Albany, N.Y. She was a “lifetime member of the Episcopal Church” according to the previous hyperlink. Notice that M.H. Charles is a member of the Council of the Huguenot Society. His [father](#), very subdued as to credentials (or they are unknown; he also was a Mason) had roots in 17th century Switzerland.

Before starting the intimidating task of reviewing the groups this Pilgrims member is interlocked with we’ll have a glance at his occupational credits. I find nothing on his first position. KBJ Architects, founded in 1946, with which M.H. Charles was with for 4 years, and reported revenue of \$158 million in 2005, has this info on [Wiki](#)---

“KBJ [Architects](#), Inc. (KBJ) is an American architectural firm based in Jacksonville, Florida. The firm designed 17 of the city's 30 tallest buildings and **"created Jacksonville's modern skyline"**, according to The Florida Times–Union newspaper. The firm designed the first high–rise in downtown Jacksonville, the 22–story Aetna Building, which opened in 1955. It took pride in "having the second–largest number of architects of any Florida firm", according to a 1997 article in The Florida Times–Union.”

Order of the Southern Cross (life member) ---Dutch Settlers Society of Albany (life member) ---Huguenot Society of Pennsylvania (he mentioned the national Society only in his scan) ---Descendants of the Founders of New Jersey (Councilor General) ---Order of Descendants of Colonial Physicians and Chirugiens (French---Surgeons) ---Sons and Daughters of the Colonial and Antebellum Bench & Bar (period of 1585 to 1861---Antebellum means before the Civil War) ---National Society of Sons and Daughters of Antebellum Planters (period 1607-1861) ---Naval Order of the United States ---Sons of Confederate Veterans (commander of General Archibald Gracie Jr. Camp #985) ---Burns Society of the City of New York---Honourable Company of Freemen of London---Saint Thomas Episcopal Church of Fifth Avenue (head usher; chairman Acquisitions Committee; member Stewardship Committee) --- Guild of All Souls---Society of King [Charles](#) the Martyr (Church of England)---Society of [Mary](#) (Anglican, not Catholic) ---Confraternity of the Blessed [Sacrament](#) (Anglican/Episcopalian)---Masonic Independent Royal Arch Lodge #2, Free & Accepted Masonry of New York City (past Worshipful Master) ---Long I Grotto Valley of New York; Ancient Chapter, Royal Arch Masons, New York City---Columbian Council of Cryptic Masons of New York City---Morton Commandery of Knights Templar of New York City---Paumonock Council of Knight Masons of New York City---Quatuor Coronati Lodge #2076 of London---Royal Order of Scotland---Saint Augustine Florida Yacht Club---and Royal Scottish Automobile Club of Glasgow.

At the same [link](#) he states leadership positions in groups he listed in his scan, which he didn't mention he was in the management of and/or there are other positions he holds in these groups in addition to the positions he stated in his scan---

Saint Nicholas Society (member of the Council)

Saint George's Society of New York (chairman activities committee and member of the Ball Committee and chairman of the Queen's Jubilee 2002)

Huguenot Society of America (Registrar General and on the membership committee)

Order of Americans of Armorial Ancestry (Secretary General)

National Society of Sons and Daughters of the Pilgrims (Councilor of the New York branch)

American Priory Order of Saint John of Jerusalem (Commander)

Sovereign Military Order of the Temple of Jerusalem ("Silver Pilgrim Shell" award)

Additionally, M.H. Charles is a [director](#) of the Hereditary Society Community currently and since 2004. Now we'll review, one by one, the groups he's listed membership in, starting with those in the scan, and moving on to these other groups not listed in the scan!

The Society of the [Cincinnati](#) which is mentioned elsewhere in this series traces to 1783 and today has branches in America and France (because France made some contributions to the Revolutionary War). It also serves as a historical group for the Continental Army. The disturbing thing is to find British loyalists, which all Pilgrims Society

members are, involved, often in leadership positions, in ostensibly patriotic groups; they cannot be trusted. President of this group today is banker Ross G. Perry of Sun Trust. He appears to not be a Pilgrims member or is unstated as such, but clearly he rubs [elbows](#) with them---



M.H. Charles is a member of the English Speaking Union which we cover elsewhere in the SS series. It's a direct Pilgrims subsidiary with the goal of making English the universal language in the planned world government. He's a member of the Order of Saint Maurice and Saint Lazarus, probably for having done some design work for a prominent Italian. [Wiki](#) states this Order is sponsored by the Italian royal house of Savoy. However, the Italian spelling is [Savoia](#), the French spelling is Savoie (yours truly) and the English spelling is Savoy, as in the Savoy Hotel in London. This history is

that around 1100 AD a group of Crusaders calling themselves the Brothers of Lazarus established a hospital in Jerusalem. The Order of Saint Maurice, also with military overtones, was founded in 1434. In 1572–1573 the two were merged and yes, the Pope was involved. Please don't let me hear from any Jesuit enthusiasts this means that M.H. Charles is a Vatican loyalist. The Crown is just as decisive in its intents and actions, witness the history of drawing and quartering in England. There indeed are overtures between The Pilgrims and the Vatican and though each group desires control, I honestly don't see that the older religious empire has it over the British. As of 1951 the Italian government no longer recognized this Order but it has continued unofficially. It has a great deal of history back of it, but little control. Whereas, what did the British Empire do? It had an empire of 40 million opium addicts in China. It seized the gold, diamond and platinum mines in South Africa. It ruled the waves for centuries and today has the Commonwealth of Nations, which encompasses over four times the land area of China!



[Founded](#) in 1875, this group may well have completely patriotic members. Groups such as this therefore should purge themselves of British royalist types such as M.H. Charles---



Next he states he's on the board of directors of the St. George's Society of New York. This does make my point valid as to the preceding group! We [read](#)---"St. George's Society of New York was founded in 1770 to assist those born under the British flag who found themselves in desperate straits in New York. In recent years, the Society has extended its reach to include people of Commonwealth descent. With approximately 800 members, the Society provides an influential network to expatriates and anglophiles and hosts several events each month." The Duke of Gloucester (Pilgrims Society) is the patron of the St. George's Society, and it does have a sprinkling of other members of The Pilgrims in its [management](#) such as Sir Peter Westmacott, current British Ambassador to America, whose wife inherited an opium

based fortune. Westmacott was profiled in number [12](#) Silver Squelchers---



He's a member of the National Society of the Sons of American Colonists is just a young tyke as such groups go, tracing to 1956. Its chief, called Governor [General](#), is Charles C. Lucas, a Pilgrims Society member who we will review towards the end of this series under royalty and nobility. It has another official named Alexander N. J. K. J. R. Bannerman! Other officials, especially Barry Howard, are prospective members of The Pilgrims. This is another case of a group's management run by Crown loyalists whereas it is ostensibly patriotic! The rank and file members are being fed subtle doses of globalism under the guise of patriotism; in this case, probably drum beating for more overseas wars---



National Society Sons of the American Colonists


At [Wiki](#) we read of his next membership--- “The Society of the Sons of St. George, established at Philadelphia for the advice and assistance of Englishmen in distress, was founded in Philadelphia, Pennsylvania, on Saint George's Day, April 23, 1772.”

<http://stgeorgephiladelphia.org/> This is definitely another pro-British, Crown loyalist, redcoat influence group posing as patriots!




Next Mister Charles The Pilgrim says he's a commander for the State of New York of the Military Order of the Stars and Bars (founded 1938), which commemorates the Confederacy, its flag, and its cause--- (“God Vindicates” is their Latin motto). At [Wiki](#) we read--- “The Military Order of the Stars and Bars is a fraternal organization for documented descendants of men who served as commissioned

officers in the armed forces of the Confederate States of America or who are descended from members of the Confederate Congress, or any elected or appointed member of the Executive Branch of the Confederate Government.” Their start page [shows](#) men who’d be absolutely hated by Blacks---cavalry genius Nathan Bedford Forrest (first Grand Wizard of the KKK) and General Stonewall Jackson.



The National Society of Descendants of Colonial Governors may or may not be the same as the Hereditary [Order](#) of Descendants of Colonial Governors (founded [1896](#)) based in South Carolina which says membership is by invitation only. If these are two separate, parallel groups, I expect both are by invite only. Twice I visually [reviewed](#) the long list of organizations at the Hereditary Community U.S. site and never found a National Society of Descendants of Colonial Governors so; I conclude he meant to state it as the second

group. No results found for "National Society of Descendants of Colonial Governors" was the Google message.




Most Colonial Governors were Crown loyalists!

Next we notice the National Society of [CAR](#) (Children of the American Revolution) in his near-boundless list. [CAR](#) is at 1776 D Street NW in D.C. ---



The Saint David's Society of New York has the below emblem at left that's not a red chili pepper but a drawing of a dragon. It was founded in [1801](#) and today claims 311 members. It appears to be descendants of Welch immigrants who became wealthy in the New World---



The Saint [Andrews](#) Society of New York was [founded](#) in 1756. "The Saint Andrew's Society of the State of New York is the oldest charitable institution in the state of New York. The organization was founded in 1756 by Scotsmen in New York City who were looking to "relieve the distressed." It was named for the patron saint of Scotland, Saint Andrew. Past presidents of the venerable society include Philip Livingston, William Alexander (the "Earl of Stirling"),


Andrew Carnegie and Ward Melville.” More specifically, it was founded to help Scots who were known to be Crown loyalists. The Livingstons are genealogically [woven](#) into more Pilgrims Society families than any other I’ve encountered and I expect that to stand. Carnegie was a member as of the 1914 roster or earlier, and Ward Melville (1887–1977) was in The Pilgrims 1957, 1969 and 1974. Melville Corporation was renamed CVS Corporation in 1996 and in 2013 had revenues of \$126.7 [billion](#) and 208,000 employees. Melville in The Pilgrims 1974 with Mellon, who was many times wealthier than him, and Melton, who was head of Dean [Witter](#) Reynolds on Wall Street---




M.H. Charles is the registrar-general of this group [founded](#) in 1883, described elsewhere, and is a member of its Pennsylvania state division---




The Order of Americans of Armorial Ancestry had as its national [leader](#) (“President General”) during 2007–2009 Charles C. Lucas Jr. (Pilgrims Society). “Armorial” has to do with heraldry as long

established in England, family groups, coats of arms, shields, military insignias and weapons---



This one is about people with ancestors who were [tavern](#) operators before July 4, 1776---before that date, as this is another indication

of a British sympathizing group, or at least its leadership and most prominent members. Just reading about this one makes you feel like you're watching a "Daniel Boone" re-run episode with Fess Parker butting heads with redcoat soldiers---



Get some oatmeal going on the stove! The Descendants of Early Quakers only dates to 1980 but their interests far longer than that. I haven't reviewed the [officers](#) to see if globalist penetration has occurred, but Mister Charles is certainly a globalist---



The Society of Colonial Wars we discussed in the profile on John Milnes Baker. M.H. Charles, Pilgrims Society, is a member of the group's managing council. The next pie M.H. Charles has a finger in is the Colonial Society of the Acorn. Sidney Hughes (1922–2007) who was a [member](#) of The Pilgrims, states that his father and grandfather “endowed” the Colonial Society of the Acorn. Info on him is scarce but you may be sure he wasn't a minimum wage type. We [find](#)---

“The Colonial Order of the Acorn is an invitation-only hereditary organization for those that are a descendant, in the male line, of a forefather resident of the American Colonies prior to July 4th, 1776.”

See? Again we see they want to have members who didn't revolt against the British Crown. The [SAR](#), Sons of the American Revolution, was founded in 1889. Based in Louisville, Kentucky, the SAR has membership [restrictions](#) and limitations, but less so than

many of these other groups. In their list of famous men who've been members of SAR, I noticed over ten Pilgrims members---there have been many more than that. <https://www.sar.org/>



The Colonial Society of Pennsylvania has this [info](#)--- “Membership in the Colonial Society of Pennsylvania (established in Philadelphia in 1874) is limited to males over the age of twenty-one descended from a male or female who settled in any colony of America (now the United States) prior to the year 1700. Membership in the organization is limited to 300 persons.”

This one is also interlocked with The Pilgrims. As an example, from page 176 of the 1966–1967 Who’s Who in America---

The General Society of the War of 1812 is probably the most outrageous of Mister Charles memberships, as the War of 1812 was a serious attempt by England to retake us militarily; whereas, as a member of The Pilgrims, he represents Royal family intentions to rule us again, openly some day in the future. Had we renewed the charter of the first United States Bank instead of allowing it to expire in 1811, the war would have never happened---all other causes of the war are vastly subsidiary to that. Bought off historians don't say anything about the expiration of the bank's charter as a cause of the British invasion. [Founded](#) in 1814, I am sure that General Andrew Jackson approved the idea of this group and may even have been a member, but he'd have not liked British activists penetrating it. Nicholas Donnell [Ward](#), Pilgrims Society, was during 1984-1987, the "Presiding President General" of this group. We'll review Ward near the end of the SS series---




National Society of Sons and Daughters of the Pilgrims is of course a reference to the historical pilgrims of the early 1600s. It was organized in [1908](#) and appears fairly benign however, the presence of Mister Charles is a signal that an infective process is transpiring---

The SDCC was [founded](#) in 1933 and states--- “An applicant must have a proven lineal, lawful descent from a clergyman who was regularly ordained, installed, or settled over a Christian church within the limits of the thirteen colonies prior to July 4, 1776, and must be acceptable to the National Council of the Society.” Here’s another group insisting on having ancestry before the Declaration of Independence. Some clergy were likely opposed to the

Revolutionary War. It's based in Medfield, Massachusetts. Several dozen clergymen, primarily Episcopalian or Anglican Church of England, have been Pilgrims members since its founding. They're very involved with the "ecumenical" (globalist church) movement. No, I don't see that they're acting for the Pope, as this is a Royalist organization!



The American Priory of the Order of Saint John of Jerusalem (American branch) is something we've discussed elsewhere. It's an old hereditary order dating back to that part of the Crusades to the Holy Land which originated from England and France, especially those parts of France which became Protestant. This group is also headed by the British sovereign and has at least several dozen Pilgrims as members at any time and appears to be among their more important interlocks. They state at their [site](#)---

"The Priory in the USA is the official branch of the Order of St John in the United States. The Order of St John is an order of chivalry and a major international humanitarian charity accredited to the United Nations, the branches of which provide health care and first responder services in over 40 nations around the world."

It does sound good, but so does the Red Cross and it has scandals. Nothing with The Pilgrims Society in close proximity can be trusted. This link mentions the [Crown](#). It's an invitation only thing and has a [member's](#) only log-in. Don't mix this one up with anything featuring the [words](#) "Knights of Malta" or "Order of Malta," which are absolutely Roman Catholic. The one Mister Charles belongs to is a Royalist headed crusader order. Hopefully this clarifies; however we must add that J. Peter Grace (Pilgrims 1969) was the head of the Knights of Malta in the USA---an openly Catholic group, headed by a man who was not public about his membership in The Pilgrims (Royalist group!) Actually the Knights of Malta, Order of Malta, does happen to be the Vatican counterpart to The Pilgrims, sponsored by the Royal family of England. The Pilgrims has around 1,400 members at last info and [Malta](#), 13,000. I began with no bias towards either group. I consistently find strong indications that the balance of power is with The Pilgrims.

The OSJ (British) in the USA is at 1850 M Street NW in DC---




You see the Royal symbology showing the Crown over this group---



M.H. Charles is a member of the elitist Lansdowne Club in London, already described in the previous profile on Pilgrims member David Burnham. The Knights Templar have a [website](#) with a [FAQ](#) page. They also are a group with a very long history with roots in the old Crusades. In fact an entire book could be done on the Templars,

and many have been. The hit TV series, “The Saint” had the hero named Simon Templar. The Templars and Protestant Free Masonry in general has long standing conflicts with Catholicism and vice versa. However, the Templars [started](#) as loyal to the Pope. In 1314 thousands of Templars were [executed](#) in France. You can certainly find those who will say the Knights Templar (all Masons) are at the top of the world heap. I can’t buy it however; they do have significant interlock with The Pilgrims--- (symbols at the Knights Templar site) ---



The [CCNY](#) is primarily Episcopalian. We [read](#)---“The Church Club of New York was established in 1887. It was incorporated six years later, in 1893. Founding members included banking magnate J.P. Morgan as well as Nicholas Murray Butler, Cornelius Vanderbilt, John Jacob Astor, Eugenius Harvey Outerbridge as well as the Rockefellers, Roosevelts, Satterlees, and the Van Rensselaers.”

These names were in The Pilgrims Society. Outerbridge, a manufacturer in the [railroad](#) industry, was first president of the Port of New York Authority.



The Church Club of New York

Organized 1887 / Incorporated 1893

The Ponte Vedra Club in Florida is named after a city in Spain by a similar name which means “Glass Bridge.” It’s one of only 30 “[Five Diamond](#)” resorts in the U.S.---



The Sovereign Military Order of the Temple of Jerusalem says of [itself](#)--- The Sovereign Military Order of the Temple of Jerusalem, Inc. is an autonomous and independent organization, incorporated in the United States, which seeks to emulate the chivalric and charity traditions of the original Templars; its members apply themselves energetically and selflessly to Christian charitable endeavors. We are a modern Christian Order of Knighthood. We are the Modern Knights Templar, an Ecumenical Christian and Chivalric charitable Order. We do not claim a direct lineage to the original Knights of the Temple. The Order is ecumenical; it does not restrict membership

to a single Christian Church. The Sovereign Military Order of the Temple of Jerusalem, Inc. (also referred to as SMOTJ) is not associated in any way with Freemasonry.”

It has strong similarities with other groups he belongs to, especially the Order of Saint John. It says it isn't Masonic, but many of its members---including himself---are Masons. These disclaimers are so lame! He is a “grand officier” in this group (note the French spelling “officier”) ---



Next he mentions he's a 32nd degree Mason. As for the double headed eagle, “There are many meanings [attached](#) to this symbol.” In 2013 there were 1,246,241 [master](#) Masons in the U.S. as far as 32nd degree, I assume the number is less. Masonry is understood to be linked to Protestantism---



His New York office is at 420 East 58th Street---



This concludes the review of details in Mister Charles scan. Now we'll review other details found on him from the web. The National Gavel Society (founded 1963) has as its current president Nicholas Donnell [Ward](#)---a member of The Pilgrims to be profiled near the end of this series. "Members of the National [Gavel](#) Society are the present and past highest governing officers of recognized hereditary societies or orders in the United States of America that honor significant milestones or events in the history of the country prior to the 28th of July 1914." That date is when World War I is considered to have started---



M.H. Charles is a member of the Order of Indian Wars of the United States. This is a very interesting and surprisingly important group which we will discuss in the closing section of this research. I guarantee it to be interesting!



The [Veteran](#) Corps of Artillery of the State of New York “is an American historic militia organization founded at the end of the American Revolutionary War for the purpose of preventing another British invasion of New York City.” It was [founded](#) in 1790. It’s ironic that its leadership was penetrated by British royalist sympathizers---that’s what The Pilgrims organization is explicitly about---masquerading as members of patriotic groups. John Ross Delafield, of an extremely prominent family in The Society, was an early 20th century leader of this artillery group and below see his name in The Pilgrims 1924 list (along with members of another Pilgrims Society family [involved](#) in magazine publishing, sewing machines, the bicycle industry of the 1890s and a Presidential run).

The Delafields were prominent in the founding of the Bank of America---



“The Society of the Order of the [Southern](#) Cross was founded in 1863 “as an organization to provide for the relief of disabled soldiers and the widows and orphans of those who had died in service to the Confederacy, today the Order of the Southern Cross serves as a philanthropic organization whose purpose is the preservation of our Southern heritage and its history. The original founders of the Order of the Southern Cross, Lt. General Leonidas Polk, Major General Patrick Cleburne and Reverend Charles Quintard had hoped that the organization they were creating, “The Order of

the Comrades of the Southern Cross” would help relieve the soldier’s anxieties as to the suffering of their families, enabling them to rededicate themselves once again to the great battles that lay ahead for the Army of Tennessee. Today, the main purpose of the Order of the Southern Cross is to provide financial assistance to qualified groups through its Grants Program and to offer scholarships to college bound students.”

M.H. Charles is therefore involved with societies commemorating both sides of the Civil War!



THE SOCIETY OF THE ORDER OF THE SOUTHERN CROSS

“The Society participates in many community activities to perpetuate the history of New [Netherland](#), with emphasis on the settlement of Fort Orange, later called Beverwijck, and the Colony of Rensselaerswijck prior to 1664.”

This group has old-line wealthy Dutch colonial land grant inheritors from 17th century origins and has an interlock with The Pilgrims Society---




Mister Charles says he's a "Councilor General" of the Society of the Descendants of the Founders of New Jersey (founded 1982) it [traces](#) historically to 1618---



The Order of [Descendants](#) of Colonial Physicians and Chirugiens (French---surgeons) is "An organization to identify and honor the memory, the courage, devotion and endurance of the Colonial

Physicians, Chirugiens and Licensed Midwives, who dedicated their lives and gave their services during the Colonial period of our country from 1607 through 1783.”

This group was [founded](#) in 1974 and may be of more than passing interest, considering that the medical industry is, or portends to become, the biggest industry of all. No wonder as to the movement to make vaccines by force! Pilgrims Society owned hospitals and Pharma interests demand it!



The Sons and Daughters of the Colonial and Antebellum Bench & Bar (period of 1585 to 1861) was [founded](#) in 1994 "to identify and honor the memory of our ancestors who served as judges or lawyers in what is now the Continental United States; to collect and preserve records and documents pertaining to the history and genealogy of these ancestors" and a few other points. [Here's](#) an official of this group with another long list of interlocking groups. A group like this may have quite a history. There may for instance have been judges who ruled in favor of banks as during the so-called "free

banking period” from 1837 to the start of the Civil War, and lawyers who defended corrupt practices---



The National Society of Sons and Daughters of Antebellum Planters uses Latin for inscription. It was [founded](#) in 1997 “to identify and honor the memory of ancestors who were planters within lands today comprising the 48 states of the continental United States between 1607 and 12 April, 1861.”



“The Naval [Order](#) of the United States was established in 1890 as a hereditary organization in the United States for members of the American sea services. Its primary mission is to encourage research and writing on naval and maritime subjects, preserve documents, portraits, and other records of prominent figures, deeds and memories, of American naval and maritime history.”

Besides Mister Charles, I’ve noticed other Pilgrims members over many years were also members of this. In fact at the last link I notice a list of notables who were members and The Pilgrims have been amply represented---



Oh dear me! I posted a forbidden symbol! But how can history be remembered if we do away with so many symbols? Mister Charles is a regional official of this 30,000 [member](#) group---



The Burns Society of New York was [founded](#) in 1871 to commemorate a famous Scottish poet. You must wonder about some of these groups M.H. Charles claims membership in---are

there some he devotes nearly no time to? Did he become a member of some of them as a way to get business? Probably so; however, it appears his ancestry suggests considerable real estate holdings. The next one is way more meaningful. It's about [Americans](#) who've been honored by the management of The City of London (the "centre" of 24 hour international banking time) as "Freemen of The City." Not all such are Pilgrims members in either branch, however there is a strong interlock---



The Honourable Company of Freemen of the City of London of North America

Mister Charles is a member of, and holds various positions in, the Saint Thomas Episcopal Church of Fifth Avenue in New York, [founded](#) in 1823. This building was completed in 1914. During 1824–1827 it was led by a relative of the awful Roosevelt family. “In the wake of the terrorist attacks of 11 September 2001, Saint Thomas Church reached out to the British expatriate community in recognition of its Anglican heritage. This culminated in an interfaith

service held at the church on 20 September 2001. The service was addressed by Prime Minister Tony Blair and broadcast live in its entirety throughout the United Kingdom. On 28 October 2002, the rector of Saint Thomas Church, the Reverend Andrew C. Mead, was made an honorary Officer of the Most Excellent Order of the British Empire (OBE) by Her Majesty Queen Elizabeth II. The honor was conferred at a ceremony at the British Embassy in Washington.” Blair and The Queen are of course, Pilgrims---the Queen since 1952!





The Guild of All Souls (American branch) [founded](#) in 1873 is “an Anglican devotional society dedicated to prayer for faithful departed Christians.” In the case of Pilgrims Society members, do they get prayed for that they won’t be in hell for leading the globalist movement? ---



The Society of King Charles the Martyr---



Here's something from the English branch (head office) and Lord Nicholas **Windsor** is almost certainly a member of The Pilgrims of Great Britain in London. In January 1649 King Charles I of England was executed by beheading. It happened at the end of the English Civil War. There's a great deal of historical intrigue in this.

"Founded in 1894, the Society's stated purpose was "intercessory prayer for the defence of the Church of England against the attacks of her enemies."



The Society of Mary is an Anglican group using old Tudor English in its meetings. It was in Tudor England that the Pope's hands were slapped away from levers of power in England, by King Henry III and

Elizabeth I, who was in power when the Spanish armada invasion of England in 1588 catastrophically failed. The Act of Settlement of 1701, still [in effect](#), prevents any Catholic from ascending to the throne of England---



The Confraternity of the Blessed Sacrament is another of Mister Charles religious dabbling activities, though he may spend scant time on it due to his large galaxy of memberships. It's Anglican [Church](#) of England, USA Episcopalian. However there is some intrigue here as fence-straddling is taking place with [Rome](#).






M.H. Charles belongs to the New York City Masonic Independent Royal Arch Lodge #2 which has been around for [over](#) a century. Below you see the symbol of the RAM Masons under an image of Mister Charles. This lodge is [connected](#) to the United Grand Lodge of England which has over 200,000 [members](#) in 6,800 branches. Grand Master of the English Masonic group is His Royal Highness (HRH) The [Duke](#) of Kent. The Duke of Kent is mentioned three times in "The Pilgrims of Great Britain," (2002, [short](#) run book) that is an earlier Duke, but you can absolutely count on the present Duke continuing that situation. The RAM Masons are not run of the mill

Masons. I don't know how many less there are of RAM versus ordinary Masons, but the [documentation](#) is adequate that if an RAM Mason has committed "murder or treason," he must be protected by secrecy in court by other Masons. That is to say, this protection is expected to be extended to RAM Masons by other RAM Masons. Yet, since this is a much higher level of Masonry than rank and file, how could they advance unless they also tow that line? Masonry makes me queasy and The Pilgrims Society absolutely frightens me---



As if to satisfy his drive for influence spreading, Mister Charles is also a member of the Ancient Chapter, Royal Arch Masons, New York City.



The Duke of Kent, Pilgrims Society, top Mason in England, Ireland, Scotland and Wales and [heir](#) of many European Royal dynasties---



A search for “Long I Grotto Valley of New York” found no results. It’s part of the Masonic mish–mash Mister Charles is involved with. In case you’re wondering, are most members of The Pilgrims Society also Masons? No, most definitely are not and it appears that fewer than ten percent are and maybe under five percent. Just enough for control or influence! He’s in the Columbian Council of Cryptic Masons of New York City which is a member of <http://www.nycryptic.org/> The Grand Council of Cryptic Masons of the State of New York. At https://en.wikipedia.org/wiki/Cryptic_Masonry we read--- “Cryptic Masonry is the third part of the York Rite system of Masonic degrees, and the last found within the Rite that deals specifically with the Hiramic Legend. These degrees are the gateway to Temple restoration rituals or the Second Temple Legend. The body itself is known as either the Council of Royal & Select Masters or Council of Cryptic Masons depending on the jurisdiction.”



The Morton Commandery of Knights Templar of New York City was organized in [1823](#). Their motto in Latin, “In Hoc Signo Vincas Non

Nobis Domine Non Nobis Sed Nomini Tuo Da Gloriam” means “In This Sign Conquer Not Unto Us Lord But to You be the Glory.” Their outlandish artistry is [here](#) showing quarter moons, Maltese crosses and an unidentified symbol.



The [Paumonock](#) Council of Knight Masons of New York City is in Garden City, New York---another of his porcupine quills. The Quatuor Coronati Lodge #2076 of London has a name meaning “The Four [Crowned](#) Ones,” that’s another unsettling item! It was [founded](#) in 1884 and dedicated to “Masonic research”---

Mister Charles the very busy Pilgrims Society member is a member of the Royal Order of Scotland in [Edinburgh](#) in which “membership is an honour extended to Freemasons by [invitation](#).” We notice “the order has existed since at least 1741.” They [have](#) a corresponding lodge in Pennsylvania.



Mister Charles is a member of the Saint Augustine Florida Yacht Club was founded in [1873](#) by men who were leaders in the Southern effort of the Civil War. I wonder if they acquired land for gold in 1873 after Congress legislated that no mortgage payments could be made in silver in any amount greater than five dollars! The Crime of '73, organized by London money powers in collusion with those in the United States who later organized The Pilgrims Society, caused indescribable suffering as countless middle class families suffered unjust foreclosures and were forced into poverty! The former

chairman of the Saint Augustine Yacht Club is a member of the same hodge-podge of [ancestral](#) lineage groups that Mister Charles is active in.




Mister Charles has membership in the Royal Scottish Automobile Club of Glasgow appears to not have a [website](#) but it definitely has an HQ---





Progressing through the list of groups Mister Charles is a member of but failed to so state in his scan, we next encounter the National Society of Descendants of Colonial Governors (Honorary Governor General) appears to not have a website. [Elsewhere](#) we find “membership is available to those men and women who are lineal descendants of those men who, prior to 1775, singly exercised supreme executive power in the American Colonies, authorized as a Colonial Governor or Acting Governor. Membership is by invitation only.” This one was [founded](#) in 1896. Colonial governors, Dutch and English but mostly English, were in a position to award huge tracts of land to others and presumably to themselves. How much land ownership does this Pilgrims Society interlocked group have as of the present? Notice the Crown symbol in their emblem. I submit that members of this group today are covert British loyalists, same as members of The Pilgrims---




Mister Charles is a member of the Council of the Saint Nicholas Society, which Dutch hereditary group we've already described. Other groups he holds membership in and is an official of, which groups have also already been described, include the Saint George's Society of New York; Huguenot Society of America; Order of Americans of Armorial Ancestry; National Society of Sons and Daughters of the Pilgrims; American Priory Order of Saint John of Jerusalem; Sovereign Military Order of the Temple of Jerusalem; and the Hereditary Society Community, of which he is a director (they show a gene strand in their emblem) --- the gene strand assures they are "qualified" to subtly control the country, led by the greatest genealogical society ever---The Pilgrims Society---

A significant number of architects have been on the roster in both Pilgrims branches for its entire history. This would be because the Society wants to control the urban landscape---to shape the future---to occupy buildings designed by members---and to profit from the designing of major buildings. I believe I can find some of these architects who didn't need the occupation for income as they were born into wealth and married more wealth. AQ study of which big city buildings are attributable to these members would be very revealing of their impact!



John's brother, Allan Griffin Baker Jr., was as of a 1985 news [item](#), president of Financial Marketing Services of New Canaan, Connecticut. John's niece married an MD, who was the son of the president of F.D. Rich Housing Corporation in Stamford, Connecticut, whose father was associated with the Journal of Commerce in New York. J.M. Baker's parents were listed in the "New York [Social](#) Blue Book," 1930. J.M. Baker's son, Ian [Archbald](#) (correct spelling; not Archibald; born December 10, 1957) has info---

"Ian Archbald Baker, explorer, educator, writer, photographer. Achievements include leading Natl. Geographic Society expedition into Tsangpo Gorge's previously unexplored section and documented and measured 110' high falls that had previously been only subject of speculation. Named it Hidden Falls of Dorje Phagmo, 1998. Field work Explorer's Club New York , India, Sikkim, and Nepal, 1981-1982; academy director semester abroad programs School International Training, Brattleboro, Vermont, 1983-1990; freelance writer, photographer, since 1993; Tour leader Smithsonian



Ian is a member of the Saint Nicholas Society (his father is a former president of), the Colonial Lords of Manors (his father was a vice president of the CLM as of 2014) and the Explorers Club---groups with long standing Pilgrims Society interlock. We discussed the Saint Nicholas Society elsewhere---a hereditary organization of old-line wealth tracing to Dutch who received large land grants in colonial America centuries ago. The Colonial Lords of [Manors](#) which operates out of post office box 269 in Roxbury, Connecticut 06783 is a membership by invitation only group for those who can prove ancestry to large landowners in New Netherland or New York back in

the 1600s. The CLM is another royalist group and is well interlocked with The Pilgrims. How much land its owners possess today is unknown, but is likely to be of scandalous extent were the “private” details known. This CLM document referencing the Van Cortlandt family (Pilgrims Society represented) alludes to their centuries old land holdings---

The Pells, an old-line New England dynasty, are also Pilgrims Society represented and Senator Claiborne Pell, inheritor of several fortunes including Lorillard Tobacco, appeared in The Pilgrims 1980 roster. The Senator, a big sponsor of the Silver Users Association, voted [for](#) the 1965 Coinage Act, deleting most silver from our coinage---



The explorers Club is discussed in another profile elsewhere in this series, under Mr. Mosse (Pilgrims Society). Having had a once-over of one of Baker's kids, we now return to J.M. Baker himself. His second wife, Elizabeth Jennings Morrison, was [mentioned](#) in the Princeton University Alumni Weekly, having a father a man with the unusual first name of **BARC** Morrison! I find only one other

reference to her [here](#) which mentions “Pilgrims” as one of his memberships, presented as a club---which it is in a secondary sense; primarily, it’s a society (more profound than a club).

Another son, James [Morrison](#) Baker, appears to be a D.C. based manager with Deloitte, founded in London in 1845. This is an accounting firm with, believe it or not, over \$34 [billion](#) in annual revenues. His other son, Hayden [Sheffield](#) Baker, is an attorney in David, Polk & Wardwell, probably among the top five Pilgrims Society law firms in New York, and having an astonishing history. Hayden has a better chance of being invited into The Pilgrims than his brother.

J.M. Baker was with the firm of Sir Basil Spence in London in 1960–1961. Spence’s name isn’t in The Pilgrims 1957 or 1969 lists. Spence was born in [British](#) India in 1907 and his father was an assayer for the Royal Mint. 1962–1964 saw J.M. Baker with Rogers & Butler architects. No trace of them in Pilgrims lists. Information isn’t complete however. Pruyn Architects (1965–1966) also shows no connection. It had [five](#) building projects totaling 1,238 feet of stories.

Let’s flash back to J.M. Baker’s first wife---Virginia Lea Busser. At this [link](#) we find her name associated with that of the [Pennock](#) family---an obscure name. The 1980–1981 Who’s Who in America, page 1713, shows (my volume, neon color added) ---

Connection? Almost certainly---this is The Pilgrims Society, history's greatest genealogical roster. We won't digress too far into the link of Virginia Busser, J.M. Baker's first wife, to this Pennock family, besides to show [this](#)---

"The Pennock family in America is descended from Christopher Pennock. According to tradition he was an officer in the service of **William of Orange**, and fought in the Battle of the Boyne in 1690. The victory of the forces of Orange on this day ended forever the reign of the Stuarts in England, and assured the English speaking world a regime of tolerance, and the end of Catholicism as a dominant political force. The histories agree that Christopher Pennock came to America about the year 1685, and settled in Pennsylvania.. He received a deed to 2000 acres of land in Chester County."

William of Orange, also known as King [William](#) III of England (1650–1702; reign 1689 to 1702) was the offspring of English and Dutch royalty. Again we find a connection in Pilgrims Society genealogies to historical royalty. These many links cannot signify nothing. Is there a group higher than the bankers? Notice that David Willard Pennock Jewitt was a member of two “royal” yacht clubs! To return now to J.M. Baker. His scan shows him president of J.M. Baker Houses Inc. and this [link](#) says it was a corporation based in New York that was active from 1985 to 1992. He resides in Connecticut---which he may have during those years. Did his home building company, or home designing enterprise, transfer from New York to Connecticut in 1992? This isn’t apparent. His scan presents this item as if it’s a current activity. At <http://www.johnmilnesbaker.com/> we find he’s still active in the field---

“John Milnes Baker, AIA is an award-winning Connecticut architect who is also licensed in NY, NJ, MA, MD, RI, TX, NC, SC, VA & PA and specializes in Residential Design: Remodeling, Alterations, Additions, and Historic Preservation.”

“John Milnes Baker's residential projects [number](#) well over five-hundred.”

As seen in his scan, his personal residence in South Kent, Connecticut, at 76 Spooner Hill Road, he named “Rathedon.” Here are some [views](#) of Rathedon. He shows descriptions of [15](#) other upscale homes. Some may be for other members of The Pilgrims. I

expect all these are owned by persons in the “orbit” of The Pilgrims organization. [Here](#) is Baker wearing one of his society medals and his other regalia, which enable him to strut while seated!

His next credential is as adjutant professor at the New School for Social Research in New York. Current trustees include attorneys from Shearman & Sterling and Debevoise & Plimpton---major Pilgrims Society law firms---

Next he mentioned a book of his about his family and another apparently related family. The genealogical revelations might be significant. “Past trustee N.Y. Revels Inc.” This group promotes traditional holiday [celebrations](#). Is there any globalism in their mix? He’s also a former trustee of the Bedford (New York) Free library. Globalists associate with libraries so as to intentionally slant library content towards globalist notions. Between 1883 and 1929, a total of 2,509 Carnegie [Libraries](#) were built as a globalist “education” plan of Andrew Carnegie (Pilgrims 1914) ---



The Katonah Historical District Advisory [Commission](#), another of Baker's former activities, covers an area that encompasses the Bedford Free Library and he is a consultant to the town of Bedford and a member of its Historic Buildings Preservation Commission. His architectural designs have been featured by Better Homes & Gardens---



During 1989 to 1990 three designs by J.M. Baker were chosen by the United States Information Agency to be included in a tour of Russia. Was there anything deeper than this? I'd guess so. In [1999](#) the USIA was merged into the State Department---




J.M. Baker is a member of the AIA, American Institute of Architects, today has 83,500 [members](#) and is [based](#) in D.C. ---



John Milnes Baker, Pilgrims Society, is a member of the National Council of Architectural Registration Boards in D.C., an influential organization---

“The National Council of Architectural Registration [Boards](#) (NCARB) is a nonprofit corporation comprising the legally constituted architectural registration boards of the 50 states, the District of Columbia, Guam, Puerto Rico, and the U.S. Virgin Islands as its members. Its mission is to protect the public health, safety, and welfare by leading the regulation of the practice of architecture through the development and application of standards for licensure and credentialing of architects. NCARB recommends model law, model regulations, and other guidelines for adoption by its member jurisdictions, but each makes its own laws and registration requirements. As a service to its members, NCARB develops, administers, and maintains the Intern Development Program (IDP)

and the Architect Registration Examination (ARE) as well as facilitates reciprocity between jurisdictions through the NCARB Certificate.”



Baker lists himself as a panel member of the American Arbitration Association---a fairly important position. Many people and businesses turn to arbitration rather than court litigation. Arbitrators can wield substantial influence. Founded in [1926](#), in 1996 it [founded](#) as a subsidiary the International Centre for Dispute Resolution with offices in New York, Mexico City, Dublin and Singapore.



Founded in 1940, the Society of Architectural Historians has 3,500 members. Its Chicago address is indicative of Pilgrims Society influence---1365 North Astor Street on Chicago's "Gold [Coast](#)" by Lake Michigan. The "Astor Street [District](#)" is the highpoint of that area. The Astors (Pilgrims Society inner circle) developed so much of Manhattan, and other cities, for certain they'd have had many architects working with them, and many of these buildings are considered historic.


The fact that J.M. Baker is a former president of the Saint Nicholas Society and a former trustee of the [Holland](#) Society suggests that he was admitted into The Pilgrims before attaining these positions, as The Pilgrims became the management of at least hundreds of organizations.

“Membership is by [invitation](#) only and limited to those men who can demonstrate descent from a resident of New York State before 1785” (in the Saint Nicholas Society). Charles W. [Neuhauser](#) Jr., first vice president, is a confirmed member of The Pilgrims and will be profiled in the final item in this series, regarding royalty and nobility. Others in management of the Saint Nicholas Society I regard as strongly prospective as Pilgrims members include W. Wells Van Pelt Jr., Peter S. Schermerhorn, and Douglas Wright III. The Van Pelt name has appeared in the genealogy of other known members and on [Wiki](#) we find---“The Van Pelts of Van Pelt Manor were part of a group of interrelated landowning families that included the

Cortelyous and the Lefferts, among others. The full extent of concentration of wealth in the old-line Dutch families is obscured by the intense intermarriage.”







Scandrett, one of the most prominent New York attorneys ever, was a director of Coro Gold Mining Company and on the executive

committee of the National Republican Club and many other positions (1940–1941 Who's Who in America, page 2274).



A significant overlap of membership exists between the Saint Nicholas Society and the Holland Society. Most members aren't Pilgrims also, only selected individuals---



This 2005 reprint makes no [mention](#) of The Pilgrims. The Order of F & P was founded in 1896. At their [site](#) you see a view of Pilgrims Society member Charles C. Lucas Jr., who will be profiled in the final section of this research, a two part discussion of Pilgrims members descended from royalty and nobility. To become a member, the

first qualification is to show you're "lineally [descended](#), in the male line of either parent, from an ancestor who settled in any of the colonies now included in the United States of America prior to May 13, 1657." There are limited other ways to join, but that's their main emphasis---they want persons descended from colonial leaders, not common folk. I do dispute their actual objective is patriotism---that's only a veneer. It's another British Crown loyalist group under covert Pilgrims Society management! [Wiki](#) states, "Its strict bloodline mandates and small size (currently less than 1,000 members), has earned it a reputation as the most exclusive lineage society in the United States." Actually, The Pilgrims Society is the most exclusive lineage society! But the difference is that men often become Pilgrims without significant ancestry. They successfully accumulate huge holdings and eventually are invited to join. Some have probably joined due to fear of retaliation if they didn't join!

"Membership in the Society of Colonial Wars is by [invitation](#) only." Founded in 1893, it has around 4,600 [members](#) and is interlocked with The Pilgrims Society in at least several dozen men. It's another British loyalist group masquerading as patriotic Americans. Wiki has a [list](#) of notable members of the SCW, and does not note that the following names in that list were also Pilgrims members---Robert W. Bingham (married into the Flagler portion of the Standard Oil

fortune; became Roosevelt's Ambassador to England in 1933; owned the Louisville Kentucky Times and the Louisville Courier Journal)---Chauncey Depew, Senator from New York 1899-1911, attorney for Vanderbilt (Pilgrims Society) railroads---Douglas Dillon, second generation Pilgrims member, chaired the Rockefeller Foundation and as Secretary of the Treasury, took America off silver coins, as authorized by the Coinage Act of 1965---



Notice that the years 1607-1775 were mostly times in which wars were against other than England in the colonies (excluding the Anglo-Dutch conflict of 1664) ---



Baker mentions membership in “Corinthians,” (Seawanhaka Corinthian Yacht) an important focal point for elitists to converge, and well interlocked with The Pilgrims. 


