

In case you missed number [28](#), we discussed Tom Kean, who chaired the 911 Commission (pages 57–74); he qualifies as a neocon, a warmonger and in intelligence.

1) Tony Blair, Anthony Charles Lynton Blair (1953---; Pilgrims Society as of [undetermined](#)) has a [wife](#) named Cherie and “a small flock of hens to provide daily fresh eggs,” presumably so he can add a tiny sum to his burgeoning fortune. Blair was British Prime [Minister](#) (1997–2007), leader of the Labour Party (1994–2007) and Shadow Home Secretary (1992–1994). About this Shadow Home

Secretary we [read](#)--- “In British politics, the Shadow Home Secretary is the person within the shadow cabinet who 'shadows' the Home Secretary; this effectively means scrutinizing government policy on home affairs including policing, national security, immigration, the criminal justice system, the prison service, and matters of citizenship. If and when the opposition party is elected to government, the Shadow Home Secretary often becomes the new Home Secretary though this is not always the case.” During 1989 to 1992 Blair was Secretary of State for Employment and during 1988 and 1989 he was Shadow Secretary of State for Energy. During 1983 to 2007 Blair was a Member of Parliament for Sedgefield. He has an older brother, Sir William James Lynton [Blair](#), who is a High Court Judge in the Queen’s Bench Division. He was of course appointed by Queen Elizabeth II, royal patron of The Pilgrims Society. I have no info as to whether Blair’s judge brother is a Pilgrims member. If not he’d certainly be in their orbit. During 2001 to 2008 the older brother was chairman of the Financial Services and Markets Tribunal and during 2003 to 2005 he was chairman of the Commercial Bar Association. In 2004 this judge brother of Tony Blair was chairman of the International Monetary Law Committee of the (globalist) International Law Association. During 2006 this judge was chairman of the Qatar Financial [Centre](#) Appeals Body. In May 2009 this career judge was co-convener of the Qatar Law Forum of Global Leaders in Law. Since 1994 the judge has held the post of visiting professor of law at the (funny money) London School of Economics. As of 1999 the judge has held

a visiting law professorship at the Centre for Commercial Law Studies at the University of London. Since 1999 the judge has been an honorary fellow of the Society for Advanced Legal Studies and according to Wiki is “an academic adviser to the Asian Institute of International Financial Law.” That last group is [interlocked](#) with giant Pilgrims Society megabank HSBC. As of 2003 the judge is licensed as a barrister (attorney) at the Eastern Caribbean Supreme Court in the British Virgin Islands. Blair, long time high official of the British government---

“Tony Blair has **amassed a personal fortune** since standing down as prime minister – often acting as an adviser to controversial businesses and regimes.”

In 2010 Blair worked out a **deal** with King Abdullah of Saudi Arabia for Blair to get **2% of business deals between the King’s son and China in regard to Petro Saudi**, run by the King’s son. Blair has **attended** meetings of the World Economic Forum.

“Former UK Prime Minister Tony Blair has signed a multimillion pound contract with a Saudi Arabian oil company to broker secret deals on the firm’s behalf with Chinese state officials, it has emerged. Tony Blair Associates, an umbrella company owned by the former Labour leader, now a Middle East envoy, agreed in November


2010 to organize deals between oil company Petro Saudi and elite Chinese officials, a leaked contract seen by The Sunday Times suggests. The deals were to be arranged during Blair's visit to the Chinese capital of Beijing in November that year. While the contract was in place, Petro Saudi reportedly paid Blair £41,000 a month to carry out these duties, and added a lucrative 2 percent cut of each successfully orchestrated agreement to the former prime minister's paycheck. Petro Saudi was reportedly informed it could not reveal Blair's role in the business arrangement without permission. Despite the firm's insistence the deal would remain shrouded in secrecy, the contract was leaked."

Petro Saudi handles the bulk sale and purchase of natural gas, liquefied petroleum gas, jet fuel, chemical feedstocks, and gasoline. We have built a diverse energy portfolio, which includes electricity, biofuels and environmental products. We continue to reinforce our offer of upstream oil and gas assets comprising large scale, high quality development and exploration projects."

“Tony Blair Associates is the umbrella organisation for our commercial operations. We work with governments on the path of reform providing advice and support on key areas of governance, modernisation and implementation. We provide geopolitical and strategic advice to multinational corporations. We bring together institutional investors with potential investment opportunities. Tony Blair's commercial activities provide important funding for his philanthropic work. Tony Blair Associates is entirely separate from

the Foundations which are independent charitable entities accountable to their own boards and trustees and subject to applicable charity regulations.”

Also at Blair’s [site](#) we discover the following---

“Mr. Blair is now leading the Breaking the Climate Deadlock Initiative, through which he is working with world leaders to bring consensus on a new and comprehensive international climate policy framework.”

Mister Obama, who as an outer circle Pilgrims member does as the Royal couple instructs, and gets orders from other members, is a big climate change fraudster. The Pilgrims Society London branch also pushes this dogma in order to boost their globalization agenda. The Climate Group, which sponsors the Breaking the Climate Deadlock Initiative, is riddled with one-worlders, and has a man with the funny name of Jonathan [BADGER](#) ---



“The Tony Blair Africa Governance Initiative helps some of Africa's most dynamic leaders deliver the change their people need to relieve poverty. Renewing Tony Blair's commitment to Africa, the Africa Governance Initiative currently operates in Rwanda, Sierra Leone, Liberia, Guinea and South Sudan advising each of the country's Presidents with a team of AGI's staff working full-time at the centre of all five governments. By combining Tony Blair's unique experience as a leader and reformer, his personal relationships with African leaders, and in-country teams of experts, the **Africa Governance Initiative** is helping to build the capacity of partners to tackle poverty and attract investment sustainably.”

The countries specified represent 10,169 square miles and population of 12 million with gold, diamonds, uranium, copper, petroleum, tin, titanium, iron, lesser known minerals and rare earths, coffee, cocoa, tea, rice, bananas and other produce as exports. Guinea alone is [estimated](#) to contain up to one half of the

entire world bauxite (aluminum ore) deposits. No wonder Pilgrims Society member Tony Blair is “interested” in these African nations. Sierra Leone officially gained independence from Britain in 1961, but apparently covert British control prevails over a half century later. And why not? The nation is a top producer of large, high quality diamonds. Naturally the independent prospectors stay poor. From Guinea, “diamonds and gold also are mined and exported on a [large](#) scale.” These countries represent 415,079 square miles and 42,321,869 population.



Blair isn't interested in relieving African or any other poverty. Pilgrims Society members cause poverty on a grand scale. Notice near the end of the above quote the word “investment.” Couple that with his assertion [elsewhere](#) that electricity development is Africa's greatest need, you perceive his utility kingpin intentions (doubtless with a raft of other Pilgrims Society members!) Blair's Africa Governance Initiative (Pilgrims Society members dictating policy to African governments) predictably is **[a vaccine pushing organization.](#)**

Blair's [team](#) represents the World Economic Forum and Imperial College of London among other globalist institutions.

“Tony Blair continues to be active in public life. He has many interests, not least his current role in the Middle East, which takes up the largest proportion of his time. Since leaving Downing Street, Tony Blair has served as the **Quartet Representative to the Middle East**. He represents the United States of America, United Nations, Russia and the European Union, working with the Palestinians to prepare for statehood as part of the international community's effort to secure peace. He has launched the Tony Blair Faith Foundation to promote respect and understanding of and between the major religions and to make the case for faith as a force for good in the modern world. The foundation creates opportunities for people of all faiths and none to come together to learn directly from each other and to take joint action on shared humanitarian goals. The 'Faith and Globalization Initiative' is a global network of leading universities, examining the role of faith in the modern world.”

Blair has [launched](#) two other companies, one named Windrush Ventures and the other named Firerush Ventures. Not only that, but [there](#) is Firerush Ventures number One---Firerush Ventures Number Two---Firerush Ventures number Three---and Windrush Ventures number One---Windrush Ventures number Two---and Windrush Ventures number Three. It sounds like he waited for a windy day to set three arson fires during which wind would be rushing! Windrush has had a **“baffling [increase in earnings.](#)”** The Gates Foundation has paid [millions](#) to Windrush. How much of Blair’s speaking and consulting fees go into buying shares in armaments manufacturers? Do they give him stock options for boosting their offerings in foreign countries?



“A very large bank [balance](#) invariably offers an entrée into his orbit.”

Blair [hosted](#) a meeting of the United Kingdom/Russia Roundtable. Blair has a consulting deal with JP Morgan Chase Bank which yields him some [unknown](#) sum. He received a \$1 [million](#) signing fee with the Washington Speaker's [Bureau](#).





Blair has [offices](#) in Grosvenor Square, which he leases from mega-billionaire Pilgrims Society kingpin Gerald Cavendish Grosvenor, the sixth Duke of Westminster, whom we will profile in a closing presentation in the Silver Squelchers series. At Blair's [site](#) however he merely provides a post office box for location! Below, the United States Embassy is among the buildings at Grosvenor Square in Mayfair district of London, owned by the Duke of Westminster (Pilgrims Society). Tony Blair's business [offices](#) are "nearby."





Blair has [connections](#) to multinational mining mega-giant [Glencore](#) with 181,000 employees. Anthony Hayward, chairman of Glencore, [and](#) John Mack, director from Morgan Stanley, are almost certainly members of The Pilgrims Society--- [“We](#) are one of the world’s largest global diversified natural resource companies and a major producer and marketer of more than 90 commodities. Our operations comprise of over 150 mining and metallurgical sites, oil production assets and agricultural facilities. With a strong footprint in both established and emerging regions for natural resources, our industrial and marketing activities are supported by a global network of more than 90 offices located in over 50 countries.”

Perhaps Blair, Hayward and Mack were positioned short Glencore shares in the last few months.

“The growth in Blair's personal [wealth](#) was illustrated in May 2008, when he agreed to pay £5.75m for the late actor John Gielgud's Buckinghamshire residence. This was in addition to the £4.45m paid earlier for a London home in Connaught Square, together with an adjoining house.”

At a recent exchange rate of 1.57 dollars to pounds, those homes represent over \$16 million. Pilgrims Society member Blair was paid \$1 [million](#) for a half hour of his time for his input into a \$36 billion “mining business takeover.”

“[Residents](#) of Wotton Underwood say Mr. **Blair lives like a superstar and that they have had to endure helicopter noise and the presence of armed police.** One family has moved out, while others claim their children have been affected. The picturesque village has been made a **designated security area under the Terrorism Act, allowing officers to stop and search passers-by and ban photography.** Mr. Blair and his wife, Cherie, are also having building work carried out. **Mr. Blair remains in close contact with world leaders.**”

A brief look at his [father](#) is justified (National Academy of Engineering document from 1991) ---

“When Eric Gross arrived in the United States in 1939, he already had earned an international reputation as a distinguished electric power engineer. By that time he had contributed significantly to

major advances in high-speed relaying and to lightening protection and grounding of high-voltage transmission networks, and had published extensively in technical journals in Austria, Czechoslovakia, Germany, France, Switzerland and the United Kingdom. Throughout his career as an educator, Eric Gross remained active as a practicing engineer; he maintained close ties with the industry; he was a registered professional engineer in Illinois, New York and Vermont and a chartered electrical engineer in the United Kingdom; he authored or coauthored more than one hundred technical and scientific papers published in professional journals around the world; he held twelve patents dealing with his inventions in the field of electric power systems protection and grounding; and he served as consultant to several major electric utility companies, equipment manufacturers, and government agencies.”

Undoubtedly Patrick Gross was born into at least several million dollars.

Patrick Gross started in defense related (“warmongering”) activities when he joined General Electric in 1965---one of the most important corporations in The Pilgrims constellation. GE being a big defense contractor, naturally he’d migrate to the Defense Department. While at Defense Gross was a crony of Robert McNamara, who went on to be president of the World Bank and appeared in the 1974 roster of The Pilgrims. American Management Systems eventually [sold](#) for around \$1.3 billion, how much went to Gross I haven’t seen, but he was the founder and chairman. He led

its growth into having 8,000 [associates](#) across the U.S. According to the Defense Business [Board](#) of the United States Department of Defense, the Lovell Group in D.C. “is a private investment and advisory firm where he works with a portfolio of venture capital backed private technology and Internet commerce companies. He is engaged by the venture investors to help the companies grow to the next stage of development and benefit from his extensive experience. Pat has been a director of more than two dozen corporations ranging from angel backed startups to NYSE firms. He has been lead independent director/presiding director of both NYSE and NASDAQ companies. He has served as chairman of the board of two private equity owned companies. He has served on and chaired audit, compensation, and governance and nominating committees. Currently, he serves on two NYSE company boards: Capital One Financial Corporation and Waste Management and three NASDAQ company boards---Career Education Corporation, Liquidity Services and Taleo Corporation.”



Gross appears to have almost a “gross” of connections---we’ll take a tour of some of these. I notice he’s a [director](#) of the Hitachi Foundation---and its chairman. It reports a modest \$25.5 million in assets. Place a lot of entities in the dozens of millions together, you get another billion of influence, and it’s long been known that foundations often “grossly” understate their holdings. The foundation is an offshoot of Hitachi Limited, a Trilateral Commission corporation based in Tokyo. Recall in this series we’ve shown the TC to be among the most important fronts operated by The Pilgrims. Hitachi [Global](#) reported 326,240 employees in 2014 in electronics, telecommunications, power plant construction, railroads, automobiles, construction machinery, digital media, financial services and more. Founding chairman in [1985](#) of the Hitachi Foundation was Pilgrims Society member Elliott Lee [Richardson](#), former U.S. Secretary of Defense and U.S. Attorney General (both in 1973); Ambassador to England (1975–1976); Secretary of Commerce (1976–1977) and a Pilgrims V.P. as of the 1980 roster. The Hitachi Foundation has disbursed over \$48 million in grants and awards. That buys significant influence, as grant recipients are likely to become globalists if they aren’t already--- then following the pattern of the entire galaxy of Pilgrims Society run foundations, these grantees are placed in posts of influence with which to weaken our sovereignty!



[Mobius](#) Management is a business software developer, possibly named after a 19<sup>th</sup> century German mathematician or a mythological personality. Sarnott Corporation I believe is a typo and should read "[Sarnoff](#) Corporation," the F and the T are keyboard neighbors. Bloomberg [confirms](#) this. David Sarnoff (Pilgrims Society) of Radio Corporation of American and National Broadcasting Company (NBC) founded it in 1942 to be involved in related fields, and several years ago it merged with another interest. Computer [Network](#) Tech Corporations is hardware and communications equipment. Evidently Gross parlayed savings to start AMS, ran it up into a big success, cashed out, and again parlayed his takings as investments in a multitude of other companies, some start ups. There also may have been substantial inherited funds. Medlantic owned one or more hospitals in D.C. involved in the acute and rehabilitative health care markets. [Baker](#) & Taylor is a privately owned book and textbook distributor with annual volume somewhere north of \$2 billion.



Capital One Financial Corporation, of which Pilgrims member Patrick Gross has been a director since 1995 and is also a member of its Risk Committee (derivatives and other investments) reported in 2013 net [income](#) of \$4.159 billion. It operates banks and credit cards especially. Why be in the silver mining business when your forerunners demonetized silver and you can be in something far more “plush”---**BANKING!** Capital One has around \$300 billion in assets and 41,100 employees. Many of you have a Capital One credit card in your wallets! The Pilgrims knew you’re there to feed off of, and didn’t announce their presence! Capital One Tower, where Gross is [called](#) “Presiding Director”---





Gross was a director of Chevy Chase Bank of which Wiki states---

Chevy Chase Bank was the largest locally-based banking company in the Washington metropolitan area. It was acquired by Capital One in 2009 and rebranded as Capital One Bank in 2010. We [read](#)---

“Chevy Chase Bank was the subject of two national class action lawsuits for violations of the Truth In Lending Act of 1968 involving as many as 7,000 mortgage borrowers. A federal district court ruled against the bank in January 2007, but the ruling was stayed pending appeal to the U.S. Seventh Circuit Court of Appeals. The Seventh Circuit Court of Appeals overturned the federal district ruling in September, 2008.”

Federal judges prone to screwing up remain in lower level courts, while the “right” judges get higher appointments! The [President](#) appoints all Federal judges, and he’s a Pilgrims Society puppet. The Wall Street Journal reported the acquisition cost to Capital One of Chevy Chase Bank was [\\$520](#) million. Gross was a [director](#) at the time. How much did this wheeling and dealing Pilgrims Society member rake in?



Liquidity [Services](#), of which Pilgrims member Gross has been a director since 2001, a much smaller interest than Capital One, but still a billion plus market cap, “provides business and government [clients](#) and buying customers with online marketplaces and integrated services for surplus assets. The company enables Global 1000 Fortune corporations, middle market companies and government agencies to maximize the value of their underutilized, obsolete and surplus industrial machinery, equipment, materials, vehicles, and inventory.”

The company is [active](#) in aerospace, defense, chemicals, oil and gas, manufacturing, pharmaceuticals, electronics, automotive, construction and other sectors. It owns [www.liquidation.com](http://www.liquidation.com) “One million businesses have used Liquidation.com to buy surplus inventory from the world’s largest retailers.” Gross, very unsurprisingly, is the “[lead](#) director” at Liquidity Services.




[Career](#) Education Corporation has over 7,000 employees, 45,000 + student enrollment and over 600,000 graduates. It owns American Inter-Continental University, Colorado Technical College, Sanford-Brown College and others. The Ripoff Report has something on [Career](#) Education Corporation---



Waste Management is "North America's leading provider of integrated environmental solutions" with over [20 million](#) customers in household, business and industrial recycling with a \$24 billion market capitalization---



[Rosetta](#) Stone, named after an inscribed stone relic discovered in Egypt in 196 BC, of which Gross has been a board member since 2006, has a market capitalization of 215 million. It offers foreign language learning systems in 30 languages. Though there's money in this field, I wonder if other Pilgrims members who are administrating the English Speaking Union, and intend English to be the official world language, look askance at this.



Taleo Corporation is a software developer with over 20 million customers which was acquired in 2012 by Oracle for [\\$1.9 billion](#). Founded in 1996, Gross became a director around six years before the buyout. How much did he pocket? Oracle itself has a member of the Seligman family (Pilgrims Society) on its board.

Also in 2006 Gross joined the board of [Bantu](#) Incorporated, “the leader in highly secure information sharing and collaboration” and

“connects all the branches of the U.S. military.” We see at its start page, “When government shares information, Bantu is there. When the armed forces communicate, Bantu is there. When the financial Industry collaborates, Bantu is there. When technology companies collaborate, Bantu is there. When health care providers share information, Bantu is there. When the educational community connects, Bantu is there.” Yes---and The Pilgrims Society is there also, backing up its claim of being “Here And Everywhere.” Image adjusted for readability---



Gross is a [founder](#) of the World Affairs [Council](#) of Washington D.C. In [1918](#) the League of Free Nations Association, founded by 141 prominent Americans (some of the Pilgrims) was set up to propagandize for America to join the British created League of Nations. The attempt failed, but the name changed to Foreign Policy Association, which in essence is identical to still another Pilgrims Society front, the United Nations Association. Gross is an [FPA](#) trustee. The Washington WAC is part of the World Affairs Councils of America and are globalist propaganda fountainheads yammering that “nation-states” are obsolete---



The Committee for [Economic](#) Development, founded in 1942, has seen quite a procession of Pilgrims Society members across the years as officials and members and has had plenty of influence on Capitol Hill---



Like so many members of The Pilgrims, Gross is or has been a trustee of one or more important hospitals, and I've had the thought for several years that the medical field will be the last ace in the hole of this group for draining wealth away from more people than any of their other strategies. Fancy a bag of saline costing \$5.16 billed to the patient at [\\$546!](#) So much for "greedy silver hoarders!"

The Aspen [Institute](#) is interested in "security and global affairs, communications, energy, health, economy, environment" and more.

It was founded in [1950](#) as the Aspen Institute for Humanistic Studies in Aspen Colorado, where it maintains a meeting facility (I meant to say, scheming facility) and since then has offices in Washington DC at 1 Du Pont Circle; and offices elsewhere, including Paris, Madrid, Berlin, Rome, Tokyo, New Delhi, Mexico City and elsewhere. It's funding comes from the usual rat pack of Pilgrims Society foundations including Ford, Carnegie and Rockefeller. Aspen Institute [maintains](#) a "Global Interdependence Initiative" and a Middle East Strategy Group and a "Homeland Security Initiative" plus their "Ethical Globalization Initiative" and their "Health and Biomedical Science" program and **OH YEAH**---their "Congressional Program." They also have an "Aspen Global Leadership Network" with special emphasis on Central America and India, and that program receives Goldman Sachs (Pilgrims Society) funding. It's another globalist think tank like Brookings Institution, controlled from behind the scenes by The Pilgrims. Current Aspen trustees besides Gross include two of the very few women members of The Pilgrims---former Secretaries of State Madeleine Albright and Condoleezza Rice, who is way at the outer edge of the group's outer circle---in other words, a highly placed hack! Gross is a "senior [mentor](#)" with the Aspen Institute.



The [Council](#) on Competitiveness (so-called and alleged) with which Gross is involved, has an ex-chairman of Du Pont (Silver Users Association) in its leadership---



Since 1992 Gross has been a trustee of the Federal City Council in D.C., which is obviously a nexus of the area power brokers, and has overlapping membership with such elite District of Columbia clubs as the Cosmos, the Metropolitan, Army-Navy, Congressional

Country Club, The City Club and so forth. Among its other [trustees](#) are Lee Folger, son of Pilgrims Society member John Clifford Folger, an Ambassador and financier profiled in [#9](#) Silver Squelchers (pages 55–58); Sharon Percy Rockefeller, who might be a Pilgrims member with her husband, the boundlessly dangerous Senator Rockefeller (1985–2015); and others representing such interests as J.P. Morgan Private Bank; Bank of America; Verizon; Pfizer; Washington Post; and a few dozen others, including top law firms.



Gross is an adviser for more than twenty years to the [Center](#) for Strategic & International Studies and is described as “a prominent American think tank based in Washington D.C. The center conducts policy studies and strategic analyses of political, economic and security issues throughout the world, with a specific focus on issues concerning international relations, trade, technology, finance, energy and geostrategy.” What is “geostrategy?” It’s a new word for “warmongering!” At the CSIS site we find they have a “Nuclear Threat Initiative.” This entity collaborates with others such as its London correspondent, the International Institute for Strategic Studies, also with members of The Pilgrims as trustees. Gross also

lists himself as a member of the IISS in London, further connecting the two entities. Other CSIS trustees include Pilgrims Society members Henry Kissinger; Frederick Whittemore of Morgan Stanley; Rockefeller wheelhorse Zbigniew Brzezinski; and the only allegedly “ex” Pilgrims member (per info I have from Europe), Maurice Greenberg, ex chairman of silver suppressor American International Group. Among the Pilgrims connected [foundations](#) contributing support for the CSIS include the Henry Luce Foundation (Time Inc. fortune); Ford Foundation; Carnegie Corporation of New York’ Alcoa Foundation; Colonial Williamsburg Foundation (Rockefellers); and General Electric Foundation. These organizations are very diverse, yet all converge on multiple objectives. The CSIS like its London counterpart, is involved in planning more regional wars and World War 3---Pilgrims Society inculcated conflicts---



Corporate and banking supporters of CSIS include Chevron, Exxon Mobil, Shell Oil, Conoco Philips, British Petroleum, Halliburton, Bank of America, IBM, Procter & Gamble, defense contractors Lockheed Martin and Northrop Grumman, Raytheon, Textron and others.

Notice the twin connections Gross has with Stanford University, including the Stanford Institute for Economic Policy [Research](#) of which we read “George [Shultz](#) was a key player in its inception,” referring to the Pilgrims Society member who has made multiple forays into the Obama White House, and who was Treasury Secretary and Secretary of State who became a director of construction colossus Bechtel Corporation, and joined the international advisory council of JPMorgan Chase---



This Institute is another synthetic money joke of these globalists--- there are no recommendations for use of gold and silver in the monetary system. Stanford University itself traces to the organizers of the gigantic Southern Pacific Railroad and other large associated interests described in [#2](#) Silver Squelchers, and most of those fortunes came under The Pilgrims Society umbrella (pages 25-34).

The Council for Excellence in Government in 2009 merged into The Partnership for [Public](#) Service which is another quill on the oversized porcupine, as a Goldman Sachs personality is a [trustee](#). Their name says it all---they want to continue placing globalists in political leadership positions; see their roster of multinationals!



The Jamestown Foundation, of which Gross has been a director since 1997, was founded in 1984 and we [read](#)---

“The Jamestown Foundation is a Washington D.C. based institute for research and analysis, founded in 1984 as a platform to support Soviet dissidents. Today its stated mission is to inform and educate policy makers about events and trends, which it regards as being of current strategic importance to the United States. Jamestown owns numerous publications that focus on China, Russia, Eurasia, and global terrorism.”

The Jamestown Foundation, like the Aspen Institute, has “programs.” Some of [them](#) are---“Terrorism Monitor” and “Eurasia Daily Monitor” and “China Brief” and “North Caucasus Monitor.” There are Admirals, Air Force Generals and so forth on the board of this foundation with Gross, whose personal interests are served the more warfare there is! What is the “North Caucasus Monitor” about? Based on the geography involved, I’d speculate it has to do with its

location at the east end of the Black Sea---strategically at the southeast end of the map showing the Ukraine, with the Black Sea petroleum resources craved after by Pilgrims Society interests like ExxonMobil, Chevron, British Petroleum, Royal Dutch Shell among others. Notice that while the name of the Jamestown Foundation suggests an interest in the historic Jamestown colony in Virginia in 1607 AD, it has to do with something totally different. In fact, the map they use shows the Eurasian continent, which is their focus---



Among the other globalist groups this Pilgrims Society member Gross is a member of includes the CFR (The Pilgrims are Penthouse, CFR is in the basement) in New York, the Washington Institute for Foreign Affairs, World Economic Forum, National Economists Club and Economic Club of Washington.



Speakers at the EC of Washington [include](#) characters from Du Pont (Silver Users Association)---The World Bank---Morgan Stanley (silver thieves)---Goldman Sachs (gold thieves)---Time Warner (cover up artists)---Federal Reserve System (main reason for price attacks on precious metals)---Treasury Department (in gloomy spirits all the time due to the silver Eagle program)---JPMorgan Chase (screws silver mining shareholders 24/7)---International Monetary Fund (gold antagonist)---Citigroup---Lazard Freres---and---that's a representative sampling in yet another Pilgrims Society sponsored nightmare rogues gallery.

Useless Bay Country Club which he says is in Washington you'd assume means in the District of Columbia, but this one is in Washington State in a Seattle suburb, possibly due to his interests in the defense contracting industries and the warmongering groups he's active in, and the presence of military [installations](#) in that state. We [find](#), "In 1792, Captain George Vancouver, an English explorer who sailed Puget Sound, called our bay Useless because his keel hit bottom before his anchor could. Today, Useless Bay Golf & Country Club features one of the Pacific Northwest's finest golf courses with a full array of amenities."

After his Pilgrims membership, perhaps the most interesting thing in his background was his enrollment at Rensselaer Polytechnic Institute, named for the Van Rensselaers mentioned several times in The Silver Squelchers series such as [#3](#) (see pages 18-19). He obtained an engineering degree there.

At Bloomberg, we notice the following additional activities of this very energetic Mister Gross, British collaborator. From here till the end of his profile all details as to his past and current connections all came from this [link](#) except for accompanying details about each particular interest located elsewhere.

“He serves as a member of the advisory board of England & Company.” The site describes it as “Washington D.C.’s leading [investment](#) bank.” Craig W. England, the founder, was previously with such Pilgrims Society [institutions](#) as Alex Brown & Sons, Irving Trust and Canadian Imperial Bank of Commerce. Two of the other directors have similar background with investment and megabanks.



McData [Services](#) Corporation, of which Gross became a director circa 2000, was later acquired for \$713 million.



“He served as a director of Alpine Access Inc.” It was later acquired by Sykes Enterprises, [with](#) 47,900 employees providing IT technical and customer support in 30 languages at 75 locations in 20 countries---



“Former director of SevenSpace Inc.” We read, “Sun Micro agrees to buy closely held Seven Space” in March 2005 for an [undisclosed](#) sum---probably in the hundreds of millions minimum. Closely held means just what it sounds like it means---it was held in few hands. How much of a haul did Pilgrims Society member Patrick Gross reel in that time? As you see, he’s been all over the map in a tremendous welter of investment activity. We read at the link---

“SevenSpace's outsourcing technology manages business software programs, including those from SAP, Oracle, PeopleSoft, and Siebel

Systems, as well as databases from Oracle, and operating systems such as Sun's Solaris version of the Unix operating systems, Microsoft's Windows and Linux.”

Seven Space [offered](#) “SpyGlass technology.” Sun was acquired by Oracle in 2010---



“He served as the Chairman at Aegis Communications Group Inc., since August 2002.” Aegis has 37,000 employees in 9 [countries](#) and was bought out by [Essar](#) and apparently resold to another [Teleperformance](#) for \$610 million. This is not to be confused with Aegis Defense Services connected to Lord Inge who we visited earlier. Clearly Mr. Gross doesn’t throw pennies around like manhole covers! Teleperformance says it’s a “citizen of the [world](#)” and a “[citizen](#) of the planet,” in simple terms---more globalism and they have “a large global [footprint](#)” and has a director connected to Citigroup (Pilgrims Society).



“Director Motista Inc.” At their site I see [Gross](#) listed as a director. We [read](#)---

“Founded in 2007 by career marketers with deep roots in building Fortune 1000 brands, Motista provides the most robust intelligence on consumer emotion. Motista rigorously models and continuously validates. Our clients include Fortune 1000 brands in consumer packaged goods, financial services, retail, hospitality, healthcare, consumer electronics and media. These clients – innovators and market leaders, large firms and middle-market challengers – share a common goal: to leverage emotion to drive results.”

The modus operandi Gross appears to use is that of providing seed capital into promising growth situations, leveraging it, and using a railroad boxcar to haul off the takings when it goes public or is sold to a larger interest. It would be interesting to know how large his mushroom cloud has become since he first ventured afield.



Gross is a [current](#) director of All Kinds of Minds Institute may be a quasi-nonprofit organization. Over 5,000 [schools](#) across America have participated in their programs, which very likely consist of barraging children with globalist ideals.



“He serves as a director of Development Alternatives Inc.” At their [site](#) we read---

“DAI works on the frontlines of international development.

Transforming ideas into action—action into impact. We are committed to shaping a more livable world.” It was founded in 1970 and is [active](#) in 160 countries. They are “responding to global transformations” [and](#) are a “global development company.” They are [active](#) in “corporate services, environment and energy” and more. According to [Wiki](#), in 2010 DAI received \$382.5 million from the United States Agency for International Development for its operations. In other words, like foreign aid “programs,” another Pilgrims Society ripoff of American taxpayers under cover of “national interest.” DAI works with the U.S. Department of Defense (the #1 specialty of Mister Gross); the World Bank; Australian Agency for International Development; Asian Development Bank; U.S. State Department and other entities. In December 2009, Allan Phillip Gross, apparently the kid brother of Pilgrims Society member Patrick Gross, was “detained by Cuban authorities after attempting to distribute satellite communications equipment. The Supreme Court of Cuba sentenced Gross to 15 years of imprisonment despite diplomatic pressure from high level American officials. Gross was released in December 2014 at the same time as other prisoners were released on both sides (US and Cuba) and announcement of planned resumption of diplomatic relations. Eva Golinger, a Venezuelan–American attorney and editor of the *Correo del Orinoco*, a web– and print–based newspaper which is financed by the Venezuelan government, claims that the DAI is a

Central Intelligence Agency front organization for their covert actions.”



“He served as Advisor of VirtualAgility, Inc.” [Virtual](#) is an advanced computer technology company---

“VirtualAgility’s Board of Directors and Advisors include retired military and industrial leaders who have dealt firsthand with the difficulties of interoperability and collaboration under crisis conditions. U.S. Department of Homeland Security and the U.S. Department of Defense utilize VirtualAgility technology in mission-critical applications requiring high degrees of security, accessibility, usability and breadth of functionality.”

Virtual [owns](#) multiple patents with other patents pending. One of its directors is a former vice Chief of Staff of the U.S. Air Force---



“Director, BuySAFE Inc.” Here he is again on yet [another](#) board, apparently waiting to score big in a buyout---



Buy Safe “provides brand building and website conversion solutions for online merchants.” It offers “a safe shopping service to online retailers and their customers.” It has some similarities with Escrow Dot Com, [and](#) is litigating against Google which, if it prevails, will have an enormous payday. Yes, in all probability there is at least one Pilgrims member on the Google board. All competition between Pilgrims members is on the “inside” and will not benefit the public!

“He has been chairman of the Board of CoreStreet Ltd. since October 2006.” This [document](#) from the National Institute of Standards and Technology outlines some details about CoreStreet, another elite computer sciences operation Gross has taken over in his personal sandbox, which is clearly a phenomenally expansive sandbox!



Next I see that CoreStreet “was acquired by Activeidentity [on](#) December 15, 2009.” The price was a pittance in Pilgrims Society [terms](#)---\$20 million. This was apparently among the smallest transactions Gross has been involved with. He’d probably risk a back injury to pick up a zinc cent on a parking lot! More like, his

retinue of bodyguards would handle the smaller deals. Bloomberg could do better to keep its data updated. Apparently Gross exited CoreStreet when the buyout transpired.

“He served as Member of the Advisory Board of Landmark Systems Corp. since 1993 and former director.” In March 1997 Gross became a director. It creates [software](#) technology “warning of potential systems problems.” It started with 247 employees and reached a multimillion market cap. It [was](#) acquired [for](#) \$53,263,000 by Allen Systems (based on shares outstanding x PPS) ---



“He serves as Member of the Advisory Board of Wyndstorm Corporation.” Wyndstorm, which was active in online marketing, social media, gaming, E commerce, customized avatars, 3-D scenery” etc., went bankrupt in [2013](#). Was Gross Short at the opportune juncture? In a bankruptcy, shares sold short need not be returned, and there is money to be made on falling prices!



“He serves as a Director of YFonGlobal LLC.” YFonGlobal was closely connected to Wyndstorm. We read [here](#) about Gross---

“American Management Systems (AMS) founder, Capitol One Board Member Patrick A. Gross, an Angel investor has joined the YFonGlobal Board of Directors. "YFonGlobal represents real forward thinking, as it leverages the exploding VoIP market drivers with high value online collaboration applications. I view this as a winning combination of technology, timing, and market interest," said Pat Gross. "Patrick Gross's investment and commitment to YFonGlobal is a validation of our business model and strategy," said YFonGlobal's CEO, Marian Sabety. “We are excited to be working with him and look forward to his invaluable assistance.”

At this [link](#) we read---

“Washington DC, USA and Vancouver, BC, Canada — May 1, 2007 — YFonGlobal, a leading edge provider of turn-key social network systems, and CounterPath Solutions, Inc. (OTCBB: CTPS), the leading provider of VoIP (Voice over IP) and Video over IP SIP softphones, today announced that the companies have entered into a strategic partnership to integrate CounterPath's award-winning softphone technology into Wyndstorm™ — YFonGlobal's social network and social media product offering.”



Gross became a director of KnowledgeMax in 2002 and it went [out](#) of business in 2003. Was he short?

“He has been a Director of Syncapse Corp. since February 14, 2012.”  
At Syncapse we [read](#)---

“Distilling the fire hose of social data into actionable consumer segments, we help brands get smarter about their audiences, across channels. This is Audience Relationship Management™ (ARM) in action. Our platform can be custom-tailored to the needs of your brand and is supported by a global team of consulting experts. Partnering with global brands like Anheuser-Busch InBev, Coca-Cola, Diageo, L’Oréal and Reckitt Benckiser, we turn insight into action.”

Syncapse offers a “90 day Performance Accelerator.” Syncapse [entered](#) into bankruptcy in 2013. Another victim of short selling, or just a loser when it’s hard to have every venture a winner when you are into so many ventures? What’s the ratio of the winnings of this Midas man compared to his losses? He’s unlikely to say, but

apparently his fortune has grown into large proportions---



“He served as a Director of Net2000 Communications Inc., since July 2000.” [Broadband](#) telecommunications was its area of business because it went [out](#) of business in May 2011. At one point its market cap was close to \$700 million and may have reached higher levels. Another belly up, X drawn on the eyelids, vulture bonanza for Pilgrims Society member Patrick Gross?



“He served as Managing Director of [CGI](#) Technologies and Solutions from 1970 to September 2002. He served as Chairman of CGI Technologies.” French Canadian investors in Quebec came in and bought control, however today there’s a CGI director who was with RTZ Corporation who could be a Pilgrims member. CGI reports 68,000 employees in 40 countries with offices in the E Commerce Tower in Montreal. Gross was chairman of CGI before the buyout---what kind of payday did he pocket? This guy is definitely

**a one man power bureau** and for certain, there are other Pilgrims Society members wielding still more influence, in spite of his astonishing web of influence---

“He served as a Member of Advisory Board of RSR Partners Inc.” [RSR](#) is an executive recruitment bureau with “a global reach.” I notice on its board such Pilgrims controlled entities as Rhodes Scholar,

Texaco, Paine Webber et al. RSR fits with his long history with American Management Systems, which gave him the seed capital to redeploy in a multitude of other trend based opportunities---the most lucrative kind.



“He serves as a director of Cloud Telecomputers.” At their [site](#) we read---

“CloudTC, a silicon valley-based software innovator in business applications and IP telephony, enables powerful business communications through its award-winning Glass platform. We develop and manufacture Android-based media phones, delivering the first truly smart IP phone. Our solution is available worldwide through leading resellers, service providers and IP PBX manufacturers.”



“Current director since 2010 of Article One Partners LLC.” [Wiki](#) says AOP is “a venture funded online [prior art](#) search community based in New York. In 2009, Article One Partners won the Silicon Valley Startup of the year. Since launching in late 2008, AOP has conducted over 1,500 research projects and rewarded more than \$5.8 million to its international researcher community. Article One Partners provides [crowdsourced](#) prior art search services by utilizing an online research community. With years of experience conducting over 1,500 IP research projects and a proven record of saving clients millions of dollars, AOP offers a variety of options to address client research needs. I also haven't found a site for The Lovell Group which Patrick Gross heads at 1725 I Street Northwest, Suite 300. I Street is traditionally known as Eye Street, and I can't resist suggesting---as in "all seeing eye" over the pyramid symbol on the trashy garbage \$1 Federal Reserve Note? Lovell Group is in the Farragut Center or Farragut Building, which says of [itself](#)---that it's an "architecturally impressive building" and---

"Position yourself strategically at **the nexus of the decision-making centers of Washington** with an office in the advantageously located Farragut Office Center. **Only two blocks from the White House and steps from the power corridor of K Street.** Ponder a bright future in your well-appointed office, or make a big impression hosting a high-level meeting."

"He serves as a Board Member at Defense Business Board." This is also from Bloomberg, and checking the DBB site I don't see Gross listed as a DBB member. However, his place has been [filled](#) by Howard E. Cox Jr. whose father, Howard E. Cox, was in the 1974 and 1980 Pilgrims Rosters. He's the brother in law of Tricia Nixon Cox, daughter of Pilgrims member Richard Nixon, who savagely attacked silver, capping it at \$1.61 the ounce with his Fascist Cost of Living Council, and attacked gold redemption, primarily by France! The Cox lineage is directly connected to that of the Delafields, powers in the founding of the Bank of America, whose family traces back 1200 years to early medieval French nobility---Count De La Feld. Howard E. Cox Jr. is very likely a Pilgrims member, and not just the son of a

deceased member. “Howard Cox is an Advisory Partner of Greylock, a national venture capital firm. Greylock has been an active investor in software, data communications, consumer internet and healthcare. Over 150 Greylock companies have gone on to become publicly held and more than 200 have successfully merged with other leading companies. Recent Greylock portfolio companies that have filed IPOs include LinkedIn, Groupon and Facebook. Mr. Cox has been a director of more than 30 companies. He is also a trustee of various Fidelity Mutual Funds.” Gross is [mentioned](#) in eight PDF documents at the DBB site. Pilgrims members such as Patrick Gross truly personify the phrase “military–industrial complex.” More warfare is being brewed at this moment in the Middle East and elsewhere so these bloodletting, carnage inflicting members of the world’s premier Secret Society can continue “seizing” and “absorbing” wealth! His wife is a “grants and contracts [fiscal](#) specialist” in D.C. Typically for Pilgrims members, they’re Episcopalians. They reside in Bethesda, Maryland suburb of D.C. [Their](#) son graduated from the fiat money propagandizing London School of Economics after attending Cornell, where he easily may have become a member of its Sphinx Head Society. He’s involved in “capital management” in New York. The daughter in law graduated from Vanderbilt University (Pilgrims Society) and is an associate in the Wall Street law firm, Davis, Polk & Wardwell (Pilgrims Society). Like many---definitely not all---other Pilgrims members, Gross is a member of the far better known Council on Foreign Relations, which

is probably the most important Pilgrims subsidiary organization in their entire **perverse constellation.**

At <http://www.nndb.com/people/36> we notice still more activity by this whirlwind of affairs Mister Gross---he is or was a member of The Club of Rome and he supported Arizona Senator McCain for President in 2008 and later Mitt Romney. McCain's father, Admiral John S. McCain, was in The Pilgrims 1969 roster. Naturally Gross supports continued warmongering as it portends to enrich him and his Pilgrims pals. He's involved with [Forward](#) Together political action committee.



Many, perhaps most, of the defense contractors Gross holds interests in and work with, use some silver as one of the many raw materials they need, and again we see this ongoing enormous

Clarkson's career has been in the aerospace, aviation and defense contracting industries. Pratt & Whitney traces to 1860 and two men by those names. That particular Pratt wasn't one of the Standard Oil Company Pratts. The Whitney of the firm is of the same Whitney family rated as the [seventh](#) wealthiest American family as of 1924 by financial historian Ferdinand Lundberg. Lundberg's rankings were wrong, perhaps because all he had to work with was publicly available details; he discounts totally the awful accumulations tracing to Dutch and British colonial times, which we've addressed elsewhere in these profiles. Nonetheless, the Whitneys achieved enormous riches including in Standard Oil. John Hay Whitney was a vice president of The Pilgrims Society as of 1969. Whitneys have had major holdings in many companies---City National [Bank](#), Great

Northern Paper, Northern Finance. It must have been during Clarkson's 20 years with Pratt & Whitney---itself a subsidiary of United Technologies, that his ascent into The Pilgrims Society started, with UT always having members on its board. Afterwards he became a top exec in the giant Boeing Company which today has 165,000 employees in 65 countries and does business in [150](#) countries, "Boeing is the world's largest aerospace company and leading manufacturer of commercial jetliners and defense, space and security systems."



I find nothing specific about Project International in Seattle he said he was involved with as of 2000. He stated he became chairman of Hitco Carbon in 2002. Their page doesn't [show](#) him; this is a

former position. HC works with Boeing and received their supplier of the year [award](#). They manufacture insulation, fuselage materials, aircraft brakes and much more. [Founded](#) in 1922, Hitco has 550 employees.



During 2000 to 2002 Clarkson was chairman of Interturbine, based in the Netherlands

During 1988–1991 Clarkson was a director of the D.C. based Partnership for Improved Air Travel, of which we [read](#)---

“The Partnership for Improved Air Travel is not quite a year old, has 95,000 members, is growing every day and brings together some of the strangest bedfellows seen in this country. The partnership is financed by major domestic air carriers and aviation manufacturers. Its members include representatives of these, along with aircraft owners, pilots, labor union officers and members, business and

industry leaders, mayors and other elected officials, frequent flyers and consumers in general.”

As of his 2005 info, Clarkson was a director of Atlas Air and Avnet. [Atlas](#) Air Worldwide Holdings is the recognized leader in global airfreight with the world’s largest fleet of modern Boeing 747 all cargo aircraft.”



As of 2005 Clarkson was a director of [Avnet](#) founded in 1921. Wiki’s old figures from 2012 [show](#) 19,100 employees and \$25.7 annual revenues---



In 1987 Clarkson became a trustee of DePauw University in Indiana and in 1996 to 2002 became vice chairman. He’s now [listed](#) as an advisory trustee.

Embry–Riddle Aeronautical University has campuses in Arizona and Florida and is “the top aerospace and aviation university in the [world](#).” Clarkson’s tenure as a [trustee](#) is no longer current. As of 2014 it has 30,687 [enrolled](#).



Clarkson’s involvement with this one is [also](#) “previous”---



During 1993 to 1999 Clarkson was an overseer of the Tuck School of Business at Dartmouth College in Hanover, New Hampshire. It has a \$282 million endowment and 560 students.



The Tuck family is little known outside New England. Amos Tuck (1810–1879) is known as a [founder](#) of the Republican Party. He was

a New Hampshire Congressman (1847–1853) and a Dartmouth College trustee. His son [Edward](#) Tuck who became wealthy in banking, railroads and world trade and was a partner in the finance house of Munroe & Company. From 1890 when he became American consul in Paris he remained in France, but was in Monte Carlo in 1938 when he died. He donated millions to museums and hospitals in Paris. Edward Hallam Tuck appears in The Pilgrims 1980 list and is either his great grandson or other family member. The New York [Times](#), October 12, 2002, in an obituary of E.H. Tuck, made no mention of his Pilgrims activities. He was with the Wall Street law firm Shearman & Sterling, with many other Pilgrims Society connections, for almost 50 years and set up the first S & S overseas office in 1962 at Paris. E.H. Tuck founded the French–American [Foundation](#) (“advancing the dialogue between French and American leaders”) in 1976 and was awarded the medal of the French Legion of Honor. He represented the government of Algeria’s state petroleum agency, Sonatrach, in its negotiations with Western oil interests. Pilgrims member Felix Rohatyn is a [member](#) of the French–American Foundation, and he is likely not the only Pilgrims member there---

# French-American Foundation

“The French–American [Foundation](#) is the principal non–governmental organization linking France and the United States at leadership levels and across the full range of the relationship between the two countries. The purpose of the French–American Foundation is to strengthen the French–American relationship as a vital component of the trans–Atlantic partnership.” These conspirators want to drag France into eventual political union with the U.K. and the United States!

The Interlochen [Center](#) for the Arts, founded in 1928 in Michigan, “draws young people from around the world to study music, theater, dance, visual art, creative writing, motion picture arts, and comparative arts. Interlochen Center for the Arts is the umbrella organization for Interlochen Arts Camp (formerly the National Music Camp, founded 1928), Interlochen Arts Academy boarding high school (founded 1962), Interlochen Public Radio (founded 1963), Interlochen College of Creative Arts (founded 2004), and the “Interlochen Presents” performing arts series.” Lawrence William

Members of The Pilgrims U.S. have been deeply involved with China going way back. George Bell Adams, who died in 2011 and wasn't in the 1980 list, admitted his membership in the 2005 Who's Who, page 20. The NYT didn't mention that detail. "He [served](#) as an arbitrator for the China International Economic and Trade Arbitration Commission; a director of the Lawyers Alliance for World Security; Chairman of the Board of Sarah Lawrence College; trustee and executive committee member of the American Trust for the British Library; fellow of the Pierpont Morgan Library; member of the Yale University Council; and member of the Board of Visitors of the CUNY Law School. He worked his entire legal career at Debevoise & Plimpton; Chairman of the firm's corporate department 1988 1993 and managing partner of its London office 1993 1996." D & P is a major Pilgrims Society law firm; these are old-line families, especially the Plimptons, who go way back in British history.

The National Bureau of Asian [Research](#) says Clarkson is now an honorary member of their board---



"Lawrence W. [Clarkson](#) has served on NBR's Board of Directors since 1993. Mr. Clarkson retired from the Boeing Company in 1999 from his position as President of Boeing Enterprises, the division that includes Boeing Business Jets, Flight Safety Boeing Training

International, and Boeing Modification and Engineering Services. He played a key role in introducing a new strategic-planning process, and represented the company at an international level. The New York Times described him in December 1996 as **“the closest thing Boeing has to a corporate secretary of state.”** He served in this position from January 1992 until February 1997, first as Vice President and then, from April 1994 on, as Senior Vice President. He was also a member of the Boeing Executive Council from 1992 to 1997. Mr. Clarkson joined Boeing in January 1988 as Commercial Airplanes’ Senior Vice President of Government and International Affairs after a twenty-year career with Pratt & Whitney, where he became the youngest president of Pratt’s Commercial Jet-Engine Division. Mr. Clarkson is Chairman of the U.S. Pacific Basin Economic Council and the National Center for Asia-Pacific Economic Cooperation. He is Director of several other international and industry organizations, and is past President of both the Washington State China Relations Council and the Japan-America Society of Washington, and a past Vice President of the Wings Club. Mr. Clarkson is Chairman of the Seattle Opera and the Interlochen Center for the Arts and is on the board of the Corporate Council for the Arts. Holding a bachelor’s degree from DePauw University and a Juris doctorate degree from the University of Florida, Mr. Clarkson is a member of the Florida Bar Association and serves as a trustee of DePauw University and as an Overseer of the Amos Tuck School at Dartmouth College. In 1998 he received DePauw’s highest honor,

the Old Gold Goblet, an annual award for “eminence in life’s work and service to the alma mater.”

The National [Center](#) for Asia-Pacific Economic Cooperation, founded in Seattle in 1994, only lists names of corporations as “governors” of the group; the usual list is there---

Clarkson is a member of the Florida Bar Association, probably linked to the matter of his involvement with Embry-Riddle Aeronautical University, which has a Florida campus---



Clarkson appears to no longer be [active](#) in the U.S. Pacific Economic Cooperation Council founded in 1980 with 22 member countries---



Clarkson is a member of the American Institute for Contemporary German Studies (director 1997–1999) at Johns Hopkins University in Baltimore



“The American Institute for Contemporary [German](#) Studies strengthens the German–American relationship in an evolving Europe and changing world. The Institute produces objective and original analyses of developments and trends in Germany, Europe and the United States; creates new transatlantic networks; and facilitates dialogue among the business, political, and academic communities to manage differences and define and promote common interests.” Pilgrims Society member James Addison [Baker](#) III is there, as are representatives from megabanks such as Citigroup and Deutsche Bank. My view; this group is a carbon copy of other Anglo banking connected groups like the American Council on Germany and among other purposes, their objectives include quietening down German officials about their country’s gold held by the NYFED! As Treasury Secretary, 1985–1988 and Secretary of State 1989–1992, Baker’s role included battling gold and silver prices through his control over our entire diplomatic apparatus! Our Ambassadors to silver producing countries may well have told

officials of those countries to remain silent about precious metals price suppression if they want trade and investment with us in all other areas!

Clarkson is a member of the important Metropolitan Club in D.C., a virtual lobbying grounds for both houses of Congress to be influenced; the MC of DC is discussed in the profile of Philip Lader, Pilgrims Society member and Crown loyalist. Clarkson is a member of the New York Yacht Club; see the profile on Charles Lawrence Brock for details. Clarkson, naturally another Episcopalian, is a member of the Order of Saint John of Jerusalem, which has strong interlock with the more important Pilgrims Society; both are headed by the British Sovereign. 4) Sarwar Kashmeri (1942---; Pilgrims by 2005, probably earlier) is an exception. Bylaw IV of The Pilgrims reads---“The members shall be citizens of the United States or its dependencies or subjects of

the British Empire, *and others prominent for their sympathy with the objects of the Society* who shall be elected by the Executive Committee, and membership in the London Pilgrims shall ipso facto constitute membership in the New York Society and vice versa.” Why would they admit a Pakistani? *Connecting People and Information*

REJIS stands for Regional Justice Information [Service](#) says “The REJIS Commission (Regional Justice Information Service) is the leading provider of cutting-edge information technology (IT) services and products for the criminal justice community and government agencies in Missouri, Kansas and parts of Illinois.” Over 300 agencies are involved. Yes, the elite control the criminal justice system and have skimmed profits off the high level of incarceration and imprisonment for nonviolent, victimless crimes. After helping to found REJIS Kashmeri went back to Pilgrims Society City to help the New York authorities in related activities until 1982. However, this [link](#) states that in 1980–1984 he was “director of the project to

computerize the New York City District Attorney's office with "PROMIS," the leading case management and law enforcement tool."


Sabzevar Incorporated, which he left in 1985, [closed](#) down in 1991. What did he exit with? Sabzevar is a city of [over](#) 200,000 in northeast Iran, several hundred miles west northwest of Afghanistan. Suspiciously, I again wonder if there's some opium connection as Persia, as Iran was once known, was a large player. This shows opium [addicts](#) in Sabzevar. Or the interest in New York may have been unrelated; not much info is available. According to [this](#) he was with Accounting Systems International World Group, 1991–1994. "He also served as the founding [chairman](#) of Accounting Systems International, the first global consortium of accounting systems integrators."

A search for Niche Systems Inc. shows as the first result <http://www.nicherms.com/> fits with the earlier REJIS results---it's "law enforcement software." Does it have a feature for flagging anti-globalists, anti-war activists, Federal Reserve critics and so on? According to [this](#) Kashmeri left Niche in 2004.



After the Niche activity Sarwar returned to consulting with the city government of New York. E Biz Chronicle---hmnn---at this [site](#) I read "Published daily from New York for corporate decision-makers

who are charged with envisioning and implementing e-business strategies. It includes e-business news, columns, special reports, backgrounders, Q and As.” The August 7, 2000 Computerworld Magazine, page 48, [shows](#) Kashmeri talking about E Biz. A site in [Zambia](#), Africa mentions it; surprisingly, little else. His scan above shows it as a current pursuit since 1999. He mentions being on the advisory council to the American Ditchley Foundation. We’ve discussed Ditchley in other profiles. The Foreign Policy Association is discussed in the profile on John Merow. The Union League [Club](#) of New York, not to be confused with the Union Club, was founded in 1863, as contrasted to the Union Club, [founded](#) in 1836. For speculative possibilities, either or both of these clubs may have had some connection with the financing of the Northern war effort, including by characters like August Belmont, a Rothschild associate. However, it’s known that during the Civil War, the Union Club refused to expel members in sympathy with the Confederacy. The Erlangers were financiers of the South and also Rothschild connected. This lists prominent historical [members](#) of the Union Club; I recognize some as Pilgrims members including the original J.P. Morgan (1837–1913). Morgan Senior was also a [member](#) of the similar Union Club, as were other Pilgrims members. Both clubs are well interlocked today with The Society.



Kashmeri is a member of the Carlton Club in London, also well interlocked with The Pilgrims London branch. Founded in [1832](#) we read on page 101 of “The Empire of The City---World Superstate” by E.C. Knuth (1946) ---

“It is likely that this dinner meeting was held at the ultra exclusive renown Carlton Club, traditional meeting place of The Pilgrims. According to accounts, this club purveys the very finest service of any club in all the world.”








The Economic Club of New York is discussed elsewhere. This book Kashmeri authored in 2008, features [zero](#) mention of The Pilgrims Society. Theodore Roosevelt IV, very likely a Pilgrims member, wrote the intro. Theodore IV became a managing director of Lehman Brothers in 1985 (Who's Who in America, 2005, page 3968). As of December [2010](#) he was with Barclays Capital. Roosevelt IV coordinated financing for Cape Wind Associates, a project north of \$1 billion, having to do with wind power generation in Massachusetts. The story reported Theo IV as chairman of the Pew Center on Global Climate Change. "Given his family's political history, he early on developed an internationalist bent." That means he's a globalist. He was with the State Department and another key investment bank, Kidder, Peabody & Company. He gave the keynote [address](#) at the National Governors association meeting in 2001. IV chairs the Center for Climate and Energy Solutions and is a trustee of the Alliance for Climate Protection, the World Resources Institute and is an advisor to the China-U.S. Center for Sustainable

Development and is a CFR member. I'd absolutely expect Theo IV to appear in a recent Pilgrims roster if we had one.



On You Tube he makes [no mention](#) of The Pilgrims.



In a speech at a Foreign Policy [Association](#) meeting, Kashmeri mentioned being acquainted with Anna Palachio (Spanish Prime Minister) ---Caspar Weinberger (an Episcopalian by the way, Pilgrims Society member, and as Defense Secretary, dumped 24,435,000 ounces of silver from the former military defense strategic stockpile for price management objectives) ---Secretary of State James Addison Baker III, who as Treasury Secretary was also a gold and silver price manager---John Major (British Prime Minister, Pilgrims London) ---General Brent Scowcroft (mentioned elsewhere in Kashmeri's profile) ---General Wesley Clark (Rhodes Scholar, potential member of The Society) and others. Diplomats and quasi-diplomats who've been members of The Pilgrims organization have connected near innumerable dots on the puzzle of the globalist world map going back for more than a century, and the public is ignorant of their role acting for the wealthy members with worldwide investment holdings.

Kashmeri's [site](#) says he's a trustee of the Calvin Coolidge Memorial Foundation. Pilgrims members have been all over Presidential administrations for over a hundred years and indirectly many members have been in management of memorial groups, libraries and museums commemorating Presidents. Oops, that may be a former laurel of his, I see no mention of him [here](#). Or did they forget to list him?



He's an advisor to the American Precision Museum, probably having to do with [his](#) degree in aerospace engineering. We read---

Adjunct Professor at Norwich University, and a fellow with the Foreign Policy Association. Author and current affairs commentator, recognized on both sides of the Atlantic as a specialist on United States-European relations. "Kashmeri's most recent book is "NATO 2.0—Reboot or Delete?" His previous one was "America and Europe after 9/11" and "Iraq: the Great Divide." Both draw on his experience as a transatlantic businessman, original

research, and on private conversations with American and European leaders. Scowcroft was made an honorary Knight of the British Empire in 1993. England has fomented World Wars and used us to win them!




His father, Aghajani [Kashmeri](#) (1908–1998) was a screenwriter (over 50 movies) and actor from India. “Aghajani Kashmeri's home in Bombay, a fourth floor apartment overlooking the Arabian Sea in a building called Keki Court, was the venue for some of the greatest poets, songwriters and singers of the time. His life is recounted in a one-hour documentary produced by his son Zuhair Kashmeri with funding from OMNI-TV of Canada.”

His brother, Zuhair Kashmeri, co-authored “Soft Target-- the Real Story Behind the Air India Disaster” ([2005](#)) ---

“On March 16, 2005, almost twenty years after one of the biggest mass murders in Canadian Aviation history, the Air-India Case


concluded with a verdict that authors Zuhair Kashmeri and Brian McAndrew predicted sixteen years ago when *Soft Target* was first published: not guilty. In this second edition, the two offer a detailed foreword that brings readers up-to-date with some startling new information surrounding the twin bombings on June 23, 1985 in the air over the Atlantic, and on the ground in Japan, which left 331 people dead. They offer key details from the trial of Ripudaman Singh Malik and Ajaib Singh Bagri that took place in a specially-built Vancouver courtroom, leads that were not followed up, and more details of India's intelligence service's clandestine interference in Canada. They explain how their own prediction that justice would not be found because of a botched investigation came true, and that only a public inquiry will offer closure to the families of the victims.”

This event is unfamiliar to me, and I'd withhold opinion without a deeper probe. The fact that this is the brother of a member of The Pilgrims Society most certainly gives cause for concern as to truthfulness.

He starts out being secretive by not identifying his wife's maiden or birth name. As we've seen, that is often an eyebrow raiser tracing that detail. 

He voted [for](#) the Coinage Act of 1965, removing most silver from our coinage. John Howland Gibbs Pell obviously had Howland family lineage, tracing to the original Mayflower colonists! The original Howland was part of a group granted a fur [trade](#) monopoly by England. J.H.G. Pell was [chancellor](#) of Long Island University and president of Wall Street Investing Corporation. "Mr. Pell was a direct [descendant](#) of John Pell, the first Lord of Pelham Manor, **which covered much of what is now Westchester County.**" At Long Island University there's the John H.G. Pell [Hall](#) of Physical Science & Engineering.



[Senator Pell](#) “was the great–great–grandson of [John Francis Hamtramck Claiborne](#), great–great–grandnephew of [George Mifflin Dallas](#) and great–great–great–grandnephew of William Charles Cole Claiborne and Nathaniel Herbert Claiborne. He was also a direct descendant of mathematician John Pell. Pell was one of the heirs to what started out as the Lorillard tobacco fortune, although the family has been out of the Lorillard firm for generations. Pell married the former Nuala O'Donnell, great–granddaughter of George Huntington Hartford, owner of the Great Atlantic and Pacific Tea Company and granddaughter of Edward V. Hartford, who perfected the automobile shock absorber, and, as such, was one of the heirs to several fortunes.”


J.F.H. Claiborne was a member of Congress from Mississippi who held newspaper [interests](#) and defended slavery. G.M. Dallas was vice president of the U.S. (1845–1849) and had been legal counsel to the awful second United States Bank (shuttered by Andrew Jackson). Dallas Texas was [named](#) after this monetary conspirator! The Pilgrims 1969 roster shows Huntington Hartford. Richard M. Haass was on his way towards eventual Pilgrims membership at least as of 1975!

During 1993 to 1994 he was with the D.C. offices of the CEIP, Carnegie Endowment for International Peace, another warmonger planning think-tank which always has Pilgrims Society members as trustees (not all of them, just the most important ones!) Following that Haass was with the CFR office in D.C. during 1994 to

1996 in similar activities, scheming to deal in servicemen's blood in staged overseas conflicts by which his warmonger sponsors would immensely profit. During 2001 to 2003 Haass was back at the State Department as “director of policy planning,” meaning more globalism. As of 2003 senior Pilgrims Society member David Rockefeller installed Haass as president of the CFR, Council on Foreign Relations, which today has some 4,900 [members](#) spread across these United States (concentrated in New York and Washington) involved in all manner of globalist activities intended to put an end to our Republic and the

dream of the Founding Fathers. World trade, world travel, diplomacy, second languages yes---globalism---no!

He's written nine books, coauthored one and edited four others and written articles for "[Foreign Affairs](#)," the CFR journal. I haven't checked all of it, but after spending 20 minutes searching, nothing was turned up in which he mentioned The Pilgrims. His book titles show him a warmonger and an advocate of overseas military interventionism and adventurism ("Conflicts Unending" and "Intervention the Use of American Military Force" and "War of Necessity"). Alliance Medical was awarded the contract by National Health Services U.K. even though a competing offer for 73 million pounds sterling had been bid. That’s how The Pilgrims Society works friends---it seizes wealth and taxpayers always get bled white! That happens everywhere The Society has sufficient influence. G 4 S whose slogan is “Securing Your World” is a multinational headquartered in West Sussex, England, offering a range of security services in 125 countries. “With **over 620,000 employees**, it is one of the world's largest private sector employers. G4S was founded in 2004 by the merger of the UK-based Securicor plc with the Denmark-based Group 4 Falck.” Among its numerous [activities](#) are

armored car services and diamond shipments. We read [also](#) that “G4S supplies security equipment and services for use at Israeli prisons, checkpoints and settlements in the West Bank. It also helps to maintain Israel's prison system. In 2007, the Israeli subsidiary of G4S signed a contract with the Israeli Prison Authority to provide security systems for major Israeli prisons. In April 2012, G4S released a statement detailing its activities in Israel – the provision of maintenance for some electronic security systems at a prison, a police station and checkpoints in the West Bank. In June 2014, Desmond Tutu and others protested at G4S's involvement with Israeli prisons. They also penned an open letter to the security firm, calling for it to "end its complicity in Israel's **abuse of child prisoners**.” We also see that in October 2013, allegations came out of prisoners being tortured at Mangaung Prison in South Africa in that dozens of the nearly 3,000 inmates at the G4S prison have been tortured using electroshock and forced injections. As of October 2013, G4S said it was investigating the allegations. The corporation has been accused of financial fraud and of paying immigrants as little as 1 pound sterling (about \$1.57) per hour.





Armor Group [International](#) was acquired by G 4 S in 2008. Armor Group was [founded](#) in 1981 “to provide protective security services principally to multinational oil and gas companies.” Wiki mentions this company was involved in a “warlord and sex trafficking scandal in Afghanistan.” As part of G4S it still provides convoy protection services, ocean transport security, armored cars for banks, surveillance detection, minefield clearing, business continuity planning in event of war or natural disaster, kidnap, ransom and extortion assistance, technical security systems and on and on. Earlier, he was foreign policy adviser to Senator Edward M. Kennedy (1973–1977), Senior Fellow at the Overseas Development Council (1970–1973), Research Associate at the International Institute for Strategic Studies (1967–1969), and foreign and domestic policy advisor to Vice President Hubert Humphrey (1968–1970). 



She was assigned to travel with senior diplomats, and took notes at key meetings, including a session between the Danish Prime Minister and the Shah. Hunter has written extensively on the Middle East, especially the Gulf region as well as the Mediterranean, Central Asia and the Transcaucasus. She has written on such topics as OPEC and the third world, the politics of Islamic revivalism, Iran after Khomeini, the Transcaucasus in transition, Central Asia since the collapse of the Soviet Union, and the future of relations between Islam and the West. Hunter is intrigued by recent developments in Iran, as that nations growing


population of young people (nearly 70 percent of the country's 68 million are under 30)."


