Royal & Hereditary Nobility Ancestry Part One

"He spoke openly against the Society"

(Line from "The Rifleman," March 3, 1963)



1) Charles William Neuhauser (year of birth undetermined; Pilgrims Society as of; also undetermined but definitely verified; probably [over](#) ten years standing) has **Schuyler lineage** on his mother's [side](#). This word means "scholar" and is pronounced "sky-lur." The Schuylers are a very old-line Dutch colonial family tracing to ancestors of [Peter](#) Schuyler (1657–1724) who was the first mayor of Albany, New York and became 22nd colonial Governor of New York (1719–1720). The Schuyler [Mansion](#) in Albany is a National Historic Landmark. The Schuylers were known as "[Patroons](#)," meaning the heads of companies and/or very large landowners. They became related by marriage to other patroons like the Van Cortlandts, Van Rensselaers, and the English Livingstons. These lines have continued to be represented to this moment in The Pilgrims Society New York, always at least several members, including with Schuyler maternal ancestry. There is no telling how much accumulated wealth this all represents. The Van Rensselaers [owned](#) among other tracts, 700,000 acres around Albany, New York. As the centuries passed such landholdings would rise to immense valuations; but of course, the tax assessor people would remain in their vest pockets to cover it up and toss the tax bite onto others not part of the phalanx of intermarried wealth! From 1764 to 1840 part of the Van Rensselaers lands went from nearly zero inhabitants to 50,000--- and they were all paying [rent](#) to the dynasty! Their [wealth](#) expressed in modern terms is estimated at **\$68 billion**. We read---



“Established in 1629 as the patroonship of Rensselaerswijck, this **massive land possession of the Van Rensselaer family** (commonly regarded as measuring twenty-four by forty-eight miles at the time of Stephen's birth) had survived the British takeover from the Dutch in 1664, when it became an English manor, and would subsequently **survive the American Revolution.**”

Nicholas M. Butler, president of The Pilgrims United States (1928–1946), married Susanna Schuyler (Who's Who in America, 1930–1931, page 441). See [#5](#) Silver Squelchers, pages 17–29, for the profile on Nicholas Murray Butler, who in his time impresses me more than Henry Kissinger (Pilgrims Society) ever did!

Peter Schuyler owned the majority of a land grant **fifty miles long** in New York's Mohawk Valley ("History of the Great American Fortunes," 1936, page 44). "This was a towering fortune; it ranked as a power of transcending importance"---Gustavus Myers. Neuhauser is another Pilgrims member with a fantastic genealogical history, and there's no certain way to know how much wealth he represents directly and by proxy---he knows, and isn't saying.

The Schuyler Copper [Mine](#) in New Jersey started operations in 1715 and amounted to some 91,000 kilograms of copper during the 1720s and some gold and silver. Shafts reached a depth of 347 feet and in 1794, the first steam engine in North America was manufactured for use at this copper mine for pumping out water. Jonathan Hornblower of Cornwall, England, played a role in their steam engine manufacture; the Hornblower dynasty of New England, represented in The Pilgrims Society, is described in [#7](#) Silver Squelchers, pages 22-34. This was a Newcomen Steam Engine, named after James Newcomen, an English inventor who helped start the Industrial Revolution of 1800-1850. The [Newcomen](#) Society of North America (1923-2007), disbanded for unclear reasons, was long headed by Pilgrims Society member Charles Penrose Jr., inheritor among other things of gold mining interests. Of his ancestor the Colorado Business Hall of [Fame](#) states he had "an enormously successful mining career" (in the late 1800's at the Cripple Creek, Colorado gold mining district) and left a foundation today worth over \$500 million. It's counterpart was the Newcomen

Society of England, managed by Pilgrims members there and represented interests tracing to the Industrial Revolution. Their emblem---“We look backward while going forward” is the inscription---



HRH The Duke of Gloucester (Pilgrims Society of Great Britain) is Royal [Patron](#) of Newcomen Society of England, which bills itself as “The International Society for the History of Engineering and Technology.”

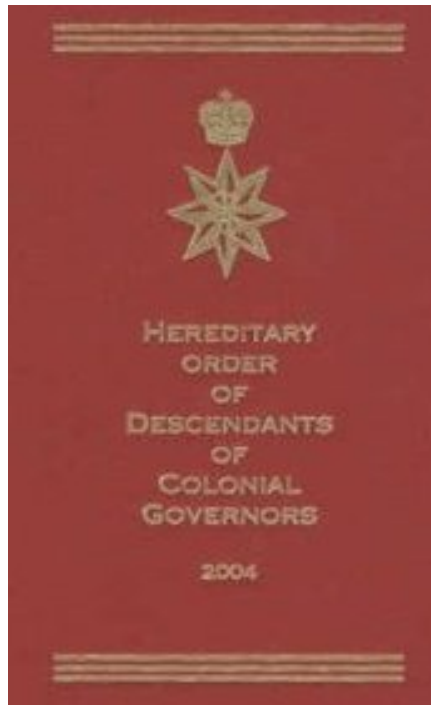
We also mentioned the Livingstons. To date, in a tally of hours which I don’t want to know the extent of, the Livingston line remains connected to more members of The Pilgrims United States than any other single line! Myers in his 1936 research stated on pages 44-45---

“Robert Livingston, progenitor of a rich and potent family which for generations exercised a profound influence in politics and other public affairs, contrived to get together an estate which soon ranked as the second largest in New York State and as one of the greatest in the Colonies. In currying favor with one official after another he was unscrupulous, dexterous and adaptable. He invariably changed his politics with the change of administration. He was appointed to an office he held for nearly half a century. Offices were created apparently for his sole benefit. He loaned money at **frightfully usurious rates** and hounded his victims without a vestige of sympathy. (start page 45) As a trader and government contractor he made enormous profits; such was his cohesive collusion with high officials that competitors found it impossible to outdo him. A current saying of him was that he made a fortune by “pinching the bellies of the soldiers; that is, as an army contractor who defrauded in quantity and quality of supplies. By a multitude of underhand and ignoble artifices he finally found himself the lord of **a manor sixteen miles long and twenty four broad**. On this estate he built flour and saw mills, a bakery and a brewery. When he died about 1728 at the age of 74 years, he left an estate which was considered of **such colossal value** that its true value was concealed for fear of further enraging the discontented people.”

Part of this reads like the stories of the Pentagon paying \$77 for simple screw drivers; no doubt, more wealth grabbing by The Pilgrims organization. Neuhauser I'm not locating in any Who's Who

volumes however; we have other acceptable sources on his Pilgrims membership. We [read](#) that he resides in Tuxedo Park, New York (residence of assorted Pilgrims members over the years) and that “his career is in investment management.” Among the other groups he holds membership in are The Hereditary Order of Descendants of Colonial Governors (Honorary Governor General); **One Hundred Living Descendants of Blood Royal; Order of the Merovingian Dynasty (Fourth Vice President General); Order of the Crown of Charlemagne (Treasurer General); National Society of Americans of Royal Descent;** General Society of Mayflower Descendants; Colonial Order of the Acorn (treasurer); and reflecting his Schuyler and Van Rensselaer heritage, the Dutch Settlers Society of Albany. He’s a member of The Order of Saint John of Jerusalem, appointed by Queen Elizabeth II. “Mr. Neuhauser is a member of the Racquet and Tennis Club of New York, the Tuxedo Club, the Maryland Club, The Pilgrims. He and his family are Episcopalian.”

Home prices currently [offered](#) in Tuxedo Park range to \$10 million. The Descendants of Colonial Governors is another interesting group, as definitely some of those Governors were Crown loyalists!



The [Tuxedo](#) Club (founded 1886) has had interlock with The Pilgrims for many years. He's a member of The Maryland [Club](#) founded in Baltimore in [1857](#)---



At Bloomberg Business Week we [notice](#) that Neuhauser is a CFA, Certified Financial Analyst who has been "an Analyst/Manager of

Reich & Tang Asset Management, LLC's Capital Management Group since October 1998. Prior to joining, he was a Senior Vice-President at Investment Counselors of Maryland since 1991. He served as a Portfolio Manager and Analyst at Delafield Asset Management, Inc. He was a Securities Analyst of Legg Mason Wood Walker, Inc. from May 1989 to July 1991 and a Securities Analyst with Bear Stearns from January 1987 to April 1989. He serves as a Director of Sequoia Fund, Inc.”

At Reich & Tang [site](#) we read that they are “one of the nation’s largest firms dedicated solely to liquidity and global cash management solutions. Our daily focus is to create, improve, and deliver smarter ideas to help banks, broker-dealers, and institutions maximize the value of their deposit, money fund, and short-term investment programs. This singular focus across several business channels combines to form a unique perspective and expertise that provides a deeper insight into the multiple disciplines within cash management.”

We also [notice](#)--- “Reich & Tang is a wholly-owned subsidiary of Natixis Global Asset Management, L.P. (“NGAM”), one of the world’s largest money management organizations. NGAM is part of Natixis, which is a subsidiary of Group BPCE, the second largest banking group in France.”

Is Neuhauser’s position in a French related financial entity connected to his membership in ancient French related orders--- the Merovingian Dynasty and the Crown of Charlemagne? I’d say---

yes---and also that these entities became connected to British royal and financial interests ages past, starting with the Norman invasion of England in 1066 AD by William The Conqueror, and other events including the marriage of Eleanor of Aquitaine (France) to King Henry II of England in AD 1152.

Delafield Asset Management is another of Neuhauser’s connections. This one very nearly takes the cake, as the Delafields were powers in the founding of the Bank of America and trace back over 1,200 years to a Count De La Feld in France! The Delafields are profiled in [#3](#) Silver Squelchers, pages 44–52. J. Dennis Delafield [looks](#) like a Pilgrims member to me; we have no definite confirmation absent a roster. At <http://moneymasters.com/default.aspx?page=DelafieldDennis> we read---

“Dennis Delafield has a very rich family heritage. His ancestors were one of the **largest original landowners in New York State**, allowing them access to George Washington and John Adams. His great uncle, Chancellor **Robert Livingston helped negotiate the Louisiana Purchase.**”

Delafield Asset Management is part of [Natixis](#) Asset Management (\$890 billion), of which Reich & Tang is also a component!



Neuhauser was also involved with Legg Mason [Global](#) Asset Management (founded in 1899 in Baltimore) which today has [\\$711](#)

billion in assets under management with 31 offices and over 3,000 employees.



Charles William Neuhauser, Pilgrims Society of the United States, **has**
ancient royal heritage from numerous blueblood lines including
Charlemagne, “the founder of Western Civilization” and the earlier
Merovingian kings of France---



There's a little known publication called the "Merovingian Mirror" at www.merovingiandynasty.com In this [issue](#) we notice this group's top three officials---are all members of The Pilgrims Society. Hardwick Smith Johnson Jr. is the "President General" and Charles Clement Lucas Jr. is "1st Vice President General" and Charles William Neuhauser is "2nd Vice President General." We are about to do a review of Lucas, and will touch on Johnson also. Notice their pervasive use of the word "General," yes, it's in reference to a military sense! Another official, Timothy Field Beard, is also a Pilgrims Society member. Make that past tense as he recently

passed on. He held the title of “Genealogist General.” That info comes from the Winter 2011 issue of Merovingian Mirror, which mentioned they have 250 members and several applications in the hopper. Barry C. Howard, their “Registrar General” has an office in Westminster, Maryland! Westminster is an area in London and a reference to the great Dukes of Westminster, and Maryland is named after England’s Queen Mary! The MM publication [mentions](#) “Gateway Ancestors” (page 3).

Neuhauser was with Bear Stearns & Company in the late 1980s, later identified by Ted Butler as the former leading silver short (well after Neuhauser’s time there).



Neuhauser is a current [director](#) of Sequoia Fund, whose share price as I write this is \$250.79. In 1970, \$10,000 [invested](#) in the Sequoia Fund grew to \$4,185,695 by year end 2014. Page 6 says Tiffany & Company is one of their long term holdings; this is a notorious Silver Users Association company with Pilgrims Society members on its board! Page 24 shows Sequoia at \$8,068,000,000 assets. However, Tiffany & Company jumped ship in spring or summer

2015 from the Silver Users Association roster. See the July 2015 release <http://sgtreport.com/wp-content/uploads/2015/07/The-Silver-Users-Association-Is-Shrinking1.pdf>



In case someone asks, “how come you didn’t mention this?” there are some potential controversies I do tend to minimize but you can click [HERE](#). However, he does identify himself as an [Episcopalian](#). In America, that’s the best religious avenue to make oneself acceptable to the sponsors of The Pilgrims Society---the British Royals. Presbyterian appears to be the runner up, and some non-Protestants and non-Christians are also members---with the size of their wealth being the overriding qualification.

2) Charles Clement [Lucas](#) Jr. (1942---; Pilgrims Society as of current info; a member for an undetermined number of years) is a Medical Doctor practicing in Larchmont, New York; state medical license # [147930](#). That’s a Manhattan suburb where many members could consult with him, and it’s doubtful he’s the only medico who’s a member up there currently. He’s one of the doctors inducted into The Pilgrims so members can see doctors who are also members so that Society business and secrets can remain confidential. Imagine

a member in delirium being treated by an MD who isn't a member---it could cause trouble. The other clear reason why some MD's are admitted is because **The Society expects to use Big Medicine, Big Hospitals and Big Pharma as its last ace in the hole for "seizing" and "absorbing" wealth from the rest of us.** To give a sense of the importance of doctors in this Secret Society, consider this---one of the founding members of The Pilgrims New York in January 1903 was Dr. Russell Bellamy. In "New York University---Its History, Influence, Equipment and Characteristics, With Biographical Sketches and Portraits of Founders, Benefactors, Officers and Alumni," volume 2, 1903, page 405 has [this](#)---

"Russell Bellamy, M.D. who enjoys a reputation as a successful practitioner **among the wealthy and fashionable** people of New York and Newport, is the fourth in a hereditary line of doctors. His father, Dr. William James Harriss Bellamy, is one of the foremost physicians of North Carolina, and his grandfather, Dr. John Dillard Bellamy, was also prominent in his profession. The Bellamy family settled in the Carolinas in the latter part of the seventeenth century. Dr. Bellamy's mother was, before her marriage, Mary Russell, and her father, Daniel **Lindsay Russell**, was before the Civil War one of the prominent planters. His maternal grandfather was General William Russell who married a sister of Patrick Henry. Dr. Bellamy, born in Wilmington, North Carolina, on February 12, 1871, was prepared for college at the Cape Fear Academy. He entered the University of North Carolina in 1887, and spent two years there,

devoting his attention to literature, chemistry, natural history and athletics. Thence he went to Davidson College, North Carolina, and there took the preparatory course in medicine. Afterwards he entered New York University Medical College, and became eminent as a student in medicine. At the age of twenty he had been first prize man for the highest average before the State Board of Medical Examiners of North Carolina, and received the Appleton Prize over seventy five competitors. At New York University Medical College he won high rank and was graduated as one of the honor men of his class in 1892. In that year he won the first prize appointment for service in Bellevue Hospital, and spent two years in that institution on the staff in obstetrics, abdominal surgery and medicine.”

Lindsay Russell (1870–1949) was descended from Daniel Lindsay Russell and was also a founding member of The Pilgrims. He was a liaison between the Vanderbilts and the Rockefellers! The Vanderbilts made possible the Rockefellers Standard Oil by means of secret rebates to the Rockefellers, enabling the Rockefellers and their associates to undercut their competitor’s prices and drive them out of the market, after which naturally, prices rose to higher levels than they would have, had competition survived! Pilgrims Society = “Monopoly Capitalism.” Page 2031 of the 1914–1915 Who’s Who in America shows this---

RUSSELL, Lindsay, lawyer; b. Wilmington, N.C., Nov. 18, 1870; s. Thomas B. and Fannie B. (Havens) R.; U. of N.C.; studied law with Ex-Gov. Russell of N.C.; admitted to bar, 1892; LL.B., U. of Mich., 1893; married. Removed to New York, 1899; mem. McLaughlin, Russell, Coe & Sprague, 1903—. Receiver Otto Heinze & Co. (United Copper brokers); dir. Am. Surety Co., The Independent (mag.). Founded, 1901, and dir. Pilgrims Soc. of London and New York; founded, 1907, and pres. Japan Soc. New York—both for promotion of Internat. friendship; pub. recognition given in London and New York and decoration of Order of Sacred Treasure, 3d Class, by Mikado, “for meritorious service”; dir. Am. Peace and Arbitration League, New York Peace Soc. Member N.Y. County Lawyers’ Assn., Southern Soc., Delta Kappa Epsilon. Republican. *Clubs*: Republican, Lawyers’. *Home*: Tuxedo Park. *Office*: 165 Broadway, New York.

More on Dr. Bellamy---

“During the following year he travelled with a patient from Manitoba to Mexico and made a special study of Rocky Mountain climates. He then went abroad and studied in some of the great medical schools and hospitals of Europe, principally the University of Vienna. Dr. Bellamy was assistant to Professor Theodor Kocher in the surgical clinic in Berne, Switzerland, in 1896. Since his return to the United States he has been steadily and successfully engaged in medical and surgical practices in his private offices in New York as well as at Newport, and also in various New York hospitals. During the winters of 1894, 1895 and 1896 he conducted a large private quiz class in medicine and surgery. He was also for some years an instructor in the New York University Medical College in physical diagnosis, material medica and operative surgery. He is now one of

the instructors of Cornell University Medical College in Obstetrics and Gynecology. On June 3, 1899, Dr. Bellamy was commissioned as First Lieutenant and Assistant Surgeon in Squadron A Cavalry, New York National Guard, and was chairman of the Squadron's athletic committee in 1900–1901. He is not only an energetic, studious and scientifically inclined practitioner in his profession, but is also an enthusiastic athlete and sportsman, and the possessor of many big game trophies. He is a member of the City Club, St. Nicholas Club, Squadron A Polo Club, Campfire Club, the **Pilgrims**, Southern Society, the New York County Medical Society, the American Medical Association, Bellevue Hospital Alumni (start page 406) Society, the Newport Golf Club of Newport, Sigma Alpha Upsilon, and other organizations. He is the author of papers and treatises, the most important of which relate to typhoid fever and surgery, and is also Examining Surgeon for the Travellers Accident Insurance Company. He was married on April 20, 1898, to Constance Trenholm, daughter of the late Honorable William L. Trenholm, **Comptroller of the Currency of the United States**, author and **prominent financier**. Dr. Bellamy's address is number 35 West 31st Street, New York City and his summer home is at Newport, Rhode Island."

William Trenholm's [father](#) was George Trenholm, **treasurer of the Confederate States of America!** Dr. Russell Bellamy organized the Manhattan Maternity Hospital, probably due to his interest in the procreative activities of other Pilgrims Society members and their

marriages, like his, uniting great wealth with greater wealth, and was on hand at the Presidential inauguration in March 1905. There are many examples of physicians in The Pilgrims Society. To return to Dr. Lucas---

C.C. Lucas Jr., Pilgrims Society, at the English Ball
Of the St. George's Society of New York, founded
To help British Crown loyalists in Revolutionary times---



Of his father, Charles Clement Lucas Senior (1908–1989) we find [this](#)---

“Charles Clement Lucas, Sr. was a very successful Wilson County tobacco farmer. He received many awards for growing some of the brightest and highest quality leaf. Each year at auction his tobacco brought in some of the highest dollars/pound. He took pride in the quality of his farm production and was available to share his knowledge with anyone interested. As a descendant of the Bass/Lucas family he embodied the ideals of the highest integrity in

all his business affairs. He married Sallie Elizabeth Williams of Sampson County, North Carolina, daughter of John Blaney Williams a very successful and prominent businessman and political leader.”

Did his tobacco get sold to the Reynolds Tobacco interests (Pilgrims Society) or by the Cullman Philip Morris interests (Pilgrims Society) or by Liggett & Myers interests (Pilgrims Society)? This [document](#) is a genealogical tracing of the Lucas ancestry over the centuries back to Plantagenet reign England and the FitzAlan dynasty in early 1300s England, whose wealth in modern terms was north of \$100 billion; the FitzAlan clan has modern representation in The Pilgrims Society of Great Britain; and this Lucas lineage goes farther back still earlier than that to the Earls of Pembroke and the signatories of the Magna Charta, and still earlier to Henry I, King of France, to King Bernard of Italy and to Emperor Charlemagne (condensed summary!) There’s this recurring theme of descendants of Royalty in The Pilgrims organization---this should be interpreted as **very disturbing!** The name Lucas traces to a region in southern Italy known as “[Lucania](#)” meaning bright or shining; there is in the Yukon Territory of Canada a Mount [Lucania](#) at 17,192 feet. Our subject Pilgrims member for this profile, Dr. Charles Clement Lucas Jr., is in fact, a [member](#) of The Order of The [Crown](#) of Charlemagne in the United States! We read---

“The Order of the Crown of Charlemagne was organized in the United States on January 1, 1939 and incorporated in the District of Columbia on October 10, 1939. It is an independent patriotic and

lineal society named in honor of the Emperor Charles the Great (742–814) and also named after an ancient noble and chivalric order in Europe which according to tradition was instituted by the Emperor in 802 to distinguish and honor his most valiant warriors who fought in the war against the heathen Saxons. Descendants of the Emperor have maintained the order without great interruption through the centuries. The Order meets once a year in Washington, DC at a "black tie" dinner event the second Thursday of April."

The "heathen Saxons" in England before the invasion by William the Conqueror from Normandy (France) in 1066 AD, have some descendants that appear in The Pilgrims Society of Great Britain, along with descendants from King William and his nobles!

Charlemagne (742–814 AD) is regarded by many historians as "the founding father of Western civilization." Here's a representative relic of him in gold---

There is not a consensus as to his size, but ancient sources show he was a seven footer and the claim was made that he could straighten four [horseshoes](#) (together), leaving him distant second to the giant Roman Emperor Gaius Julius Verus Maximinus Thrax. The Romans left their genetics in ancient Britain, and in the 1914 Pilgrims

London list we notice Edward T. Agius, very Roman or Latin sounding name, whose grandson became chairman of Barclays and a Rothschild son in law! I'd bet that a fair number of Pilgrims London members have some old Roman genetics---this may partly account for why England is modern history's greatest instigator of warfare! Like most members of The Pilgrims United States, Lucas is (predictably) an Episcopalian.

Charles C. Lucas Jr. identifies himself as a member of The Pilgrims Society [here](#) and listed other groups he is a member of and look at his regalia and symbolic decorations he's boasting of. He lists 67 hereditary Orders he belongs to; two Orders of Chivalry; and 18 other organizations besides The Pilgrims---partial excerpt---notice the frequent use of the term "General," the military connotation is no accident---

The Augustan Society mentions [connections](#) between ancient Egyptian dynasties and the much more recent Charlemagne and William the Conqueror and descendants of Knights in the Crusades to the Holy Land---the word Augustan is very suggestive of a Roman Empire connection as the Romans were also in Egypt.



Lucas is a member of the Huguenot Society of [America](#) (founded 1883), discussed under Robin Renwick. They're a French Protestant faction, quite wealthy historically, who warred with the Catholic Church and eventually most of them fled France due to the conflict. Many members of The Pilgrims have Huguenot ancestry.



Like religious controversies, I'm not interested in getting into a brouhaha about Masonry; most Pilgrims aren't Masons; I distrust Masonry as I've been told by Masons that they're pledged to "help" each other (that is, at the expense of the rest of society---a city manager is a Mason; he accepts bids, and if a Mason bids and isn't low bidder, he WILL get the contract! Imagine how Masonry [affects](#) the [court](#) system! The 700 members of The Pilgrims in New York have way more influence than millions of Masons, however---

The Sovereign Military [Order](#) of the Temple of Jerusalem

The Ancient Heraldic & Chivalric Order of Albion was founded in 1643. "Hereditary Membership is [limited](#) to direct lineal descendants of Sir Edmund Plowden; an original member of the Order; or an ancestor from a family of known hereditary Peerage who settled, during the seventeenth century, on land within the proposed Province of New Albion in North America, and whose progeny rendered distinguished and official service in the founding of the United States of America. Membership is *limited* and *strictly* by invitation only."



Order of Descendants of Pirates & Privateers

This group represents descendants of people 1609–1865 involved
In piracy, privateering (“corsairs”) including [SCUTTLING](#) of ships!



The Order of the [Crown](#) in America is limited to 400 members and is strictly by invitation only. “Eligibility for membership consists not simply of proving legitimate royal descent, but of establishing worthiness of the high distinction this membership confers. It is also required that the candidates shall have attained their majority and that the ladies be members of either The Colonial Dames of America or The National Society, Colonial Dames of America.” There is a difference between “colonial dames” and “revolutionary women,” the difference in this case means “loyalty to the British Crown in the twenty first century.”



The Order of the [Merovingian](#) Dynasty refers to a royal line who dominated France for around 300 years before the coming of Charlemagne---



In "Jewels of the Crown," Fall 2007, page 5
<http://www.charlemagne.org> we read---

"The Merovingian Dynasty (began 451 AD) was the earliest point that such lineage could be extended. At present there are over 110 members of the Order of the Merovingian Dynasty."

Why did the dynasty start in AD 451? Because in that year the Battle of Chalons, also called the Battle of the Catalaunian Plains, took place in what is today northeastern France. A Roman led coalition

by Flavius Aetius (left) forced the retreat of Attila the Hun in what is still regarded as one of the 15 [most](#) important battles in history! The grounds were blood soaked over a large area; ancient [sources](#) claim from 165,000 to 300,000 battle casualties.



Their site <http://www.merovingiandynasty.org/> says the dynasty was in power from 448 AD to 571 AD, less than half the duration I've seen other sources claim. It may refer to their peak years. Their start page gets in your face like few others I've ever seen; a glance is recommended. [This](#) image of the Order of the Merovingian Dynasty shows at far left, identified Pilgrims Society member Charles William Neuhauser (who we will profile next) and at far right, Pilgrims member Charles Clement Lucas Jr. and the bald fellow in the middle, I believe is H.S. Johnson Jr., another Pilgrims member (not completely certain as to the name and the face). Top row far left I believe is Barry Christopher [Howard](#) (a potential future Pilgrims member) ---get a load of the pretentious decorations and the sashes denoting royalty---



Here's a [brief](#) speech by Pilgrims member Dr. Lucas from 2006 delivered at the Corinthian Yacht Club on the Merovingians. I suggest it as a read. A quote---

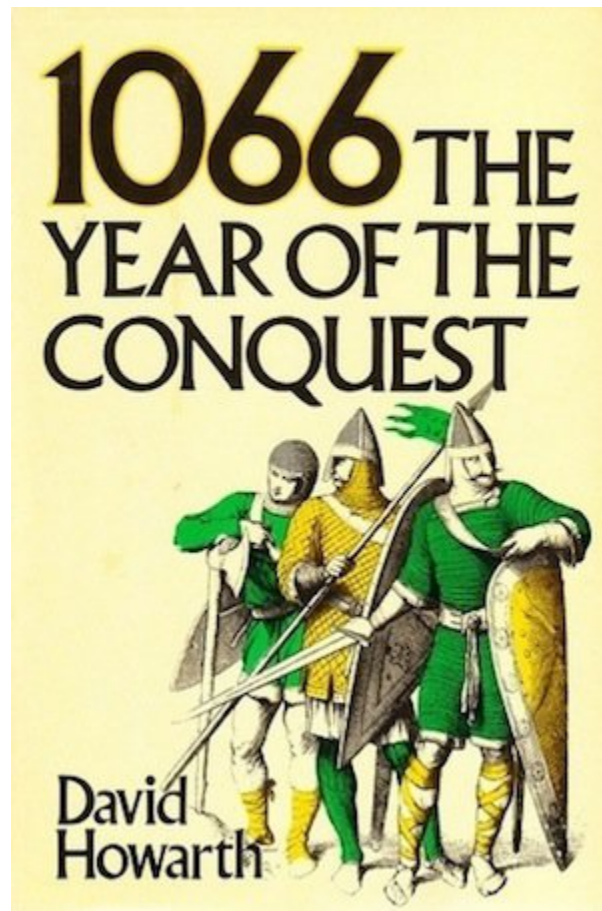
“Merovingian history provides a focus for understanding the political history of Western Europe in the two and half centuries following the deposition of Romulus Augustulus. The Merovingian kingdom had a significant role to play in the transmission of culture from the late Roman period to the Carolingian period.”

Yes---North and South Carolina are both named for an Old World dynasty! http://www.merovingiandynasty.org/details.php?id=current_officers shows several identifiable members of The Pilgrims---Timothy Field [Beard](#) (recently deceased); Charles William

Neuhauser; and Philip Robert Livingston I'd bet [serious](#) money---is a [member](#), and not far from the inner circle!

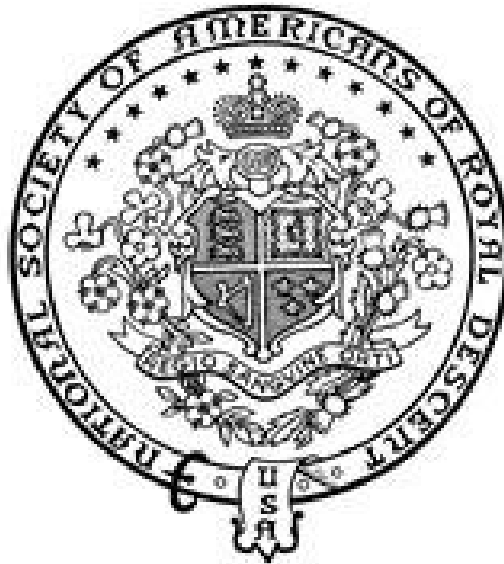
The Order of the Three Crusades 1096–1192 is [mentioned](#) on page 4 of the fall 2008 issue of “Jewels of the Crown,” newsletter of the Order of the Crown of Charlemagne in the United States---“The Order of the Three Crusades was founded in 1936. Membership is limited to lineal descendants of participants in one of the first three crusades 1096–1192. To be accepted, the Crusade ancestor must have gone to repel the Turkish Army from Europe and Palestine as a soldier Crusader between 1096 and 1192. A mere pilgrimage to Jerusalem as a religious gesture was not a crusade or acceptable for ancestral lineage to become a member of the Order. Membership is strictly by invitation only.” The Order of the [Crown](#) of Charlemagne in the United States we recently discussed. Charlemagne was [mentioned](#) as “the monumental eighth century Frankish king who founded the Holy Roman Empire.” Timothy Field Beard (1930–2015) is [mentioned](#) on the start page of the Order of the Crown of Charlemagne in the United States; he was in The Pilgrims; they didn't mention it.

The Order of the Norman Conquest appears to not have a site. Nonetheless we know it has to do with the invasion in 1066 AD of England and the takeover by King William I with his success at the fabled Battle of Hastings, perhaps among the ten most important military engagements in world history. It is certain to be restricted to persons who can establish lineage to knights and nobles who fought with William---



The Army–Navy Club in Washington, site of Silver Users association meetings, is the [site](#) for the annual meeting on April 14, 2015, of the Order of the Norman Conquest. In fact the link lists 22 other hereditary and ancestral historical groups meeting at the Army–Navy Club during 2015---seven of them are groups to which Charles Clement Lucas Jr., our subject member of The Pilgrims for this profile, also belongs to! Other Washington Clubs these groups will meet at in 2015 include The Cosmos Club (interlocked with The Pilgrims); Sulgrave Club (interlocked with The Pilgrims); Metropolitan Club (interlocked with The Pilgrims); the University Club (interlocked with The Pilgrims); and the Chevy Chase Club (interlocked with The Pilgrims).

The National Society of Americans of Royal Descent, of which Charles C. Lucas Jr. is “Curator General,” has this as its emblem---



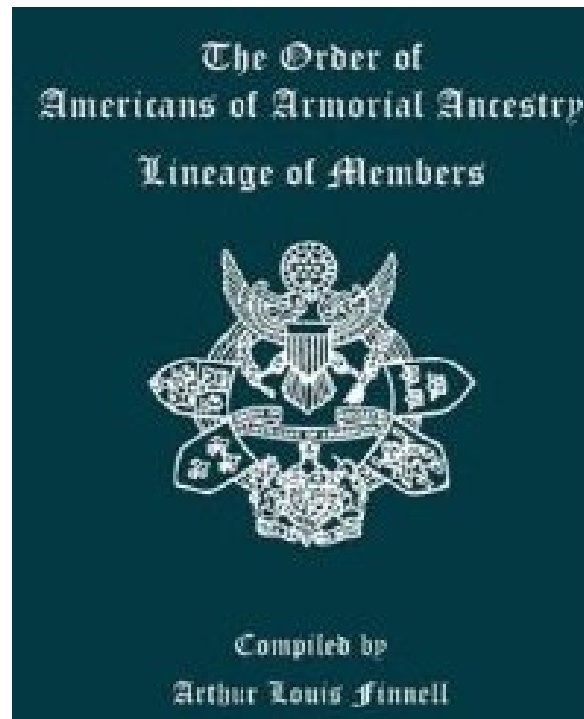
“Established in 1908, the National Society of Americans of Royal [Descent](#) has the distinction of being the only national patriotic lineage society founded in Georgetown in the City of Washington, in the District of Columbia. The Society was registered with the College of Arms in London, England on January 1, 1936. Persons of Royal Descent from Ruling Houses of Europe and the British Isles who are members of certain recognized American ancestral societies having to do with periods of American History anterior to the American Revolution shall be eligible to membership. Membership in the society is strictly by invitation only. The current president is Dr. Hardwick Smith Johnson Jr.” Johnson is a [member](#) of The Pilgrims and the [Beresford](#) Family Society. Beresford is a name found in

rosters of The Pilgrims Society London and represents large real estate holdings in England, Ireland, and Manhattan.

The Order of Americans of [Armorial](#) Ancestry is immediately suspect due to two aspects---being founded in 1903, the same year The Pilgrims were founded indicates this was another Pilgrims Offshoot from the start (8 months [after](#) The Pilgrims) and the word “armorial” refers to medieval weapons of battle. They are hereditary warmongers with a Pilgrims Society interlock---very bad seed!

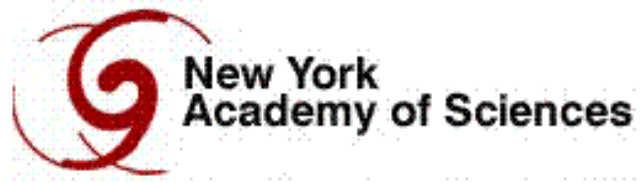

The Order of Saint John of Jerusalem is a Crusaders Order headed by the British Sovereign and is therefore of great importance. We addressed the organization in “Pilgrims Society [Takeover](#) of Bitcoin,” pages 115–117 and 120. The Order of Indian Wars of the United States, also of great significance, is addressed in the profile on Nicholas Donnell Ward. Dr. Lucas, Pilgrims Society, graduated from Duke University. His son, Charles C. Lucas III, possibly a Pilgrims member or on the waiting list, was [elected](#) to the board of trustees of the Duke Endowment, a foundation which forms an important part of the financial support for Duke University. Lucas Senior is a member of the North Carolina Society of the City of New York. That’s what manipulators and influence peddlers do---they create strings to pull, and lots of them. He’s a member of the influential New York Academy of [Sciences](#) founded in 1817---it has a

Rockefeller family operative on its [board](#)---patents of all descriptions developed there will accrue to the coffers of The Pilgrims organization---



Lucas is a member of the Union Club of New York, discussed in the profile of Charles Lawrence Brock. Lucas was inducted into The Order of the Long Leaf Pine, North Carolina's highest state government award. Lucas earns a high income as an MD however; to what extent does that contrast to his inherited wealth, and/or the wealth he represents as a proxy for certain family groups in this royalty mish-mash? We can only conjecture; since The Pilgrims was set up to "gradually absorb the wealth of the world," my inclination is that this medical doctor is not run of the mill in the assets

department. “We are very particular as to who we let in” has been discussed elsewhere. Would Dr. Lucas be interested in testifying before Congress in a publicly televised session as to what The Pilgrims Society and its interlocking groups are up to? How about current **MEMBERSHIP ROSTERS** of these Worthy Gentlemen loyal to the British Royal family? ---

As a Yale graduate, Moore may have become a member of one of the “super fraternities” there, such as Wolf’s Head Society; it seems doubtful all of them would have missed him. The Dewey Ballantine law firm has long standing deep connections in The Pilgrims Society, same as Breed, Abbott & Morgan, except more so. Known since 2007 as Dewey & LeBoeuf, this other name also has long standing connections in The Society. We could do a long digression

reviewing individuals in these two firms, their connections are very weighty! Moore's calling cards at Harvard, Cornell, New York University, Practising Law Institute and Oxford University are impressive. PLI is part of the State University of New York---



The Tax Lawyer, sponsored by Georgetown University, has Moore as an expert commentator---

Moore says he's president of the National Society to Prevent Blindness; I don't see his name at their [site](#); he may mean to say, "honorary" president or it may be a detail he hasn't updated. A fair number of members over the years have been identified with anti-blindness groups. My view is that their interest is more in greed

than do-gooders. By 1908 when this group was founded, it was known that world knowledge had surged forward dramatically since 1808; I believe they “envisioned” a future time when blindness could be medically reversed, and these super capitalists will cartelize the patents and gouge recipients accordingly!



The A.D. Henderson Foundation in Fort Lauderdale, Florida, apparently makes no [mention](#) of Moore. What’s up with him? Is it more info which is outdated? Is he there in a “shadow” capacity, running the show while being mostly concealed? It’s about early childhood “education”---

Same situation goes for the Phoenix Theatre Institute (location unknown, possibly England). There is a Phoenix [Theatre](#) in Arizona; I see no mention of him there. Is he trying to lead researchers a merry chase? There is a Foundation for the Future of Man in [Lambertville](#), New Jersey. It was founded in 1971 as a State of Delaware entity. I’ve seen a few [references](#) to it before in connection to other Pilgrims members. The [Institute](#) of Aegean Prehistory, founded in 1982 in Philadelphia, has made over 3,000

research grants. No details at the site mention who the trustees are---it may be possible these Pilgrims are using researchers to locate treasures, gold and gems, or valuable archaeological artifacts, that can be recovered and donated to museums they're trustees of and generate huge tax deductions---



The American Friends of the Victoria & Albert Museum (London) is based in Greenwich, Connecticut. I find no [reference](#) there to Moore. However, he may have founded it as he states, then turned it over to others---



The V & A Museum, founded in 1852, is named for Queen Victoria and Prince Albert, who among other activities were champions of the Chinese opium for silver “trade.” Several V & A [trustees](#) appear prospective as members of The Pilgrims London; confirmation is presently unavailable.



Moore says he’s a conservator of the New York Public Library meaning; someone in charge of supervising the upkeep thereof,

such as ordering repairs and purview of artworks and other related concerns---



In a search for the Foundation for the Renaissance of St. Petersburg Russia, of which Moore says he's a trustee, the strongest result I find is [this](#) having to do with a real estate and building materials conglomerate in St. Petersburg, Russia, with 16,000 employees. Meaning; I can't tell this is definitely the same thing he's talking about, but there are several probable [indications](#). Next he says he's a trustee of the Malcolm Weiner Foundation. [M.W.](#) "is an Aegean prehistorian, retired principal in an investment management firm." M.W. married a woman with "Talbot" as part of her name; this is a very old English name with lots of history and he was born in China in 1935---China abandoned its long standing silver standard on November 3, 1935. What were his parents doing in China at that time? "Wiener was the founder and chairman of the Millburn

Corporation, Millburn Ridgefield Corporation, CommInVest (1977–1997) and ShareInVest (1982–1997). In 1982, he founded the Institute for Aegean Prehistory (INSTAP).” M.W. is or has been a trustee of the American School of Classical Studies at Athens, the Metropolitan Museum of Art and is a CFR member.

At the Laurence Levine Charitable Fund we finally find Moore’s [name](#) at a site he claims linkage to! This one appears a mere sand box operation with assets below \$5 million however; what do you want to bet these Pilgrims will pick up a clad quarter if they see one on the sidewalk? He says he’s vice chairman of the New York Historical Society; again, I don’t see his name; it may be another case of he didn’t update his info. However, there are other [definite](#) Pilgrims Society names there---Beekman, of an old-line Dutch dynasty with large land holdings; and Pennoyer, close relations of the J.P. Morgan clan.

Youth America Grand Prix in New York is a dance organization. Again, I don’t find his name in their [list](#). As honorary chairman, they may have omitted to list him but this is usually not the case. I don’t find a Governor’s Commission on Scholastic Achievement; actually, it’s a “[Committee](#),” info as to who is on it isn’t directly available. Another phantom post, or an ex position, or a current one? Apparently Moore, styled “Lord Bridestowe” was big with President George H.W. Bush, who is himself heir to no less than three old lines that [trace](#) back to King Edward I of England (reign 1272 to 1307 AD)

known famously as “Longshanks” from Gibson’s 1995 movie “Braveheart.”

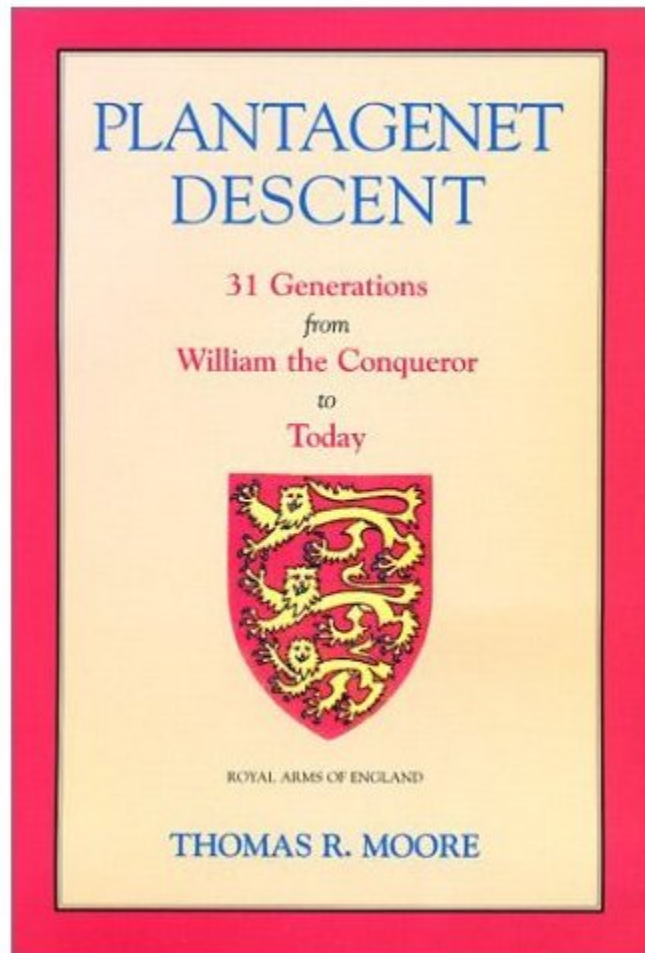
Next Moore states he’s an advisor to King Michael I of Romania (born 1921) who was forced to leave in 1947. He started using one of his family’s ancestral titles, “Prince of Hohenzollern” and married Princess Anne of Bourbon–Parma. There’s a tremendous history in these names. In 1585 the Duke of Parma laid siege to Antwerp, Belgium. The Bourbons were an important French dynasty. The Hohenzollerns were a royal house tracing to AD 1061 in Prussia, Germany and Romania. There’s far more of course; we will stop with these three items.



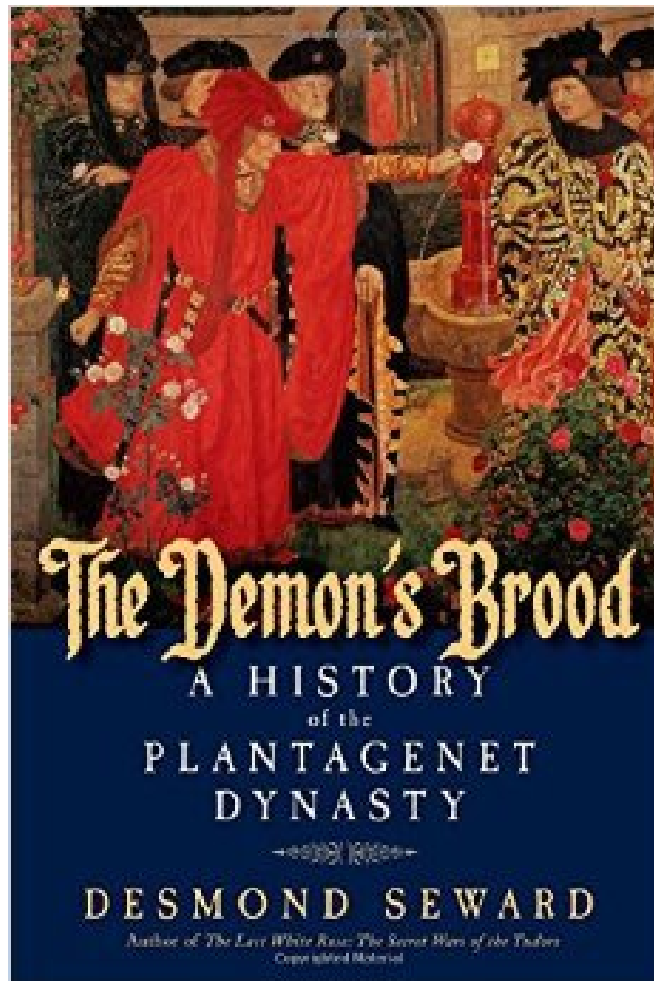
At some point Moore was awarded the title Lord Bridestowe by Elizabeth II, Queen and patron of The Pilgrims Society. He’s a member of the Order of the Merovingian Dynasty and the Order of the Crown of Charlemagne which we won’t describe in his profile, having addressed those groups in other profiles. He’s a member of

the Order of Barons of Magna Charta, which may in fact be the Baronial Order of Magna Charta, also described elsewhere. The Order of Plantagenet is one I haven't noticed in other Pilgrims profiles with royal roots. In a search for it, this link appears at the top of the list <http://www.britroyals.com/plantagenet.htm>

“Plantagenet Descent: Thirty One Generations from William the Conqueror to Today” is an item of definite [interest](#) Moore published in 1995. This character is another Pilgrims Society member with an off the scale ancestral lineage tracing back 949 years, and really before the Norman invasion of England in AD 1066---



Strictly speaking, the Plantagenet dynasty held sway in England from AD [1154](#) with the uniting of King Henry II and Eleanor of Aquitaine, to 1485 when the Tudor era started. The histories are quite lengthy. The Plantagenet lineages didn't disappear when the Tudor era started, however; notice Moore connects it to 1995. "The Demon's Brood---A History of the Plantagenet Dynasty" came out in September 2014. For every word I type, I read six to eight times as much and this [book](#) is on my list---Seward is a recurring name in both London and New York branches of The Pilgrims---

Moore being a Wall Street lawyer would know about estate planning. He's seen details outsiders will never know anything about, and must have worked with many Pilgrims Society families, and with many just outside the organization. He's a supporter of [Oceana](#) "Protecting the World's Oceans" which was founded in 2001 by several other foundations including the Rockefeller Brothers Fund (Pilgrims Society). Their interest, very subtly implied, is that the world's oceans can benefit from large human population reduction. Unfortunately, that's correct---but do you see these Pilgrims elites offering to sterilize themselves? They also very likely are interested in seabed mineral mining, to be done by the "right" interests, possibly licensed by the United Nations, which is under their tight covert control.



The Roscoe [Pound](#) Prize from Harvard is named for a legal scholar who was appointed in 1929 by President Hoover (Pilgrims Society) to be a member of the Wickersham Commission (George W. Wickersham, Pilgrims Society) which “investigated” the law enforcement scene in the United States. The St. Andrews and St. George’s Society have to do with people of Scottish and English ancestry and are discussed elsewhere. I’d guess that the leadership of the St. Andrews Society, led by Pilgrims Society members, doesn’t favor Scottish secession from the United Kingdom! The Confrerie de la Chaine de Rotisseurs, founded in 1248 AD in Paris, is

“...the world’s oldest international gastronomic society, founded in Paris in 1248 by King Louis IX, possibly as a ploy to coordinate the nobles and aristocrats. It is devoted to preserving the camaraderie and pleasures of the table and to promoting excellence in all areas of the hospitality arts. Each year the society sponsors young chef and sommelier competitions that attract contestants from throughout the world, while the Chaîne Foundation provides scholarships for students in these fields. Chaîne is based on the traditions and practices of the old French royal guild of meat roasters. Revived in 1950, the society has professional and amateur members in more than 90 countries worldwide. In the United States, there are nearly 130 bailliages (chapters), each offering a variety of culinary activities to suit the interests of local members.”

I’d say most members of this group would be safe to have as neighbors, but that a relative few people at the top are

questionable. Notice Moore claiming four top level posts in this group---



The Confrérie des Chevaliers du [Tastevin](#), founded in 1703, was until 1934 known as Ordre de la Boisson, Order of the Beverage. Now known as the Fraternity of Knights of the Wine Tasting Cup, it's an exclusive group of Burgundy wine enthusiasts. This one is not a mass membership group; membership is by invitation only; "Members are hierarchically ranked (in descending order) as Grand officier, Officier-commandeur, Commandeur, and Chevalier. The Confrérie counts among its membership businessmen, luminaries, and celebrities, including politicians and military leaders, diplomats, executives."



In “David---Report on a Rockefeller” by William Hoffman (1971) page 101 has this---

“He’s a little stronger in Burgundies than I am, I guess,” said William A.M. Burden, a descendant of the Vanderbilts “but I’m probably a little stronger in Bordeaux.”

The book mentions Bilderberg, but not The Pilgrims. Burden was a longtime member at least to 1957 and Ambassador to Belgium and [director](#) of Allied Chemical (silver user); CBS; Hanover Bank; Lockheed Aircraft “and other major companies.” Burden was

president of the France–America Society and director of the CFR and the Atlantic Institute.

Moore states membership in the Church Club of New York.

Founded in [1887](#), the original J.P. Morgan Senior was among the founders. Morgan was a vice president of The Pilgrims when he died in 1913. As expected, this is overwhelmingly an Episcopalian organization and linked to the Crown's Church of England. When the English organize a conspiracy, they take it deeper by far than anyone else! Moore has offices at 785 Park Avenue in Manhattan, which is represented by Douglas L. [Elliman](#) & Company, another Pilgrims Society interest described in the profile on Theodore R. Gamble Jr. The Order of Descendants of Knights of the Garter appears to be the same as the Society of Descendants of Knights of the Garter also has Pilgrims member Charles C. Lucas Jr. as a member. Founded at Philadelphia in 1929, requirements for membership are to show lineage to members of this group in England, [founded](#) in AD 1348 by King Edward III; their page states 1345.



Probably both years are correct---it was organized in 1345 and a Royal charter granted in 1348. The motto translates to “shamed be the person who thinks evil of it.” I’ve seen the [view](#) before that the Order of the Garter rules over all other secret societies. It’s limited to [24](#) members at any one time. That may have been true until The Pilgrims were organized in 1902–1903. For The Pilgrims to become the top group, it was necessary to bring in many powerful Americans, few of whom have ancestry to the Knights of the Garter.

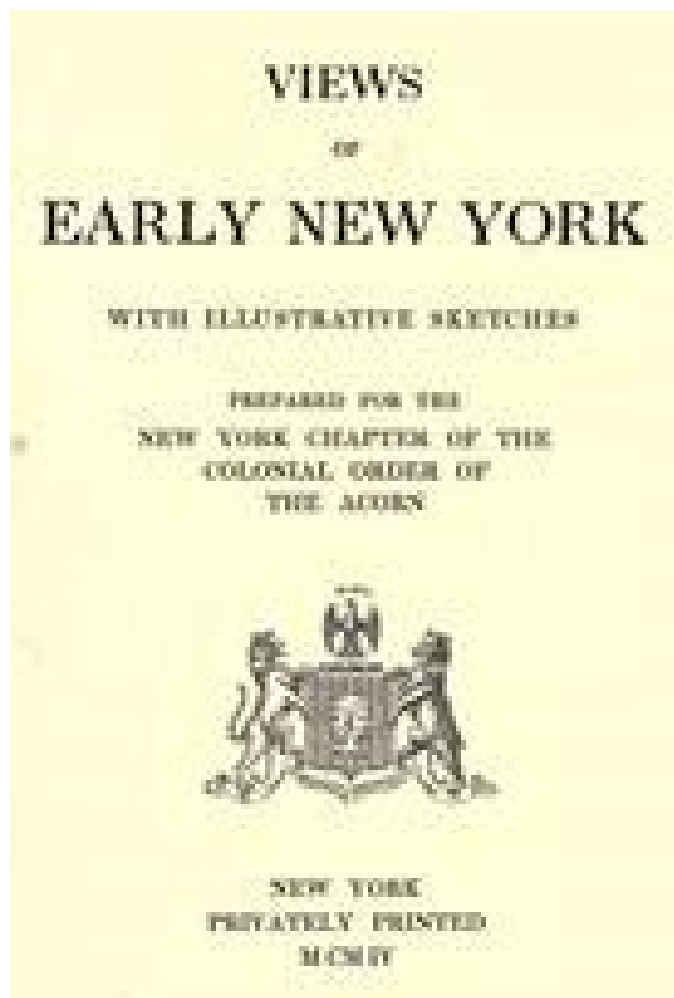

As a member of the Baronial Order of the Magna Charta there's no telling how deep his English ancestry goes but members of this group trace to the meeting at Runnymede England at 1215 AD with the King. The Baronial Order is described in the profile of Charles C. Lucas Jr. The Colonial Order of the Acorn had a Pilgrims Society member as lifetime chancellor. Sidney Hughes (1922–2007) wasn't in The Pilgrims 1980 roster but [here's](#) proof he was a member. He's among the members there's little info available from public records; he bragged that he had no Social Security number; those are for serfs, not for Lords! [Here's](#) a description of another member of the Colonial Order of the Acorn who appears to not be a Pilgrims member. Ancestry dot com reports "address [withheld](#)" by the Colonial Order of the Acorn which says, "It is a prerequisite that a candidate shall be a descendant, in the male line, of a forefather

resident prior to July 4, 1776, in one of the North American Colonies, that afterwards became the thirteen original states, and shall be nominated for membership and seconded by members of the Order. Membership is strictly by invitation only.” That link lists several hundred hereditary societies, of widely varying importance; The Pilgrims Society is not included.



The Jamestowne Society is another very old-line hereditary colonial society [founded](#) in 1936 “for descendants of stockholders in the Virginia Company of London and the descendants of those who owned land or who had domiciles in Jamestown or on Jamestown

Island prior to the year 1700.” In other words, another elitist group with large land holdings tracing back centuries, with key members interlocked with the grand superintending organization---The Pilgrims Society. Membership in the Jamestowne Society is by [invitation](#) only. We are of course describing the historic founding of Jamestowne, Virginia, in May 1607 AD.





Badman III has held three top level posts with the Society of Colonial Wars; for description, see in the profile on Stanley Dean Heisler. In 1993, and still as of 2005, Badman III was chairman of the New York based Conference of Patriotic and Historical Societies, similar to and heavily interlocked with The [Hereditary](#) Society Community of the

United States. These groups, dominated by a select few Pilgrims Society members, extrapolate influence across a wide spectrum of individuals. The HSC shows a sketch of a strand of genetic material indicating the “purity” of their lines and how their members are “genetically qualified” to wield control over the lives of the vast public without their consent---



Badman is a certified member of the National Council of [Architectural](#) Registration Boards; the name is descriptive of its activities and its members literally shape our national skylines---



NCARB is at 1801 K Street Northwest in D.C. ---



He's a member of the American [Institute](#) of Architects in Washington, D.C., founded in 1857---



The New England Society we describe in the profile on Stanley Dean Heisler. The Round Hill Association is an upper [crust](#) organization in pricey Greenwich, Connecticut, where he's practiced as a real estate developer and an architect---



Badman is a member of the Mayflower Society, described in the profile on Miner Hill Warner, president of The Pilgrims United States. He states he's a member of something called the Plymouth Committee (or Commission); I find no definite info on this one. He's a member of the Yale Club in New York, described in the profile on David T. Schiff. Mister Badman is a member of the Greenwich, Connecticut Country Club---





And this one, which only [traces](#) to 1981---



This one was founded in the 1890s at Old Forge, New York---



Naturally Mister Badman, the Pilgrims Society member, is another Episcopalian. He married Katherine Ballantine; yes, this is another family with Pilgrims Society connections! Arthur A. Ballantine (Pilgrims 1957) and John H. Ballantine (Pilgrims 1969 and 1974) and there's an old world spelling variation, John Ballantyne, in The Pilgrims London 1980 roster. Arthur Atwood Ballantine had a son named John Winthrop Ballantine, indicating old-line Winthrop (Pilgrims Society) ancestry tracing to 1600s colonial Massachusetts. A.A. was undersecretary of the Treasury in 1932 to May 1933 meaning, that as of early March 1933 when Roosevelt issued his criminal Executive Order 6102 seizing gold from the public, A.A. Ballantine would have played a role in the first few months of that infamy. He became a trustee of the warmonger planning Carnegie Endowment for International Peace and was an attorney involved with the Saltonstall family in Massachusetts, big legislative pals with the Silver Users Association. A.A. Ballantine's son Arthur Jr. stated (verbatim, page 152, 1976-1977 Who's Who in America) ---

"The effort to understand, rather than to resist, the forces sweeping through the post World War II world has made my life stimulating."

Those are the forces commanded by The Pilgrims Society, of which his gold grabbing father was a member; junior was a delegate in 1973 to the Europe-America Conference in Amsterdam, similar to Bilderberg. He settled in Durango, Colorado, where he became the publisher of the Durango Colorado Herald newspaper and a director of the First National Bank of Durango. Junior's wife was a member

of the Cowles (Pilgrims Society) newspaper publishing family of Iowa who had national reach. She was a director of the Des Moines Register & Tribune and a member of the Colorado Advisory Council on Population; the Colorado Land Use Commission (“not an elitist? You don’t get land!”) and she was president of the Southwest Colorado **Mental Health Center** (page 162, 1981 WW volume) and another Episcopalian. In “America’s Successful Men of Affairs” by Henry Hall New York Tribune, 1896) we [find](#) on page 54 we read of the Ballantines---“The head of this family grew to be the wealthiest man in Newark, the value of his personal property being nearly \$5,000,000. He was prominent in other lines of business and in financial institutions.” His first big strike was in the brewing industry after which he acquired large land holdings. Peter H. Ballantine died in 1882 and John H. Ballantine in 1895.” Apparently the John H. Ballantine of The Pilgrims 1969 and 1974 lists is his great grandson. John Herbert Ballantine, grandson of Peter Ballantine, [founded](#) Neptune International Corporation, which today supplies [meters](#) to over 2,500 water utility companies.

During 1981 to 1986 Badman was an exec and board member of Parsons Brinckerhoff, [founded](#) in 1885 and today with 14,000 employees. “The firm has worked on some of the most notable infrastructure projects of the 20th century, including: the Detroit-Windsor Tunnel (1930); the Scheldt Tunnel in Antwerp, Belgium (1933); The Buzzards Bay Railroad Bridge on Cape Cod, Massachusetts (1935); The 1939 World's Fair in New York City; the

Garden State Parkway in New Jersey (1957); the Hampton Roads Bridge–Tunnel in Virginia (1957); the Pell Bridge in Newport, Rhode Island (1969); the I–95/Fort McHenry Tunnel (1980); the H–3 Highway in Oahu, Hawaii (1997); the Sabiya Power Station in Kuwait (2000) and the rapid transit systems of San Francisco (1972); Atlanta (1979); Singapore (1987); Taipei (1996); and Caracas (1983).” Charles M. Brinckerhoff was in The Pilgrims 1969 and 1974 rosters---he was head of major copper miner Anaconda and a director of First National City Bank. Brinckerhoff was decorated by the government of Chile due to large mining activities there and was a director of ACF Industries---



As of 1991 and into 2005 Badman was an exec with H.W. Lochner; this is no longer [current](#). This firm [consists](#) of civil and structural engineers, rail and transit, aviation, construction and other industries. We notice many Pilgrims members no longer active on various boards or exec positions; they may however, be heavy holders of shares---



Badman III is a 1966 Yale graduate. Most likely he's a member of one of the Yale super-fraternities, of which Skull & Bones has had a touch more than its fair share of attention. The point is, young men, who don't hold levers of power so early in their lives, are admitted to outer circle, but important, groups like Bones; whereas The Pilgrims takes many more years for admission, it being the controlling group. We indeed are in a gerontocracy, but they maintain sufficient younger members to step in when an elder member is incapacitated.

His daughter Lindsay Cathryn is directly or indirectly [involved](#) with vaccinating children at Denver Children's Hospital. Indications are that Badman's first wife, Jane Howland, wasn't mentioned in his scan. Her family dates back to Massachusetts Bay Colony and has had modern representation in The Pilgrims Society. John Badman [IV](#) is an attorney. If his father is deemed important enough, IV will be admitted into The Society. If not, their finances will still be in alliance with The Society.

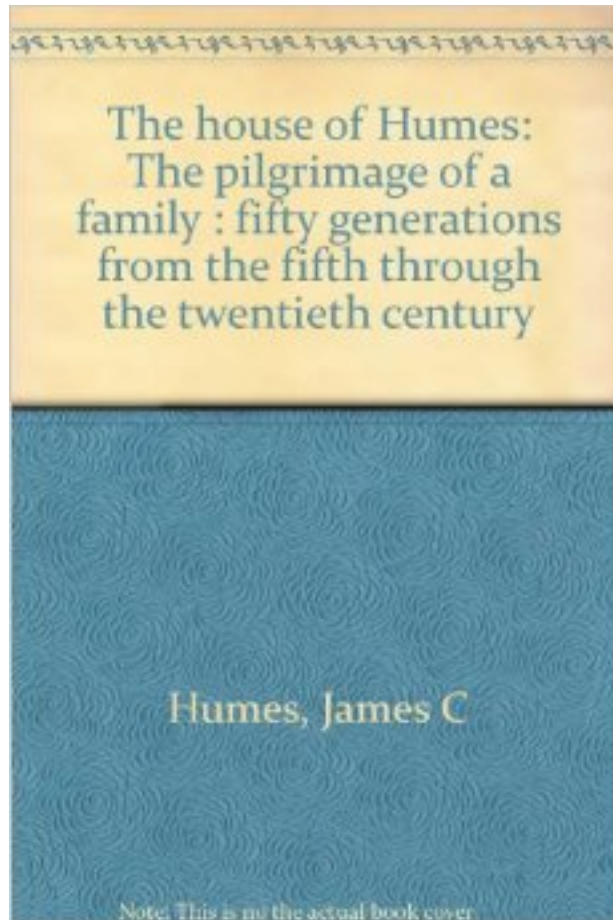

This guy's grandfather, Samuel [Humes](#), was associated with Jersey Shore Banking Company and Electric Light Company of Jersey Shore and married into "a leading family" of Connecticut; her ancestors traced to 1001 AD in England. Her ancestors arrived on The Mayflower in 1620 and we read, "There were some twenty-seven coats-of-arms in the family, and the representatives in England filled positions of honor and trust."

The name Hamilton is [associated](#) with the Humes family a fair [number](#) of times; making me wonder if there's linkage to banking

stooge Alexander Hamilton. Humes is author of around two [dozen](#) books (this [link](#) says 30) none of which, using the Search Inside feature, have anything to say about The Pilgrims Society. “He has served as a communications advisor to major U.S. corporations, including IBM and DuPont.” That’s two Humes connections with entities opposing monetary silver---a bank and the world’s largest industrial silver user. If we look for more connections, we will find more to reasonably interpret in this manner. This Humes family, with “Hume” a related name---has amazing roots, and in it we find nobility. Notice Humes near the end of his scan states membership in the Order of Magna Charta, whose full name is “Baronial Order of Magna Charta,” dating to AD 1215 and the historic meeting at Runnymede with King John of England. Here’s his [book](#) from 1994 detailing his fantastic ancestral genealogy dating back one and one half millennia---



At http://books.google.com/books/about/The_House_of_Humes we read--- “The emigrant ancestor was Thomas Humes (1768–1816) who was born in Castle Hume, Ireland. Thomas was a descendant of Irish nobility and Scottish royalty.”

Financier and wartime shipbuilding fortune heir George Vanderneth Merrill, Pilgrims Society, whom we profile elsewhere in this series, married Janice Humes of this same Humes family. The 1949 Pilgrims New York roster lists Augustine L. Humes and John P. Humes is in the 1974 and 1980 New York Pilgrims rosters. The

1950–1951 Who's Who in America, page 1331, shows this about A.L. Humes, and his middle name, "Leftwich," is yes---another Pilgrims Society genealogy---

James [Leftwich](#) Harrison (1895–1973, Pilgrims 1969 and other years) was an exec of the behemoth National City Bank, New York.

A.L. Humes was associated with the Hornblowers, an old-line Massachusetts and New England based Pilgrims Society dynasty; the name is well known in Wall Street circles. We profiled the Hornblower interests on pages 22–34 of [#7](#) Silver Squelchers. Notice he works out to have been the father of John P. Humes, who became a member in later years; and that he was an IBM director.

He was on The Pilgrims warmonger bandwagon during 1918 with the War Trade Board and just of course he was an Episcopalian, showing his English religious connections. The 1976–1977 Who's Who in America, page 1533, shows that John P. Humes (deceased 1985) married the granddaughter of charter Pilgrims Society member Jacob Schmidlapp; Jean C. Schmidlapp, who was on the [executive](#) committee of the American–Austrian Foundation. The AA Foundation sponsors a [Humes](#) Visiting Professorship program.



Carl J. Schmidlapp, son of Jacob Schmidlapp, was the [father](#) of Jean Cooper Schmidlapp. Carl was a [vice](#) president of the Rockefeller–Astor Chase National Bank! Jacob Schmidlapp was a director of National Water Company; Equitable Life Assurance Society; Electric Security Company; Union Savings Bank & Trust; Degnon Construction Company; American Security Company and others and held interests in Cigar manufacturing and whiskey distilleries (Who's Who in America, page 2068, 1914–1915).

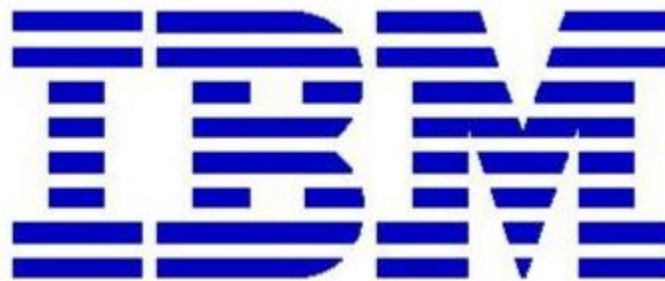
Shearman & Sterling is among the most important Pilgrims Society law firms in the U.S. branch. Humes held the post of Ambassador to Austria then became a director of the U.S.-Austrian Chamber of Commerce. J.P. Humes was involved with various organizations described elsewhere in this series of Pilgrims profiles post the 1980 roster. The International Law [Association](#) today with 3,500 members "was founded in Brussels in 1873. Its objectives, under its Constitution, are "the study, clarification and development of international law, both public and private, and the furtherance of international understanding and respect for international law". The ILA has consultative status, as an international non-governmental

organisation, with a number of the United Nations specialized agencies.” It has significant interlock with Pilgrims Society members who were/are attorneys---



That's enough coverage on other Humes family members; we return to James Calhoun Humes. There's a chance he has ancestry tracing to John C. [Calhoun](#) (1782–1850) of South Carolina, who was a major national political figure in his time and supported the second (British allied) Bank of the United States. His grandson, John Caldwell Calhoun, became a charter member in January 1903 of The Pilgrims; details on him appear in "[Racism](#), Basketball, Secret Societies, Warfare and Silver," released in May 2014. During 1962 to 1965 James Humes was a member of the Pennsylvania state legislature; records may possibly indicate a stance on the issue of silver coinage, which was a hot national topic in those days. If

Humes wasn't in favor of ending silver coinage, my jaw would drop off and hit the floor. Humes later became an [advisor](#) to Du Pont, the world's biggest industrial silver users and members of the Silver Users Association; and an advisor to IBM, of which his father was a director.



Chances are very high that Humes was acquainted with the paper money family of Pennsylvania, the nefarious Biddle clan, who warred with Andrew Jackson and later became Pilgrims Society members! The Biddles are described in "Pilgrims Society Takeover of [Bitcoin](#)," pages 59–77. The in the late 1960s Humes was an official of the Philadelphia Bar Association, [founded](#) in 1802---



As of 1969 James Calhoun Humes became officially involved with Presidential affairs. Described by [NNDB](#) as "speechwriter for five

Presidents,” Humes wrote for Eisenhower, Nixon, Ford, Reagan and Bush The First. They were/are all Pilgrims Society members; apparently the **INNER CIRCLE** wanted assurance the “right” things would be said for public and Congressional consumption.

Humes has [held](#) professorial positions at the University of Pennsylvania; Colorado State University at Pueblo; University of Southern Colorado; and University of Colorado at Colorado Springs. Being a university professor and Presidential speechwriter and an author of two dozen books suggests an outer circle member; however, his ancestral and relationship connections suggest mid-circle status in The Pilgrims---he’s not just a high level flunky!



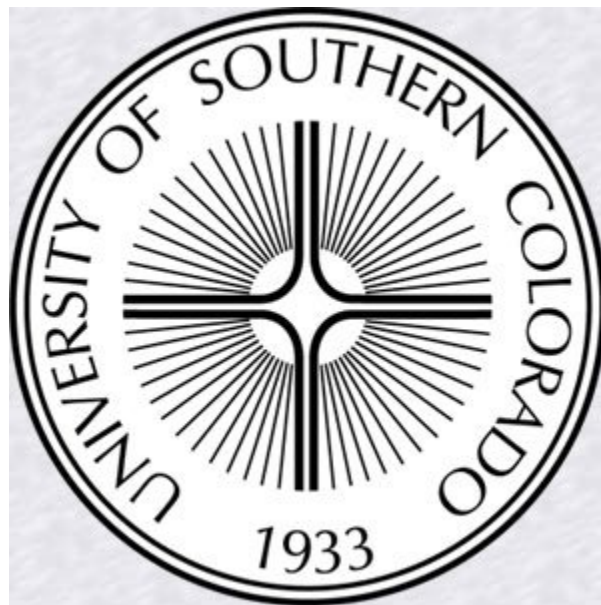

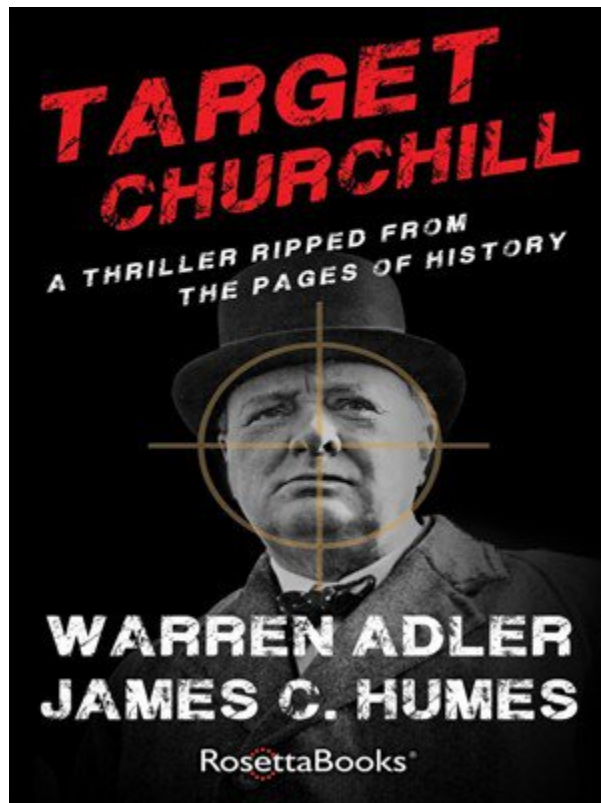

British Empire, a carbon copy of The Pilgrims but including lower level, yet still important, globalists-----

As of 2005 James Calhoun Humes was a member of the United States National Commission for UNESCO; this appears to no longer be [current](#); but it reconfirms this man is a globalist. That is the United Nations Educational, Scientific & Cultural Organization. At this State Department [link](#) we read--- “The U.S. National Commission for the United Nations Educational, Scientific, Cultural Organization is a Federal Advisory Committee to the Department of State that supports worldwide humanitarian development and values by coordinating efforts and delivering expert advice from the Federal, State and Local Governments and from Non-Governmental Organizations on issues of Education, Science, Communications and Culture.” Since the State Department is 1,000% under Pilgrims Society control, naturally it backs globalist schemes---

There is a James A. & Mary Hayes Lord Scholarship [fund](#) at Central Connecticut State University. The Lord family, originally from England, had two members in 1637 among the [founders](#) of Hartford, Connecticut---Richard and Thomas Lord. Jerome Lord's son, Hayes Alexander FitzWarin Lord, opens quite an ancestral portal! [Here](#) we read, "Warin of Metz the patriarch is however a

"shadowy or mythical figure" about whom little is certain. The later mediaeval romance *Fouke le Fitz Waryn* gives his name as "Warin de Metz". Whatever his true place of origin it is however generally believed that **the head of the Warin family came to England during the reign of William the Conqueror (1066–1087).** Neither the father nor his sons were during that reign tenants-in-chief, that is to say important feudal barons rather their grants of lands were obtained from later kings." Castles in Wales and England were in this family, and there's a research on the early French origins (post-Merovingian dynasty) of the FitzWarins---



The Gettysburg [Times](#) (Pennsylvania), January 14, 1988, page 5-B, mentioned Jerome Lord's daughter, Stavelly Hampston DeHodnet Lord---

“Miss Stavely Hampston de Hodnet Lord was presented to society on November 27 at the Bachelors Cotillion in Baltimore. On December 19, she was the guest of honor at a private reception given by Mrs. John Arthur Logan of Washington D.C. On December 22 she made her debut at the Debutante Cotillion and Christmas Ball in the Grand Ballroom of the Waldorf Astoria in New York City; on December 23 at the Christmas Ball in the Grand Ballroom of the Mayflower Hotel in Washington; and on December 29 at the International Debutante Cotillion, also in the Grand Ballroom of the Waldorf Astoria, where she represented Maryland and the District of Columbia. In February she has been invited to attend the French debutante assembly, the Rally of Paris, in the Automobile Club on the Place de la Concorde. Subsequently she will be guest of honor at a private reception given in Paris by the Count and Countess de Rede de Vulpillieres. Later in the season she will make her debut in Palm Beach. Stavely is a graduate of West Heath School in Sevenoaks, England, and is currently studying at the Sorbonne in Paris. She is the daughter of Mr. and Mrs. Jerome Edmund Lord of Chevy Chase, Maryland. Mrs. Lord is the former Eleanor Louise Collins of Gettysburg.”

The 1914 Pilgrims New York roster shows Chester S. Lord; also in the 1924 and 1933 rosters; he was [associated](#) with The New York Sun newspaper. The 1914 London Pilgrims roster shows Bertram Lord. The 1933, 1940 and 1949 Pilgrims New York rosters show

Thomas Coatsworth Lord. The 1957 Pilgrims New York roster shows Henry Gardner Lord. Oswald B. Lord is listed in The Pilgrims New York 1957, 1969 and 1974. Joseph F. Lord is in The Pilgrims New York lists for 1949, 1957 and 1969. That's a total of seven (7) members of this Lord family we know of in this group, 1914 (or earlier) to the present. This doesn't include information gaps, however---we have no full rosters since 1980! We need to probe their genealogy.

Thomas C. Lord's father was a [member](#) of the American Psychological Association (hunting for "heretics" and "witches" under the label of "mental illness.") What a way for elitists to dispose of opposition---just define those opposing you as "disturbed" or "disordered," those who oppose Crown globalism. "Coatsworth" was the name of the High Sheriff of [Northumberland](#) as of 1720. An 1873 source shows two Lords [directors](#) of New England Mutual Insurance Company. A 1921 [source](#) shows that Mr. Henry Gardner Lord was an eighth generation descendant of William Bradford (1590-1657), who was a five time [Governor](#) of Plymouth Colony. It appears that the grandson of Joseph F. Lord is with [Deutsche](#) Bank Securities. When Bankers Trust of New York merged with Deutsche Bank in 1998, it [increased](#) the Anglo-American influence in said institution.

“After reading about the secret life of Alan Z. Feuer [in *The New York Times*](#) this weekend I thought of a girl I knew and dated briefly as an undergrad, Wallis, and her family, the Lords. A befitting name; a society columnist writing for the Baltimore Sun in 1996 (four years before I met them) described them as "a Montgomery County family who travel the world attending debutante balls":

“According to Ms. Jean Sprain Wilson, who works for Jerome Lord Enterprises, a literary agency, Savile Collins de **FitzAlan** de Dinan Lord was among 130 debutantes invited to attend the Opera Ball in Vienna, Austria, last Thursday evening. The deb and her parents, former Baltimoreans Mr. and Mrs. Jerome Edmund Lord, arrived in Vienna a week before the ball so the debutantes and their escorts could take lessons at the prestigious Elmayer dancing school. Savile and her escort, **Prince Alfred von Liechtenstein** of Reichersberg, Austria, and the others were taught the Linkswalzer, or Left Turn Waltz, which had to be mastered to participate in the Viennese Opera Ball. Years after, the next time I heard of the Lords was when I saw a wedding announcement for the daughter I'd dated pop up in the social media stream of a mutual acquaintance. In the 12th century Anglican Church of St. Mary the Virgin in Steeple Bumpstead, Suffolk, England, Wallis Jennings de Pantulf de Bary Macsherry Lord was wed to Andrew Richard Hart. The bridesmaids

were the bride's sisters, Stavely Hampston de Hodnet Lord and Savile Collins de Montenay Lord. The ring-bearer was the bride's nephew, Master Hayes Collins Lord. The bride is descended from Guarin de Metz and Fulque FitzWarin, the central figures in the 13th-century French manuscript, *Le Romans de Fulque FitzWarin*, **who was one of the Barons at Magna Carta in AD 1215.**



Prince [Alfred](#) is a “consultant on globalization” and has this video with the “International [Peace](#) Foundation.”

“You could believe Alan Z. Feuer was invited; or even that he'd been asked to teach the wedding party how to step a left-turning waltz, so as not let down the side at the refined but somewhat *démodé* reception. In view of this spectacular parade of names, some parts of the Internet were delighted by the names on parade; other commenters were incredulous. I see that Dr. Lord -- Jerome, maybe, if we met again now, though I'd have to keep in mind that

"he insists upon the pronunciation "Jair-um" instead of the German" -- recently self-published a collection of comical letters addressed to his real-life friend, Minerva Heller Neiditz. An excerpt, very much in keeping with the themes of history, etiquette, and wit which I remember from that brief visit more than ten years ago."

"Worse yet, **the King of Spain** had been misinformed that it was to be a masquerade party. When the King stepped from his outrigger, The Penelope, he was dressed in an upswept wig and billowing gown with deep-cut décolletage, the costume of a perfumed courtesan from the court of King Niall of Namibia. At the party, he flirted successfully with the person he thought was Henry, to the point where he had both hands on one of Henry's thighs -- he remembered having heard that if there was any man in England who had trunks for thighs, it was Henry VIII, King of Tudor -- he uncovered a rather thin thigh, not at all what he would consider a tudorial thigh, and without further attempts at what he himself referred to in his later memoirs as "manipulaciones furtivas" (cheap feels) he embarked for home the same night without so much as a blown-out candle to his credit. This was an astounding setback for Wolsey's idea of birthday coordinations, and Henry, delighted, pretended to be stung to learn that the King of Spain had been in his own back yard, and the entire Spanish Armada had been anchored in the Thames."

"But Wolsey still had the Pope on his side, if not exactly in his lap,

and he decided the following year to attempt further coordinations with an invitation. he knew that if and when Henry learned that the Pope was coming, he would never allow himself to be upstaged, and his attendance was thus secured. Wolsy also realized the Pope had never been to England, spoke no English, had never seen a map of England, had met Woolsey only once, at his coronation, had never met Henry VIII, and had a lot of suitcases. In short, he was a tourist first class who was ripe for a conversion to the English Way. --- from *Letters to Minerva.....from a mind unraveling* (pages 99–100).”

This strangely worded passage mentions the FitzAlan family also (Pilgrims Society London), with tremendous wealth in their genealogy, as described in [#11](#) Silver Squelchers, pages 37–40, showing FitzAlan wealth of \$118 billion in modern terms. Jerome Lord’s daughters have names straight out of early medieval Britain and Europe. The Gentleman’s Magazine, volume 91, part 2, 1821, page 393, [mentions](#) the De Hodnets estates, manors and connections back to King [Richard](#) II of England (1377–1399 AD). At <http://knight-france.com/geneal/names/2761.htm> we notice---

“The patriarch of the Fitz Warin family was a 12th century knight known as Warin de Metz an individual whose identity has proved to be **quite an enigma to countless generations of historians and academics alike.**”

Montenay is a village in Mayenne, a “department” (state or province) of France which was organized in [1790](#) during the bloody,

catastrophic French Revolution. For some basis Jerome Lord, Pilgrims Society member, named his third daughter after this location inland from Brittany and within the old bounds of Norman France. The June 9, 1997, Hartford Connecticut [Courant](#) newspaper reported on Jerome Lord's fourth daughter, also named after ancient aristocratic nobility---

"Academic Dean Paul Druzinsky was breezing through the awarding of degrees for the class of 75 seniors graduating from Miss Porter's School when he faced his only challenge. His eyes had fallen on the name of the school's 43rd listed graduate -- Dorian Warfield d'Amours de Courbet duBarryoe Lord."

Her second to last appellation should read "DuBarry." Her name is a mix of old French and English nobility. The [Warfields](#) were among the major founders of the State of Maryland with "extensive land holdings." The Pilgrims New York 1969 roster shows Ethelbert Warfield. He was a director of General Reinsurance Corporation; North Star Reinsurance Corporation; Technical Equipment Corporation; American Saint Gobain Corporation and was a law partner in Satterlee, Warfield & Stephens (Who's Who in America, 1970-1971, page 2383). Jerome Lord's fifth daughter, Wallis Jennings DePantulph has a name that appears to trace to the Norman invasion of William the Conqueror in AD 1066.

http://www.myheritage.com/names/christaina_fitzalan traces the name back to 1145 AD, three or four generations later to the Earl of Oswestry. There is no doubt; The Pilgrims Society features the most

complex and influential genealogies in history. In [1636](#) AD Thomas and Richard Lord left Newtown, Massachusetts, to be part of the founding of a settlement on the Connecticut River that became Hartford.

During the late 1950s Jerome Lord was with The Taft School, a college prep school for children of Crown sympathizing families. [Founded](#) in 1890, the Taft School was founded by a member of the powerful political family of the same name, represented in both The Pilgrims and the decidedly [inferior](#), though of longer standing, Skull & Bones Society.



In 1961–1962 Lord had editorial input into textbooks of Allyn & Bacon, [founded](#) in 1868 at Boston---

Allyn & Bacon

During 1963–1965 Lord had management oversight of Teachers College at Columbia University in New York, founded in 1887 and today with a \$200 million endowment---



During 1965–1969 Lord was with CUNY, City University of New York, [founded](#) before the Civil War and today with a \$3 billion endowment---



During 1969 to 1970 Jerome Lord was involved with the Brookings Institution, probably among the five top elitist/globalist think tanks anywhere, and had funding from the Ford Foundation (Pilgrims Society) and the Carnegie Foundation (Pilgrims Society). Next (1971–1973) Lord migrated to the U.S. Department of Education during the Nixon (Pilgrims Society) anti-gold and anti-silver administration. Actually then it was still known as Health, Education and Welfare under Elliott Richardson and Caspar Weinberger (1990 executive committee), who both later became members of The

Pilgrims---Richardson, as of February 20, 1975, when he became Ambassador to England (Pilgrims V.P. by 1989) ---and Weinberger (an Episcopalian), by 1981 or a few years later---



The National Center for [Education](#) was part of HEW and Lord was senior associate of the NCE (1973–1986). Following this he made himself president of Jerome Lord Enterprises in Washington. What was/is that? Take your pick---there's an apartment [locator](#) company in Bethesda, Maryland, by that name, although that appears too mundane for him to be involved with, even if he set it up and found someone else to run it; or Jerome Lord Enterprises in Wilmington, [Delaware](#), although that's a stretch, as his scan says Washington, not Wilmington; Bethesda Maryland is in the metro D.C. area. However, it's probably neither of these, although he may have started other companies; Jerome Lord Enterprises is or was as of [1996](#), a literary agency in D.C. Next his scanned info flashes back to 1975–1976, when he was an educational consultant to the Defense Department---



As of 2005 Lord was chairman of something called the Federal Interagency Panel for Research on Adulthood, for which nothing is found using a search in quotation marks. Nevertheless, some shifty, shady Pilgrims Society activities were being carried out, with taxpayer funds and as of 2005 he was a member of “various other national panels and commissions” (all having to do with globalization and dragging America back under Crown rule!) He stated membership in the World Affairs Council of Washington---



I haven't found mention of The Pilgrims organization in any of his books. During 1978 to 1983 Lord was a trustee of St. John's Child Development Center in D.C., part of an Episcopalian group [founded](#) back in 1868. Then he flashes back again to 1965–1969 when he was an advisor to the New York Urban Corps, and tantalizingly follows that with “others,” leaving them unidentified. As of 2005 Lord was a member of the council of the Friends of the Folger Shakespeare Library. The FSL is described on pages 55–58 of [#9](#) Silver Squelchers as having multiple connections in The Pilgrims. The National Symphony Orchestra in D.C., of which Lord was a sponsor as of 2005, was founded in 1931---



Next we see Lord donated more than one reception room in the U.S. Department of State; possibly that means the furnishings. Members of The Pilgrims have been all over the State Department since 1903 like termites in the frame of a house. Naturally with worldwide holdings they must control foreign relations. He listed several other groups and clubs, most of which we cover in profiles of other Pilgrims members. People like Jerome Lord don't have to work for a living. He got into the educational system to program teachers and students for British Crown globalism.

7) Stanley D. Heisler (1946---; Pilgrims by 2014; probably some years before then, estimate before 2003) features details that could have been incorporated into “Why Silver Price Fixing Lawsuits Always Get [Trashed](#),” released in February 2015.

I’m unfamiliar with any of the law firms listed here; there might be a Pilgrims connection somewhere. Excepting of course his own law practice in New York, which he started in 2001, which is a likely year he may have been admitted into The Society. During 1991 to 1994 he was with a firm with the amusing name of Squadron, Ellenoff,

Plesent, Sheinfeld & Sorkin. The [Wiki](#) entry on it mentions it was adviser to billionaire Rupert Murdoch in many of the important media acquisitions of News Corporation and it had around 200 law partners. Certainly Murdoch is high on a list I maintain of highly likely Pilgrims members who can't so far be confirmed due to the deep secrecy. At some point well before his admission into The Pilgrims, Heisler was in their orbit by some means, probably just before he got the speechwriter position in 1965 with Oregon Secretary of State Tom McCall, who became Governor. However, it seems more likely that Heisler's eventual rise into The Pilgrims was due to his association with Tom [McCall](#). Tom's maternal grandfather was so-called "copper king" Thomas [Lawson](#) (1857–1925) who was known for "the fortune he amassed for himself through highly dubious stock manipulations" and "became a multimillionaire during the copper boom of the late 1890s." Lawson joined forces with Henry H. Rogers (1840–1909), who almost certainly was a Pilgrims member; absence of complete information prevents confirmation. Rogers was a key figure in Standard Oil, and the Rockefellers (Pilgrims) were also involved with Lawson and Rogers in copper syndicate activities centered in Montana---the Anaconda Copper Mine. Allegedly, Lawson broke ranks with these wealthier men and later died in poverty---due to breaking ranks with them? Or was that all just for public appearances? Tom McCall's paternal grandfather was Samuel W. McCall (1851–1923) who was a Congressman from Massachusetts (1893–1913) and Governor of Massachusetts (1916–1919). East coast politicians are

seldom outside the grasp of the Money Power; I expect McCall was one of their boys.

During 1969 to 1973 Heisler was legislative assistant and speechwriter for Oregon Republican Senator Bob [Packwood](#) (duration of terms---1969 to 1995) who resigned from the Senate under accusations of sexual harassment and assault of some women he had “access” to. Did Heisler get to have any fun associated with the Senator’s extracurricular activities? Heisler’s info doesn’t show any marriage. Packwood, who was "one of the country's most powerful elected officials" was a gun control backer and was quite pliable to the demands of a particular small Middle East country---the one England made possible 30 years after 1918 with the Balfour Declaration (Sir Arthur Balfour, Pilgrims Society and Lord Rothschild, Pilgrims Society). After leaving the Senate in disgrace, Packwood made his talents available to corporations for miscellaneous consulting and lobbying advice.

Heisler’s father Donald was a [member](#) of the Oregon House of Representatives and “he was instrumental in building of The Dalles Dam and The Dalles Bridge. For the latter, he helped get legislation passed at the Federal level as well as in the states of Oregon and Washington. He helped establish the electrical utilities---Rural Electrical Association (REA) and the Public Utility District (PUD) in The Dalles and Wasco County. He also assisted in forming the Chenoweth Irrigation District and The Dalles Irrigation District. In

addition to his law practice, he had a cherry orchard near The Dalles.”

The Dalles Dam ([8875](#) feet long) is a big hydroelectric power producer---



Heisler’s father [lived](#) to be 99 and was District Attorney of Wasco County during 1948 to 1956 and practiced law from 1938 to 1990. His father, Charles Monroe Heisler (1879–1957) was a [member](#) of the Masonic Lodge and owned ranching interests.



It may be that Heisler's pop left him some number of millions to invest somewhere. Heisler got entrance to the White House during 1973–1976 as vice chairman of the President's Air Quality Advisory Board. That placed Heisler in proximity to President Nixon (Pilgrims Society member before he closed the gold window and before he imposed a Federal price cap of \$1.61 the ounce on silver) and Gerald R. Ford (Pilgrims Society, who as a Michigan Congressman voted [for](#) the Coinage Act of 1965, removing most silver from American coinage!) This [reference](#) shows that as of 1953 or earlier, Donald Heisler was District Attorney of Wasco County Oregon. Stanley D. Heisler is [identified](#) as a divorce lawyer in Manhattan.

Sure---scheme ways to keep and concentrate wealth in Pilgrims Society hands.

Heisler became a member of the historical Crusades related Order of Saint John of Jerusalem, sponsored by the Crown of England. The OSJ is discussed in “Pilgrims Society [Takeover](#) of Bitcoin,” pages 115–117 and 120. The Order of Saint Lazarus appears to date [earlier](#) than 1090 AD. The Order of Saint Maurice was founded in 1434 by Amadeus VIII, Duke of Savoy, who became Antipope Felix V. The order declined, but in 1572 was reestablished by Pope Pius V at the instigation of the then–Duke of Savoy. Before its transfer to the House of Savoy, the Order of Saint Lazarus maintained a number of leper hospitals, prominent among these an institution in the Italian city of Capua. French knights were reluctant to accept the Savoy grand mastership with effect in their country and the French kings maintained protectorate over [Order of Saint Lazarus](#). In 1572 Pope Gregory XIII merged the Italian foundation of the Order of Saint Lazarus with the Order of St Maurice. The new order was charged to defend the Holy See as well as continue to assist lepers.”

There’s a huge amount of history in these ancient Crusader orders. Both the Pope and those refusing to acknowledge his authority were involved in these orders. The Knights of Malta, very much in existence today, is definitely Catholic. It is in fact, the Vatican counterpart to the Anglican, Church of England, Episcopalian Protestant, Royal family Pilgrims Society. The Knights of Malta is a worthy study I haven’t spent great time in. It is definitely a second

fiddle to The Pilgrims because England shrugged off Vatican control in the 16th century, and towards the end of the 17th century, England invented what became modern central banking---easily the greatest engine of profit ever conceived. The Order of St. John of Jerusalem is headed by the Queen---not by the Pope (see Heisler's scan!)
Reading further---

“After Italy became a republic in 1946 the order was effectively replaced by the Order of Merit of the Italian Republic. Since 1951 it has not been recognized officially by the Italian state. The House of Savoy in exile continued to bestow the order. Today it is granted to persons eminent in the public service, science, art, letters, trade, and charitable works. While the continued use of those decorations conferred prior to 1951 is permitted in Italy, the crowns on the ribbons issued before 1946 must be substituted for as many five pointed stars on military uniforms. The generally accepted Grand Master of the Order is Vittorio Emanuele, Prince of Naples, the current head of the House of Savoy.”

The House of Savoy, tracing to the year 1003 AD, is actually in several branches---Savoia (Italian) and Savoie (French) and migration occurred and there is a Savoy Hotel in London, scene of some Pilgrims meetings over the years. France today has two provinces in the Alps named Savoie, though one of them is at a lower altitude. It's from the Savoie area of France that Charles Savoie writing these long researches comes from on his paternal side. A Royal house! However, there are so many of us in France,

French Quebec Canada, Louisiana and elsewhere---that virtually all Savoies are just as plain as any ordinary folk. I, an extremely fractional descendant of royalty, say that royalty should fade completely from the world scene. If you care to read about Vittorio Emanuele, Prince of Naples, who made the award to Stanley D. Heisler, click [here](#). What is the influence of hereditary royalty in today's world? Apparently it's far more than most realize, and the accumulations of wealth, officially unmeasurable, are staggering, else there wouldn't be so many royal connections inside The Pilgrims organization.

Heisler since 2009 has been a director for New York State members of the [Sons](#) of the Revolution, founded in 1876, the centennial year of the American Revolution. I've long noticed a pattern of these royalist Pilgrims Society members being in the leadership of groups which are ostensibly patriotic---this is Crown infiltration. The rank and file in these groups are not of the same views and most likely don't know about their groups being penetrated by British influence which wants America back under Royal family rule! Heisler also lists the SAR as something he's into---Sons of the American Revolution, a similar group founded in 1889. Many Pilgrims have been in the SAR also, while the rank and file are unlikely to be British loyalists. Notice Heisler served a term as an official of the Society of [Colonial Wars](#) (founded 1893). I've seen so many Pilgrims in this one that if there were that many fleas on a big dog, the dog would be anemic! Same goes for many other patriotic historical groups---Sons of the

American Revolution, American Legion and a fair number of others. Infiltrated, and in some cases founded by---British sympathizers. The Holland Society of New York is another. As you'd expect, it was founded by people who came from that country in the Old World. In this case, again it's an elitist thing (Franklin Roosevelt was a member) representing large, old-line land inheritors who became British loyalists in order to retain their landholdings. [Holland Society](#) (1885) has a strong interlock with The Pilgrims. The Society of Descendants of Washington's army at Valley Forge---do they really want Heisler as a member, inasmuch as he's a member of the world's top neo-British Empire group---The Pilgrims?





The St. George's Society of New York was founded in 1770 to assist British subjects who wished to remain loyal to the King of England. Members of this group today, which has a strong Pilgrims interlock, are definitely Royal family loyalists! The St. Andrews Society makes [statements](#) hardly anyone could find fault with. However, I feel there's something deeper going on. Their emphasis has to do with helping people of Scottish ancestry, but is there something more,

such as “Scots who are English loyalists?” It was founded in the mid-[1760's](#), just a few years before the St. George's Society, in times when anti-British sentiment was rising. It has a significant Pilgrims interlock. Many members of these groups if you knew them, would turn out to be okay, because they aren't British loyalists; their more important members being the sad exception.



SAINT ANDREW'S SOCIETY OF THE STATE OF NEW YORK

The Society for the Promotion of [Hellenic](#) Studies, founded in 1879 in London, concerns itself with investigations of ancient, medieval and modern Greek culture. Prominent London bankers have long been “concerned” with Greece and it is they who finance professors, academics and researchers. [Seven](#) presidents of the Society have been knighted by the British Sovereign. No one gets knighted without making a contribution to British world influence.



The Edmund Rice (1638) [Association](#)---exactly how they so state---memorializes Edmund Rice, who arrived in Massachusetts Bay Colony in 1638, becoming a [founder](#) of the city of Sudbury,

Massachusetts. In the first 12 generations of this Rice lineage, an estimated 4,400,000 persons have come about. All British loyalists? Hardly so, but then there's this penetration by Heisler.

Heisler has held three leadership posts in the Society of Mayflower Descendants, including two current. It again has strong overlap into The Pilgrims. These interlocks with genealogical and historical groups are predictable, given the fantastic ancestry of these Pilgrims. [Founded](#) in 1897, it's a historical and genealogical group with tremendous background. Haven't we always heard that the Pilgrims who crossed the ocean on the Mayflower were only seeking religious freedom and a new world? Yes, but British influence attempts are more ceaseless than any other human endeavor. This [list](#) they have is indicative. Of 36 names of people who were or are on the scene and could have been members of The Pilgrims Society, and are also members of the Society of Mayflower Descendants, I can ID over 22% of them (8) as having been members of both groups. There's also The Pilgrim Society at Plymouth, Massachusetts, founded in 1820, which is way different than the group we're examining, yet again, there's an overlap, and a member of the Hornblower (Pilgrims Society) financial dynasty has been an official of this 1820 group. It's about the Royals recapturing loyalty where it was once lost, though some never renounced it. The rank and file of these groups are unaware of this penetrating influence by The Pilgrims Society in New York of their historical, patriotic and genealogical societies.



Despite having been born in Oregon, Heisler was a director (2009–2011) of the New England Society of the City of New York. This group dates to [1805](#) and describes itself as a social and charitable organization and who can impugn that? Looking deeper we notice it's just another elitist hangout, perhaps with some ordinary folks as members. We [notice](#) that the original J.P. Morgan was president of this group in 1889–1891 (he was a vice president of The Pilgrims by 1913 or earlier) and that the New England society started a J.P. Morgan annual [award](#) in 1962. I see several identifiable Pilgrims members have won this award including Robert Lee Sterling Jr., (1933–2014) whose Pilgrims membership was surprisingly mentioned [here](#). His associations included White, Weld & Company; Shearson Lehman Brothers; J.P. Morgan & Company; Merrill Lynch and Wood, Struthers & Winthrop, Winthrop Asset Management and member of the Bathing Corporation of Southampton---all Pilgrims Society entities.



The Colonial Society of Pennsylvania, founded in 1874, [limits](#) membership to 300, elitist at the start. This traces lineages to pre-Revolutionary War times when the big landowners were all British loyalists. They have a list of last names associated with this group. Several are immediately recognizable in interlock with The Pilgrims. A single example is illustrative of the interlock between The Pilgrims and the Colonial Society of Pennsylvania, from page 176 of the 1966-1967 Who's Who in America---

BEVAN, David C(rumley), railroad exec.; born Wayne, Pa., Aug. 5, 1906; s. Howard Sloan and Matilda (Crumley) B.; A.B., Haverford Coll., 1929; M.B.A., Harvard, 1931; m. Mary Gilbert Heist, June 10, 1936; children—David Crumley, John Strong. Employee Provident Trust Co. of Phila., 1931, asst. trust officer, 1940, asst. v.p., 1946, dir., 1951-60; with W.P.B., 1942; mem. Lend Lease Mission to Australia, 1943-44, acting head, 1944; dep. head U.S. Mission Econ. Affairs, London, Eng., 1945; asst. treas. N.Y. Life Ins. Co., 1946, asst. v.p., 1947, treas., 1949-51; v.p. in charge finance, Pa. The web of connections is vast---Lawrence Bevan was in The Pilgrims 1957 London roster. David Bevan appears much wealthier than Heisler, who nonetheless was admitted for reasons acceptable to The Pilgrims inner circle. Notice David was with the Lend-Lease Administration before he became an insurance, railroad and natural gas tycoon, something his wife Mary "Heist" may have helped him with! The LLA was the entity that developed silver leasing! This was known to Nevada Senator Patrick McCarran. The St. [Nicholas](#) Society of New York was founded in 1835 and is a largely Dutch colonial heritage association. Recall through the Silver Squelchers we've seen that large Dutch land grant owners in the New World later

retained their lands after the British takeover of New York in 1664, having pledged loyalty to England, and some of their descendants became important members of The Pilgrims Society. At any given moment, The Pilgrims New York will have at least several dozen members of Dutch ancestry. They list several notable persons who received the St. Nicholas Society Medal of Merit, for one, Pilgrims Society member Thomas Watson Senior of IBM Corporation, who we profiled in [#6](#) Silver Squelchers, pages 17–29.



Another of Heisler's memberships, The Vancouver [Club](#), has a membership waiting list---same as many other such groups. It was founded in 1889 and says of [itself](#)---

"The Club is a place to dine and connect with other professionals who are shaping the very fabric and creative energy of the West Coast. Over the years, Club members have influenced the growth of both the city of Vancouver and the province of British Columbia. New members soon find themselves welcomed by people from

industries of every stripe, from diverse local companies and creative organizations to multinational, global ventures.”

How many gold and silver mining company executives and directors are members at the Vancouver Club? What are their private interactions with other members who represent Pilgrims Society linked megabanks---Royal Bank of Canada---Canadian Imperial Bank of Commerce---HSBC---Scotia Bank---Bank of Montreal, Citibank and others. Are any gold and silver mining company men acquainted with Pilgrims Society member Stanley Dean Heisler through the Vancouver Club? Are there other Pilgrims members present, including from London? Are miners being chided to lock hedges in at toilet prices? Are they being coached to find ways to chisel, cut corners and costs so they can keep bleeding silver without dying at these toilet prices? Are they being suggested to high-grade their best ore and give away the shareholders future? Do I suspect the very worst? Absolutely, because termites never stop gnawing. Notice the symbol of the British Crown over the Vancouver Club---



The Vancouver Club is at 915 West Hastings Street.
Many **mining companies** are on Hastings Street and
Burrard, Howe, and nearby streets downtown---



This image from the College of Arms Foundation, a Pilgrims front run for the Royal family, shows our **INVESTIGATIVE SUBJECT** S.D. Heisler in the center (they may spell it “centre”) flanked at left by “Clafrenceaux King of Arms” Hubert Chesshyre and on the right by “Principal King of Arms” Peter Gwynne-Jones, Commander of the Victorian Order---



Chesshyre was “an [officer](#) of arms to Queen Elizabeth II for more than 40 years.” His ancestors included heartless bastards in the British East India Company, exporting opium from India into China! He also has ancestors from the villainous [Dutch](#) East India Company, who marked up spices 600 to one! Chesshyre has numerous astonishing genealogical features; he may easily be a Pilgrims Society member. Gwynne-Jones was an officer at the College of Arms Foundation in London and I regard him as somewhat less likely to have been in The Pilgrims.

The Yale Club of New York, quite significant, is described elsewhere in the closing series after the 1980 Pilgrims lists. Ditto for the University Club. The Nassau Club is actually in New Jersey at

Princeton University. Founded in 1889, the [Nassau](#) Club is another likely globalist “node”---



The Arlington [Club](#) on Lexington Avenue appears fairly recent. Pilgrims members have so many connections as to be able to exert their influence all the more profoundly.



This one also uses a symbol of royalty---



This [site](#) apparently hasn't received any injunction to cease regarding its mention of The Vancouver Club as a **"child trafficking center."** Additionally the site states---

"The fact that the Queen of England came to Canada decades ago and took her pick of native children to molest and use in ritualistic cult sacrifices is, of course, a bitter pill to swallow, but it is all true. Mass graves don't lie."

I have no info on this besides that site. Make of it what you will. I believe it could be true.

Heisler lists himself as a member of the New York State Bar Association and the Association of the Bar of the City of New York---both of major importance, and both have had numerous

Pilgrims members across the years in leadership positions. Founded in 1870, the Bar Association of New York City as it's also [known](#), has a Cyrus R. [Vance](#) Center for International Justice as a project it maintains.



Cyrus [Vance](#) (1917–2002, Pilgrims 1969, 1974 and other years) was Secretary of State (1977– April 28, 1980). Since the Secretary of State has authority over all our Ambassadors, Vance was in a position to exert influence in all silver producing nations with the objective of hampering the Hunt–Arab silver play. Did he do so? It seems impossible that he wouldn't have. Such matters require sacrificial amounts to time for investigating newspaper archives, especially foreign language newspapers. Vance was the cousin and adopted son of John W. [Davis](#), a founder of the Council on Foreign Relations of which Vance would later become an official. Davis (Pilgrims Society) was ambassador to England (1918–1921) as The Pilgrims Society on both sides of the Atlantic was soaking up wealth

in the aftermath of World War One, which they planned, sponsored and entirely caused; and his daughter married into the United States Rubber Company fortune. Vance became chairman in 1997 of the American Iranian Council; he was also chairman of the Rockefeller Foundation (1975–1977) and chairman of the Federal reserve Bank of New York (1989–1991), a trustee of Yale University for 17 years and director of companies as General Dynamics (warmongers) and New York Times (managed media) ---page 3500, 1994 Who's Who. Vance's father in law was a Pilgrims member; his son is current Manhattan District Attorney. Adding a veritable mountain range of other details to the picture, my conclusion is that The Pilgrims Society has controlling influence over the top legal organizations in America! The New York State Bar Association, founded in 1876, has the same characteristics. The 1974 Pilgrims roster shows Vance with the son of Federal Reserve plotter Frank Vanderlip (also a member at the time) and several members of Dutch descent, including Van [Dine](#) of Morgan Stanley and Skull & Bones Society---

“The Dynastic Orders of the Royal House of Savoy are among the oldest orders of chivalry in the world. Their origins and their principles, traditions and humanitarian goals, like those of Royal

Don't forget that Heisler identifies himself as Episcopalian---the USA affiliate of the British Royal family's Anglican Church of England! Pigott is a very uncommon, old English name. There may be a connection between Sir Stephen Pigott (Pilgrims London 1940 and other years), who was a major ship and cruise line [builder](#) and pioneer in ocean going propulsion engineering, and this endeavor of the Savoy Orders---

Stanley Dean Heisler's connections are most impressive---his father was a really big wheel in affairs of the State of Oregon and S.D.H. was involved with several key Senators---among many other activities--- yet par for a member of The Pilgrims. He maintains a law [office](#) at 750 Fifth Avenue. He is [rated](#) as a “Super Lawyer” and has another office at 330 Madison Avenue (or one of the addresses is previous). This [link](#) shows Heisler posing with his pompous blue blooded hereditary genealogical associates displaying their **overbloated Olympian egos!**

8) Charles Vernon Anson (1944---; Pilgrims Society as of [undetermined](#)) there's little on this one besides his [address](#) is Winton House (actually a castle) in East Sussex, England---



In “The Plantagenet Roll of the Blood Royal: The Mortimer–Percy [Volume](#)” (2013) pages 541 to 599 contain multiple references to this name “Anson” and also “Vernon.” The British Royal Navy List for the year 1884, page 382 [shows](#) a Charles V. Anson, undoubtedly his ancestor. I regret not having more on this person. There are many names in Pilgrims rosters located by Van Der Reijden and myself that are very obscure. The Pilgrims New York 1940 shows a George T. Mortimer and the 1969 and 1974 lists show a Henry Tilford Mortimer, most likely of the same lines as mentioned in that 2013 book.

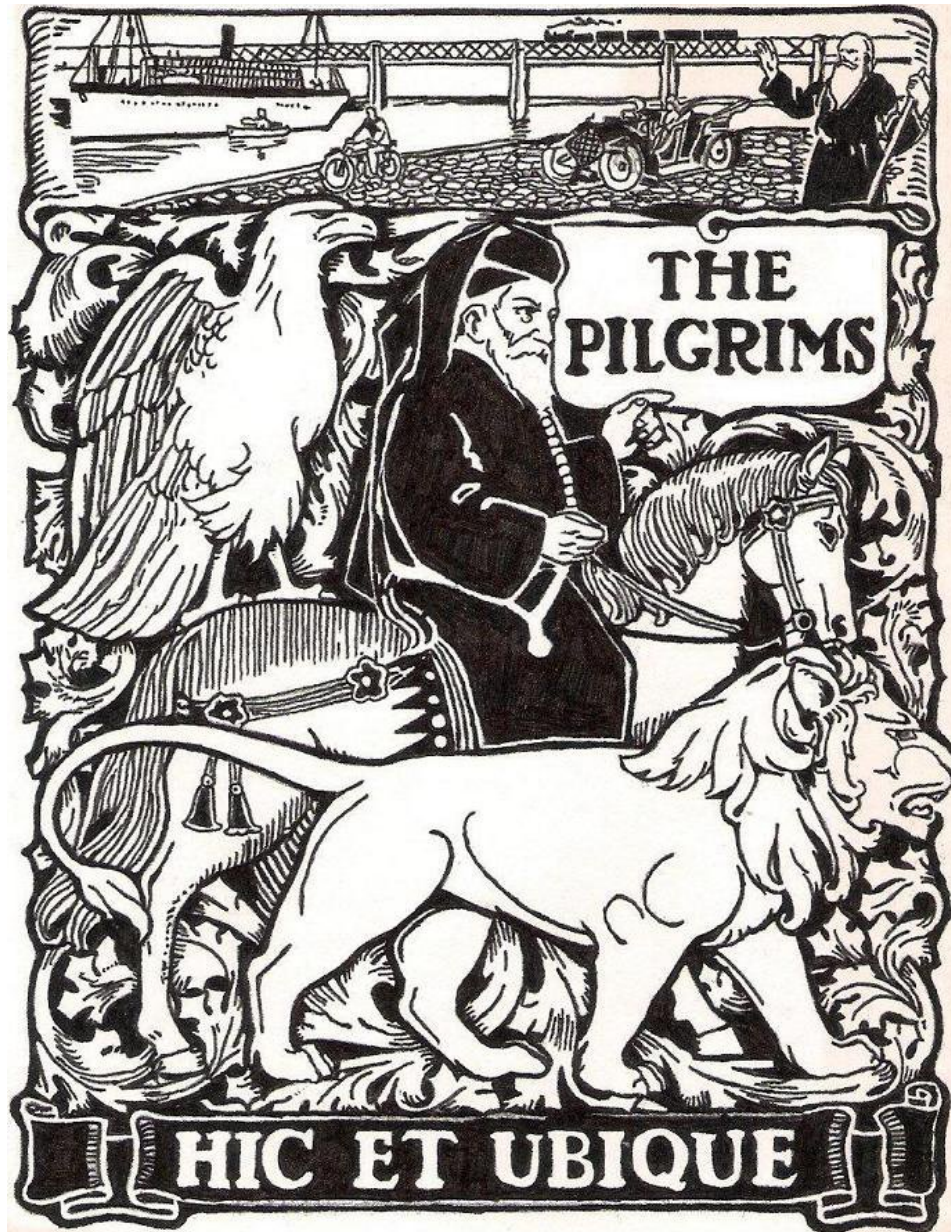
“The Mortimers have married so many people in so many families, they’re often referred to as the ‘marrying Mortimers,’ because they often married very well,” said pre-eminent New York social chronicler David Patrick Columbia. “They think very highly of their genealogy and their family tree. They’ve always been a very social family, but they’re also extremely tight-lipped.” The Mortimer family traces its origins to John Jay, the nation’s first chief justice. One of the current generation, Robert Livingston Mortimer, that trusty husband of Tinsley, is the great-grandson of Henry Morgan Tilford, a president of **Standard Oil**, and he bears as well the name of Robert Livingston. Christine Mortimer Biddle is the daughter of Katherine Mortimer and Oliver Cadwell Biddle. Mr. Biddle was of the Philadelphia Biddles. “I’ve always been fascinated by privilege,” said Eve Pell. Ms. Pell, who lives in San Francisco, recently finished a biography of both the Pell and Mortimer families called *We Used to Own the Bronx*. “**We’re actually very un-American in spirit**,” she said. “Horatio Alger would not be welcome in our family. And the idea is to inherit your money and not make it—**and the longer ago, the better.**”

The ancient monarchical pattern remains---old wealth marries old wealth, and key representatives or their proxies become members of The Pilgrims Society, the secret “Senate” of the super rich and their old Royal sponsors! Are the Royals over the international bankers? There are definite indications to that effect. Henry Tilford Mortimer was with Bear, Stearns & Company and before that, with a

lesser known investment bank---Clark, Dodge & Company. The stepson of Henry T. Mortimer Jr. generated \$353 million in [losses](#) related to “unauthorized credit default swaps” at CALYON, a trading division of Credit Agricole of Paris. Those losses became someone’s gains. CALYON has had involvement in silver trading in this case as a [SHORT](#).

This **concludes** The Silver Squelchers series as it concerns current members (as of the next two episodes!). The main factor missing which prohibits more detail on The Pilgrims is the absence of current rosters. They insist they want to “promote good relations between America and Great Britain” or some such very similar statement and yet, to do this, almost 90% of their members must remain unknown to the public---not as to specific identities, but as to the matter of their membership in this unique, obscure, arcane, shadowy top upper echelon Society. I am considering a third run-through (the first such series was “Silver Suppressors Hiding in the Dark,” which was smaller in scope. A third series covering this group could consist of ten to 15 members from 1902–1903 and 1907 and 1914 and 1919 and 1924 and 1933 and 1940 and 1949 and 1957 and 1969 and 1974 and 1980---years that located lists have been found (1907 and 1919 were officials only). This will be called Silver Squelchers Flashback series. **I intend to present mostly identities I haven’t mentioned anywhere to date.**
