

RUM AND SILVER

Seen on bumper sticker---"If you aren't completely appalled, you haven't been paying attention."

Ocean going pirates used to drink rum and steal silver, but this isn't the focus for this month. What was that old slogan, "yo ho-ho and a bottle of rum!" "Death Rides A Horse" (1966) had a quotation---

"Get a good strong bottle of rum, because the more this man drinks, the more he talks!"

In this case, Rum is short for Rumsfeld, the Defense Secretary in the current Bush administration. Some folks call him "Rummy," and he could become one if things go too far against his wishes. The New York Times, September 28, 2003, ran a feature on him, "Drunk On Rummy." I can't say whether Donald Rumsfeld has any rum drinking habit, but I can truly say, he has stolen some silver. Not so much for himself, but to benefit the Silver Users Association and the Federal Reserve System.

Rumsfeld is one of the most **threateningly dangerous operators** to ever hold high positions in the American government. In times past, I would have said that about Elliott Richardson (Pilgrims Society), former Attorney General who "persuaded" numerous cops to not cite him for drunk driving. Please bear in mind, when I make such statements, these are my personal views. If you are a silver investor I am confident I can convert you to a thumbs down attitude on this operator; and even if you are not! There are elements here and other places who favor Mr. Rum. Let's take a look at Donald Rumsfeld and see how it has affected silver investors in the past, and how he could harmfully affect us in the near future---



That's a more youthful Don Rumsfeld sporting eyeglasses, while he was White House chief of Staff under President Gerald Ford (Pilgrims Society) and vice president Nelson Rockefeller (Pilgrims Society) during 1974-1975. Rumsfeld later became a trustee of the Gerald Ford Foundation. Richard Cheney, of Texas poaching and shooting the wrong target fame, was deputy chief of staff at that time. Rummy was Defense Secretary, 1975-1977. Rumsfeld was born in Chicago on July 9, 1932. As a young man Rumsfeld became administrative assistant to Congressman David S. Dennison Jr., Ohio Republican, 1957-1959. In 1959 Rum became staff assistant to Robert P. Griffin, Michigan Congressman. Members of Congress from Michigan have a solid track record of supporting Dow Chemical, Silver Users Association member and large-scale chemical polluter. Rum went directly into the financial community in 1960-1962 as an investment banker with A.G. Becker & Company, later noticed to have Warburg family ties. In fall 1962 Rum was elected to the House of Representatives from the 13th District in Illinois, and was reelected in 1964, 1966 and 1968. While in Congress, Rumsfeld's votes supported the Treasury Department's objectives to phase out silver coins, melt them down and gift them to the Silver Users Association. Rum was on the Joint Economic Committee, the Government

Operations Committee, the Committee on Science and Aeronautics and the Subcommittees on Military and Foreign Operations. It was that background which spring boarded Rum to become Defense Secretary in two Administrations.

Rum was a founder of the Japanese-American Inter-Parliamentary Council, a liaison between the legislative bodies of the two nations. It has probably functioned in the shadow of the Trilateral Commission. He was a member of the U.S. Joint Advisory Commission on U.S./Japan Relations - Reagan Administration (1983 - 1984); and was on the Commission on U.S.-Japan Relations in 1989-1991. In 1969, Rumsfeld resigned his seat in Congress to serve as a Cabinet member and as the Director of the Office of Economic Opportunity and Assistant to President Nixon. You ask, economic opportunity for whom? He then went on to be Counselor to President Nixon from 1970 to 1973; the Director of the Cost of Living Council from 1971 to 1973; Chairman, Property Review Board (ominous sounding), 1971-1973; and Ambassador and Permanent Representative to the North Atlantic Treaty Organization (NATO) from 1973 to 1974. NATO is another British attempt to recapture their American "colonies" by treaties and military coordination. Around 1974 he was also a director of the National Center for Voluntary Action, described in bland, reassuring tones at www.presidency.ucsb.edu/ws/index.php?pid=2305 Pilgrims Society member John W. Gardner, head of The Urban Coalition and Common Cause, was a director of the NCVA. Gardner, trustee of the Rockefeller Brothers Fund, was a director of Shell Oil; Time; New York Telephone; and American Airlines. His 1961 book "Excellence," on the back cover, asks, "Can we be equal and Excellent too?" (No---only Pilgrims Society types can be equal; the rest of us must be excellent.) The impression the NCVA seems to convey is, "volunteer or we'll coerce you" to do this, that or the other!

In Rum's role as director of the Cost of Living Council current vice president Richard Cheney seconded him as number two administrator in that depraved Fascist agency

Blame was never placed on the Federal Reserve for causing inflation, but on "rising prices." Both are known to be members of the Council on Foreign Relations, public front for The Pilgrims

Society, and either man could easily be a member of the far more secretive elite group. All such groups favor created paper money; certainly, since the most powerful of their members are behind its creation. The Cost of Living Council was a peacetime counterpart to the World War II Office of Price Administration (OPA). While the United States was fighting Fascist Italy, it was practicing Fascism here, by telling businesses what they could sell their products for. In order to show how the Cost of Living Council seriously harmed American silver producers, let's back track briefly---

The Wall Street Journal, November 20, 1967, page 28 remarked---

"Silver users are growing critical of the Government's weekly silver sales program, complaining the Government is holding up the price of silver by seeking to obtain top prices for its metal."

Well, SUA does not want any silver producers or owners to obtain top prices for their metal! That item reminds you of a story that came out on the front page of the WSJ barely three weeks earlier (October 26, 1967), "Copper Strike Cuts Silver Supply; U.S. Helps Users" talk about an organization that feeds off others (taxpayers and miners), rather than fending for itself---that's the freeloading, pick pocketing Silver Users Association!

From a not so lofty price of \$2.07 an ounce in 1967 Treasury Department silver auctions to the Silver Users Association, silver was crushed down to \$1.61 an ounce by edict of the Rumsfeld-Cheney managed Cost of Living Council---a price slash of over 22%! Imagine smashing through the side of a mountain and constructing tunnels to pulverize ore and extract silver, the vampires leeching off you are complaining metal costs too much at Uncle Sam's giveaway orgy, then that ends, but a Fascist Federal Agency is created that tries to break your back with an even lower price! Apparently they wanted Idaho miners to subsist on potato peels. As we see in the Wall Street Journal, July 24, 1972, page 16---

“The Phase 2 price ceiling on domestic silver is \$1.61 an ounce. The Cost of Living Council has created an artificial tightness by ruling that silver refined from domestic ore can’t be sold to U.S. **users** at more than the ceiling price.”

In that article, Hecla Mining Company called the ruling, “arbitrary and capricious discrimination against a basic industry.”

If you were a silver miner in those days, you’d be mad as hell about it, raving furious like the Mongolian Nightmare, Killer Khan---



“**He’s a ruthless little bastard**”---Nixon on Rumsfeld, 1971, well, no wonder the choice of words. If you were invested in a

silver mining venture you certainly would have seen Rummy as
a **BASTARD**---



In this more recent pose, Rumsfeld seems to be saying,
“Two dollars, two dollars per ounce, is what silver miners are
entitled to---that’s not an inflationary price!”

Funny how Bell & Howell has been a member of the National
Photographic Manufacturers Association (silver users), and
how several of Rum’s buddies headed that corporation---as
we shall see. “The Cloud Minders” episode of “Star Trek,”
aired on February 28, 1969, showed Captain Kirk kidnapping
the High Advisor and forcing him to dig in the mines.
James, you should have given someone on Capitol Hill that
experience.

The Wall Street Journal, April 14, 1972, page 3, reported
that American Smelting & Refining Company (ASARCO)
petitioned the Cost of Living Council for silver and zinc prices
to be exempted from price controls. The CLC denied the
request, saying that higher prices would create an
“inflationary impact.” WSJ reported on July 24, 1972, page
16, that James McClure (R., Idaho) asked the CLC to exempt
all silver mining. The petition was denied. The Federally
dictated silver price ceiling was \$1.61 an ounce, well below

the maximum price of \$2.41 an ounce for silver at the Treasury "auctions" (give-aways) to the Silver Users Association, summer 1967 through fall 1970. But less than three weeks later WSJ, August 11, 1972, page 5 reported---

"Domestically produced silver used for commercial, industrial and manufacturing purposes was exempted from price controls. The action by the Cost of Living Council was prompted by the recent development of a two-tier price system for the metal, with the uncontrolled international price rising about 20 cents above the domestic ceiling price of \$1.61 an ounce. The council noted that the price disparity encouraged both exporting and hoarding of domestic silver. Noting that well over half of the silver used in the U.S. is imported and free of controls, the council said any increase in the price of domestic silver will have only a minimal inflationary impact."

Wasn't it just terrible that there was an "uncontrolled international price" that was higher than what Rum and Cheney ordered? How dare the world defy these dignified gentlemen? After all, they shit diamonds, don't they? Friends, none of you have seen me full blast; sometimes, self-restraint has to be loosened. Idaho miners were stockpiling ore, shipping concentrate elsewhere and curtailing operations due to the Capitol Hill thieves. When the CLC was forced to back off, they changed their tune about inflation, yet never blaming the Federal Reserve. In 1982-1983 Rum was President Reagan's envoy on the Law of the Sea Treaty, which presumably includes in some ten inch thick document, plans to render oceanic silver mining a venture of low profitability, even if prices could otherwise justify it. Let's look at Rumsfeld's other "business" background after one more dash of data---in 1974 he was listed as a member of the advisory committee for the Congressional fellowship program of the American Political Science Association; certainly an extremely active operator!

From 1977 to 1985 he served as Chief Executive Officer, President, and then Chairman of G.D. Searle & Co., a worldwide

pharmaceutical company, during which time their product, Aspartame, was approved by the FDA. The successful turnaround there earned him awards as the Outstanding Chief Executive Officer in the Pharmaceutical Industry from the Wall Street Transcript (1980) and Financial World (1981). He was Senior Advisor to Reagan's Panel on Strategic Systems. He was also Chairman and Chief Executive Officer of General Instrument Corporation (merged into Motorola) from October 1990 to August 1993. Rumsfeld was a member of the board of directors Tribune Company, large-scale newspaper publishers. He also served as director of Metricom, Inc, and was a member of the U.S./Russia Business Forum. He chaired General Instrument Corporation in the early 1990's (merged into Motorola) and has been a trustee of the Eisenhower Exchange Fellowships, a globalist indoctrination tool similar to the Fulbright Scholarships.

Rumsfeld has been listed as a member of Freedom House, another internationalist organization. A current trustee is Robert Hormats of Goldman Sachs, also a director of Englehard, Silver Users Association members of long standing. Not only is Rumsfeld hostile to a decent silver price, it appears that everyone he associates with shares that outlook.

Skinner went on to become Secretary of Transportation squelching the cries of the pilots who were by now having seizures on this seizure-triggering drug, aspartame, and then Chief of Staff under President Bush's father. Some of these people reach high places. Even Supreme Justice Clarence Thomas is a former Monsanto attorney. (Monsanto bought Searle in 1985, and sold it a few years ago). When Ashcroft became Attorney General, Thompson from King and Spalding Attorneys (another former Monsanto attorney) became deputy under Ashcroft. (Attorneys for NutraSweet and Coke).

However, the FDA still refused to allow NutraSweet on the market. It is a deadly neurotoxic drug masquerading as an additive. It interacts with all antidepressants, L-dopa, Coumadin, hormones, insulin, all cardiac medication, and many others. It also is a chemical hypersensitization drug so that it interacts with vaccines, other toxins, other unsafe sweeteners like Splenda which has a chlorinated base like DDT and can cause autoimmune disease. It has a synergistic and additive effect with MSG. (www.truthinlabeling.org). Both being excitotoxins, the aspartic acid in aspartame, and MSG, the glutamate people were found using aspartame as the placebo for MSG studies, even before it was approved. The FDA has known this for a quarter of a century and done nothing even though its against the law. Searle went on to build a NutraSweet factory and had \$9 million worth of inventory.

Donald Rumsfeld was on President Reagan's transition team and the day after he took office he appointed an FDA

Commissioner who would approve aspartame. The FDA set up a Board of Inquiry of the best scientists they had to offer, who said aspartame is not safe and causes brain tumors, and the petition for approval is hereby revoked. The new FDA Commissioner, Arthur Hull Hayes, over-ruled that Board of Inquiry and then went to work for the PR Agency of the manufacturer, Burson-Marsteller, at a rumored \$1000.00 a day, and has refused to talk to the press ever since. Rumsfeld calling in his markers is even documented in the Congressional Record!

In order to get it in other countries, Searle made a business deal with Professor Paul Turner in England. They knew if England found out the FDA wanted them indicted for fraud it could never get approved. Parliament found out and there was a big blow out but the order was never rescinded. The story was in the Guardian. Now all they had to do was rubberstamp this deadly poison around the world.

There were three congressional hearings because of the outcry of the people being poisoned. Senator Orrin Hatch refused to allow hearings for a long time. The first hearing was in 1985, and Senator Hatch and others were paid by Monsanto. So the bill by Senator Metzenbaum never got out of committee. This bill would have put a moratorium on aspartame, and [would have] had the NIH do independent studies on the problems being seen in the population, interaction with drugs, seizures, what it does to the fetus and even behavioral problems in children. This is due to the depletion of serotonin caused by the phenylalanine in aspartame.

I spoke to the European Union a couple of years ago and brought them the damning government records so they would know that aspartame was never proven safe. This was at the time they were going to write a new report, again because of the outcry on aspartame. I also gave them some

of Monsanto's flawed research and showed them what they had done. You can't show a poison to be safe on studies without fixing them. But those from industry were part of the committee so what the EU did was eliminate all the damning research and use the flawed. They didn't even look at their own research. With regard to Desert Storm Syndrome, you may recall the government did a study and came up with Lou Gehrigs. The pop companies sent aspartame laced pop to the Persian Gulf to sit in the 120 degree Arabian sun and break down to formaldehyde cocktails. Go to www.dorway.com and read the [protest](#) of the National Soft Drink Association and you'll see they said it decomposes at 86 degrees. So the pop companies knew the gun was loaded. The NSDA also quoted the law that said it's illegal to put anything in carbonated beverages that decomposes or adulterates the drink. Yet the pop companies turned around and added it to the beverages anyway. And it would interact with vaccines like the Antrax given to the troops - never approved by the FDA. Back in 1996 when Dr. John Olney (founded the field of neuroscience called excitotoxicity, and attempted to stop the approval of aspartame with Attorney James Turner) made world news on the aspartame/brain tumor connection he was on 60 Minutes. Michael Friedman knowing full well the main reason the FDA [had] refused to allow aspartame on the market for 16 years was the brain tumors, got on 60 Minutes and defended Monsanto by saying aspartame did not cause brain tumors. Yet the FDA's own toxicologist, Dr. Adrian Gross, told Congress that without a shadow of a doubt aspartame can cause brain tumors and brain cancer, and violated the Delaney Amendment which forbid putting

anything in food you know will cause cancer. His last words to Congress were "And if the FDA violates its own law, who is left to protect the public?" All you have to do is read the Bressler Report (FDA audit) on www.dorway.com where Searle was caught excising brain tumors from the rats and putting them back in the study. When the rats died they resurrected them on paper. I spoke with Jerome Bressler as did Dr. H. J. Roberts (Aspartame Disease: An Ignored Epidemic, www.sunsentpress.com or 1 800 827 7991) and neurosurgeon Russell Blaylock, M.D. (author of Excitotoxins: The Taste That Kills, www.russellblaylockmd.com). He told us the studies were so bad that the FDA removed the 20% of his report that was the most damning. He also said to try and attain a cover letter as well as two mice studies. Dr. Roberts wrote his congressman to get this, but the FDA refused.

I asked Michael Friedman when he was going to get his reward for selling out to Monsanto, but he never answered. In June 1999 he got his reward when Monsanto hired him. I told him at the time the FDA no longer needed a revolving door, they could build a bridge to take care of the traffic.

Today we are faced with what may be one of the largest plagues in world history, [Aspartame Disease](#). Bush's political crony in Texas, Governor Rick Perry, is in on the Trans-Texas Corridor, an immense land-grab, totally unconstitutional in nature, which construction fits into the plans for a North American Union. It is linked to the Department of Commerce, run by Cuban born Carlos Gutierrez, ex-chief of Kellogg Company (appointed by Mr. Bush). The SPP calls itself "a trilateral initiative;" so, did they borrow a word from someone?

KICK THE RUM HABIT!

Kick the Rumsfeld habit, America! He chaired the U.S. Trade Deficit Review Commission in 1999-2000; you wonder if they considered what happens when the rest of the world balks at accepting our synthetic dollars that they can't use

here to buy oil and gas! Let's just view some brief highlights of Rumsfeld's career as Secretary of Defense since 2001.

Rum is an extremely hard-hitting, tough fellow! That is, with other folks lives. In the days of Alexander The Great, Attila The Hun and in early medieval times, William The Conqueror, then later Vlad Tepes (Vlad The Impaler, Dracula) and Genghis Khan, were all military leaders who actually led the charge into battle! The Chicago Tribune quoted Rumsfeld as saying the following: "The administration should clarify its intent in Viet Nam," he said. "People lack confidence in the credibility of our government." Even our allies are beginning to suspect what we say, he charged. "It's a difficult thing today to be informed about our government even without all the secrecy," he said. "With the secrecy, it's impossible. The American people will do what's right when they have the information they need." (Chicago Tribune, 4/13/66)

Rum is expert at speaking out of both sides of his mouth.

In December 2004 a soldier asked Rumsfeld in a "Town Hall" setting that was broadcast back in the USA---

"Why do we soldiers have to dig through local landfills for pieces of scrap metal and compromised ballistic glass to

armor our vehicles, and why don't we have those resources readily available to us?"

After asking Wilson to repeat his question, which excited cheers among the 2,300 troops assembled, a startled Rumsfeld replied, "You go to war with the army you have, not the army you might want or wish to have at a later time." That's so satisfactory for a coward who never has to face gunfire or bombs!

I ask the reader to consider, why are we occupying Iraq? Mr. Bush incessantly prated for weeks on end before the invasion there were "weapons of mass destruction" in Iraq. None were found. The cynical onlooker would have guessed that such weapons would have been planted there by occupying forces, in order to say, "Look what we found, Mr. Bush was right!" Now that almost 3,000 U.S. troops have been killed and many more have come home with battle scars, missing feet, arms, kidneys, blinded and so forth, we hear, it may be necessary to attack Iran. The reason? It seems Iran wants nuclear power for its country. That should hardly be considered subversive. However, it is also alleged, they want to have nuclear attack weapons. India has more such missiles than does Pakistan. With Israel and Iran hating each other, it's another case of a religious based hatred going back thousands of years. Arab states see American involvement in Iraq as a continuation of the Crusades---a 1,000-year intermittent war! The Monroe Doctrine of the early 1820's told Europe and Britain, "hands off North America." We were protecting our own shores. When Switzerland takes a stance of nonintervention, they are called "neutrals." If an American takes the same stance,

he is denounced as an "isolationist." The propaganda creators have crafted such a negative aura about that word that it could equate to "deranged child molester." What a wonderful way to keep us involved in British sponsored wars!

It is very convenient that the British leadership as well as our own, has a strong bias in favor of Israel. Fact is, Iran has been the target of British tampering in the early 1950's with the overthrow of Mossadeqh and the installation of the Shah, and long before that during struggles with the Ottoman Empire and activities in the Opium Trade. The British and American elitists would like to occupy Iran so as to access oil in and around the Caspian Sea. Iran itself contains vast natural gas and oil resources. Rumsfeld attended the 2002 meeting. Sir Peter chairs British Petroleum, world's 5th largest industrial, and Goldman Sachs International. Rum was well acquainted with Sir Sutherland while they concurrently served on the board of Asea Brown Boveri (ABB) based in Switzerland. ABB is a considerable consumer of bullion silver. The London Times, February 8, 1980, page 18, said---

"The company uses 20 tonnes of silver annually in various branches."

ABB annual reports from the last several years might show higher rates of silver usage than that, especially if annual revenues, adjusted for inflation, are significantly greater. You have to wonder if much of their silver came from Swiss banks who stored silver for individuals holding certs, but the

silver was leased out (never to return). Perhaps these certs have some legend near the bottom line on their flip side, in invisible ink, forcing paper settlement of the claims! At any rate, Dr. Fritz Leutwiler, who was president of the Swiss National Bank, also chaired Asea Brown Boveri in the mid 1980's! That could have been so convenient---just send a truckload of bullion from the vaults over to the industrial for use in exchange for a tiny interest rate! Work those sterile assets! Maybe it cost less than \$1.61 per ounce! Some day we may discover the real details as to silver leasing and just how conniving and dirty it was. Fritz was also quite public as to statements he made concerning central bank intervention in managing gold prices to the downside. What the hell is Mr. Bush doing calling North Korea part of the "Axis of Evil" when he appointed Rum to be Defense Secretary, just after Rum took part in a big sale of strategic nuclear plants to N.K.? Rum was listed, in the year 2000, as

Chairman of the U.S. Commission to Assess National Security Space Management and Organization. **WOW**, Rum even has had oversight of satellites! Rum chaired the Commission on the Ballistic Missile Threat to the United States in 1998-1999, another bizarre item on his perverted resume. In his official capacity in that Commission he remarked---

"North Korea maintains an active weapons of mass destruction programme, including a nuclear weapons program."

Since Israel realizes North Korea and Iran are probably friendly with each other, how do they feel about that nuclear deal which was worth several hundred million for ABB, as Rum passes himself off otherwise as their friend? Maybe North Korea is assisting Iran with technology! This is also the same slick operator who once served as Chairman of the Congressional Leadership's National Security Advisory Group---



Suppose North Korea, using the Rumsfeld-Sutherland ABB nuclear deal as a springboard, reaches the stage where it can hit Mount Rainier in Washington state, and Mount Shasta in northern California, both dormant volcanos soaring over 14,000 feet, this causes them to erupt, and half of

western U.S.A. and Canada are devastated? Would Rumsfeld connive some way to blame the destruction on "greedy silver miners" wanting more than \$1.61 per ounce?

From 1985 to 1990 he was a senior advisor to William Blair & Co., an investment banking firm. On March 10, 2002, USA Today www.usatoday.com/money/finance/2002-03-11-blair.htm reported Blair execs were convicted of a "massive scheme of securities fraud" (173 counts) that took place from 1989-1998. "Racketeering" was the indictment www.thestreet.com/brknews/brokerages/1018776.html says that Blair people took boxes of computer printouts from Salomon Smith Barney and used the info to contact 10,000 of its customers. That's funny, since Rumsfeld later chaired the Salomon Smith Barney International Advisory board (the same brokerage whose ace analyst Jack Grubman conned millions of investors to buy shares of five companies whose shares tumbled 99.9%!) Pilgrims Society member J. Morton Davis, demonstrated the Society's untouchability by avoiding any criminal charges, controlled D.H. Blair!

Davis controlled Interneuron Corporation, which marketed Redux, an obesity "medication," that had to be pulled due to causing heart valve damage. Davis has a son in law worth \$617 million (Genetic Engineering News, 100 Molecular Millionaires, 2002) while presumably Davis is even wealthier. During this time (1985-1990), Rumsfeld also worked with Bechtel negotiating a pipeline deal in Iraq. First Rumsfeld does something to make a foe of Israel stronger, then he attacks it. Looks as if all Rum wants is war, war, and more war, saying in unison with the German Panzer tank commander (brilliantly acted by Robert Shaw) in a conversation in the 1966 film "The Battle of the Bulge"---

"If we are not winning the war and we are not losing the war, then what is happening?"

"The best thing possible is happening! The war will go on!"



Rumsfeld was featured guest at a meeting of the Council On Foreign Relations (CFR, 4,200 slithering members nationwide) on May 27, 2003. That meeting was presided over by Peter G. Peterson, chairman of the CFR, selected by fellow Pilgrims Society member David Rockefeller to head the organization after he stepped down in 1985. The 1974 Who's Who, page 2665 has Rumsfeld stating "member New York Council on Foreign Relations," so he is a member of very long standing.

"The Council on Foreign Relations was founded in 1921 by businessmen, bankers, and lawyers determined to keep the United States engaged in the world."

Founded in 1921 by Pilgrims Society members as a more visible public front, "determined to keep the United States engaged in the world," meaning, engaged in foreign conflicts! War is very profitable and fulfills the goals of population reduction and creation of world government after which presumably, the Crown intends to reveal itself. From remarks made by Peterson we learn the following---in 1970 Rumsfeld ran the "Anti-Poverty Program," very sardonic if you were a silver miner and he starts pillaging your finances

with a Federally imposed price cap; Nixon himself worked in the OPA, Office of Price Administration during WWII, dictating prices to various industries (helping Pilgrims run conglomerates take over smaller concerns who couldn't survive the price capping); and Peterson first met Rum at the home of Illinois Senator Charles Percy back in the mid-1960's. Percy was head of silver user Bell & Howell (photography) before Peterson assumed that post. Percy's daughter Sharon married a Rockefeller. Sharon Percy married John D. Rockefeller IV, great grandson of the original Rocky who founded the sinister Standard Oil Empire. Today the Empire is dropping gas prices temporarily only so that Congressional incumbents can be reelected. If accomplished, the war on Iran can get started. In that event, Rumsfeld can say, silver hoarders must surrender their metal for the war effort. We could be compensated in FRN's at the old Cost of Living Council rate of \$1.61 per ounce. There is no outrage that crazed lunatics will stop short of. 

Unfortunately, this appears to be another quasi-religious organization, with so many Jewish names present. This does not make me blameworthy of anything to point this out, since legal tradition inviolably holds that the truth is an absolute defense against libel. Granted there are religious hatreds seething in the Middle East. Bennett, Secretary of Education (1985-1988) who became "Drug Czar" under President George H.W. Bush The First. Interestingly, Bennett is a director of Catholic Campaign for America, proving of course that there is more going on in the minds of war advocates than simply "Israel versus Arab countries." Bennett is also an Olin fellow at the Hudson Institute (named after Pilgrims member John M. Olin of Olin Chemical). James T. De Graffenreid, chairman of the Center for Security Policy in D.C., www.centerforsecuritypolicy.org of which Rumsfeld is a member, is also Catholic. This center has a project called Divest Terror and another called Coalition for Security, Liberty and the Law, that supports the Patriot Act. Their site has a page, "Our Man Rumsfeld," and one of their directors is a Boeing executive. Ahh, the profits of war! "No discussion of how the Lobby operates would be complete without examining one of its most powerful weapons: the charge of anti-Semitism. Anyone who criticizes Israeli actions or says that pro-Israel groups have significant influence over U.S. Middle East policy—an influence that AIPAC celebrates—stands a good chance of getting labeled an anti-Semite. In fact, anyone who says that there is an Israel Lobby runs the risk of being charged with anti-Semitism, even though the Israeli media themselves refer to America's 'Jewish Lobby.' In effect, the Lobby boasts of its own power and then attacks anyone who calls attention to it."

Harvard professor Stephen Walt of the John F. Kennedy School of Government and John Mearscheimer of the University of Chicago Department of Political Science published an 83 page research piece in March 2006 entitled, "The Israeli Lobby and U.S. Foreign Policy" at [www.ksgnotes1.harvard.edu/Research/wpaper.nsf/rwp/RWP06-011/\\$File/rwp_06_011_walt.pdf](http://www.ksgnotes1.harvard.edu/Research/wpaper.nsf/rwp/RWP06-011/$File/rwp_06_011_walt.pdf)

Page 42 has them remarking---

"The Lobby's campaign for regime change in Iran and Syria could lead the United States to attack those countries, with potentially disastrous results. We do not need another Iraq."

It was the surest possible bet that this Lobby and its associates would denounce their report based on name calling, rather than attempt refutation using strictly hard

facts. You can see the details at www.commondreams.org/views06/0413-20.htm of the firestorm that took place last April after they release their report. As silver investors, we have far more to lose than our metal if the U.S. is prodded by foreign powers, including the ever-infamous Great Britain---we stand to lose our young men, perhaps by the hundreds of thousands. Iran is many times stronger today than Iraq when we invaded it. I believe the Bush administration have "higher" goals in mind than attacking another Arab state---the Pilgrims Society wants the monumental natural resources in Iran and the Caspian Sea. Middle East affairs are not new to Rum---he was Reagan's special envoy to that region in 1983-1984.

A hallmark of monarchies and totalitarian states is that they always contain a faction that has succeeded in obstructing all questioning and criticism of their actions. We cannot allow this to come about, else the America of the Founding Fathers be set at naught. I ask the critics to quote these last two sentences if they have a dart to hurl at me.

The US ships in the Gulf will already have come within range of the Sunburn missiles and the even more-advanced SS-NX-26 Yakhonts missiles, also Russian-made (speed: Mach 2.9; range: 180 miles) deployed by the Iranians along the Gulf's northern shore. The IRC, or International Relations Center (new to me) is based in Silver City, New Mexico, and says it is concerned about “the militaristic drift of the country.” I am not a person who claims to have all the answers. Many times I feel as if I have very few answers. Speaking only for myself, I do not agree that because religious hatreds exist in the Middle East, that we should therefore go to war for either side. Did I miss something in the Bible? Sorry, I prefer to not debate that here. RUMSFELD & THE RAND CORPORATION

Just before becoming Defense Secretary for the second time, Rumsfeld was a trustee of The Rand Corporation, a very important "think tank" in Washington D.C. At www.rand.org they state their alleged purpose---

"To further and promote scientific, educational, and charitable purposes, all for the public welfare and security of the United States of America."

Who creates the definitions of what public welfare consists of? "Security" has become an extremely toxic word---it means, we must forfeit all our privacy and scrap the Bill of Rights! At their site you find---

"It was on May 14, 1948, that Project RAND — an outgrowth of World War II — separated from the Douglas Aircraft Company of Santa Monica, California, and became an independent, nonprofit organization. Adopting its name from a contraction of the term research and development, the newly formed entity was dedicated to furthering and promoting scientific, educational, and charitable purposes for the public welfare and security of the United States."

"Almost at once, RAND developed a unique style, blending scrupulous nonpartisanship with rigorous, fact-based analysis to tackle society's most pressing problems. Over time, RAND assembled a unique corps of researchers, notable not only for individual skills but also for interdisciplinary cooperation. By the 1960s, RAND was bringing its trademark mode of empirical, nonpartisan, independent analysis to the study of many urgent domestic social and economic problems."

Donald Douglas of Douglas Aircraft was a Pilgrims Society member. It was merged to become McDonnell-Douglas, on that board sat Harold Holmes Helm of Chemical Bank, one time chairman of the admissions committee of The Pilgrims.

On the Rand Europe board of trustees is Sir Lawrence Freedman, Professor of War Studies at King's College in London. **WARMONGERS!** The United Kingdom Ministry of Defense and the Crown Agents are listed as Rand clients!

Lord Renwick of Clifton, chairman, JPMorgan United Kingdom, is on the Rand Europe Advisory Board. The Lord Renwick is a member of The Pilgrims of Great Britain who was a director of Harmony Gold, 1999-2004; of BHP Billiton, 1997-2005; was U.K. Ambassador to South Africa, 1987-1991; to the U.S.A., 1991-1995; and is now a director of Fluor Corporation, global construction firm with 30,000 employees; Compagnie Financiere Richemont; SAB-Miller, brewing company active in 60 countries; and Kazakhmys PLC, copper mining concern in Kazakhstan with \$441 million profits on \$1.3 billion volume in 2004. Firms like Fluor, Bechtel, Halliburton, Carlyle Group, ExxonMobil, BP and others are probably dreaming about resource seizure and "reconstruction" in Iran.

Rand Corporation has a Project Air Force, and it has two former Defense Secretaries as trustees---Frank Carlucci (CFR) of Carlyle Group and Harold Brown (CFR) of the Warburg interests. Timothy Geithner (CFR), president of the Federal Reserve Bank of New York, is a trustee; other trustees are Paul O' Neill of the Mellon interests, former Treasury Secretary; Jerry Speyer, of the Speyer family of Pilgrims Society members (international banking and real estate); and arrogant, cocky looking Philip Lader, former Ambassador to the United Kingdom, Pilgrims Society member, chairman of London based WPP Group (world's largest advertising agency); director, AES Corporation, "the global power company" with 30,000 employees; Lloyd's of London; Marathon Oil; senior advisor to Morgan Stanley International; trustee, British Museum and Duke University

Public Policy Institute; owner of interest in Sea Pines company, real estate resort community developer in South Carolina---



There could be some Rand study on how best to seize silver for military purposes, from investors; the study would not be limited to USA targets. These are the type interests Rumsfeld associates with. Rand does research for the National Institute for Mental Health; "mental health" presumably meaning, we are healthy if we agree with the aims of those in power! Rand also does research for the Federal Bureau of Investigation and the Department of Homeland Security. If it's war on Iran in the making, be prepared for a nationalization (confiscation) of silver for "defense" purposes. Hey boy, want to post this recommendation at your site? I ask that those of you who are attorneys in sympathy with this view, take appropriate measures to set up a clearing-house for legal grievants, working with operators of precious metals websites. This would extend to another call for impeachment of the President in the event he attempts to ignore the blame of the silver users, because Barbara Franklin of Dow Chemical helped him in his campaign. Making innocent parties stand good for a problem caused by greedy interests is one of the worst possible travesties of justice.

And let America not be directed by any foreign interests. I believe all nations have a right to exist---I said---all nations---and that something can be worked out rather than attacking Iran, which could cause China and Russia to enter the conflict. If we are on the way to Armageddon, I discharged my conscience by calling for nonintervention (neutrality). Maybe we can enjoy our silver for a few years, before death comes to each one of us, in whatever way. I certainly hope Mr. Rumsfeld does not get my 18 year old nephew killed by drafting him and sending him overseas because secretive elitists planned a larger scale war. I don't want to see him with a stump where an arm was, or in his grave before his time because of religious hatreds and greed. Many Americans are weary of stupid senseless interventionism. Let's bring our soldiers home before any

more are killed. Dialogue between a German soldier and his commanding officer in "The Battle of the Bulge" (1966) calls Rumsfeld to mind---

"All you believe in is the war! You have the war, you like the war! And all I have are my sons and I don't want to lose them!"

"I am not responsible for your children!"

"You are, you would make them soldiers!"

"Yes, and they will fight!"

"And they will die!"

"If necessary!"

"Necessary for who, for you?"

"You are not only a fool, you are a traitor!"

"And you are a murderer! You would murder my sons, you would murder my country, you would murder the whole world!"

These views are not from some "peacenik." I would have jumped at the chance to serve in a justifiable combat such as the Revolutionary War or War of 1812. The Middle East is not a comparison. Caspar Weinberger, Defense Secretary when Britain retook the Falklands Islands from their rightful owner Argentina, told The Pilgrims of Great Britain on January 27, 1994 and spoke of---

"...a mutual love of freedom, a mutual willingness to fight to keep it whatever the cost."

That's all code language, his view of freedom meaning world government. He was a Bechtel executive who later chaired Forbes Magazine. Weinberger wasn't Jewish---he was once treasurer of the Episcopal Diocese of California.

As for silver price unfriendly Rumsfeld, let a Congress populated by enough new faces say, they are ready to oust Nixon's "**ruthless little bastard.**" Let Congress quote the words of Captain Bligh in "Mutiny On The Bounty" (1962)---
